NARRATIVE CONTRACTOR OF THE PROPERTY OF THE PR

On Thursday, September 25, 2025, at approximately 0723 hours, while conducting traffic enforcement in the area of 4th Street and US Highway 1, I observed a white Dodge SUV make an improper right turn on red, where posted "No Right Turn On Red".

I conducted a traffic stop on the vehicle (FL / PEQC05) at the 100 block of US Highway 1. Upon making contact with the driver, later identified as, Samuel Mendez-Perez, I asked him for his license, registration, and insurance.

1, Ofc. 2. Dominguez, was dispatched to 1865 18th Avenue in reference to a potential stolen vehicle.

Upon arrival, I made contact with the complainant, Kassandra Whitworth. She advised that her vehicle 2007 Ford SUV with FI tag# BF64HJ was borrowed around 9:00pm on 09/24/25 by Jessica Stewart and Cyteria Davis last night to run to a nearby store. However, they had not returned the vehicle as of this time. Kassandra also advised that they were only invited to her house to stay overnight, and they did not live there. After not hearing from Stewart and Davis for hours, she wanted us to attempt to locate the vehicle but declined to report it stolen.

After putting out a BOLO for the Kassandra's vehicle at 1122hrs., Cpl. Lachowicz located the vehicle in the area of US1 Hwy/17th Street and conducted a traffic stop on it in the 900 block of 18th Street. Myself and the complainant Kassandra went to the location to retrieve her vehicle. Cpl. Lachowicz informed me that Davis was the driver of the vehicle and she had a suspended Florida drivers license. Through a records search, her license had been canceled indefinitely due to habitual traffic offender since 02/22/2022.

On scene, I spoke to the driver Davis and she acknowledged that she did not have a driver's license and had to pay fines. At this time, Davis was detained for not having a valid license. The vehicle was then searched by Cpl. Lachowicz and he located a cigarette pack (Brand 305, green in color, non menthol) in the center console cup holder. Cpl. Lachowicz looked inside the cigarette pack and observed a rock-like substance and a powder white substance wrapped in a clear / paper holder. Cpl. Lachowicz field tested the substances and they tested positive for Methamphetamine and Fentanyl. The substances were later weighed totaling 1.9 grams of Methamphetamine (w/packaging) and 1.6 grams of Fentanyl (w/packaging).

I read Davis his Miranda rights which he acknowledge and waived. Davis was willing to talk to me about the substances that were found. I asked Davis about the items and he denied that they belonged to him. NOTE: Cpl. Lachowicz advised me that Davis was smoking a 305 cigarette upon making the traffic stop. Davis's passenger, Jessica Stewart advised she did not smoke cigarettes and did not know anything illegal was in the vehicle. Davis was then transported to the Indian River County Jail for holding with no bond.

On 9/25/25 at approximately 1245 hours, VBPD S10, with the assistance of VBPD CRT and Sebastian Police Department CR $_{1}$, executed a narcotics search warrant on the residence located at 466 19th Pl. Vero Beach, FL 32960.

While securing the residence, CRT members located and secured defendant Gregory Chaney, W/M DOB 3/11/75, who was found sitting on the bed inside the guest bedroom of the residence. No other occupants were inside the residence.

While conducting the search of the residence, VBPD Detective J. Maslan #40 located numerous items of paraphernalia commonly associated with the use of illicit narcotics inside a white hutch and with bedside table, in the quest bedroom where Chaney was found. Those items included multiple scales with residue, a large amount of small plastic baggies, and a small plastic baggie with an orange color capsule with the markings "Adderall XR". The capsule was confirmed by Drugs.com pill identifier as Amphetamine/Dextroamphetamine (Adderall), a Schedule II controlled substance in the State of Florida. There was a piece of notebook paper inside the guest bedroom closet where Chaney was located that had his name on it, showing Chaney as the person in custody of that bedroom. There were no other names or other items with other subjects names found inside the guest bedroom.

While conducting a search of the guest bathroom, four small Ziploc style baggies were found in the bathroom trash can, immediately next to the toilet. Those baggies contained green plant material and were wet, consistent with those that contained illicit narcotics that were flushed in the toilet, but then removed and placed in the trash can due to the baggies not making down the toilet. There also appeared to be a small amount of dark plant material on the rim of the toilet similar to the plant material found in some of the wet baggies.

Gregory Chaney was the only occupant of the residence at the time of the search and there was a significant lapse of time, approximately 2 and a half to three hours, between defendant Cassie Murillo, W/F DOB 7/19/79, being picked up in a vehicle from the residence and the search of the residence. After being picked up, Cassie Murillo was located at a separate location in the City of Vero Beach and never returned into the residence until the search was completed.

Due to Gregory Chaney suspected to have disposed of controlled substances prior to be taken into custody, he was charged with Tampering with Physical Evidence (FS 918.13(1a)), a third degree felony.

Due to Gregory Chaney possessing the suspected Amphetamine/Dextroamphetamine (Adderall) capsule, he was charged with Possession of a Controlled Substance without a Prescription (893.13(6a)), a third degree felony. He was issued Florida UTC ALZPACE for this offense.

Due to Gregory Chaney possessing numerous items of drug paraphernalia, he was charged with Possession of Drug Paraphernalia (893.147(1)), a first degree misdemeanor.

Chaney was transported to the Indian River County Jail without incident.
