**NARRATIVE**

Over the past few weeks, Teach Chris Rahal has been complaining about the odor of urine and observing wet spots near the east side double doors of building seven (7), at the Vero beach High School main campus.

On Thursday, September 25th, 2026, Rahal advised me that the odor was real bad and there was a large area that was wet. Rahal was not initially clear on the location of the occurrence, and I reviewed the interior cameras and I was unable to locate any evidence of urine. The video review did reveal a black male, dressed in jeans and wearing a hoodie that was in the vicinity of the doorway, but I did not observe any improper actions. On Friday, September 26th, 2025, Rahal text me two (2) photos of the wet concrete and again complained of a strong urine odor. I stated to Rahal that the location he sent was the exterior side of the door and he stated, "yes", that is where it always is located. I explained that I searched videos on the interior side and not the exterior side and I would conduct a more extensive video review.

I spent approximately four (4) hours reviewing campus video surveillance from multiple days over the past two weeks that spanned from Monday, September 15th, 2025, through Friday, September 26th, 2025, during the time frames of 6:20am - 6:45am. After the review was completed of the campus video surveillance, I was able to identify only one (1), student who was at that location daily, and he was later identified as Jaylen Fleming. The campus video surveillance on the exterior side of building seven (7), did not capture a full view of the double doors that lead into the east side stairwell, and the interior stairwell camera showed Fleming at that location daily, but never the act occurring. The urinating was occurring in the northwest area of the exterior doorway.

On Sunday, September 28th, 2026, I responded to the campus to try and identify a location that would assist with identifying the act taking place. While I stood at the location of occurrence and looked to the east while surveying the best perspective to try and catch the act occurring, there was only one usable location that I could identify, the west side lobby of the small gym, building fourteen (14). I entered the west side lobby and assessed the preparation that would be needed to ensure my concealment from people outside of the lobby. This location provided a clear sight path to the area in question which was free of any obstructions. I blacked out the interior lobby side gym door windows with black craft paper and I left the exterior windows alone.

On Monday, September 29th, 2025, I entered the west side lobby of building fourteen (14) and I placed my agency issued body camera on the interior side, south door crash bar, to capture a recording at that location. At approximately 6:31am, Fleming walked into the east side area of building seven (7). I observed Fleming walk along the sidewalk and then walk into the east side exterior door area that leads to the east stairwell. Fleming immediately walked into the northwest corner of the wall and urinated. I could see the liquid stream making contact with the wall and liquid flowing and collecting atop the concrete surface. After urinating, Fleming walked away from the northwest corner and remained at that location as he does daily. On this date, I did not photograph the ground prior to the incident which already had water atop the ground from the recent rains that occurred. Based upon the environmental factors, it was not clear on the ground that Fleming had urinated and I elected to try and collect more evidence the following day.

On Tuesday, September 30th, 2025, I conducted the same surveillance as the day prior. While positioned inside the west lobby of building fourteen (14), I observed Fleming on the east side of building seven (7) at approximately 6:34am while walking south on the sidewalk in between building fourteen (14) and seven (7). I watched Fleming walk west heading towards building seven (7) and he first walked towards the main, east side hallway doors and remained there for a brief period of time. There was other students that I could see to the north of my location as well as custodial staff that was in the vicinity. At approximately 6:37am, Fleming walked into the corridor area that

leads to the east stairwell and walked in and out of the immediate area. At approximately 6:39am, Fleming walked into the northwest corner and urinated. I could see the liquid stream making contact with the wall and liquid flowing and collecting atop the concrete surface. After urinating, Fleming walked away from the northwest corner and remained at that location as he does daily. During this occurrence, I took still photographs and video recordings of the ground surface both before and after the occurrence to document the wet location as I viewed it.

Due to a busier than normal day of activities on campus, I was unable to address the issues with Fleming but school administration was made aware of the urinating that was occurring on school grounds and what my investigation revealed. As the day concluded I advised administration that I would continue my investigation on Wednesday.

On Wednesday, October 1st, 2025, I conducted additional surveillance as the two (2) days prior. At approximately 6:35am, I observed Fleming walking along the sidewalk in between buildings fourteen (14) and seven (7), where other students had congregated. Fleming immediately walked into the building seven (7), east stairwell corridor, and urinated against the northwest corner wall. I could see the liquid stream making contact with the wall and liquid flowing and collecting atop the concrete surface. After urinating, Fleming walked away from the northwest corner and remained at that location as he does daily. During this occurrence, I took still photographs and video recordings of the ground surface both before and after the occurrence to document the wet location as I viewed it.

I advised administration that I would be making contact with Fleming and arresting him for disorderly conduct, violation of Florida State Statute (FSS), 877.03 as his actions would corrupt the public morals and outrage the sense of public decency. At approximately 11:20am, I made contact with Fleming and I conducted an audio and video recorded interview with my agency issued body camera in the presence of VBHS Principal, Rachel Finnegan. Fleming was read his Miranda rights and stated he understood them and would answer questions. When I explained the facts of the case to Fleming and asked him why he was urinating against the building he stated he did not do it and then stated he did not want to answer any further questions.

Fleming was then taken into custody and mechanical hand restraints were applied which were checked for proper fit and double locked. Fleming was transported to the Indian River County Jail without incident. The body camera videos and photographs that were taken will be preserved for future evidentiary findings.






### NARRATIVE

On October 1, 2025 at approximately 1250 hours, I, Deputy Gadacz responded to 1201 Old Dixie Highway (7 Eleven), in reference to a disturbance.

Upon arrival, I made contact with the employees at 7 Eleven. The employees advised an unknown white male who was later identified as Benjamin Elias Daum, was causing a disturbance in their store. Employees advised Daum was cursing at them and told the employee working the register that she was a "bitch and a black nigger". The employee became very upset and distraught so she contacted law enforcement.

Daum was then located inside of the store and I spoke with him about the incident. Daum advised he was yelling at the employees. Daum stated he had a lot to drink and relapsed. On Wednesday, October 1<sup>st</sup>, 2025, at approximately 2300 hours, I, Deputy M. Neill #6317 was observing traffic near the 800 block of 9<sup>th</sup> Street SW (Oslo Road), Vero Beach, Indian River County, Florida.

During this time I observed a silver Dodge Challenger traveling westbound. The driver, was wearing a facemask which covered his head and face. Upon entering the roadway to confirm this, the subject started to accelerate at a higher rate of speed than what was previously being traveled. I attempted to catch up to the vehicle to initiate a traffic stop. During this time, I estimate that the vehicle was traveling approximately 90MPH down 9<sup>th</sup> Street SW.

Upon getting closer to the vehicle, I observed it make a left turn and proceed south on 27<sup>th</sup> Avenue SW. The vehicle was still traveling at a speed greater than the posted speed limit. Due to traffic being slower, the suspect vehicle passed the slower vehicle on a double yellow. Upon approaching 14<sup>th</sup> Street SW, the vehicle was now driving on the wrong side of the roadway and had turned all of their lights off. Upon getting on to 14<sup>th</sup> Street SW, the vehicle corrected its travel and was no longer driving on the wrong side of the roadway. The vehicle then turned northbound on 26<sup>th</sup> Avenue SW and stopped in front of 1305 26<sup>th</sup> Avenue SW, Vero Beach, Florida.

As the vehicle was stopping, I was finally able to catch up and initiate a traffic stop. I activated my blue emergency lights. The driver, later identified as Mr. David Prince, exited the vehicle and started walking towards the residence. He was addressed at taser point and ordered to stop. He then turned around and started to walk back towards the vehicle. I had to physically grab Mr. Prince and pull him away from the vehicle to prevent him from getting back in. While on the ground, Mr. Prince refused commands to place his hands behind his back upon being taken in to custody by other deputies.

The passenger in the vehicle is currently dating Mr. Prince and has done so on and off for the past couple of years. She advised that she was afraid for her life as Mr. Prince was driving recklessly. She informed Mr. Prince to stop multiple times, to which he replied "shut the fuck up bitch". The victim then put her head down until the vehicle came to a stop. At no point in time did the victim feel as if she was free to leave or have the opportunity to do such.

I advised Mr. Prince of his Miranda Rights. He advised he understood his rights and was willing to speak to me. Mr. Prince advised he drove like that because he was scared of losing the vehicle, as it also did not have a tag attached. Mr. Prince admitted that what he did was stupid and that he was sorry for it. Mr. Prince advised he did what he did only for seeing law enforcement and knowing that he did not have valid registration for the vehicle. Mr. Prince confirmed that the victim, asked him to stop during this event, but he told her no and continued driving. Mr. Prince confirmed that he was wearing a facemask earlier as well. He said he wears one all the time because he is from Chicago and this is a normal thing to do up there.

Upon inspecting the vehicle, I confirmed that it did not have a tag attached. After looking at the vehicle and noticing the driver, I remembered that I have previous dealt with Mr. Prince on September 4<sup>th</sup>, 2025 under call number 2025-00094871. On this call Mr. Prince was warned that operating a vehicle which is unregistered is a
