On 04/29/2024, at approximately 1823 hours, I responded the parking lot of 931 12th Street (Plaza Auto Shop) in reference to a suspicious vehicle.

Prior to my arrival, I was advised by the property owner, that two male subjects driving a white sedan bearing Florida tag (99DMNF) pulled into a parking space in between his shop and another business that was currently closed. The complaint later advised, that he observed the subjects removed items out of a dumpster, without permission and placed them into their vehicle.

Upon my arrival, I observed the white sedan being occupied by two male subjects. When I made contact with the driver by knocking on the driver's side window, the subject immediately starting making furtive movements, by attempting to conceal unknown item that was in his left hand underneath his seat. I also observed that the passenger, had a cup in his right hand with numerous items sticking out of it, wedge the cup into the passenger door panel.

Due to having prior contact with both subjects in a law enforcement capacity during narcotic investigations, I was able to identify the driver as Colin Knight and the front seat passenger as Christopher Satcher. I also had personal knowledge that both subjects are active users of Methamphetamine, Heroin/Fentanyl.

When Knight provided me with his license, I observed that it was violent shaking in his left hand. I also noticed that Knights heart beat was at a rapid pace, due to the front of his shirt rising up and down at a fast rate.

Deputy Williams arrived, on scene with his K9 partner and I was advised Deputy Williams, that his K9 partner alerted to the vehicle to the vehicle for the presence of narcotics or contra band.

During a search of the vehicle, Deputy Williams located the cup that Satcher placed into the passenger door. While looking inside of the cup, he located a small plastic baggie that contained a crystal rock like substance. I was able to identify the substance as methamphetamine, due to my training and experience in narcotic investigations. The substance field tested positive for methamphetamine.

While searching the floorboard of the vehicle, where Knight was attempting to conceal an unknown item, Corporal Ruiz, discovered a purple sock. When Corporal Ruiz open the sock, he observed a baggie that contained a white powdery substance. At the same location, he observed a glass smoking pipe (meth pipe) that contained a burnt white substance. The substance field tested positive for Fentanyl. It was also placed on a digital scale and received a digital reading of 4.10 grams. Corporal Ruiz also discovered dozens of small clear plastic baggies that are commonly used to package narcotics, inside of the driver's side door panel.

Post Miranda Warnings, Knight admitted that intravenously used fentanyl, earlier in the day. Knight then advised, that he was trying to conceal the sock that contained the narcotics, due to Satcher throwing it at him, upon me making contact with them.

Satcher was transported to the Indian River County Jail for processing. Prior to arriving at the jail, Knight advised that he

Post Miranda Warnings, Satcher admitted to using Methamphetamine, on today's date and that he forgot that he placed the baggie inside of the cup. Satcher could not explain why he was sitting in the vehicle at the above mention location.

Satcher was transported to the Indian River County Jail for processing.

NARRATIVE

On Monday, April 29, 2024 at approximately 1239 hours I responded to the area of the Harbor Freight (2006 58th Avenue) and the Bank of America (5780 20th Street) in reference to a shoplifting suspect.

Upon my arrival in the area I observed a white male fitting the description of the male suspect from the shoplifting incident. The male subject was sitting on the curb between the Harbor Freight and the Bank of America eating an eggroll. The was suspect was described as a white male wearing a rainbow hat, black pants and an off-white shirt.

Upon making contact with the subject I detained the male subject and placed him in hand restraints.

I read the subject his Miranda Warning from a preprinted agency issued card and acknowledged he understood his rights by stating "yes". The male subject identified himself as Joseph Carlberg DOB: 09/24/1993.

Joseph provided the statement he knew why I was with him and being detained. Joseph advised that he was homeless and just hungry.

I was sent a photo of the male subject and the subject was identified by the photo.

Joseph advised that the items he took from Walmart were in the blue Walmart bag besides the other eggroll and hot dog. The hot dog and eggroll were located in the green reusable bag next to the blue Walmart bag.

It should be noted that Joseph is seen walking throughout the Walmart store with the green reusable bag and a blue Walmart bag concealing items in both bags.

I made contact with LaShawnda Ray the ASI who provided the written statements that follows; I, API LaShawnda Ray of Wal-Mart Asset Protection while walking the sales floor observed an individual now known to me as Joseph Carlberg, selecting merchandise then concealing it into an unpaid reusable shopping bag such as groceries. I continued observation via sales floor as Joseph Carlberg continued to select and conceal the unpaid merchandise into the shopping bags. Joseph Carlberg then passed all last points of sale by exiting out of the General Merchandise, making no attempt to pay for the unpaid merchandise that he concealed into the reusable shopping bags. I stopped Joseph Carlberg identifying myself as Wal-Mart Asset Protection along with Store Manager Michael Gayle and requested he return inside to the AP office. Joseph Carlberg did not cooperate and fled the property on foot towards State Road 60. IRCSO was notified and was given Joseph Carlberg whereabouts. A training receipt was obtained on all unpaid merchandise; Joseph Carlberg failed to pay for 15 items totaling \$37.05. Wal-Mart wishes to prosecute and trespass.

I reviewed the in-store surveillance video of the incident and concur with the statement provided by Ray.

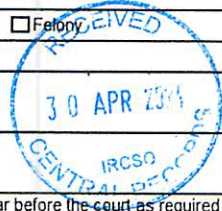

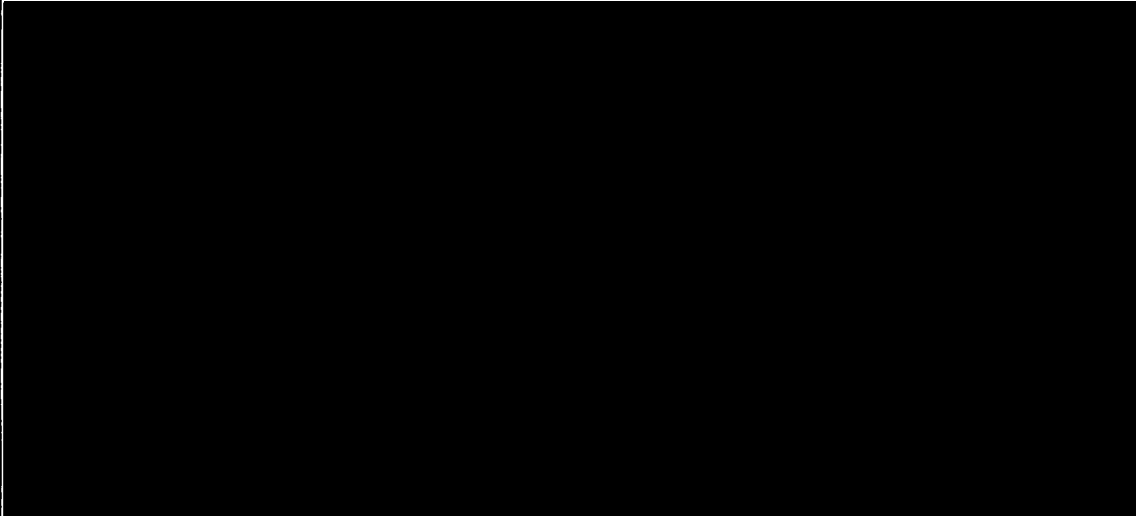

Upon making contact with the driver, I advised her that the reason for the traffic stop was due to having an expired tag on the white Ford (FL tag # CE56KV). When I asked for her license, she stated she did not have it with her. I then asked her if she had ever been issued one or if there were any suspensions, to which she stated that she had a suspended license and was a habitual offender. She stated she had recently been arrested for driving while license suspended.

The driver stated she did not have any identification on her and provided me with her name and date of birth. The driver was later identified as Erica Roberts (B/F DOB 09/17/1998).

I then conducted a FCIC/NCIC check of Roberts' license status which showed numerous suspensions, which are as follows:
