On 04/24/25 at approximately 1:36 AM, I was sitting on 12th Street near 58th Avenue. I observed a small vehicle exit the Oaks of Vero and head east on 12th Street. Due to a recent string of auto burglaries, and the fact that one of the suspects was seen on video riding a scooter, I exited onto 12th Street and caught up with the scooter just east of 43rd Avenue.

Upon catching up with the vehicle, I observed it did not have an operable tag light, and the tag affixed to it had faded characters at the beginning.

I conducted a traffic stop in the 3700 block of 12th Street. I activated my emergency lights without the siren initially. The vehicle continued traveling east on 12th Street, failing to stop for my emergency vehicle. I activated my sirens several times and used different tones in an attempt to get the operator's attention. The subject still failed to stop.

As we approached the intersection of 27th Avenue, the light was a steady red. The scooter briefly stopped, then continued through the red light and proceeded eastbound, still failing to stop. The vehicle-maintained speeds between 32 to 34 MPH. In the 900 block of 12th Street, two other units were present to assist. With the road widening to two lanes, I pulled up beside the suspect and visually confirmed he was a male. While alongside him, he yelled that he was going to stop. I then slowed down and pulled back behind him.

At Commerce Avenue and 12th Street, the suspect turned north into the Publix Plaza, immediately turned east into the first parking aisle, then cut back north behind Starbucks. He continued north across the parking lot to Carrabba's, drove through the bushes, up onto the outer sidewalk of the business, then cut through a grass swale and another hedge before exiting to U.S. Highway 1. He then proceeded north on the sidewalk along the west side of U.S. Highway 1.

At this time, I lost visual contact with the suspect, but other deputies continued to follow him. I turned off my emergency equipment and proceeded north on U.S. Highway 1 toward 15th Place, the last reported location of the suspect. While en-route, I observed the suspect come back west on 15th Place, crossing U.S. Highway 1 and entering the bowling alley plaza. I made a U-turn and headed south. As I passed the plaza entrance near the Green Marlin, I saw the suspect exiting and heading north on U.S. Highway 1. I made another U-turn to follow.

In the 1600 block of U.S. Highway 1, I observed the suspect traveling north in the southbound lanes before turning west onto 17th Street. He continued west and ran a steady red light at Old Dixie and 17th Street. A Vero Beach Police Officer stationed at the intersection turned out behind the suspect with emergency lights activated. I lost visual contact due to the red light. I later observed Vero Beach Police turning north onto 14th Avenue and then west onto 17th Street. Once on 17th Street, I saw the taillight of the moped traveling west through the parking area behind the high school football stadium.

I paralleled the suspect's location by traveling south on 14th Court to 16th Street. I heard that the suspect was westbound on 18th Street, so I went north on 20th Avenue to 18th Street, where I saw him cutting across and heading south on 20th Avenue. I turned around and followed. The suspect continued west on 18th Street, cut through an opening in the 3500 block where police could not continue pursuit, and I reestablished visual contact at 41st Avenue as he headed south toward 16th Street.

The suspect continued south to 14th Street, then west to 43rd Avenue before turning north. I proceeded to 43rd Avenue via 16th Street and waited at the light before turning south. I then observed the suspect traveling north on 43rd Avenue. He passed me and turned west onto 16th Street. He crashed the moped in the 4600 block of 16th Street, where he was taken into custody by deputies.

Once the suspect was handcuffed, Deputy Crawford rolled him over to conduct a search. A small plastic baggie containing suspected cocaine fell from his pants. When rolled to the other side, another similar baggie fell out. Both baggies were collected by Deputy Crawford. Deputies Crawford and McKenzie conducted a field test, which returned a positive result for cocaine. The total weight, including packaging, was 1.35 grams.

At the scene, I made contact with the suspect who identified himself as Ariel Velez. I read him his Miranda rights, and he acknowledged that he understood. I explained the reason for the attempted stop, to which he responded that he "should not be in this position right now." I asked him if what was in his pocket was a little bit of cocaine, and he confirmed, "yeah." I advised that I may charge him for the cocaine, and he replied, "alright."

I transported the suspect to Cleveland Clinic for medical clearance, and then to the county jail for processing. At the jail, staff advised that his fingerprints returned the name Christian Velez. When I asked if he was Christian, he denied it and stated that Christian was his brother. I informed him that his fingerprints matched Christian Velez, not Ariel, and that he did not resemble Ariel in the Florida driver's license photo. He continued to claim he was not Christian.

I contacted the mother of his children and advised her of the situation. She confirmed that the suspect's real name was Christian Velez and that Ariel was his brother.

A records check revealed that Christian Velez had four active warrants out of Broward County:

1. Possession of a firearm by a convicted felon
2. Carrying a concealed firearm
3. Resisting without violence
4. Driving with a suspended license

All warrants were no bond. Case #20009994CF10A.

His driver's license was found to be suspended indefinitely as of 12/06/21. The moped was registered to another individual, and the tag did not belong to that vehicle. Additionally, the tag expired in 08/2024. Christian stated he had purchased the moped but had not yet registered it or obtained a tag in his name.

At this time, I placed Christian Velez under arrest for the following charges:





On Thursday, April 24, 2025 at 0816 hours, I responded to 1707 16th Street, Vero Beach High School, in reference to a domestic disturbance. Upon arrival, I made contact with a school resource officer, Indian River County Sheriff's Officer Sgt. Sheperd, in the parking lot across the street from the school, and connected to the football stadium, located on the corner of 17th Avenue and 16th Street.

I was informed that there had been a domestic disturbance between two high school students, which had taken place in this parking lot. This disturbance occurred inside of a red 2010 Toyota Corolla, bearing Florida license plate #RYLU72. At this point, I took over the investigation and made contact with all involved parties.

I made contact with the victim, a juvenile going by SG. SG stated that she was in the vehicle with the suspect, Miguel De Jesus, prior to going into school. SG and De Jesus were both seated in the front passenger's seat of the vehicle. A male walked by the vehicle and De Jesus thought that SG was looking at him. De Jesus then became very upset and started yelling at SG, causing a verbal disturbance. While De Jesus was yelling at SG, SG did not respond to De Jesus, causing him to become more irate with her. De Jesus then began slapping, hitting, and pulling SG's hair. SG stated that De Jesus hit her numerous times in the right arm, right thigh, and on the left side of her face, with both an open hand and a closed fist. In between getting slapped and hit, De Jesus also grabbed and yanked SG's hair, causing some hair to be ripped out of her head. De Jesus was then pulled off of SG by numerous bystanders.

SG did appear to be very distraught and emotional while officers were on scene. SG had redness and swelling to the left side of her face, as well as numerous red marks and bruising beginning to form on her right forearm, upper right arm, and upper right thigh.

I made contact with De Jesus, who stated that he was sitting in the front passenger's seat of the vehicle with SG, when a verbal argument ensued. At first, De Jesus stated that nothing had gotten physical, but changed his statement and said that he might have hit SG with his back pack when he was trying to exit the vehicle. De Jesus did not have any further comment at this time.

De Jesus had multiple small abrasions and small lacerations on both of his hands and forearms, all of which appeared to be old injuries. When questioned about the injuries, De Jesus stated that he works in landscaping and that's how he obtained the injuries.

SG did state that she [REDACTED] and it is a common occurrence for him to hit and attack her, but she has never had law enforcement intervene prior to this incident.

There were multiple bystanders, who all wished to remain anonymous. After questioning the bystanders, they stated that they noticed De Jesus and SG in some sort physical disturbance in the front passenger's seat of the vehicle. They intervened and were able to pull De Jesus off SG. They then notified the school resource officers and waited for law enforcement to arrive on scene.

De Jesus was taken into custody and transported to the Indian River County Jail without incident.

De Jesus was charged with FSS 784.03 (1A1) Domestic Battery, touch or strike.

All injuries were photographed and uploaded into evidence.

A domestic violence packet was filled out and turned into records at Vero Beach Police Department.

I immediately recognized White as the male suspect from a Burglary call for service the night before on 4/23/2025. White was asked twice to exit the vehicle he was seated in which he acknowledged, but did not move out of the vehicle. I then grabbed hold of White and escorted him out of the vehicle which he complied with. White was then placed into mechanical hand restraints while the investigation into the disturbance was completed.

Corporal Radock stood by with White while I spoke with the other party involved in the disturbance. Corporal Radock advised me he conducted a weapons pat down of White and while conducting it, his shirt moved, revealing a crack pipe protruding out from the right change pocket of White's jeans. Corporal Radock advised after locating the pipe, he conducted a search of White which yielded a sandwich baggie in White's left pant pocket which contained a loose, clear crystal-like substance. This substance, based on my training and experience, resembled methamphetamine. Also in the same sandwich baggie were two smaller baggies containing an unknown off-white colored powder. The substance resembled powder cocaine or fentanyl.

The crystal-like substance was field tested which gave a presumptive positive result for methamphetamine. The off-white powder was tested for cocaine and fentanyl with a presumptive positive result for fentanyl.

Post Miranda Warning, White stated he understood his rights and waived them, wishing to speak with the police. White stated at no point was the disturbance physical and he never laid a hand on the female. White first stated he smokes marijuana and alleged the crack pipe was for marijuana and the narcotics were opioids or "Roxys". When shown the items, White agreed the crystal-like substance looked like Methamphetamine but denies using it. White also changed his story and agreed the pipe located was in fact a crack pipe. White and I then discussed his struggles with drug addiction after recently becoming homeless.

I interviewed the female involved in the disturbance who stated at no point was she struck by White.

In conclusion, there was no probable cause to charge White with any battery-related crimes stemming from the disturbance. I do find probable cause to charge White with two counts of F.S.S. 893.13 (6)(a) Possession of a Controlled Substance and F.S.S. 893.147(1)(b) Possession of Drug Paraphernalia.

NARRATIVE

On Thursday, April 24, 2025 at 1022 hours, I responded to 695 S US Highway 1 in reference to a suspicious incident.

On arrival, I made contact with Dawn Trodglan with whom I have had previous calls for service at the same location. Dawn advised a white male was seen on her trail camera's going to the electrical box behind her building and stealing copper electrical wire. Multiple previous cases are active regarding the same subject. Specifically, on April 19, 2025 at 1152 hours, Deputy Newman made contact with Dawn when her trail camera's showed the white male carrying red bolt cutters with black handles behind the building. The subject then uses the bolt cutters to cut the locks on the electrical box. The subject removes the copper wire and leaves. I was not until this morning at 1022 hours was a vehicle identified by the caller as a Gray Buick with a black fabric top. Real Time Crime Center analyst captured the vehicle traveling South on US Highway 1 at 1005 hours bearing FL Tag KX501W. A canvass of the area located the vehicle at 11th Place SW and S US Highway 1. Sgt D. Rodriguez pulled up to the vehicle and observed a white male in the driver seat matching the suspect description. Sgt D. Rodriguez identified the male by FL identification card as Paul Paradis.

I responded to the location and read Paul his Miranda Warnings and asked him if he had been to the old packing house located at 695 S US Highway 1. Paul stated that he was at the location today and twice yesterday because he was attempting to make contact with a friend who is homeless. Paul explained that he would walk around to the back of the building and shout his name, if he didn't answer he would leave and try again at another time. I asked Paul to identify his friend by name however he paused for a short period of time to remember his name before stating "Donnie". I asked Paul if he ever had permission to be on the property and he stated "No". I asked Paul if he ever took anything from the property and he replied "No", I asked Paul if he was familiar with the electrical box behind the building and if he ever made entry into the box. Paul replied "No".

Trail camera still shots had been recovered showing Paul on 4/19/2025 holding a bolt cutter that was red with black handles. Paul then places the cutter into position to cut the lock and after doing so enters the box to remove copper electrical wire. Multiple still frame shots show Paul clearly at each phase of the act. Paul was also captured on trail camera's yesterday 4/23/2025 returning to the box to gather more wire. I presented Paul with this information and he then admitted to being on the property and cutting the lock. Paul stated he had bolt cutters in his vehicle which were later located and matched the photograph. Paul explained that there was not much wire in the box when he opened it however he had already scrapped the stolen wire.

In regards to Pauls driver's license, He stated he was aware it was suspended but that he paid his child support this morning and was going to have the license reinstated today. Paul was unable to show proof of making any form of payment. A search through DAVID revealed a prior DUI conviction on 08/19/2016 and two driving while license suspended convictions on 09/03/2020 and 08/22/2024.

Based on the totality of the investigation, I found Paul Paradis in violation of trespass on property with the intent to comitt a crime, criminal mischief, possession of burglary tools, felony theft and felony DWLS habitual offender.

Paul was transported to the Indian River County Sheriffs Office without incident.



While conducting the search, multiple items of paraphernalia was discovered in David Hampton's room. Contained in his room were three metal spoons with fentanyl residue, one used syringe containing suspect fentanyl, and one plastic clear baggie containing white powder residue. Corporal McElvy field tested the residue off of the spoon and it showed positive results for trace amounts of fentanyl.



On Thursday, April 24<sup>th</sup>, 2025 at approximately 1813 hours, I, Deputy Sheriff Ramiro Doval was stationary at the 7500 block of State Road 60, when I observed a red sports motorcycle with two occupants on the motorcycle. The driver of the motorcycle did not have eye protection while operating the motorcycle, which is in violation of F.S.S 316.211(2), which states a person may not operate a motorcycle unless the person is wearing an eye-protective device over his or her eyes of a type approved by The Department of Highway Safety and Motor Vehicles.

I could see the driver of the motorcycle turn his head over to look at my marked patrol vehicle, the driver was wearing a full-face mask covering his head and mouth and only leaving his eyes visible. I was able to enter State Road 60 from where I was stationary and attempt to catch up to the motorcycle. While attempting to close distance on the motorcycle. I was able to observe the driver of the motorcycle look back at my patrol vehicle and began to drive recklessly, changing lanes abruptly and passing other vehicles at a high rate of speed, and increasing his speed. I was not able to get a speed on the motorcycle. I did observe a motorist in the inside lane tail lights turn red, when the motorcycle was changing lanes abruptly, indicating the motorist had to brake in attempts to avoid a collision with the motorcycle.

I was able to close the distance on the vehicle at the intersection of State Road 60 and 66<sup>th</sup> Avenue. The motorcycle then used its turn signal to turn into the Indian River Mall's west entrance, where I was able to read the tag on the motorcycle of Florida #21LJX.

The motorcycle came to a stop at the Dillard's parking lot. I made contact with the driver of the motorcycle, later identified as Alex Argueta by his Florida driver's license. I asked Alex if he had his drivers license with him, Alex stated "not the bike though", indicating he did not have a motorcycle endorsement, but had his regular license, which he was able to provide. I advised Alex, he observed me pull out where I was stationary and he began to drive in and out of traffic, he stated "yeah" and smirked. I was able to confirm he did not have a motorcycle endorsement by his driver's license and DAVID.

I asked the passenger, later identified as Jacqueline Perez, if she stated anything to him or if Alex stated anything to her while I was attempting to gain distance on the motorcycle. Jacqueline stated yes, she tapped his stomach and told him to stop, but he continued to drive recklessly.

I asked if he had any documentation for the motorcycle, he stated no. He bought the motorcycle on Sunday from a "Guy" in Sebastian Florida, but had no paperwork. While interviewing him, he was able to provide a photo of a bill of sale of the motorcycle with the seller's information but his name was not on the form. I confirmed the motorcycle was not stolen.

At this time, I placed Alex under arrest for the following offenses;

**Count 1.) F.S.S 316.192(1)(A) Reckless Driving, when Alex operated a motorcycle in an erratic manner, and willful or wanton disregard for the safety of persons or property, when he was observed operating a motorcycle in and out traffic at a high rate of speed, in and out of traffic, causing one motorist to use her brakes in order to avoid a collision with the motorcycle or other motorists.**

**Count 2.) F.S.S 316.03(5) No Motorcycle Endorsement, which states the following; A person may not operate a motorcycle unless he or she holds a driver license that authorizes such operation, subject to appropriate restrictions and**






### NARRATIVE

On 04/24/2025, at approximately 1827 hours, I responded to the 4100 block of Old Dixie to assist Deputy Magill with a traffic stop involving a reckless driver.

Prior to Deputy Magill locating the vehicle, 911 dispatch advised that a caller identified as [REDACTED] was following behind a Ford sedan bearing Florida tag (KA829Z), along 1100 block of 41<sup>st</sup> Street and observed that vehicle was swerving from left to right and was periodical driving along the grass shoulder of the roadway. When the vehicle approached the intersection of 41<sup>st</sup> Street and U.S. Highway, [REDACTED] noticed that the vehicle was stopped partially in the middle of the intersection.

Deputy Magill located the vehicle and noticed that it almost turn into oncoming traffic, as it made a left-hand turn from 38th Lane onto US Highway 1 north. The traffic light turned green, Deputy Magill made a U-turn and headed north in an attempt to catch up to the vehicle. When Deputy Magill was approaching US Highway 1 and 41st Street, the vehicle headed north, through the traffic light at US Highway 1 northbound and 41st Street was red.

Deputy Magill noticed the vehicle went through the red light and came to a complete stop in the middle of the intersection, as traffic was going through the intersection. After observing the above mention vehicle driving pattern, Deputy Magill waited until the light turned green and the vehicle began traveling west on 41st Street, and initiated a traffic stop.

When Deputy Magill approached the passenger side of the vehicle, and he made contact with the solo occupant Jessica Brown and observed that both of her eyes were blood shot red and watery. Deputy Magill also noticed that her speech was slurred when she asked him if she needed to provide him with her driver's license. While Jessica was providing Deputy Magill with her license, she handed him her debt card and vehicle registration. At the time, Deputy Magill informed her, that he needed her license, when she started looking around in her vehicle and eventually grabbed it from the area in front of the shifter.

Upon my arrival, I made contact with Jessica who was standing at the rear of her vehicle. While observing her, I noticed what appeared to be a melted candy bar, dripping off out of her mouth onto her chest area. When Jessica made direct eye contact with me, I immediately noticed that both of her pupils were pin point and both of her eye lids were droopy and almost appeared that she was attempting to fall asleep.

Next, I informed Jessica that I would be conducting a D.U.I investigation, which she stated that she understood. During a brief conversation, Jessica stated that she consumed a mimosa alcoholic beverage approximately around 0900 hours this morning. She then informed me that, she was currently on the way to a friend's house and made an alcoholic mix drink, that was currently sitting in a cup holder in the vehicle to bring to her friend. When Jessica spoke, I noticed that her words were severely slurred when she spoke. I also observed that her body would periodically sway from front to back.

During the Horizontal Gaze Nystagmus Exercise, Jessica showed a lack of smooth pursuit in both eyes, with distinct and

sustained nystagmus at maximum deviation. I also observed an onset of nystagmus prior to 45 degrees. I continued to notice, that both of her pupils were still point and both eye lids were droopy. Jessica's body was noticed to be swaying from front to back.

During the demonstration and instructional phase of the Walk and Turn Exercise, Jessica started the exercise, prior to being instructed to start by taking four steps that were not heel to toe or straight in a line. During the first portion, Jessica missed steps 2,3,4, and 8. None of her steps were heel to toe or straight in a line. While conducting a turn, to conduct the second portion of the exercise, both of Jessica's feet stepped off of the line, paused and asked if she should continue. During the second portion, Jessica missed all nine steps, that were also observed not to be heel to toe.

During One-Leg Stand Exercise, Jessica's body was observed swaying from left to right and she placed her left foot on the ground at the 12 second mark of the exercise. Jessica then raised her right foot to restart the exercise and her body was observed again to be swaying from left to right.

The following exercise I explained and demonstrated was the finger to nose. After explaining and demonstrating the exercise, Jessica stated that she understood the instructions.

At the jail, Deputy Cazares requested to submit to a lawful test of her breath for the purpose of determining its alcohol content. A lawful test of the Jessica's breath was obtained using an Intoxilyzer 8000 to determine its alcohol content. The results were 0.000 BrAC and 0.000 BrAC which is inconstant with her performance of Standardized Field Sobriety Exercises

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On 04/25/2025, at 23:00 (Specifically include facts constituting cause for arrest.)

PROBABLE CAUSE STATEMENT

On 04/24/2025, at approximately 23:00 hours, I was traveling westbound over the Barber Bridge. I was travelling behind a Dodge Challenger (FL tag #88FCRW) that was struggling to maintain in its lane while traveling in the first lane of travel. While coming over the bridge, I observed the Challenger almost veered out of their designated lane before the driver managed to correct their steering. The vehicle then continued at a slow rate of speed as we approached the red light at Indian River Boulevard. Just before reaching the intersection, the driver conducted a lane change without using their turn indicator. When the light cycled to green, I followed behind the vehicle as we continued southbound on Indian River Boulevard. The vehicle continued to travel well below the speed limit. The driver occupied the first lane of travel and again struggled to maintain a straight path of travel. I then observed the Challenger following too close to a vehicle that was traveling in front of them. At this point, I conducted a traffic stop on the Challenger in the 2100 block of Indian River Boulevard.

Once the vehicle was stopped, I made contact with the driver of the vehicle, Lawrence Connor. While speaking with Mr. Connor, I noticed that he would mumble his words and that he struggled to maintain focus on the requests I gave him. I also observed that Mr. Connor had glassy eyes and that he would squint heavily while speaking with me. At times, Mr. Connor would shut his eyes closed while conversing with me. While he was providing me with his documentation and license, Mr. Connor informed me that he was coming from the beach, and he uttered that he had consumed a couple of beers.

Based on my observations, I was concerned that Mr. Connor was impaired, and I asked him to exit from the vehicle. As Mr. Connor exited the car, I observed that he had an open container of beer stored on his driver's door. This beer was a "Corona" that was a third of the way empty. I then walked Mr. Connor to the trunk of his vehicle. Mr. Connor acted erratically by facing away from me, standing in a military resting position with his hands placed behind his back. At this point, I requested an additional unit to assist me. Officer A. Gonzalez (#414) and Officer S. Gonzalez (#471) arrived to assist me.

I asked Mr. Connor to perform a series of standardized field sobriety exercises to determine if he was able to safely operate a motor vehicle. Mr. Connor was cooperative. I then explained and demonstrated each exercise before having Mr. Connor perform them. I additionally had Mr. Connor acknowledge that he understood each exercise before having him perform them. I observed the following:

#### Horizontal Gaze Nystagmus:

- Resting nystagmus was not present and Mr. Connor's pupils were equal in size.
- I did observe the lack of smooth pursuit in both eyes.
- Mr. Connor tried to avoid performing the exercise by focusing on things in the background instead of focusing his eyes on the stimulus. I had to advise Mr. Connor to follow instructions and maintain his focus so I could observe his eyes at maximum deviation.
- Distinct and sustained nystagmus at maximum deviation was observed.
- Mr. Connor would follow the stimulus with his entire head, and failed to keep his head fixed forward.
- I observed the onset of nystagmus prior to 45 degrees in both eyes.

#### Walk and Turn:

- Mr. Connor repeatedly failed to follow instructions.
- Mr. Connor attempted to start the exercise before being instructed to do so.
- Mr. Connor became argumentative during instructions.
- Mr. Connor did not touch his heel to his toes on almost all of his steps.
- Mr. Connor began the exercise and then stopped after the first series of steps forward to argue with the instructions provided to him. Mr. Connor was provided the entirety of the instructions again. He had to be warned several times to stop interrupting and to listen to the instructions that were being provided to him. I then gave Mr. Connor another opportunity to perform the exercise.
- On the second attempt at the walk and turn, Mr. Connor conducted 10 steps forward, an improper turn, and then performed 12 steps on the way back.
- Mr. Connor stepped off the line while performing the exercise.
- Mr. Connor used his arms for balance during the exercise.

#### One Leg Stand:

- Mr. Connor repeatedly interrupted the instructions.
- Mr. Connor began to complain and stated that he suffered from Sciatica. I explained to Mr. Connor that I would note his concerns regarding any previous injuries and that he would have to perform the exercises to the best of his abilities.
- Mr. Connor struggled to maintain his balance in the starting position.
- Mr. Connor struggled to maintain his balance while performing the exercise.
- Mr. Connor used his arms for balance for majority of the exercise.

- Mr. Connor lost his balance and placed his foot down on the ground. He then resumed the position and continued his count.

The entirety of these exercises were captured on my body worn camera.

At this time, based on the totality of my observations, I placed Mr. Connor under arrest at 23:40 hours for driving under the influence of alcohol. While securing Mr. Connor's vehicle, I retrieved the opened bottle of beer. I then located two additional unopened bottles that were stored in a cooler on the front passenger seat. These beers were cold to touch, with visible condensation on them. I noted that all of the beers were located within the immediate reach of the driver. I collected photographs of the alcoholic beverages that I located in the vehicle. These photographs were later uploaded to Evidence Library, along with my footage from this investigation.

At 23:51 hours I transported Mr. Connor to the Indian River County Jail. Once at the Indian River County Jail, I completed a twenty-minute observation period on Mr. Connor. Mr. Connor was then walked to the intoxilyzer room at the Indian River County Jail. Deputy Rodriguez was present with me as the breath test was performed. Mr. Connor provided me with two samples of his breath with the alcohol content of 0.129 and 0.123 g/210L. I issued Mr. Connor:

- One FL DUI UTC (AFVKJBE) for violation of FSS 316.193(1A) Driving under the influence of alcohol.
- One written warning for failure to operate his vehicle in a single lane of travel.
- One written warning for changing lanes without indication.

My agency BWC was utilized for this investigation, and this incident did occur within the city limits of Vero Beach, Florida.
