


NARRATIVE

This is an Amended Arrest Report to fix narrative issues.

On Monday, December 8, 2025 at approximately 1037 hours I responded to [REDACTED] in reference to a disturbance.

Upon my arrival I made contact with Richard Woodruff (the caller) who advised that the subject later identified as Gary Wilkin punched another [REDACTED] while in the community swimming pool.

Richard pointed at Wilkin as the man who punched [REDACTED] in the mouth.

It should be noted that Wilkin was wearing a pair of black or dark blue shorts and a pair of sunglasses. Wilkin also has gray hair and a beard. The male subject described in the call by dispatch.

I spoke with [REDACTED] who was still in the pool on the shallower end (north end). [REDACTED] advised that Wilkin started yelling profanities at the people in the pool at the pool fence. Wilkin then entered the pool area and started yelling profanities at the people in the pool again. Wilkin then got into the pool and grabbed [REDACTED] and punched [REDACTED] in the mouth. [REDACTED] also stated that Wilkin grabbed [REDACTED] during the altercation.

[REDACTED] making [REDACTED] 75 years of age when Wilkin battered [REDACTED] This is a violation of F.S.S. 784.08 Battery of a person 65 years or older.

It could be seen that [REDACTED] had a swollen lip on the right side [REDACTED] of the mouth and was actively bleeding from the injury.

I spoke Wilkin who walked up to me to approximately arms-length away. I requested Wilkin step back away from me since I was standing near the pool edge.


Wilkin advised that he was asleep in his residence that is next to the pool on the far side of the residence. Wilkin then woke up and heard the people in the pool. Wilkin advised that he had been drinking alcohol the night before and stated that he was "hungover". Wilkin continued, he stated that he went to go to the restroom in his residence and still heard the people in the pool. Wilkin advised that he exited his residence and walked to the fence and asked the people politely to quiet down. Wilkin advised that he does not remember what happened next.

I spoke with [REDACTED] who advised that [REDACTED] were participating in the pool aerobics class when Wilkin began yelling profanities at the people in the pool from his residence and at the fence of the pool. [REDACTED] further stated that Wilkin entered the pool area and got into the pool and tried to grab [REDACTED] and then punched [REDACTED] in the mouth. [REDACTED] tried to get Wilkin away from [REDACTED] Wilkin grabbed [REDACTED] and tried to hit [REDACTED] several times.

[REDACTED] 73 years of age when Wilkin battered [REDACTED] This is a violation of F.S.S. 784.08 Battery of a person 65 years or older.

Due to visible injury to [REDACTED] I instructed Wilkin to turn around and place his hands behind his back. Wilkin refused to comply. I again instructed Wilkin to turn around and place his hands behind his back, again he refused. I reached for his left wrist and Wilkin pulled away from me. At this point, I activated my taser and Wilkin stood against the fence with his hands behind his back.

Deputy Chouinard placed hand restraints onto Wilkin and escorted him to the rear seat of his patrol vehicle.

[REDACTED] complained of [REDACTED] neck hurting and [REDACTED] mouth was still bleeding, EMS was requested and responded to the scene and evaluated [REDACTED]

I supplied [REDACTED] a Witness statement forms to fill out with [REDACTED] statements of the incident and will attach them to this case.






NARRATIVE

On December 9<sup>th</sup>, 2025, at 0738 hours, I responded to Wawa located at 1180 US-1, Vero Beach, FL 32960 in reference to a shop lifting. Dispatch advised that a white male wearing a plaid jacket, hat, and black short with a bag was stealing merchandise and left the scene on foot northbound.

Upon arrival, I made contact with Wawa manager, Jessica Smith, who stated that the aforementioned described male took a monster from the fridge and poured it into a Wawa cup. Jessica also stated that the male grabbed a turkey sandwich.

Jessica provided me with a picture of the suspect when he was walking away from the store.

Jessica provided surveillance footage of the incident. The incident recorded the male at the cash register with a Wawa cup and turkey sandwich in his hand. Jessica provided an explanation while the surveillance played. The suspect was at the cash register trying to pay with his card. The card declined multiple times and the male was told by the cashier to go to the ATM to withdraw money so he could pay for his items. Jessica approached the male with the empty monster that he discarded in the trash can after pouring the monster in the Wawa cup. Jessica stated that she advised the male to pay for the monster and his payment should not just be listed as a fountain drink. The male then leaves the register area and goes out of the frame which is when Jessica stated the male attempted to withdraw money.

Jessica stated that the male could not withdraw any money and stated he would be back in 5 minutes to pay for his items. Jessica believed that the suspects statement was a lie as the male has stolen from the store numerous times on several different occasions. Jessica stated that the male was not given permission to return later to pay and had to pay for the items now.

Jessica advised that all the items stolen from the store would value at \$9.50 (Wawa cup, Monster, Turkey Sandwich). Jessica stated she wanted to prosecute on behalf of Wawa.

Deputy I. McKay read Hofer his Miranda Rights to which Hofer admitted to stealing the drink.

The drink and turkey sandwich were not recovered on Hofer's person as we located Hofer approximately an hour after the crime occurred, allowing Hofer to discard the perishable items.

While in the back of my patrol vehicle, Hofer expressed his frustration with being arrested for a turkey sandwich.

NARRATIVE

On December 9<sup>th</sup>, 2025 at approximately 0856 hours, I responded to a call of a reckless driver. Public Safety Dispatch advised that a witness observed a vehicle traveling recklessly.

The vehicle was described by witness Sharron to be a silver in color Honda CRV bearing Florida tag 77EGWX. Sharon stated to dispatch the vehicle was traveling all over the road, traveling at a high rate of speed, and almost hitting other vehicles. As Sharon continued to follow the Silver Honda CRV, she advised dispatch that the vehicle began to drive slow and erratic and then pick up speed.

Sergeant D. Rodriguez caught up to the vehicle as it was traveling north at the 1600 block of us Highway 1 and confirmed the Florida tag provided to dispatch, 77EGWX. Sgt. Rodriguez then observed the vehicle weaving within its lane and on several occasions passing the white line and then traveling across the lane and crossing the solid double yellow lines. Sgt. Rodriguez attempted to conducted a traffic stop on the vehicle at the intersection of 10<sup>th</sup> Avenue and 20<sup>th</sup> Place. The vehicle continued west on 20<sup>th</sup> Place and turned north on 11<sup>th</sup> Avenue where it stopped in traffic waiting at the red light. The final stop of the vehicle was the 1100 block of 21<sup>st</sup> street.

Upon stopping the vehicle, I approached it and observed the driver, later identified as Amanda Jean Seal, who appeared confused and unable to follow simple commands. I immediately noticed red glassy eyes and the odor of an alcoholic beverage emitting from her breath and person. I asked Seal multiple times for her to put the vehicle in park to which she finally did. As Seal exited the vehicle, she was very uneasy on her feet, swaying side to side. I asked Seal to step to the sidewalk for her safety.

Seal indicated that she had not been drinking alcohol but that she was grieving due to her mother murdering her father.

I became concerned Seal was impaired beyond her normal faculties by alcoholic beverages or chemical or controlled substances. To dispel my concerns, I asked Seal if she would participate in a series of standardized field sobriety exercises, to which she agreed. Next, Seal was asked a series of medical questions by Sgt. Rodriguez to ensure she could participate in field sobriety exercises. Seal stated she had [REDACTED] See Sgt. Rodriguez' supplement for more information on the line of medical questioning.

All field sobriety exercises were explained and demonstrated proficiently prior to Seal beginning each exercise and I confirmed she understood the instructions prior to the start of each exercise.

The following exercises were performed:

- 1.) HORIZONTAL GAZE NYSTAGMUS - I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior 45-degrees was not observed. Vertical Gaze Nystagmus was not conducted.

- 4.) WALK AND TURN – The exercise was conducted twice for a fairer evaluation to confirm Seal understood the exercise. A straight line of tape was used for the exercise. On the first nine steps, Seal missed heel to toe, took only 8 steps, and used her arms to balance. On the second nine steps, Seal missed heel to toe, only took 8 steps, and used her arms to balance.

Overall, Amanda Jean Seal performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on December 9th, 2025, Amanda Seal was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance and was impaired beyond her normal faculties, incapable of operating a vehicle safely.

Seal was arrested for DUI at 0949 hours and was advised of the charge. I took Seal into custody without incident and transported her to the Indian River County Jail for booking.

After I arrived at the jail, Deputy Sheriff Green advised me that Seal refused to provide a breath sample.

Corporal Chouinard assisted with a vehicle inventory and search for evidence of DUI. Sergeant Rodriguez discovered two empty "nip" type bottles of alcoholic beverages in the center console. One was a "Pink Whitney" brand of vodka that was labeled 60 proof. The other was a "Svedka" bottle of vodka that was labeled 70 proof. Two full bottles of Pink Whitney were discovered in Seal's purse.

Corporal Chouinard attempted to contact complainant Sharon, however the call went to voicemail.

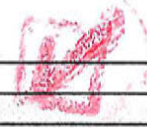

### NARRATIVE

On December 9, 2025, at approximately 1105 hours, Corporal Munni and I responded to a reported shoplifting incident at the Walmart store located at 5555 20th Street in Vero Beach, Florida.

Upon arrival, I made contact with Walmart Asset Protection Officer Jacob B. Parker, who provided a detailed briefing and escorted me to review closed-circuit television (CCTV) surveillance footage from self-checkout register number 28. The footage clearly depicted the suspect, later identified as Jessica R. Melendez, engaging in skip-scanning by holding two items in her hands while deliberately scanning only one of them. Melendez then placed both items into the bagging area, proceeded to bag the unscanned item along with the scanned one, and added them to her shopping cart. The video further showed additional merchandise, including a container of cranberry juice, that was removed from shelves and placed in the cart without ever approaching the scanning or bagging area, demonstrating clear intent to deprive the merchant of possession and full retail value.

Melendez completed the transaction by paying for 41 items totaling \$280.37 but failed to pay for 10 items with a combined retail value of \$110.25. After passing all points of sale, she was promptly detained by the Walmart Loss Prevention Team before exiting the premises. During initial contact, Melendez was unable to produce any form of identification. However, her identity was positively verified through a records check with Indian River County Sheriff's Office Dispatch, which confirmed her as Jessica R. Melendez and revealed an active Trespass After Warning (TAW) case number 2022-740644 for a prior retail theft offense at the same location.

Based on the totality of circumstances, Melendez was mirandized and placed into custody without incident. When asked her actions, Melendez stated "I might have missed a few items, it's no big deal, I will pay for them now". Melendez was also questioned about the previous TAW to which she stated that she wasn't aware of a Trespass, but then changed her story to that was aware that she had a TAW, but thought it expired after one year.

The following charges are as follows:

Shoplifting/Retail Theft

Trespass After Warning

Melendez was transported to the Indian River County Sheriff's Office Correctional Facility.

This case is closed by arrest cleared.

On **12/09/2025** at **12:04** (Specifically include facts constituting cause for arrest.)



I, Officer Bannister was actively patrolling the 2100 block Indian River Boulevard.

While traveling northbound, I was able to notice a black dodge ram with a black male driver wearing a light-colored shirt, not wearing a seat belt, stopped in the inner lane of southbound traffic. I made a U-turn, never losing visual of the truck, and attempted to get behind the truck in order to initiate a traffic stop. I saw the truck make a right turn on 17th Street and begin heading westbound. The truck then made a U-turn near 5th Avenue, I was able to initiate a traffic on this vehicle, A black 2020 Dodge Ram bearing FL License Plate DV8930K, at this time. The Ram came to a final stop in the 1600 block of 4th Avenue. I approached the vehicle, and explained to the black male driver wearing a light colored shirt, that he was being stopped for not wearing a seatbelt. The driver, later identified as Joshua Scott, immediately became verbally combative, stating that he was wearing his seatbelt, which was currently behind his person. I then asked Scott for his Driver's License, Vehicle Registration, and Proof of Insurance, to which he refused to provide, stating that he wanted to speak to a supervisor. I notified Corporal Lachowicz, #429, of the request at this time. I continued to attempt to get Scott's information from him to which he continued to sit quietly. At this time, Scott began nervously looking around the vehicle and refused to look for any type of documentation. Scott reluctantly provided his name and date of birth at this time. I then asked Scott if he had a valid Florida Driver's License, to which he replied that he did not due to it being suspended. Once Officer Scroggins, #483 arrived on scene, I instructed Scott to step out of the vehicle, due to him admitting he was knowingly driving on a suspended license, and for officer safety, due to Scott being verbally combative, and nervously looking around the vehicle. Once the door was opened, I attempted to detain Scott, to which he immediately and continuously attempted to pull his arms away from officers control. Officers were able to get Scott's arms behind his back, and he was detained and escorted to my patrol vehicle at this time, without further incident.

An NCIC/FCIC check of Scott, showed that he did have a suspended license as of March 18, 2025.







Scott was officially taken into custody at this time and transported to the Indian River County Jail without further incident.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:  
On 12/09/2025, at 17:20 (Specifically include facts constituting cause for arrest.)



On Tuesday, December 9, 2025, I responded to Walmart, located at 2001 US 1, in reference to a theft incident.

Upon arrival, I made contact with all parties involved. I first spoke with Chris Matson, a Walmart employee known to me from prior law enforcement encounters. Chris stated he observed a female conceal items into a shopping bag. He explained that he followed the female as she selected several items and placed them into a shopping bag in her cart. Chris stated the female had already gone through a checkout lane but then returned to the grocery area without leaving the store. Upon returning, she selected additional items and placed them into the same shopping bag from her recent purchase. Chris advised he observed the female exit the store without attempting to purchase any of the newly selected items. He stated he made contact with the female outside the store and asked her to return to his office. These items included chicken nuggets, lunch meat, steak and cupcakes. The total amount for these items is \$172.00.

I then made contact with the female, identified as Gwendolyn Green via her Florida driver's license. Gwendolyn stated she "messed up" and was "messing with their things." After being read Miranda, Gwendolyn stated, "I'm going to jail." When asked what she meant, she admitted to "stealing." Upon further questioning, Gwendolyn admitted to committing petit theft. She confirmed she had paid for some items, then returned to the grocery area to select more items. Gwendolyn stated the newly selected items were "worth a lot of money," and she did not attempt to pay for any of them. She also stated she has been arrested in the past for similar crimes.

I then reviewed security camera footage, which confirmed the incident as described. I observed Gwendolyn walk back into the grocery area and place several items into her shopping cart after completing her initial purchase. Gwendolyn was then observed leaving the store without attempting to purchase the newly selected items.

Due to the above, Gwendolyn was placed under arrest for petit theft.

It should be noted that Gwendolyn was found guilty of petit theft in 2002 and 2023.

On December 9th, 2025, at approximately 2000 hours, I responded to the Walmart Supercenter located at 5555 20th Street, Vero Beach, Florida, in reference to a shoplifting.

Upon arrival, I made contact with the caller and Asset Protection Investigator (API), Nathan Toliver, who advised that he observed a white male, later identified as William Joseph Johnson, inside the sporting goods department placing merchandise into Walmart shopping bags while repeatedly looking over his shoulders. Johnson then pushed a shopping cart containing food items toward the west entrance/exit doors, and exited the store, passing all points of sale without paying for the merchandise.

API Toliver followed and made contact with Johnson outside of the store and escorted him back to the loss prevention office. Toliver later showed me surveillance video footage of the incident, which I reviewed and confirmed was consistent with his statements. Toliver advised that all stolen merchandise was recovered, consisting of approximately 49 food items and 1 pillow case with a total retail value of \$287.95.

Sergeant Flores advised Johnson of his Miranda rights, which Johnson stated he understood and agreed to waive. When asked what happened, Johnson stated he had been experiencing financial difficulties over the past month due to the Veterans Affairs (VA) reducing his disability rating from 80% to approximately 50%, which substantially lowered his monthly income and led him to commit the offense in order to feed his family.

Toliver informed me that the store wished to proceed with prosecution. Johnson was subsequently taken into custody and transported to the Indian River County Jail for the following charge:

1. Retail theft (shoplifting), consistent with F.S.S. 812.015.





## NARRATIVE

On Tuesday, December 9, 2025, at approximately 2040 hours Cpl. M. Hatton and I were dispatched to 540 8<sup>th</sup> Place Apt 101, Vero Beach, FL, in reference to a shooting incident.

While enroute, IRCSO Public Safety Dispatch stated the caller heard a "loud pop", went into her room and observed a bullet hole in the ceiling. She observed an air mattress that was next to her bed deflated. The complainant could still hear the people upstairs shuffling around. The bullet came from the apartment upstairs.

Upon law enforcement arrival contact was made with the complainant, Marianna Gallegos, who resided in Apartment 101. Deputy Glading advised me she entered the complainant's residence and confirmed there was a bullet defect in the ceiling along with a bullet fragment. Meaning a bullet was fired into the apartment.

Lt. Jaworski made contact with one of the residents that lived upstairs (Apartment 201) via phone, identified as Ashley Scarlett who advised the following:

Her and her son were not in town and were currently in Fort Pierce during the time of the incident. The only person who should be inside the residence is her boyfriend, Charles Brown. She did not own any firearm and has never seen Mr. Brown with any firearms. Ashley also gave Lt. Jaworski the phone number for Mr. Brown.

When Lt. Jaworski made contact with Mr. Brown he stated that it was an accident and that the firearm is under the bed.

Upon making contact with Mr. Brown outside of the residence he was placed in handcuffs which were double locked and check for fit. Mr. Brown was read Miranda Warnings which he verbally stated he understood. Post Miranda, Brown advised the following:

Brown admitted to the firearm going off in his possession. He was attempting to clear the firearm and make it safe, however when doing so he still had the magazine in. He racked the slide of the weapon ejecting a round out of the ejection port and then took the magazine out. He then pointed the firearm at the mattress and pulled the trigger to check if there was a round inside the weapon. The firearm proceeded to fire a round and he realized that he did not take the magazine out before he racked the slide. He proceeded to put the gun under the mattress after the incident. He admitted his wrongdoing and mishandling of the firearm and said it was dumb of him. He had also been drinking tonight and had 5-6 glasses of alcohol before the incident occurred.

While speaking with Brown, I could smell the strong odor of an alcoholic beverage emitting from his breath. Brown's speech was slurred and his eyes were bloodshot and watery.

A criminal history report on Mr. Brown was ran by Public Safety Dispatch. Brown had multiple felony convictions in his criminal history. One being on 02/09/2004 he was adjudicated guilty for carrying a firearm without a license (felony) in the state of Pennsylvania. On 02/09/2004 he was also adjudicated guilty regarding controlled substance, drug, device and cosmetic act (felony) in the State of Pennsylvania.
