PROBABLE CAUSE STATEMENT

On June 24th at approximately 2152 hours, I responded to [REDACTED] in reference to physical disturbance.

Upon arrival, I made contact with Lindy Joslin, Identified by Florida Driver License. Lindy explained that earlier she was fixing her boyfriend's scooter (Shane Snyder, identified by his Florida Driver License) and he got mad about it. Lindy stated they have been [REDACTED]. Lindy stated they began arguing. Lindy stated she was sitting on a chair when Shane came up to her and punched her in her face. Lindy stated she then kicked him in his scrotum and left the house. I asked Lindy if anything like this has happened before with Shane she stated yes and then proceeded to show me photos of other incidents.

Lindy appeared to have a major injury to her face. I observed her teeth on the left side pushed back and falling out. There was blood running out of her mouth down her neck. It should be noted Lindy was in visible pain through out the interview. Lindy was transported to SRMC by EMS. (Rescue 8 Run # 2026-00017437)

Lindy was given a Domestic Violence Packet and signed the Exemption from Public Record Disclosure form. Lindy also agreed to do the Domestic Violence Lethality Assessment. Lindy was told that she is in a possible lethal situation. Lindy was also asked to answer a First Appearance Questionnaire and she agreed.

Officer Hatton 432 explained Shane requested to get looked at regarding a previous issue with his scrotum that has now been aggravated by being kicked.

Shane was read his Miranda Warning by Officer Hatton. Shane stated Lindy was fixing his bike and messed up the tire. Shane stated he got mad and they began to argue. Shane stated later on Lindy, was sitting in a chair and she kicked him in his scrotum and that he doesn't remember anything else. Officers then asked how his hand got bloody which he responded stating that he hurt his hand when trying to fix the bike.

I observed cuts on two of Shane's knuckles on his right hand. This would be consistent with punching or striking something or someone.

I determined Shane to be the primary aggressor in this incident and placed him under arrest. Shane was then transported in my patrol vehicle to Cleveland Clinic for medical clearance and then transported to Indian River Jail without incident.

NARRATIVE

On Thursday, June 25, 2026, at approximately 1840 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the intersection of 27th Avenue SW and 9th Street SW (Oslo Road), Vero Beach, Indian River County, Florida.

Prior to the traffic stop, I observed a vehicle facing northbound on 27th Avenue SW. I was behind the vehicle in the turn lane directly next to it. The vehicle had all of its windows down, allowing me to see within the vehicle. I observed that the driver, who I recognized as Mr. Michael Zaniewski from prior interactions. Mr. Zaniewski did not have his seatbelt on as it was visibly against the B Pillar of the vehicle.

After the vehicle received the green light, I activated my blue emergency lights to conduct the traffic stop. The vehicle then pulled in to the Cumberland Farms.

During the stop, I confirmed that the driver was Mr. Zaniewski. He advised that he did not have a license. He was then removed from the vehicle.

I ran Mr. Zaniewski's information in to FCIC/NCIC. This confirmed that Mr. Zaniewski still did not have a valid license. He has two suspensions on his license for failing to pay traffic fines.

I advised Mr. Zaniewski of his Miranda Rights. He confirmed that he knew his license was suspended for failing to pay a traffic control device citation and has not fixed his license since.

On 03/28/2026, I conducted a traffic stop on Mr. Zaniewski as he was operating a bicycle. There I confirmed he knew his license was suspended during this interaction. This was documented on call 2026-00032860.

Based on the above information, Mr. Zaniewski knew that his privilege to drive and operate a motor vehicle within this state was suspended. He was then placed under arrest. During a search incident to arrest, a glass pipe was located within his left pants pocket. This pipe was consistent with being drug paraphernalia due to burn marks and a white residue. Within his right pants pocket was a crack rock.

I searched the vehicle for any other contraband. Within the vehicle, near the center console was another piece of crack.

The total weight of crack cocaine was 0.9 grams. The substance field tested presumptive positive on scene as being cocaine base.

I questioned Mr. Zaniewski about the other narcotics found. He confirmed that they did not belong to the passenger and belonged to him.

Based on the above statements and evidence, I believe there is probable cause to arrest Mr. Zaniewski for possession of a controlled substance, pursuant to FSS 893.13, possession of drug paraphernalia, pursuant to FSS 893.147, and for

NARRATIVE

On Thursday, June 25, 2026, at approximately 2005 hours, I responded to the area of 4th Street and US Highway 1 in Vero Beach, Florida in reference to a reckless driver operating a white Tesla (FL / EBK2953).

While orbiting the area of 8th Street and 6th Avenue (Pemberly Palms), the Indian River County Sheriff's Office helicopter "HAWK" observed a white in color Tesla exit the neighborhood and travel eastbound on 8th Street. The vehicle made then a right-hand turn to travel south on Indian River Blvd. As the vehicle approached Mullinax Ford (480 US Highway 1), the vehicle made a right-hand turn and traveled through the parking lot westbound toward US Highway 1. Hawk observed the vehicle fail to come to a complete stop a stop sign, proceed to make a right-hand turn on to US Highway 1, and proceeded to travel northbound at a high rate of speed. As the vehicle approached 6th Avenue, it veered right on to 6th Avenue and continued to travel at a high rate of speed. HAWK then observed the vehicle fail to come to a complete stop at a steady red light at the intersection of 8th Street and 6th Avenue. The vehicle conducted a right-hand turn and, again, traveled at a high rate of speed eastbound on 8th Street. Once the vehicle approached the Pemberly Palms entrance, it turned left into the complex. The vehicle proceeded to make a right-hand turn and travel eastbound in the complex, then reversed into a parking spot.

Due to the un-natural driving habits displayed, Deputy Lozada and Sgt. Le conducted a high-risk traffic stop. I arrived on scene and took custody of the driver, identified as Mr. Anton Lee by his Florida driver's license which was located inside the vehicle. Anton was placed under arrest for reckless driving and secured in handcuffs.

Deputies made an approach and cleared the vehicle for any additional persons during which I could smell the distinct odor of burnt marijuana emanating from inside the vehicle. Sgt. Le stated he located remnants of marijuana and a "roach" inside the vehicle.

I went back to the patrol car and spoke with Anton. I could smell the odor of marijuana emanating from his person. Based on his reckless driving, and odor of marijuana, I believed Anton was impaired and requested he complete Standard Field Sobriety Exercises (SFSE's).

Anton agreed and was taken out of handcuffs. I questioned Anton about his medical history and he stated he was currently under the care of a doctor for an eye infection. Anton was not wearing glasses. Anton stated he was a landscaper for his uncle's company.

The first exercise I administered was the Horizontal Gaze Nystagmus (HGN) exercise. I explained the exercise to Anton who stated he understood the instructions. Anton's pupils were of equal size and

tracked simultaneously. I did not observe any validated indicators of impairment during this exercise. Anton swayed slightly while completing this exercise.

The second exercise I administered was the Lack of Convergence Exercise. I explained the exercise to Anton who stated he understood the instructions. During this exercise, I observed Lack of convergence in Antons Left eye.

The third exercise I administered was the Walk and Turn (WAT) exercise. I explained and demonstrated the exercise to Anton who stated he understood the instructions. Anton was directed into the starting position. During this exercise, I observed the following validated clues of impairment. During the instruction phase, I observed the following validated clues of impairment: Failed to maintain the starting position and started to walk prior to being instructed to do so. During the walking stage, I observed the following validated clues of impairment: Failed to touch heel to toe, improper number of steps, improper turn and stopped walking to steady. Anton stopped before his turn and asked questions regarding how he was supposed to run. Anton DID NOT complete this exercise to standard.

The fourth exercise I administered was the One Leg Stand (OLS). I explained and demonstrated the exercise to Anton who stated he understood the instructions. Anton began by raising his Right foot off the ground for approximately 4 seconds. During this exercise, I observed the following clues of impairment: Put foot down, used arms to balance, and swayed while completing the exercise. Anton was laughing during this attempt and question the instructions stating, "I can't put it down?" Anton DID NOT complete this exercise to standard.

The fifth exercise I administered was the Modified Romberg Balance exercise. I explained and demonstrated the exercise to Anton who stated he understood the instructions. During this exercise, Anton counted to "30 seconds" in 18 seconds. Anton had to be reminded to count in is his head as instructed. I observed rapid eye flutters in both eyes during this exercise.

The sixth exercise I administered was the Finger to Nose (FTN) exercise. I explained and demonstrated the exercise to Anton who stated he understood the instructions. I explained the instructions to Anton twice during this exercise. I observed the following clues of impairment:

- L1 – Pad
- R2 – Tip
- L3 – Pad
- R4 – Pad
- R5 – Tip
- L6 – Pad.

Based on the above statements and indicators of impairment, Anton was placed under arrest for Driving under the influence and transported to the Indian River County Jail Complex by Deputy Mr. Ruiz (4491).

Upon arrival at the jail complex, Anton was requested to submit a sample of his breath to determine its alcoholic content. Anton compliant and stated "anything you need!" Anton provided two valid samples: 0.000 g/210L and 0.000 g/210L.

I then requested Anton to provide a sample of his urine to determine the presence of chemical or controlled substances. He became less cooperative and stated, "I have a lawyer, should I even be talking to you?" Anton eventually refused to take the test and I read him Implied consent.
