### NARRATIVE

On 10/28/2025, at approximately 0844 hours, I, Deputy A. Brady, along with Deputy J. Chamberlain, responded to the 4300 block of 45<sup>th</sup> Street in reference to a disorderly male. The call for service was called into the Indian River County Public Safety Dispatch over the radio by a sworn Indian River County Sheriff's Office Special Deputy, Civilian Traffic Assistant, M. Wood. Wood was wearing a Sheriff's Office uniform, with a Sheriff's Office marked vehicle, with the emergency lights active. Woods stated over the radio he was conducting a school crossing detail for children walking to school when he observed the defendant begging vehicles in traffic for money. Wood stated he asked the defendant to leave the area so the children did not have to walk around him or so that drivers would not be distracted and cause an accident. Wood stated the defendant became irate, standing in the middle of the road screaming at passing vehicles, causing a traffic hazard.

Upon arrival, D/S Chamberlain and I made contact with the defendant, Thomas B. Young. I immediately could smell a strong odor of an alcoholic beverage coming from Young. It was evident by Young's rude behavior and the odor of alcohol, that he was impaired. I attempted to explain to Young the Indian River County Ordinance making it illegal to beg, peddle, or solicit on a county right of way. Young would not allow me to get a sentence out and continued to argue with me. I then told Young to vacate the area and that there is an ordinance prohibiting panhandling in the county. Young then began to walk into traffic, where D/S Chamberlain and I had to follow and hold up traffic, as to not cause an accident. Young turned back towards D/S Chamberlain and I and continued to argue instead of leaving. I then attempted to take Young into custody for disorderly intoxication, at which time he tensed his arms and began to pull away from me. I then took Young to the ground and placed him in handcuffs. I helped Young to his feet, walked him to my patrol vehicle, and secured him in the rear.

With CTA Wood's statement of Young screaming at oncoming traffic, causing a traffic hazard, the odor of alcohol on his breath, and Young physically resisting arrest, there is probable cause to charge Thomas B. Young with violations of F.S.S. 856.011 Disorderly intoxication, F.S.S. 843.02 resist arrest without violence, and Indian River County Ordinance 312.06(O) Illegal to beg, peddle, or solicit in the county right of way.

I transported Young to the Indian River County Jail, where he was turned over to Corrections Deputies without incident.

My involvement with this case was recorded on my body-worn camera.

On October 28<sup>th</sup>, 2025, at approximately 0849 hours, Deputy Bartuccelli and I responded to 1645 9<sup>th</sup> SW in reference to a Risk Protection Follow-Up. The Follow-Up was in reference to a compliance hearing to meet with Stephanie Gattis who has not been showing up to her Risk Protection Order court hearings. The current Risk Protection Order case for Ms. Gattis is

Upon our arrival at 1645 9th St SW, I activated my agency issued body camera. I knocked on the door and Ms. Gattis came to the door and advised she needed to change quick. Ms. Gattis then returned to the front door and I introduced Deputy Bartuccelli and I, advising that we were there in reference to her Risk Protection Compliance Hearing. I explained that due to her not showing up for her zoom hearings, the Indian River County Sheriff Office Legal Team, with the approval from Judge White, asked Deputy Bartuccelli and I to conduct a compliance hearing in person.

Ms. Gattis seemed in the right state of mind when I was talking to her and knew that she had a new court date coming on November 6th, at 0930 hours. I asked Ms. Gattis if she was ever explained that she could not be around or in possession of firearms or ammunition when she was served with her Risk Protection Order by Detective Rispoli. Ms. Gattis stated she did understand and she has not been in possession of any but they were all over the house. Ms. Gattis invited us inside so she could show us where the firearms were.

Ms. Gattis first led us into the kitchen on the right side of the living room and to the immediate left, was the laundry room. On top of a shelf, above the washer, was an un-secured Ruger .22 caliber revolver with 7 rounds of ammunition inside. Ms. Gattis then led us to the living room and advised that there was a pistol in the night stand next to the couch. Deputy Bartuccelli opened the night stand and we located a Taurus .38 special revolver with 7 rounds of ammunition. I un-loaded both firearms and secured them inside of my vehicle. These firearms were un-secured and easily accessible. Ms. Gattis then advised that her roommate Randle Johnston has more firearms inside of his bedroom. Deputy Bartuccelli and I did not enter Mr. Johnston's bedroom due to him not being home, but the door was wide open and Gattis had access to those firearms as well.

While explaining to Ms. Gattis that she knew she can't be around or posses anything, she advised that they are not hers because we seized her only firearm she owned. Ms. Gattis then openly admitted on her own free will that she had taken the Taurus .38 Special revolver out of Randle's van and placed it into the nightstand. I asked if she placed the firearm in that location before or after she was served with her Risk Protection Order. Ms. Gattis advised it was after she was served and when she got home from Behavioral Health Center.

### NARRATIVE

On Tuesday, October 28, 2025, at approximately 1320 hours, I responded to Walmart, located at 5555 20th Street, Vero Beach, Indian River County, Florida, in reference to a reported shoplifting incident.

Public Safety Dispatch advised the description of two suspects, a white female wearing a gray shirt, black leggings, and short red hair and a white male wearing white shirt and green shorts.

Deputy S. Lewis, a Corrections K9 Deputy with the Indian River County Sheriff's Office, advised via radio that he had observed a female matching the suspect description walking northbound on the east sidewalk of 58th Avenue, north of State Road 60/20th Street. Deputy Lewis, operating a marked patrol vehicle and wearing his issued Class C uniform, made contact with the female, later identified as Camilla R. Brown.

Deputy Lewis asked Brown if she had come from Walmart with a male companion, to which she replied, "yes." When Brown asked if she was in trouble, Deputy Lewis informed her that deputies needed to speak with her about an incident that had occurred at Walmart.

Upon arrival, I made contact with Brown regarding the alleged theft. Brown stated that she did not take any items from the store but admitted to consuming food items inside the store without paying for them. She denied leaving the store with any unpaid merchandise. Brown stated she was accompanied by Joseph Lerchefeld, date of birth 3/28/1983.

Loss Prevention Officer (LPO) Jacob Parker stated that, while monitoring CCTV surveillance, he observed a white female (later identified as Brown) and a white male (later identified as Joseph Lerchenfeld) consuming candy and food items while walking throughout the store. Parker further stated that Brown selected a gray hoodie jacket, removed the price tag, and put it on.

The pair later abandoned their shopping cart—containing opened food and candy packages—and exited the store via the grocery exit, passing all points of sale without rendering payment for the consumed food and jacket. Brown was still wearing the unpaid-for gray hoodie at the time.

# NARRATIVE (Continuation)

Parker stated that Brown was stopped after exiting and was asked to accompany Walmart personnel to the Asset Protection (AP) office. Brown refused, fled from the store, and ran northbound toward 58th Avenue. Parker also confirmed that Brown had been previously trespassed from all Walmart properties. Walmart's total pre tax loss was \$37.98 (post tax \$40.31), and the business wished to pursue criminal prosecution and a renewed trespass warning.

Dowdy corroborated Parker's statement, adding that she personally observed Brown putting on a silver jacket in the men's department and walking through the store while wearing it. Dowdy stated that after Brown passed all points of sale, she identified herself and requested that Brown return to the LPO office. As they walked toward the office, Brown removed the jacket, threw it on the floor, and fled the store on foot.

I reviewed the provided surveillance footage, which showed a white female wearing a silver jacket, gray shirt, black leggings, and a white male wearing a white shirt and green shorts consuming food and candy items while walking through the store. The female removed a tag from a jacket, put it on, and later exited the store past all points of sale without paying.

A check via dispatch confirmed that Camilla R. Brown had an active Trespass After Warning (TAW) from Walmart under OCA/2019-180920.

Based on my investigation, witness statements, video surveillance, and physical evidence, I determined that probable cause exists to believe that Camilla R. Brown knowingly obtaining or using, or endeavoring to obtain or use, merchandise from a retail establishment with the intent to deprive the merchant of possession, use, benefit, or full retail value thereof and willfully entering or remaining in a structure or conveyance after having been warned to depart or not to return.

Camilla R. Brown was placed under arrest for Retail Theft (Shoplifting) and Trespass After Warning. Camilla was transported to the Indian River County Jail for processing without incident.

Upon arrival, I made contact with Jesus Romero, who was identified by his Florida driver's license. Jesus stated that his exwife, Marilyn Romero, had been texting him throughout the day and later arrived at his residence, causing a disturbance. Jesus reported that Marilyn repeatedly banged on the front door, yelled, and attempted to open it several times, despite him being outside the residence. Jesus stated that at one point, Marilyn entered her vehicle, which was parked in the driveway. He said that as he attempted to walk away, Marilyn placed her vehicle in reverse, struck him, and caused him to fall to the ground. Jesus sustained visible injuries to his left elbow and forearm but declined medical attention.

I then made contact with Marilyn Romero, who was identified via name and DOB then cross referenced with ELVIS. After being read her Miranda rights, Marilyn confirmed that she was involved in a verbal argument with Jesus. She admitted to being near the front door but denied attempting to open it. When questioned about the incident involving her vehicle striking Jesus, Marilyn acknowledged that the incident occurred. She further stated that she was aware Jesus was behind her vehicle before reversing but still chose to back up. Marilyn observed Jesus fall to the ground and then drove the vehicle forward.

The incident was partially captured on home security cameras. After reviewing the footage, I observed Jesus standing behind a stationary vehicle when it suddenly began reversing, making contact with him. Due to camera settings, no additional footage of the incident was available. It shall be noted Marilyn appeared to have adequate space in the front of her vehicle to leave the location and that she was not in any danger at the time.

Based on statements, physical evidence, and video footage, it was determined that Marilyn Romero was the primary aggressor. She was placed under arrest for aggravated battery with a deadly weapon involving domestic violence and transported to the Indian River County Jail without incident.
