 On **09/01/2026**, at **14:38** (Specifically include facts constituting cause for arrest.)

On Tuesday, September 1, 2026 at 1438 hours, I, Officer Bannister, responded 1225 16th Street, Go-Line, in reference to a subject with a warrant. Upon arrival, Officers made contact with the security staff at this location, who stated a black male, wearing a blue polo shirt, blue jeans, and a black hat, with a black bag, had just left this location and began heading south on 16th Street. Security staff had been notified prior to this incident that the male, Jacolby Dunbar, had multiple active warrants and that he frequents this location.

Contact was made with Dunbar, who positively matched the description given, at the intersection of 10th Avenue and 17th Street, and he was detained without incident. Dunbar was positively identified via his State of Florida issued Identification Card. Following a NCIC/FCIC records check of Dunbar, I was notified that he did have an active warrant out of Indian River County, #312026CF000936A, for the following charges, 2 counts of FSS 784.03 (2) for Battery- prior convic felon batt commit 2nd sub battery-F/3, and 1 count of FSS 741.31(4)(a) for contempt of court- viol injunction protection domestic violence-M/1. 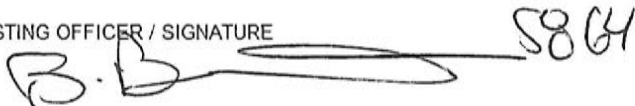
