



On Tuesday, September 16, 2025 at approximately 1018 hours I responded to Vero Beach Christian Church, 3250 9th Street SW, Vero Beach, Florida 32968 in reference to a suspicious person.

While en route to the call dispatch advised there was a male on the bench having a hard time staying awake and declined emergency medical assistance; finding that this call was not an attempt to report an overdose or summon emergency medical aide, I proceeded with my criminal investigation.

Upon arrival I observed a male sweating heavily, snoring, leaned over a bag seated on a bench, directly in front of an open and active church. I quietly removed the bag from under the male for officer safety as I immediately recognized this male, later identified to be Brian Bainter, to be under the influence of some sort of drug based upon my training and experience.

As the male awoke, I noted his pupils to be pin-point which further affirmed my suspicion of recent narcotic use.

I asked Mr. Bainter where the drugs were to which he informed me something to the effect of "Im going to jail." Shortly before stating the drugs were in his pocket.

I placed Mr. Bainter in handcuffs for the purposes of an investigative detention. A subsequent search based upon his admission to "meth" – slang for methamphetamine, in his pocket revealed a small multi colored zipper bag/toy box. Inside of this box was a white crystal like substance in a small clear baggie which I recognized through my training and experience to likely be methamphetamine; I initially believed this to be fentanyl based upon my observations of Mr. Bainter.

I conducted a field test of the substance first for methamphetamine which yielded a field presumptive positive result by a distinct blue coloration change of the test kit. I then tested this substance for the presence of fentanyl; which yielded a field presumptive positive result for the presence of fentanyl based upon a distinct rapid orange coloration change.

I conducted a probable cause search of the bag which had been in Mr. Bainter's possession which also contained his wallet with his Florida Identification card inside.

In this bag, I found a rolled shirt piece, which I believed would contain contraband. I unrolled this item allowing the contents to fall on the ground as the likelihood of encountering a needle was substantial.

As this shirt unfurled, 3 needles and a long, bulbed, glass stemmed pipe fell to the ground.

Based upon the results of this investigation and after confirming this call was not called in as an overdose or any attempt to summon emergency medical aide for Mr. Bainter, he was placed under arrest for 1 count of possession

My body worn camera was active.

The pre and post test weights of the bag with the white crystal like substance which had tested for methamphetamine and fentanyl were both approximately 1.06grams in packaging.


Upon secondary search prior to transport to the jail, Mr. Bainter informed me he potentially had some drugs in his sock. Upon peeling off his sock a small bag containing a grey powdery substance fell to the ground. The substance tested field presumptive positive for the presence of Fentanyl; weighing 0.52grams in packaging.

Mr. Bainter was subsequently charged with an additional count of possession of a controlled substance for the fentanyl found in his sock.

This report is cleared by arrest closed.

Your affiant told her to stop dialing which she ignored and continued dialing.

Your affiant then had Sebastian Police dispatch contact the phone number they had received the 911 calls from. When dispatch did this, your affiant observed Bobbi's phone began to ring, she answered and our dispatcher answered the phone. Your affiant then contacted dispatch on the radio and asked if they were on the line with the caller again to which dispatch confirmed they were. Your affiant then ordered Bobbi to put down the cell phone and stand up.





NARRATIVE

On September 16th, 2025, at 1849 hours, I conducted a traffic stop at the 1700 block of 41st Ave, Vero Beach, Florida 32960.

Prior to the stop, I was in contact with a concerned citizen who advised that a subject by the name of Lateesia Jordan was currently at her residence. The citizen actively observed Jordan enter the passenger side of a black dodge challenger bearing FL tag PWTT73 and travel north bound on 41st Ave.

I received a picture from the citizen which displayed a short medium-heavier build black female with brown hair standing at the hood of the previously aforementioned vehicle. The picture displayed similar characteristics of Jordan as Jordan is registered to be a 5'1" 215 lb black female according to the Indian River County warrant report. The concerned citizen advised that the subject in the picture was confirmed to be Jordan and advised they had just taken the picture before Jordan had gotten into the vehicle.

I am familiar with the housing structure of Jordan as prior I have surveilled the area looking for Jordan.

While on the phone with the concerned citizen who was actively giving me updates of the location of the vehicle, I was driving westbound on 16th Street when I observed the black challenger stopped at the stop sign of 41st Ave and 16th Street.

The vehicle's location was accurately depicted from the concerned citizen as the vehicle was travelling northbound from 41st Ave indicating that the vehicle was departing from Jordan's residence.

While slowing down to see which direction of travel the vehicle would go, I observed a female resembling the same appearance as the female in the picture sitting in the passenger seat.

The vehicle contained a registered owner who had an expired license. I initiated my emergency lights to conduct a traffic stop.

I made contact with the vehicle and the driver identified herself as Deshondra McGriff. I looked into the passenger seat and immediately identified Lateesia Jordan sitting in the front passenger seat. I asked for identification from Jordan and she advised she did not have her ID on her.

Deputy Le arrived on scene and Jordan was asked to step out of the vehicle. Jordan complied with the request and provided me with her name and date of birth, confirming her warrant.

Dispatch advised Lateesia Jordan had two active warrants out of Indian River County for the following:

Felony Violation of Probation

Flee/Elude Police

Cruelty Towards Child- Abuse Child without Great Bodily Harm

On 09/17/25, I, Ofcr. S. Gonzalez (471), was stopped in the parking lot of the 7-11 convenience store located at 1976 43rd Avenue when I observed the defendant pull in off of eastbound 20th Street, cut through the parking lot of Young's Market, and stop at the 7-11.

As a matter of course, I conducted a driver's registration check and discovered that the defendant did not have a valid driver's license.

The Defendant then exited the 7-11 parking lot a short time later onto northbound 43rd Avenue and then turned onto westbound 20th Street, at which time I pulled out onto 43rd Avenue to follow the Defendant and initiate a traffic stop. However, upon doing so, the Defendant hurriedly made his turn and created distance between us.

I caught up to the defendant at approximately 50th Avenue on westbound 20th Street when he abruptly turned left into the shopping center through the entrance in front of Sonny's BBQ. I continued west to the next median break where I turned into the shopping plaza ahead of the defendant, and we crossed paths.

I immediately turned around and fell in behind the Defendant, immediately initiating a traffic stop by activating the emergency lights on my fully marked police vehicle. At this point, I had a concern that the defendant may attempt to flee; however, he pulled into a parking space in front of Murphy's USA gas pumps and came to a complete stop.

I exited my police vehicle and approached the Defendant on the driver's side of the vehicle.

Upon making contact with the Defendant, I requested his driver's license. The Defendant stated that he did not have a license. I clarified if the defendant simply didn't have his license in his possession or just did not have a license. The defendant affirmed that he did not have a license.

When I asked the Defendant if he had been trying to avoid or evade me, he admitted that he had been.

I then asked the Defendant why he was driving if he did not have a license, to which he stated that he usually rides his bicycle, but that he was driving because it had been raining and was on his way back to work at the Walmart [located at 5555 20th Street].

A review of the Defendant's Driver History shows that the defendant has two active suspensions on his license, as follows:

- Criminal Failure to Pay as of 07/22/25 Indian River County, Florida
- Driving w/ Unlawful Bal .08 or above as of 06/05/24 Commonwealth of Virginia

THEREFORE, based upon the totality of the foregoing, the defendant was placed under arrest and transported to the Indian River County Jail where he was processed, booked, and issued Criminal UTC no.: ALZP98E.

The offense described hereinabove occurred within the City of Vero Beach, Indian River County, Florida.

The stop was recorded with the use of both my in-car and body-worn video cameras, which were subsequently uploaded to a secure server.


