The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 05/29/2026, at 00:03 (Specifically include facts constituting cause for arrest.)

On 05/29/2026 at approximately 0003 hours, I, Ofc. Herrera, responded to 1436 Old Dixie Hwy (Dom's Bar), to assist Ofc. Covarrubias in a traffic accident that occurred in the parking lot.

Upon arrival, I observed a white male sitting on a red motorcycle bearing Florida tag SDWD36 located behind a white SUV bearing Florida tag RLUY13. It appeared as though the motorcycle was involved in the accident with the white SUV. The motorcycle had damage to the front fender, and the left turn signal was broken off. The white SUV had damage on the right side of the rear bumper. I was able to observe red pain transfer from the motorcycle on the bumper of the SUV.

I then spoke with Trenton D. Ryan DOB 11/19/1998, who informed me that there was an altercation inside involving the white male on the motorcycle, later identified as George William Hall JR. Via his Virginia Identification card (A69792576). Mr. Ryan stated that as Mr. Hall started to make his way out of the building, he and another gentleman named Otis L. Dean DOB 08/07/1973, tried to stop him from getting on his motorcycle due to Mr. Hall appearing to be intoxicated.

I then spoke with Mr. Dean who stated that he was trying to verbally prevent Mr. Hall from leaving. Mr. Dean stated he observed Mr. Hall getting on his motorcycle and riding it into the rear of the white SUV.

Due to there being a traffic accident, Ofc. Covarrubias conducted a traffic crash investigation. Once Ofc. Covarrubias concluded his investigation he informed me that he observed Mr. Hall losing his balance while dismounting his motorcycle and several signs of impairment. The signs were a strong odor of an alcoholic beverage coming from Mr. Halls breath, the inability to balance while walking, swaying, and slurred speech.

After Ofc. Covarrubias concluded his traffic crash investigation I informed him that I would be conducting a DUI Investigation. We approached Mr. Hall and informed him that the traffic crash investigation was now over and I, Ofc. Herrera, will be changing over to a DUI Investigation due the above-mentioned signs of impairment.

I asked Mr. Hall if he would participate in some Standardized Field Sobriety Exercises which he declined by stating "I aint doing shit, I aint doing nothing, take me to jail." After refusing to perform Standardized Field Sobriety Exercises, Mr. Hall Was placed under arrest at 0026 hours on 5/29/2026.

Due to Mr. Hall being involved in a minor motor vehicle accident, I transported him to the Cleveland Clinic Indian River Hospital for medical clearance. After being cleared from the hospital, I transported Mr. Hall to the Indian River County Jail.

At 0233 hours 5/29/2026 Mr. Hall was placed on video at the Indian River County jail Intox room. D/S Rentas of the Indian River County Sheriff's Office who is a certified Breath Test Operator then asked Mr. Hall if he would provide a sample of his breath for the purpose of determining its alcohol content, which he then refused. D/S Rentas then read Mr. Hall Implied Consent which he then refused.

A Drivers License check was conducted on Mr. Halls Virginia ID Card through Vero Beach Telecommunications, which showed his Virginia DL was currently revoked, and notice of suspension/revocation was received by the addressee. The DL check also showed that Mr. Hall does not currently possess a motorcycle endorsement or motorcycle license. It should be noted that the registration for the motorcycle does not show any DL information for Mr. Hall, who is the registered owner.

- Mr. Hall was arrested for the following:
DUI Refusal in violation of FSS 316.193(1a)
Refusal to submit to testing in violation of FSS 316.1939(1)
Driving While License Suspended in violation of FFS 322.34(2a)
Operation Motorcycle Without Endorsement in violation of FSS 322.03(5)

Mr. Hall was later turned over to the Indian River County Jail staff for booking, processing and to be held on a \$1,300.00 Bond.

This incident was captured on my agency issue BWC and later uploaded to Vero Beach Evidence Library.

On May 29, 2026, at approximately 0358 hours, I responded to [REDACTED] in reference to a suspicious person. While en route, the caller David Marousky, stated a white male, entered his property from the north side and jumped over a fence onto his pool area.

Upon my arrival, I approached a metal gate on the south side of the property. As I approached, I heard someone walking inside the gated area, I shined my light, drew my service weapon, and asked to see his hands. The suspect later identified as Michael Bailey, was compliant and obeyed my commands. Bailey stated he was drunk and lost multiple times. Sergeant Le placed Bailey in handcuff and escorted him to my patrol vehicle.

I read Bailey his Miranda rights, which he understood and agreed to speak with me. Bailey stated he was at Sean Ryan's Pub drinking until 2230 hours. He then rode his bike and does not remember how he woke up in the back yard drunk and lost.

It should be noted that on every possible entrance or opening of the property, there are bright yellow "No Trespass" Posted signs.

I then spoke with Marousky, who stated, he has video footage of Bailey entering his property, and climbing his gate to enter his pool area.

Bailey willfully entered the structure, bypassed the visible "No Trespass" sign, climbed into a gated area, and remained until law enforcement arrived.

Based on the statements provided, the visible posted signs, and video footage of the incident, I find probable cause charge Michael Bailey with:

1. F.S.S. 810.09- Trespass.






On May 29, 2026 at approximately 18:56 hours, I responded to 5555 20th Street (Walmart), in reference to a Shoplifting call for service.

Prior to my arrival, I was informed by Indian River County Dispatch Channel 1 that the complainant stated there was a white male individual inside of the store who they wanted trespassed. The complainant advised Dispatch that the male entered the bathroom with merchandise and came out with nothing.

Upon my arrival, I entered the Walmart location and located the individual walking near the grocery section towards the exit. The male individual was later identified as Steven Phillip Roth. I observed steven holding a box of gaming cards in his hand. Steven was told that he is being trespassed and was asked to leave the store. The merchandise Steven had in his possession was given to the Asset protection personnel, Scottie Ingo. Steven willingly exited the store passing all points of sale and remained outside next to my marked agency issued patrol vehicle.

Deputy D. Magill arrived on scene to assist. Deputy Magill asked for consent to search Steven's pockets and he stated he could. Prior to my arrival Deputy Lowell and loss prevention officer, Scottie Ingo were outside with the suspect, Steven Roth.

I approached them and gathered Steven's identification and conducted an NCIC/FCIC query, along with a local records check, and discovered Steven has been arrested for retail theft in the past.

When Steven exits the isle the cards and calculator are no longer viable, but Steven is observed holding his shirt away from his waist in an effort to conceal the items he placed in his pants.

On May 29, 2026 at approximately 21:52 hours, I responded to [REDACTED] in reference to a physical Domestic Violence call for service.

Prior to my arrival, I was informed by Indian River County Dispatch Channel 1 that the complainant stated her boyfriend, Steven Rascati choked her and threw her to the ground.

Upon my arrival, I entered the [REDACTED] where the victim, Kimberly Ann Keen was located. Kimberly stated that Steven is her boyfriend and they are currently in an [REDACTED] [REDACTED] Kimberly stated that she and Steven both [REDACTED]

Kimberly stated the altercation happened because Steven believed she was cheating on him with another individual.

Kimberly was shaking, distraught, and crying while speaking to me. Kimberly stated she was involved in a physical altercation with her boyfriend Steven Rascati. Kimberly stated she was inside of her room going to sleep while Steven was outside in the living room of the residence building a puzzle. Kimberly stated Steven came into her room while she was sleeping and began to yell and scream at her. Kimberly stated while Steven was yelling profanity at her, he grabbed a pillow off of the bed and forcefully put it over her face. Kimberly stated Steven had one hand around her neck choking her and the other hand was pushing down against the pillow that was over her face. Kimberly stated while she was being choked by her neck and suffocated with the pillow, Steven continued to yell and scream at her. Kimberly stated that Steven repeatedly stated "I am going to kill you, you fucking bitch" while Steven was physically attacking her. Kimberly stated while she was being choked and suffocated, it restricted her air flow and she could not breathe properly. Kimberly stated Steven applied a great amount of pressure to her throat and neck while covering her nose and mouth with the pillow. Kimberly stated the force was strong enough to impede her normal breathing operation. Kimberly stated she was able to push Steven off of her just enough so she could escape from him. Kimberly stated after she got away from Steven, she grabbed some clothes and went to leave the residence. Kimberly stated as she was leaving the residence, Steven physically pushed her outside the door. Kimberly stated after she was pushed outside of the residence, she observed Steven throw her dog outside with her. Kimberly stated she grabbed her dog and got into her vehicle to meet with law enforcement by the gate.

While on scene, Kimberly had noticeable red marks and redness on her neck and throat as well as a scratch mark on her right arm. Kimberly stated the injuries she sustained were a direct result from Steven's aggressive physical behavior.

After my interview with Kimberly, we drove back over to the residence where Steven was located.

Assisting deputy, J. Chamberlain had Steven detained in handcuffs prior to my arrival. Deputy Chamberlain stated Steven had pulled away and tensed up as he was trying to place him into custody.

Deputy Chamberlain provided me with the following probable cause statement that read the following:

"On Friday, May 29, 2026 at approximately 2200 hours I responded to [REDACTED] in reference to a disturbance.

Upon my arrival I attempted to locate the victim who had fled the scene for her own safety. As I searched for her, I was advised another deputy was coming on scene and would be making contact with her.

I then responded to the residence where I attempted to establish a small perimeter around the exterior of the residence given that on [REDACTED] I overheard something to the effect of weapons being within the home.

As I began to encircle the residence, the side door opened where I immediately observed a male who I knew to be Steven Rascati. Based on my initial observation of his stance I believed him to be likely under the influence. As Mr. Rascati began to speak, I confirmed my suspicion of his intoxication. I know through my training and experience that individuals under the influence tend to act irrationally and often become irate or noncompliant with law enforcement.

I requested Mr. Rascati exit the residence where he initially declined; he then exited and sat on the steps to the residence. The door was open and he was seated in a position which would have allowed him to retreat back in to his residence easily and without forewarning. Due to this and the mention of firearms in the home; coupled with Deputy Lowell advising via radio he had probable cause for Battery by Strangulation on Mr. Rascati I attempted to effect an investigative detention by informing Mr. Rascati he was going to be detained and reaching for his hand and arm.

Immediately upon receiving this information, Mr. Rascati stiffened his body posture and appeared to attempt to scoot backward; I believed Mr. Rascati was attempting to retreat to the interior of his residence to avoid arrest.

As a result of Mr. Rascati's failure to comply with lawful orders and his physical resistance to less forceful techniques, I underhooked his legs and pulled him off the stairs and to the ground. I then utilized light pressure on his left arm as he continued to brace his body by tensing his muscles. As a result, Mr. Rascati was warned if he did not comply more force would be utilized against him.

As I placed Mr. Rascati in to handcuffs, he initially refused to provide deputies his right arm. As I gained control over the right arm, he grabbed my hand and then his own hand, further delaying his detention in handcuffs.

As I escorted Mr. Rascati to my patrol vehicle, he required forward pressure to make him walk toward my car. Mr. Rascati began referring to the victim as a "whore" and a "Cunt", stating he hadn't done anything; he had only thrown her out of the house; and that she was cheating on him. Mr. Rascati stated these numerous times during spontaneous utterances. After this, Mr. Rascati began to ramble about the Free Masons controlling the catholic church and stating something about the Jewish temple.

I noted Mr. Rascati smelled overwhelmingly of the odor of an alcoholic beverage which increased as he spoke.

I provided the victim, Ms. Keen, a Domestic Violence Rights and Remedies pamphlet and completed FDLE's lethality assessment which indicated a HIGH-RISK assessment as Ms. Keen answered in the affirmative to questions 2,3,4,5,6,8,

10, and 11. Ms. Keen advised he had battered her previously but did not report the situation to law enforcement. I then contacted the On-Call Victim's Advocate for the Indian River County Sheriff's Office, L. Saputo. I provided my probable cause for Resisting without Violence to Deputy Lowell for his affidavit of arrest. I requested Indian River County Fire Rescue respond to evaluate Ms. Keen given the allegations of Strangulation as I had observed light redness still present on her neck. (Run# 2026-00015005). My body worn camera was active. This concludes my involvement in this case."

Furthermore, into my investigation, I read Steven his Miranda Warnings and he advised he understood them. Steven was hesitant at first to speak with law enforcement but later stated he would. Steven stated he was in the living room of his residence and believed Kimberly to have been cheating on him, therefore he grabbed her phone and began to look through it. Steven stated while he was looking through Kimberly's phone, she was standing right next to him observing overhead. Steven stated he got into an argument with Kimberly and wanted her out of the house. Steven stated Kimberly went into the bedroom and went under the sheets and he continued to tell her to leave the house. Steven stated it was just an argument and he never put his hands on Kimberly. When Steven was asked how Kimberly received the red marks on her throat and arm, he stated he did not know and denied any allegation of physical contact. Steven appeared to be intoxicated.

The victim, Kimberly was screened with the Florida Lethality questionnaire and based of the results, Kimberly was at High-Risk of a potential lethal situation. Kimberly was advised of this situation.

From the statements provided and the injuries on scene, I determined Steven to be the primary aggressor.

Steven was transported to the Indian River County Jail.

NARRATIVE

On Saturday, May 30, 2026 at approximately 0015 hours I observed a vehicle traveling West on State Route 60, in the approximate area of the 9000 block, Vero Beach, Florida 32966 with no illuminated registration lights.

I conducted a traffic stop on this vehicle after verifying the vehicle had no rear illuminated registration lights in violation of F.S.S. 316.221(2). The final stop took place at the South entrance to Interstate 95.

I approached the vehicle from the passenger side where I identified myself by name. I requested the driver, a young black male, to provide his driver's license. The male, later identified as Mr. Chandler Perceval, informed me he did not know if he had a hardship license or not.

Immediately this rose concern for Mr. Perceval's lawful ability to operate a motor vehicle upon the public roadways of the State of Florida; as through my training and experience individuals with hardship licenses have had their driving privileges revoked or suspended and are generally aware of their ability to drive, or lack thereof.

Mr. Perceval advised me his lawyer had told him something to the effect of pay the citations and reinstatement fee and he should be able to obtain a hardship license.

Mr. Perceval then produced a photograph on his phone of his driver's license. It is noteworthy that in the course of my traffic enforcement experience individuals who do not have the lawful privilege of operating motor vehicles commonly do not have a physical driver's license and often identify themselves by way of photographs of previous licenses.

I recorded the driver's license number on the LEARNERS PERMIT (P621104050440) which I then conducted an FCIC/NCIC query on my agency issued mobile computer. I observed Mr. Chandler Dowinsky Perceval to be listed as a HABITUAL TRAFFIC VIOLATOR with a 60.0 month suspension effective date of 03/09/2026.

I then conducted a DAVID query of Mr. Perceval where I observed Mr. Perceval's driver history to show this HTO status to be effective the same date, with notice provided 02/19/2026 in the County of Palm Beach. I further observed that Mr. Perceval's DAVID profile showed a total of 3 previous DWLS.

I confirmed, twice, the Habitual Traffic Violator status via radio channel 2 with dispatch.

I detained Mr. Perceval in handcuffs where I informed him of his constitutionally protected rights in the form of a Miranda Warning.

Mr. Perceval agreed to speak with me without a lawyer present. I was advised of the following in substance:

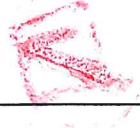

PROBABLE CAUSE STATEMENT

On May 30, 2026, at approximately 0112 hours, I was traveling to Best Western to assist Officer Didier on a call when I observed a gray BMW with the emergency lights on parked on the side of the road facing southbound on US Hwy 1. As I passed, driving northbound on US Hwy 1, I observed the driver slumped over. I did a U-turn and got behind the vehicle. I initiated a possible disabled vehicle.

Once the vehicle was secured, I initiated contact with the driver. The driver was sweating profusely. When he awoke from his slumber, I asked the driver for his driver's license. I could smell an alcoholic beverage emitting from his breath, his eyes were glossy, and he did not know where he was.

I had the driver step out of the vehicle; he was unsteady on his feet, and was unaudible when he spoke. The driver was identified by name and date of birth as Rashon L. Hart, 4/9/1992. A query with dispatch revealed that Rashon did not have a valid driver's license since 2023. When Rashon over heard another officer's radio stating that his license was not valid, he said "fuck"

When asked if he knew if his license was suspended, Rashon avoided answering the question. I repeated the question, and he said, "take me"

Rashon also stated that he had a restricted driver's license. A further query showed that Rashon was also invalid from the state of Virginia.

At this time, Rashon was placed in mechanical restraints, double locked.

Officer Didier asked Rashon if he was willing to do FSE, field sobriety exercises. Rashon refused.

There were also open alcoholic containers scattered in the front and back seats of the vehicle.

Rashon was arrested for driving with a suspended license with knowledge, FSS 316.34 and also for driving under the influence, FSS 316.193.

Rashon was transported to the county jail without incident.

At the county jail, Rashon refused to submit a breath sample with Deputy Canales.

On May 30, 2026, at approximately 0031 hours, I was traveling south on Interstate 95 when I observed a vehicle approaching me from the rear at a high rate of speed. I visually estimated the vehicles speed to be 100 MPH. I confirmed the vehicles speed to be 102 MPH with my RADAR-STALKER DSR 2X SN: DB031280.

As the vehicles was approaching me from the rear, I had to move from the left lane to the center lane to avoid be struck from behind. As the vehicle got approximately two car lengths away, the driver rapidly slowed, most likely do to observing my marked patrol vehicle.

I initiated a traffic stop on the blue Mercedes SUV bearing Pennsylvania tag MZH9583 at MM 144 on Interstate 95 by activating the emergency light on my patrol vehicle.

NARRATIVE

On Saturday, May 30, 2026, at approximately 0157 hours, I conducted traffic enforcement in the area of the 1300 block of Indian River Boulevard, Vero Beach, Indian River County, Florida, 32962.

While conducting traffic enforcement, I observed a white Ford pickup truck travelling southbound on Indian River Boulevard. I visually estimated the pickup truck to be travelling at approximately 65 miles per hour. It should be noted, the posted speed limit on Indian River Boulevard in that area is 45 miles per hour. The mounted radar in my marked patrol vehicle sounded a solid tone and displayed a speed of 65 miles per hour for the pickup truck, confirming my estimation. I then travelled to catch up to the Ford Ranger, bearing Florida tag 65VBQB, as it approached the intersection of Indian River Boulevard and U.S. Highway 1. As the driver approached the intersection, he activated his left turn signal and crossed over two (2) lanes marked with a solid white line. I then notified the communications center of the impending traffic stop and awaited the traffic control signal to change. Once the signal changed, the driver turned southbound on U.S. Highway 1, and I activated my emergency lights to initiate a traffic stop. The driver turned west onto 1st Street and pulled into the business located at 400 1st Street, in Vero Beach.

I then approached the driver's side window of the Ford and made contact with the driver, and sole occupant of the vehicle. The driver was identified as Mr. Cameron McFarland, via his Florida Driver's License. As I spoke with Mr. McFarland, I detected the distinct odor of an alcoholic beverage emanating from his person, which grew stronger as he spoke. Deputy M. Ciofalo (6321) arrived on scene and approached the passenger side of the vehicle. Upon his arrival at the window, he advised me he detected the odor of an alcoholic beverage emanating from the driver. Mr. McFarland advised he had visited two (2) establishments known to serve alcoholic beverages after he left work. As he searched for his registration and proof of insurance, he presented a certificate of title, which was not requested. I became concerned Mr. McFarland was impaired beyond his normal faculties, and requested he participate in field sobriety exercises to dispel my concern. He agreed to participate and exited the vehicle. I asked a series of medical questions to ensure he could participate in the standardized field sobriety exercises (SFSE). He stated he had not been diagnosed with diabetes and did not wear contact lenses. He advised he had experienced [REDACTED] All SFSEs were explained and demonstrated proficiently prior to Mr. McFarland beginning each exercise, and I confirmed he understood the instructions prior to his attempts.

The following exercises were performed:

1. Horizontal Gaze Nystagmus – No resting nystagmus was observed. Equal pupil size and equal tracking were observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed in both eyes, and the onset of nystagmus prior to 45-degrees was observed at an estimated 30-35 degree angle.

2. Walk and Turn – Mr. McFarland was directed to a level area of a parking lot, and advised to imagine a straight line. Mr. McFarland agreed the area was level and he would imagine a straight line. During the instructional phase, Mr. McFarland did not maintain the instructed position and was unable to maintain his balance. While attempting the first nine steps, he utilized his arms to balance, stepped off the line and missed heel to toe. He then performed an improper turn. He attempted to complete the second nine steps, during which he utilized his arms to balance, stepped off the line and missed heel to toe.

3. One Leg Stand – Mr. McFarland chose to lift his right foot, and counted from 1001 to 1013, during which he utilized his arms to balance. He then placed his foot down, and had to be told to continue the exercise. He lifted his right foot again and continued counting. He continuously utilized his arms to balance, and swayed during the remainder of the exercise. Throughout the exercise, he failed to follow the instruction provided to look at his foot during the exercise.

Overall, Mr. McFarland did not perform the SFSEs to standard.

Based on my investigation, probable cause was established that Mr. McFarland was in actual physical control of a motor vehicle while under the influence of alcoholic beverages and/or a chemical or controlled substance, and was impaired beyond his normal faculties and incapable of operating a motor vehicle safely. He was placed in handcuffs, which were checked for proper fit and double-locked. He was then placed in the back seat of my marked patrol car.

It should be noted, an inventory of Mr. McFarland's Ford Ranger was conducted, during which multiple cans of alcoholic beverages were located. One can of Modelo, a known alcoholic beverage, was located on the front passenger seat, which was open and contained a small amount of the remaining alcoholic beverage. I poured out the alcoholic beverage, then continued to assist with the inventory. See Deputy Ciofalo's supplement for additional information.

Mr. McFarland was then transported to the Indian River County Jail and was turned over to Corrections Deputy M. Cazares (5932) for a breath test. Deputy Cazares advised Mr. McFarland agreed to provide a breath sample. At the conclusion of the test, the breath sample showed Mr. McFarland had a breath alcohol concentration (BrAC) of 0.194 grams per 210 liters of breath, and 0.191 grams per 210 liters of breath. I utilized the Driver And Vehicle Information Database (DAVID) and conducted a query of Mr. McFarland's driving history, which revealed a prior offense of Driving Under the Influence on May 7, 2023 with a disposition of Guilty.

Mr. McFarland was issued a DUI Citation (ANHCAFE) for the violation of F.S.S. 316.193(4) – DUI with B.A.C.

NARRATIVE

On Saturday May 30, 2026, at approximately 1846 hours, I responded to [REDACTED] in reference to a Disturbance.

Upon my arrival, I made contact with Victim, James Hargrove, who stated the following in substance. He was in his residence and was approached by the suspect. Suspect comes over every day to use his phone. He told the suspect that he does not want him to use his phone today and wanted him to leave his residence. A verbal argument broke out by the front door and the suspect picked up a broken piece of wood swinging it towards James making contact with on his left leg. After the suspect struck James's leg, James began to bleed from the open wound. The suspect threw the piece of wood on the ground and left the scene.

While taking pictures of the scene I notice multiple pulls of blood in the living room of the residence. Outside I observed blood trails from when I saw James walking back from the street to his front door.

James was unable to give a name of the suspect but was able to give a clothing description and a direction of travel.

Description received via dispatch notes was a black male, wearing yellow shorts, and a brown shirt, heading southbound on [REDACTED]

I asked James once we find the suspect would he like to pursue charges and he stated, yes.

I asked James to show me where the wood made contact. James lifted up his pants leg and I observed a gaping wound the size of my palm with skin hanging. The wound was actively bleeding with fatty tissue exposed, with the skin still attached at the posterior side of the leg. I asked James if he still could move his toes and he was able to. Due to the severity of the wound I believe it to be permanent disfigurement due to James needing multiple stitches to pull and attach the skin back over the wound.

EMS arrived on scene and transported James to Cleveland Clinic Hospital.

Available units BOLO'D the area to find the suspect that fit the description that was giving.

Deputy J. Yerian asked a witness across the street who may have seen the incident.

Witness gave us a different description of suspect which was advised to units of a black male, approximately 5'10, no shirt, black hair, approximately 170 lbs.

Deputies found a person matching the description that was given. Deputies approached the suspect,




I explained the reason for stop to Susan, that she passed me going 50 mph in a 35-mph zone and she replied "that's not that bad".

While speaking with Susan I observed a clear plastic cup, greenish tint with a lime floating in it, it resembled an alcoholic beverage you would get from an establishment, in the center console of the vehicle and there was a slur to her speech.

At this point I asked Susan how much she has had to drink tonight and after a short pause she replied "none, I've had no drinks at all". I asked Susan what the contents of the cup in the center console was and she stated my ex-husband was a Connecticut state trooper. I replied, so you should know you can't drink and drive. I told Susan we are going to start over and again asked her how much she has had to drink and she replied "I didn't finish this and I didn't want to waste it", referring to the beverage in the cup. I asked her again what the contents was and she replied, "Just Tito's and ginger ale, but it's weak". She stated she was coming from Malabar Mo's and they make weak drinks. Susan continued to talk and again stated she was married to a Connecticut State trooper, and stated "I know the rules".

Susan stated she was meeting a friend at Earl's Hideaway and asked, if she could stay there for a few hours then leave. I advised her to dispose of the drink in the center console, which she did. I returned to my vehicle to run her information.

When I returned to the car, I asked Susan if she would be willing to conduct Standardize Field Sobriety exercise's and she replied "are you joking with me right now". I advised her not at all and she replied I thought you was going to give me a warning. Susan became confrontational with me, telling me I destroyed evidence by having her dump out the drink. I again asked if she would be willing to perform the exercise and she replied "what would happen, if I don't?" (Video time 07:18 mins). As I attempted to answer her question, she stated I just moved down here. I told her she was drinking and driving and I didn't know the level of her impairment.

I informed her I would have to base my decision off of what I had observed up to this point. She replied "that's giving you evidence" (Video time 07:35 mins). I advised her again I would have if she didn't conduct the field sobriety exercise, I would have to base my decision off of the evidence I have at this time. Susan asked what evidence I had. I explained to her she has an open container in her vehicle, she admitted to drinking prior to the stop. She replied she didn't want to finish that drink at the bar, it was too much for her. Susan continued to avoid to answer the question presented to her. I continued to speak with Susan until my back up unit arrived and I removed her from her vehicle. I explained to her the exercise would allow me to judge her intoxication level. I explained to her the exercise's I would be performing. She stated she was embarrassed and want to move to a different parking lot. I advised her I was not going to move to a different parking lot to perform the exercise. Susan again asked me what her options were and I again explained to her if she didn't conduct the exercise, I would have to go off what I have seen to this point. She replied "are you going to give me a ticket?". I advised her at this point I had enough evidence to suspect she was driving under the influence. I advised her the exercises would help judge her intoxication level. Susan continued to evade the question and continually wanted to move locations for the exercises.

I again asked her if she would participate in the exercise's and she again evaded the question. At this point I told her t shut the vehicle off which she complied with. I spoke with her again about performing the exercises and she replied, so I'm going to get it either way and I replied no; however, if you refuse them, she would be under arrest for DUI and at the jail she would be able to provide a breath sample if she wished.

Ofc. Sanchez arrived on scene so I requested Susan to exit the vehicle. Once she exited the vehicle, she stated, so are you

going to take me to jail. I once again explained the options to her. At this time, I explained she was too impaired to drive. Susan agreed to conduct the exercise.

To start the exercise, I asked if she had any medical issues or brain injuries, I would need to be aware of and she stated no.

I placed Susan in the starting position to start the HGN test. I advised Susan she needed to stay in that position until she was told otherwise. I told Susan to stand with her feet together and her arms down to her side, I demonstrated how I needed her to be. Before I started the test, I produced the stimulus, which was a red light. Susan confirmed it was red. I told her to follow the light with only her eyes and to not move her head and she stated she understood.

During the exercise on the first pass for the equal tracking phase I had to remind her to not move her head. I then performed the smooth pursuit, Susan jumped ahead of the stimulus and she had to be reminded once again to not move her head. While attempting to conduct the maximum deviation I bouncing of the right eye, as I proceeded to move to the left eye Susan again moved her head. At this time, she stated her left eye is not great, she had [REDACTED] At this point I had to start the test over.

On the second time conducting the test, I had equal tracking, smooth pursuit she continued to jump ahead of the stimulus. With Maximum deviation I had fluttering of the eyes and for onset of Nystagmus I had fluttering of the eyes prior to the 45-degree angle. While conducting these tests there was a strong odor of an Alcoholic beverage emitting from Susan's mouth.

The next exercise performed was the walk and turn. I instructed Susan to go to some painted lines for the drive thru of the business. While setting up for this exercise I asked Susan on a scale of 1 to 10, 1 being completely sober and 10 being sick in the morning where she believed she was and she stated a 2.

At this I placed in the starting position an advised her she needed to stay in this position until I told her to start and she stated she understood. I asked Susan if she was able to walk in the boots she had on, or if she preferred to do it barefoot and she stated with her boots on. I explained the starting position to Susan telling her to place her left foot on the white line and place her right foot in front of her left with the heel of her right touching the toe of her left. She questioned if I could do this as I demonstrated how I needed her to stand. At this point she started to conduct the exercise without being told or given the rest of the directions. I stopped her and attempted to get her in the starting position again, and she stated she is at a disadvantage because she used to be a ballerina. She then stated when you ski you use poles and you have to keep your arms out to the side for balance. I again explained to Susan how I needed her to be for the starting position. Once there I told her to stand like that. As I was trying to explain what I needed her to do in the exercise, Susan again left the starting position I had put her in.

I demonstrated to her what I needed of her and; however, to save time I only took 3 steps. Susan questioned why I only did 3, and I told her again why I only did three; however, I needed her to do 9. Again, I had to place her in the starting position, before we could proceed.

I advised Susan to start the exercise as she was walking, I was documenting the clues by voice she missed heel to toe on steps 1, and 3 and she stopped the exercise asking what that meant by she missed. I explained to her the documentation. Susan did not count any steps out loud as instructed. I requested her to start the exercise over again. While attempting to put her in the starting position again she became argumentative. At this point she stated I think I need a attorney. I explained if she didn't want to complete the exercise that was fine; however, I would have to base my decision on what I have seen at this point.

She said she believed she was missing it because she wasn't conducting the exercise exactly how I demonstrated it. Susan started the exercise again and took 13 steps, Susan stopped and asked if that was nine. I asked if she remembered the

instructions and she made the turn and proceeded walk back again taking 13 steps. Susan did not count any steps out loud as instructed.

I placed Susan in the starting position for the next exercise the one leg stand. I advised Susan to stay in that position until she is instructed to start and she acknowledged. I told her to pick her foot up approximately six inches off the ground. She stated didn't know what six inches was, so I told her approximately the size of a coke can. Susan again did not stay in the starting position as originally instructed. She again stated she needed her arms out for balance. Before starting the exercise, she asked if she could have two chances, I told her no and again had to put her back in the starting position.

I asked Susan to start the exercise and at no time did she do as I requested and had no balance for longer then 1 second.




After the conclusion of the exercise and the evidence I had prior to starting the exercise's I believed Susan's normal faculties were impaired.

NARRATIVE

On Sunday, May 31st, 2026, at 0016, I conducted a traffic stop on an orange-colored Dodge Charger bearing FL/ RCFD25, at 700 US Highway 1, Sebastian, for violating FSS 316.2953. Upon making contact with the driver, later identified as Andrew P. Gayle, I was met with the overwhelming odor of burnt marijuana emitting from interior of the vehicle. I asked Gayle when was the last time he smoked marijuana, and he responded approximately 4 hours earlier. I then asked Gayle if there was any marijuana inside the vehicle too which he expressed there was, in the trunk. It should be noted that Gayle possessed a valid medical marijuana license, however, multiple small amounts of a green leafy substance, suspected marijuana commonly referred to as shake, could be seen from the exterior of the vehicle.

After collecting Gayle's driver's license and vehicle registration, I requested that he exit the vehicle; too which he complied. Sebastian Police Department (SPD) Officer Sanchez and myself began a probable cause search of the interior compartments of the vehicle. While searching through the center console of the vehicle, I located 4 cartridges of suspected THC oil, a partially burnt suspected marijuana joint in the cup holder, and two bottles of Standardized Mitragyna speciosa extract (Kratom containing 7-OH). Additionally, SPD Officer Sanchez located two packages of Kratom tablets containing Mitragyna speciosa (7-OH), on the front passenger floor board. while searching the trunk of the suspect vehicle, I located a black drawstring bag with a plastic vacuum sealed bag inside, containing mushrooms. After located the mushrooms, Gayle spontaneously expressed that the mushrooms were magic mushrooms, and that they had been in the trunk of the aforementioned vehicle for over a year. Gayle was subsequently detained without incident.

After securing Gayle in the rear of my patrol vehicle, I continued searching the suspect vehicle and located multiple containers of medicinal marijuana flower, gummies, and oil. I collected all the medicinal items labeled that they contained THC. Additionally, I collected the items I suspected contained THC, and utilized an agency issued field drug test kit, to test the suspected synthetic cannabinoids; which revealed a positive test result for the presence of THC. After completing my search of the suspect vehicle, Deputy Magill arrived on scene and provided me with an agency issued field drug test kit that tested for psilocybin. Deputy Magill tested the suspected "magic mushrooms," which resulted in a positive test result for the presence of psilocybin.

I then went and made contact with Gayle, and advised him of his Miranda Rights, too which he expressed his understanding. Post Miranda, Gayle advised he wished to speak with me. I informed Gayle that I had probable cause for his arrest for possession of a controlled substance, in reference to the mushrooms containing psilocybin. Gayle then expressed again, that the mushrooms were over a year old, proving that he had knowledge. Additionally, Gayle expressed he got the mushrooms to share with a

friend for his birthday; indicated possession with the intent to distribute.

After discussing the mushrooms, I informed Gayle that he was also violating FSS 893.13, possession of a controlled substance, by improperly storing/possessing the marijuana and synthetic cannabinoids. Gayle expressed that he had a valid medical marijuana license, and I informed him that in accordance with the Florida Office of Medical Marijuana Use (OMMU), his medical license will be suspended due to him violating the rules and regulations.

It should be noted that an emergency rule was filed on 8/19/2025, classifying isolated and/or concentrated 7-hydroxymitragynine (7-OH) as a Schedule I controlled substance in Florida; per FL Rule: 2ER25-2.

Through my investigation, I found Andrew P. Gayle, to be in violation of;

- (x1) FSS 893.13(1)(a)(1), Possession with the intent to distribute a scheduled 1 controlled substance (mushrooms containing psilocybin)
- (x6), FSS 893.131(a)(2), Possession of synthetic cannabinoids (x4 THC vape cartridges, THC oil, and THC gummies)
- (x4), FSS 893.13(6)(b), Possession of marijuana not more than 20g (a partially burnt marijuana joint, a plastic container containing loose marijuana, 2 plastic bags containing loose marijuana)
- (x4), FSS 893.13, Possession of a controlled substance (x2 bottles of liquid 7-OH Kratom, x2 packages of sealed 7-OH Kratom tablets)

In relation to Andrew P. Gayle's aforementioned charges, Gayle was issued 15 criminal citations (one citation for each count) in reference to violating FSS 893.13.




NARRATIVE

On May 31, 2026, at approximately 0234 hours, I was stationary at approximately MM 150 facing south bound on Interstate 95 in the median, when I observed three (3) vehicles side by side traveling south on Interstate 95 at a high rate of speed. I visually estimated their speed to me 100 MPH. I activated my Stalker Radar and confirmed their speed to be 101 MPH as they traveled side by side taking up all three (3) lanes of travel south on Interstate 95.

As the three (3) vehicles approached me, the vehicles in the middle and right lane slowed, while the vehicle in the left lane continued at speed.

I pulled out from the median, and informed Indian River County Sheriff's Office Dispatch, that I had three (3) vehicles drag racing southbound on Interstate 95 at MM 149.

I caught up to the vehicles at approximately MM 148 and initiated a traffic stop on a red Infiniti bearing Florida tag 08FSUX, which was in the left lane, by activating the emergency lights on my marked patrol car. The vehicle that was in the far-right lane also stopped on the opposite side of Interstate 95.

I requested Deputy Green as back-up, and informed him to conduct a traffic stop on the vehicle that was stopped on the opposite side of the road. I informed Deputy Green of the facts relating to my stop. See Deputy Greens supplement.

I approached the driver side of the vehicle and made contact with the driver, Malachai Amos, I requested his driver's license, registration, and proof of insurance, which was provided. I requested Malachai to the front of my patrol car as I conducted NCIC/FCIC queries. When I completed with my queries, I exited by patrol car and placed Malachai in handcuff restraints, checked for proper fit, and placed him in the rear of my patrol car.

I approached the vehicle and requested the passenger's driver's licenses, which they provided. I conducted a query on Devin Ellis, who was the registered owner of the vehicle, and Carlos Williams, the rear passenger. Once I confirmed Devin's drivers license was valid, I returned to the vehicle, and released them from the scene.

I transported Malachai to the county jail and charged him with violation of Florida Statute 316.1922(1)(B), super speeder, and violation of Florida State Statute 316.191(2)(A), speed racing on the highway.

This investigation was captured on my body worn camera, and the dash camera of my patrol car.

This investigation is cleared by arrest.

NARRATIVE

On Sunday, May 31, 2026, at approximately 1103 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with Courtney Elizabeth Thomas on the front lawn of the residence near the front door. Thomas explained that she and the father of her child, Christopher Michael Dones, had been involved in a verbal dispute. Thomas further stated that she had gone out the previous night with her friends and, when she returned home that morning, Dones became extremely upset and began gathering her belongings. Thomas stated that Dones threw her belongings onto the floor of the living room area of the residence.

Thomas wanted me to advise Dones that he was not allowed to do that because she was a [REDACTED]. I clarified with Thomas whether the dispute had been verbal only, and she confirmed that it had. Thomas stated that nothing physical had occurred.

I entered the residence to make contact with Dones. As I walked through the front door, I observed several clothing items scattered throughout the living room area. I inquired with Dones regarding what had occurred. Dones advised that he was throwing Thomas's belongings out of the residence. Due to this statement, I advised Dones that he could not lawfully remove her from the residence in that manner and that an eviction would have to occur through the proper legal process.

Dones then inquired about the investigation, and I informed him that Thomas had advised that nothing physical had occurred. Dones stated that Thomas's statement was incorrect. Dones explained that Thomas had thrown a cellular telephone at his leg and had also struck him with a flip-flop sandal.

Dones further advised that the incident had been captured on an interior surveillance camera located in the living room area. I asked Dones to show me the video footage, and he consented.

While reviewing the footage, I observed Thomas and Dones engaged in a verbal argument regarding Thomas going out with her friends. Thomas suddenly became enraged and began yelling at Dones. Thomas then threw what Dones identified as a cellular telephone. The argument continued, and Thomas moved a flip-flop sandal from her left hand to her right hand. Thomas continued yelling and then threw the sandal at Dones, striking him in the abdomen.

Dones was provided a Community Request Link through the Axon Capture App. I confirmed that Dones successfully uploaded the video, which was stored in Axon Evidence.


Shortly after reviewing the footage, Dones advised that he did not wish to have Thomas arrested and stated that he merely wanted her "out of here." I advised Dones that, based on his statements and the video evidence, Thomas would be taken into custody.

At the time of initial contact, no marks, bruises or abrasions were observed on Dones to document.

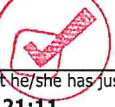

 On **05/31/2026** at **23:25** (Specifically include facts constituting cause for arrest.)

On Sunday May 31st, 2026, while on routine patrol, I was advised of a silver Honda four door with illegal window tint. I approached the vehicle from the rear at the intersection of Old Dixie Highway and 16th Street. At this time, Officer Marty (459) pulled into the left turn lane and confirmed that she was unable to see inside the vehicle due to the window tint being dark. As we crossed through the intersection continuing south on Old Dixie, I activated my emergency lights to initiate a traffic stop on the vehicle. At this time, I provided Vero Beach Police dispatch with the temporary Florida Tag of EBC0303. The vehicle began to pull over into the bridge center parking lot at which time, it began to accelerate and flee the traffic stop. The vehicle pulled out onto 14th Avenue head north before turning west on 16th Street and fleeing at a high rate of speed. The vehicle continued west on 16th Street where they ran a red traffic signal at the intersection of 27th Avenue. The vehicle then headed south on 34th Avenue before turning east on 12th Street. While traveling east on 12th Street I was advised to terminate at which time I turned my emergency lights off. I observed the vehicle turn south on 20th avenue, at which time I made a south bound turn to keep eye's on the vehicle until Indian River County deputies could respond to the area. It was at this time I observed the vehicle black out as it traveled south before heading east on 8th street at which time I lost visual of the vehicle. Once approaching the intersection, I observed a silver vehicle in the grass median heading towards a canal and a black male in a white shirt running from the driver seat. Believing the vehicle may have been involved in a traffic crash I activated my emergency lights again and pulled up to the vehicle as K9 Officer Doty went towards the driver who was running.

At this time, I made contact with a [redacted] in the passenger seat and advised [redacted] not to move until another unit arrived. I then made contact with the [redacted] who will be referred to as [redacted] for this report. At that time, [redacted] was placed in handcuffs and in the back of my patrol vehicle. K9 Officer Doty detained the other male who advised that he fled due to not having an active driver's license. The male driver who ran from the vehicle was identified as William Rigby. Upon making contact with Rigby I advised him of his Miranda Rights and asked if he wished to speak to me which he advised no but he had just made a dumb decision and asked for his cash to be turned over to his brother [redacted] or [redacted] when she came to pick up his brother which I stated that I would.

[redacted] Rigby and [redacted] arrived on scene at which time the cash and [redacted] was turned over to Shaneka Stinson. The vehicle was removed from the scene by Collision's Towing.

Rigby was transported to the Indian River County jail with out further incident. Rigby is charged with F.S.S. -316.1935(2) - FLEE ELUDE LEO WITH LIGHTS SIREN ACTIVE, F.S.S. - 322.34(10b1) - DRIVE WITH SUSPENDED REVOKED LICENSE, F.S.S. - 316.192(2a) - RECKLESS DRIVING 1ST OFF and F.S.S. - 843.02 - OBSTRUCT WO VIOLENCE. Rigby was issued citations for all 3 traffic violations. Rigby is currently being held on no bond.
