## Arrest Affidavit Report

#### NARRATIVE

On August 5, 2025, at approximately 0056 hours, I was dispatched to Cumberland Farms, located at 4490 US Highway 1, Vero Beach, Florida, in reference to a shoplifting.

Prior to arriving on scene, Indian River County Sheriff's Office Dispatch advised the complainant stated the suspect left the scene on a bicycle headed south from the location, a black male wearing a black shirt, black shorts, and carrying two cases of Bud Light that he just stole.

Due to the information relayed by Dispatch I began to search the area for the suspect. I began traveling west on 43<sup>rd</sup> Street from Old Dixie Highway, when Deputy Pollacek informed me, he believed he saw the suspect at the intersection of 43<sup>rd</sup> Street and 25<sup>th</sup> Avenue.

I proceeded west and observed a black male matching the description provided by the complainant to Dispatch riding a bicycle carrying two cases of Bud Light. When the suspect, later identified as Makalex Sarette observed me heading in his direction in my marked patrol car, he threw the two cases of Bud Light, jumped off his bike and began running north on 25<sup>th</sup> Avenue. I exited my patrol car and observed Makalex proceed west through the yard of the residence located at, 4315 25<sup>th</sup> Avenue. After a short foot pursuit, I took Makalex into custody in the front yard of the residence located at, 4326 26<sup>th</sup> Avenue. I placed him in handcuff restraints, checked for proper fit and placed him in my patrol car.

I proceeded to Cumberland Farms and made contact with the complainant, Megan Thompson. I returned the two cases of Bud Light to Megan, and asked if Cumberland Farms would like to pursue charges, she advised they would. Megan informed me she did not have access to the cameras, but filmed him on her cell phone leaving without paying for the two cases of Bud Light. Megan showed me the video of Makalex departing the store carrying the two cases of Bud Light. Megan, also stated that she believes Makalex stole beer earlier in the evening, but would have to wait till the manager arrived to view the footage. I asked Megan when the manager would arrive, she informed me 0400 hours. I informed Megan that I will charge him with the current retail theft, and return when the manager arrives, if we can confirm a second retail theft, I will charge him with the other one.

I asked Megan to provide me a receipt for the two cases of Bud Light. The two cases are valued at \$41.98.

When I returned to my patrol car Makalex informed me he could provide a receipt for the beer. I asked where it was, he advised it was on his phone, which he did not possess. I informed Makalex that he did not purchase the beer because they never rang him up at the register. Makalex stated he was never at Cumberland Farms, and purchased the beer from the Quick Stop down the road. I informed Makalex he was lying, because I just watched the video of him departing Cumberland Farms with the two cases of Bud Light.

It should be noted Makalex was arrested at Walmart, located at 5555 20th Street, Vero Beach, Florida, on June 30, 2025, for grand theft, and is currently out on bond.

Makalex was transported to the County Jail without further issue.

This investigation was captured on my agency body worn camera.

This investigation is cleared with the arrest of Makalex for retail theft.
