PROBABLE CAUSE STATEMENT

On 9/11/2025 at approximately 1640 hours, officers with the Sebastian Police Department responded to 2001 US Highway 1 (Walmart) in reference to a shoplifting in progress. According to loss prevention associate Dawn Ethier, the males shoplifted approximately \$5,900 from the store on 9/6/2025. Ethier stated the males were concealing thousands of dollars worth of clothing items inside tote bins in shopping carts. All officers on scene were in marked Sebastian Police Patrol vehicles wearing Road Patrol uniforms.

Upon arrival, Sgt. Maison and Officer Irwin responded inside the store and attempted to apprehend one of the males. Sgt. Maison stated the one male (Later identified as Yasnier Castaneda) initially fled upon sight of him and Officer Irwin. Loss Prevention Associate Christopher Matson confirmed the male who fled was one of the suspects. Sgt. Maison was later able to apprehend Castaneda in the rear of the store.

While I was searching the area for the second male, I was given the description of a black male wearing a blue shirt. I observed a male matching the description (Identified as Heclian Rodriguez Felipe) exiting the garden center with Ethier behind him pointing at him. I activated my emergency equipment on my marked patrol vehicle with Felipe complying after I pointed to the front of my patrol vehicle. Felipe did not speak any English on seen but provided a photograph of his driver license. Using google translate, Felipe only was able to communicate that he took an uber to Wal-Mart, was from Miami but new friends in the area, and did not understand why he was being stopped. Felipe denied driving a vehicle to Wal-Mart. Both males were advised via google translate they were being detained pending an investigation. Shortly after, Sergeant Maison responded with Castaneda and both were sat down next to the front right tire of PD Vehicle 62. While the investigation was ongoing, a trespass warning was completed for both subjects.

Ethier provided the following statement of the incident on today's date: "I, APA Dawn Ethier, working Loss Prevention for the Sebastian Florida Wal-Mart store #1068. On this day 9-11-25 I was walking the front end when I came across this male with a generator and other numerous items in his cart. He was traveling back and forth looking suspicious. I contacted Matson to help keep surveillance. Once we had eyes on the first male (Heclian) he met up with the second male (Yasnier) who had a blue tote in a cart and filling it with reebok ladies' clothes, and health and beauty items. I then was able to identify that these were the same two males from 9-6-25 that pushed out the vacuums and totes full of merchandise. I notified Sebastian Police of these males and the days that they were in the Wal-Mart system from doing the exact same technique of taking items without attempting to pay. The amount that was recovered for the incident today from both males is \$3,923.87." The total amount of items recovered is 197.

Officer Martinez responded to the scene who is a Spanish Speaking Officer. Officer Martinez admonished both males separately of their rights in Spanish which they both stated to him they understood them. While Officer Martinez was attempting to speak with the males, the identity of Yasnier came into question. Yasnier originally provided a picture of a driver license for another unknown person as his form of identification. Officer Martinez spoke with Yasnier where he provided different birthdays. Yasnier willingly provided credit cards which provided his true name.

While the males were separated, I observed a vehicle key fob which appeared to be hidden and tucked underneath my front right tire. I motioned Yasnier who was seated next to the tire to stand up which he complied with. I then stated "Manos" which is the Spanish word for hands and took hold of Yasnier's hands with the help of Sergeant Maison. Yasnier immediately tensed his arms, successfully pulling the right arm forward, defeating our grasps while handcuffs were being applied. After a short struggle, Yasnier was able to be successfully detained. Officer Martinez subsequently detained Heclian.

The vehicle key was determined to belong to a 2025 Hyundai Sedan in the parking lot using the alarm function. In the rear seat in the back of the vehicle in plain view was countless items of merchandise still with tags fixed to them. Ethier responded to the parking lot and advised Vero Beach Wal-Mart had a shoplifting with these males earlier in the day with some of the suspected property being in the rear of the vehicle in sight (IRCSO Case 2025-97939). (The vehicle was towed to SPD Impound by Collision's Towing.)

According to documents prepared by Wal-Mart Loss Prevention, both Yasnier and Heclian are suspected of committing numerous shoplifting incidents throughout the State of Florida. Loss Prevention advised via documentation Yasnier is suspected in at least 41 shoplifting events throughout the State of Florida and Heclian is suspected in at least 16 shoplifting incidents throughout the State of Florida, with a combined total of \$78,873.22.

The following is the information from the incident on 9/6/2025 with the same subjects, (SPD Case 25-1652) "I, Dawn Ethier, working Loss Prevention for the Sebastian Florida Wal-Mart store #1068, I was notified by the front-end cashier that a male was walking back and forth the front end with two shark vacuums and a pot and pan set in a car. After reviewing video, it is seen that a male had selected numerous packs of meat, two shark vacuums and a pot and pan set. He then pushed out the grocery door passing all points of sale to a waiting u-haul. After going more into the video I found that there was a second male that also in the store at the same time and he selected a tote and filled it with mens polo shirts, and womens reebok shirts and watches The first male (Heclian Felipe) is seen pushing out a blue tote the first time and the cart with the vacuums the second time both times not attempting to pay for any of the items. The second male was seen retrieving the tote and doing most the selection of shirts and watches and pushes the tote out of the grocery door passing all points of

sale not attempting to pay for the waiting u-haul. These two males were identified by Sebastian Police Department as they were called for these two males in the store on 9-11-25 selecting clothing and concealing into a blue tote as they had done on this day 9-6-25. The amount for this incident is \$5954.88. Walmart seeks restitution." The following statement was confirmed via Wal-Mart Surveillance video.

Based on the facts and statements above and both males being positively identified by loss prevention from prior incidents and video footage, both males were determined to be working together and shoplifting in unison with each other. On today's date, the males endeavored to steal the items in the carts they abandoned inside the store and it was evident the intention was to steal them due to this being their method of theft based on past incidents. Both males were placed under arrest and charged with the following:

AB- "I don't need trees from you. I do not like u. U did me dirty and I am done with you I have been done like 8 months ago. I told u I would rather be alone and I meant it. U made me feel like shut and I don't even wanna talk because it just makes me remember what you did to me. So bye."

ROB- "I'm sorry"

ROB- "I still want to see you though."

AB- "No"

ROB- "Okay"

ROB- "If I give you \$500 could I eat you out one time?"

ROB- "Just between you me and you? Are your kids doing good and everything?"

AB- I am about to report you to the police you know it's illegal to offer money for sex right?"

ROB- "Damn okay my bad"

ROB- "ill leave you alone sorry"

After receiving the above text messages, AB contacted the Sheriff's Office for advice.

AB informed me that after Robert sent messages to her sister offering money for sexual acts, she looked Robert up and

AB sent me the above text exchange at 1336 hours. After reading and observing that Robert was leaving to go to Melbourne, I did not want to miss an opportunity for a controlled phone call, so I contacted AB and informed her I would be coming to her residence.

Prior to arriving at AB's residence, I contacted Detective York to get the conditions of Robert's sexual offender status. During our conversation I informed Detective York that Robert was utilizing unique telephone number (772) 303-4621. Detective York searched Robert in the sexual offender database and informed me that Robert had not registered that telephone number with the Florida Department of law Enforcement or the Indian River County Sheriff Office. Detective York asked me to confirm how long Robert had been utilizing unique telephone number (772) 303-4621, and informed me if it was longer than 48 hours, it was a violation of (F.S. 943.0435(4)(e)2,; 775.21(6)(g)5.b), a condition of his sexual offender status, and a felony.

I arrived at AB's residence to conduct a controlled phone call with Robert. I had AB call unique telephone number (772) 303-4621.

A male voice answered the phone. At the completion of the phone call, I asked AB who she was speaking with. AB informed me she was speaking with Robert. I asked how she knew it was Robert, and she informed me that it was his voice. I asked AB how she met Robert, and she informed me at Dom's.

After completing the controlled phone call with Robert, I asked AB to send me every text message in order that she had received from Robert. I wanted to confirm how long Robert had been utilizing unique telephone number (772) 303-4621.

I asked AB how long has Robert been utilizing unique telephone number (772) 303-4621, to contact her. AB advised that she recently had an issue with her phone, and can only remember the first conversation from unique telephone number (772) 303-4621, starting on September 4, 2025. AB stated that Robert had contacted her from different numbers in the past, and would try to locate that information for me.

Due to what AB was saying, it furthered my suspicion that Robert was utilizing a "text now app" to generate phone numbers to make contact with women to solicit them for sex, as he did AB and her sister. That way the phone number he was utilizing was not registered to him, and not registered with the Florida Department of law Enforcement or the Indian River County Sheriff Office in case of a complaint for his behavior.

I contacted Detective York and informed him of the conversation, and he asked if I had researched unique telephone number (772) 303-4621 to see if it was registered to Robert through a cell phone carrier. I informed Detective York that I did and unique telephone number (772) 303-4621 was not registered to Robert.

I informed Detective York that I believed it to be a "text now" number. Detective York utilized a Law Enforcement database and informed me it was a "text now" number. ROBERT- "I'm playing pool rn"

AB- "Okay what about later?"

After the completion of this investigation, I established that Robert had been utilizing a cell phone with the "text now" internet identifier, which produced unique telephone number (772) 303-4621, longer than 48 hours without reporting them, which is a violation of his conditions as a sexual offender.

Due to Robert telling AB that he was playing pool, I contacted K9 Deputy McKay, and asked him to check the parking lot of Uptown Speakeasy Pub & Package, located at 760 8th Court, #8, Vero Beach, Florida, for his white Toyota bearing Florida tag 30DZLJ.

K9 Deputy McKay contacted me and informed me Robert's vehicle was in the parking lot. I informed K9 Deputy McKay I was heading to his location.





NARRATIVE

On Thursday, September 11, 2025 at 1504 hours, I responded to [REDACTED] in reference to a disturbance.

The caller was identified as [REDACTED] advised public safety dispatch that [REDACTED] identified as Frank Brown put hands on [REDACTED]

On my arrival, Frank was in the driveway making spontaneous utterances that he didn't touch anyone and he kept repeating himself. In the garage I made contact with Dorothy Scott who I directed back into the residence to separate the parties. [REDACTED]

[REDACTED] Scott stated Brown was in Gifford all day and was intoxicated on both alcohol and drugs. [REDACTED] accused her of being unfaithful with him and went on to say she was "getting with his brother". Scott stated she [REDACTED] denied the argument ever got physical. I spoke to Scott's son identified as Delvin Cotton who explained to me that he was alerted to the argument by his younger sister DA. She knocked on the bathroom door yelling it's an emergency. He came to his mother's bedroom door where the arguing was and observed Brown holding Scott in a choke hold with her bent over by the doorway. Scott then spoke up again and said he wasn't choking her because she was lying on the bed. Cotton looked at his mother and then stated he didn't know what happened and walked away. I sensed the mother was trying to protect the step father so I asked to speak with the daughter [REDACTED] When I spoke to DA she stated she did see her mother being held in a choke hold by brown and was very scared which is why she alerted her older brother. Both Scott and Cotton also advised that Brown had made verbal threats to "knock her out" during the argument. No injuries were visible and Scott would not provide a written statement or advise if at anytime her airway was restricted due to her claims of the fight not being physical.

Based on witness statements, I found Brown in violation of FSS 784.03 battery and based on the [REDACTED] and relationship a No Bond enhancement was added for domestic violence.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On 09/11/2025 at 22:19 (Specifically include facts constituting cause for arrest.)

On 9/11/2025 at approximately 1640 hours, officers with the Sebastian Police Department responded to 2001 US Highway 1 (Walmart) in reference to a shoplifting in progress. According to loss prevention associate Dawn Ethier, the males shoplifted approximately \$5,900 from the store on 9/6/2025. Ethier stated the males were concealing thousands of dollars worth of clothing items inside tote bins in shopping carts. All officers on scene were in marked Sebastian Police Patrol vehicles wearing Road Patrol uniforms.

Upon arrival, Sgt. Maison and Officer Irwin responded inside the store and attempted to apprehend one of the males. Sgt. Maison stated the one male (Later identified as Yasnier Castaneda) initially fled upon sight of him and Officer Irwin. Loss Prevention Associate Christopher Matson confirmed the male who fled was one of the suspects. Sgt. Maison was later able to apprehend Castaneda in the rear of the store.

While I was searching the area for the second male, I was given the description of a black male wearing a blue shirt. I observed a male matching the description (Identified as Heclian Rodriguez Felipe) exiting the garden center with Ethier behind him pointing at him. I activated my emergency equipment on my marked patrol vehicle with Felipe complying after I pointed to the front of my patrol vehicle. Felipe did not speak any English on seen but provided a photograph of his driver license. Using google translate, Felipe only was able to communicate that he took an uber to Wal-Mart, was from Miami but new friends in the area, and did not understand why he was being stopped. Felipe denied driving a vehicle to Wal-Mart. Both males were advised via google translate they were being detained pending an investigation. Shortly after, Sergeant Maison responded with Castaneda and both were sat down next to the front right tire of PD Vehicle 62. While the investigation was ongoing, a trespass warning was completed for both subjects.

Ethier provided the following statement of the incident on today's date: "I, APA Dawn Ethier, working Loss Prevention for the Sebastian Florida Wal-Mart store #1068. On this day 9-11-25 I was walking the front end when I came across this male with a generator and other numerous items in his cart. He was traveling back and forth looking suspicious. I contacted Matson to help keep surveillance. Once we had eyes on the first male (Heclian) he met up with the second male (Yasnier) who had a blue tote in a cart and filling it with reebok ladies' clothes, and health and beauty items. I then was able to identify that these were the same two males from 9-6-25 that pushed out the vacuums and totes full of merchandise. I notified Sebastian Police of these males and the days that they were in the Wal-Mart system from doing the exact same technique of taking items without attempting to pay. The amount that was recovered for the incident today from both males is \$3,923.87." The total amount of items recovered is 197.

Officer Martinez responded to the scene who is a Spanish Speaking Officer. Officer Martinez admonished both males separately of their rights in Spanish which they both stated to him they understood them. While Officer Martinez was attempting to speak with the males, the identity of Yasnier came into question. Yasnier originally provided a picture of a driver license for another unknown person as his form of identification. Officer Martinez spoke with Yasnier where he provided different birthdays. Yasnier willingly provided credit cards which provided his true name.

While the males were separated, I observed a vehicle key fob which appeared to be hidden and tucked underneath my front right tire. I motioned Yasnier who was seated next to the tire to stand up which he complied with. I then stated "Manos" which is the Spanish word for hands and took hold of Yasnier's hands with the help of Sergeant Maison. Yasnier immediately tensed his arms, successfully pulling the right arm forward, defeating our grasps while handcuffs were being applied. After a short struggle, Yasnier was able to be successfully detained. Officer Martinez subsequently detained Heclian.

The vehicle key was determined to belong to a 2025 Hyundai Sedan in the parking lot using the alarm function. In the rear seat in the back of the vehicle in plain view was countless items of merchandise still with tags fixed to them. Ethier responded to the parking lot and advised Vero Beach Wal-Mart had a shoplifting with these males earlier in the day with some of the suspected property being in the rear of the vehicle in sight (IRCSO Case 2025-97939). (The vehicle was towed to SPD Impound by Collision's Towing.)

According to documents prepared by Wal-Mart Loss Prevention, both Yasnier and Heclian are suspected of committing numerous shoplifting incidents throughout the State of Florida. Loss Prevention advised via documentation Yasnier is suspected in at least 41 shoplifting events throughout the State of Florida and Heclian is suspected in at least 16 shoplifting incidents throughout the State of Florida, with a combined total of \$78,873.22.

The following is the information from the incident on 9/6/2025 with the same subjects, (SPD Case 25-1652) "I, Dawn Ethier, working Loss Prevention for the Sebastian Florida Wal-Mart store #1068, I was notified by the front-end cashier that a male was walking back and forth the front end with two shark vacuums and a pot and pan set in a car. After reviewing video, it is seen that a male had selected numerous packs of meat, two shark vacuums and a pot and pan set. He then pushed out the grocery door passing all points of sale to a waiting u-haul. After going more into the video I found that there was a second male that also in the store at the same time and he selected a tote and filled it with mens polo shirts, and womens reebok shirts and watches The first male (Heclian Felipe) is seen pushing out a blue tote the first time and the cart with the vacuums the second time both times not attempting to pay for any of the items. The second male was seen retrieving the tote and doing most the selection of shirts and watches and pushes the tote out of the grocery door passing all points of

sale not attempting to pay for the waiting u-haul. These two males were identified by Sebastian Police Department as they were called for these two males in the store on 9-11-25 selecting clothing and concealing into a blue tote as they had done on this day 9-6-25. The amount for this incident is \$5954.88. Walmart seeks restitution." The following statement was confirmed via Wal-Mart Surveillance video.

Based on the facts and statements above and both males being positively identified by loss prevention from prior incidents and video footage, both males were determined to be working together and shoplifting in unison with each other. On today's date, the males endeavored to steal the items in the carts they abandoned inside the store and it was evident the intention was to steal them due to this being their method of theft based on past incidents. Both males were placed under arrest and charged with the following:
