## NARRATIVE

On July 16th, 2025, at approximately 1301 hours reference to Jessica Dollins who had an active warrant related to court case number 31-2025-WF-003362-A. observed Dollins exit the residence and enter her Red Mazda 3 bearing Florida tag BH97UB. Based on this observation conducted a traffic stop at the 1800 block of 7th Avenue.

I made contact with the driver, who was Jessica Dollins and placed her into custody. When I questioned Dollins if she had any illegal narcotics, Dollins stated that narcotics were concealed in her clothing near her breast. I read Miranda warnings to Dollins and she confirmed understanding. Dollins subsequently invoked her rights and did not speak with law enforcement.

Sergeant J. Fricke responded to the scene and conducted a search of Dollins' person. During the search Sergeant Fricke located the following items: A clear plastic bag containing a white rock substance near Dollins right breast. A clear plastic bag containing a white rock substance and a clear glass pipe with a burnt residue near Dollins left breast. Based on my training and job experience I suspected the substance to be crack rock cocaine and the glass pipe is commonly used for smoking crack cocaine.

used an agency field-test kit to test the suspected cocaine. The results showed a positive results for the presence of cocaine. The total weight of the cocaine is 8.68 grams.

Based on the above information, I established probable cause for the following:

-FSS 893.13, possession of a controlled substance (cocaine)

-FSS 893.147, possession of drug paraphernalia.

Dollins was transported to the Indian River County Jail without incident.

## NARRATIVE

On Thursday, July 17th, 2025 at 0009 hours, I was traveling Southbound on 20th Avenue Southwest when I observed a white Chevrolet pickup bearing Florida tag# 49AJMH without an operable tag light. I activated my emerency lights and conducted a traffic stop on the vehicle at the 1600 block of 20th Avenue Southwest.

Upon approach of the vehicle, I made contact with the driver and sole occupant, identified as Michael Taylor. Taylor stated he had been previously pulled over for the tag light violation. It should be noted that when I asked Taylor if there was anything illegal in the vehicle he asked if he could just go home. I then asked Taylor again if there anything illegal in the car, in which he took a deep breath and openly stated he had crack cocaine in the vehicle. Taylor advised he was sitting on the crack cocaine, which was wrapped around a brown piece of paper.

When another unit arrived on scene, Taylor was asked to step out of the vehicle and was placed in handcuffs.

I then conducted a search of the vehicle, in which I located the wrapped around brown piece of paper. The wrapped brown piece of paper contained a white rock like substance, which I identified as crack cocaine through previous training and experience. Corporal Thomas then tested the crack cocaine using an agency issued field test kit, which positively resulted for the presence of cocaine.

I then made contact with Taylor and advised him of his Miranda warnings, in which he acknowledged and continued to speak with me. Post Miranda, Taylor stated he has been using crack cocaine for twenty years. Taylor identified the white rock like substance as cocaine. Taylor stated he gets the crack cocaine from Gifford.

Due to the above mentioned, I criminally charged Taylor with the following charges:

F.S.S 893.13 Possession of Controlled Substance (Crack Cocaine)

Taylor was then transported to the Indian River County Jail without further incident.

Once at the jail, the crack cocaine was weighed approximately 0.59 grams.
