NARRATIVE

On Tuesday, March 18, 2025 at 0836 hours, I responded to the 1400 block of S US Highway 1 in reference to a crash with unknown injuries.

On arrival, I identified Lennox Davian Baker as the driver of a 2013 Silver Hyundai Genesis Bearing FL Temporary Tag DUN2709. Lennox was unable to provide a driver's license and when asked where it was he stated he did not have one. A search through David revealed a revocation effective 04/04/2017 and numerous financial suspensions dating back to 12/19/2016 all of which still require action. Lennox advised he was aware he did not have a drivers license however was only going to the store to get baby formula.

Lennox did not reside within Indian River County and did not qualify for a notice to appear. Lennox was placed under arrest for violation of FSS 322.34 driving on a suspended/revoked license with knowledge. Lennox was issued criminal uniform traffic citation AJ5T25E.

Lennox was transported to the Indian River County Jail after medical clearance without issue.




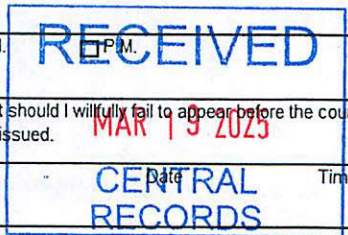
