**NARRATIVE**

On Wednesday, April 22, 2026, at approximately 0456 hours, I performed a traffic stop on a vehicle at 915 S US Highway 1 in Vero Beach, FL.

I was conducting stationary traffic enforcement while parked in the 700 block of S US Highway 1, when I observed a vehicle traveling southbound at a high rate of speed. I estimated the vehicle to be driving at approximately 65 mph in a 45 mph zone. I activated my patrol vehicle-mounted rearward-facing Stalker DSR 2x radar antenna. The digital readout indicated the vehicle was traveling at 66 mph, which was corroborated with an audio doppler tone.

Once the white, Toyota coupe bearing FL tag QUVE06, passed to the south of me, I pulled out behind it to affect a traffic stop. The vehicle turned west on Oslo Road and then south behind the Walgreens at 915 S US Highway 1, before turning and parking in a parking space.

I made contact with the driver and sole occupant, William Bradley Dougall DOB 12/15/2002. He stated he was traveling from his home in Vero Beach to his job at Maverick Boats in Fort Pierce. Dougall provided me his vehicle registration, which indicated the registered owner to be his mother, Bevohn Dougall. Dougall stated he did not know where his proof of insurance was. He additionally stated he didn't have his license with him. I asked why he didn't have his FL driver's license with him, to which he responded by stating that his license was suspended. Dougall stated he knew his license had been suspended for several weeks, but that he had to get to work.

I queried Dougall's information through Indian River County Public Safety Dispatch. They did confirm that his license was suspended. When I searched Dougall's driver history through the FL Driver and Vehicle Information Database (DAVID), I discovered his license had been suspended since 05/29/2024. Dougall had one previous guilty disposition for Driving while license suspended/cancelled/revoked, five guilty dispositions for speeding since June of 2022, one failure to pay traffic fine, and three failure to appear on traffic summons.

Based on the aforementioned information, I had probable cause to place William Dougall under arrest. He was transported to the Indian River County Jail and charged with the following:

1 Count – F.S.S. 322.34(2)(A), Knowingly Driving while License Suspended/Revoked - UTC# AKFR6PE, Bond- \$150.
