NARRATIVE

On April 17th, 2024 at approximately 1924 hours, I arrived at [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with Alicia K. Hargraves, Calvin L. Arduini, and Melissa Sue Arduini. I first interviewed Hargraves, she informed me that she arrived at [REDACTED] to pick up her grandchild as part of a custody-sharing agreement between Arduini and Hargraves' daughter. She stated that when she arrived at the door, Arduini refused to let her take her grandchild with her and pushed her back several times out of the doorway. She stated she then walked to [REDACTED] where she called for law enforcement and waited until our arrival. She would later state that Calvin Arduini threw liquid bleach from a bottle at her after he pushed her after being questioned on why bleach was on Melissa Arduini's car. She would also later state that Arduini pushed her to the ground when interviewed again.

I then made contact with Alicia N. Goodnight, who resides at [REDACTED] and stated she was a friend of Hargraves. She stated that while she sat on her porch, she rounded the corner of her residence after hearing a commotion and saw Calvin Arduini push Hargraves several times from the doorway before Hargraves came over to her residence.

I then interviewed Calvin Arduini. He stated that when Hargraves arrived at his front door, she attempted to pull upon the front door to get past him into the residence. He did not want to allow her into the residence and struggled with Hargraves to close the door. He stated he did not touch her besides her grabbing his wrist at one point to remove it from the door handle. He then said that he managed to shut the door, at which point he saw Hargraves take a bottle of bleach from the front porch of his residence and begin pouring it over Melissa Arduini's car parked in the driveway [REDACTED]. He then showed me a video of the incident he stated he recorded on his cell phone through his front window. It showed the silhouette of a white female in dark clothing with purple-colored hair that matched the appearance of Hargraves at the scene. She poured liquid from a white container onto the car, and splashing sounds could be heard in the video. After Arduini walks outside with the camera, the video shows Hargraves clearly walking away from the direction of Arduini's driveway with no one else in the immediate area. The bleach container on the porch of the residence was white as well.

After reviewing the video and statements made by those at the scene, I took Hargraves into custody for Criminal Mischief for approximately \$3,000 in damage to her primary means of transportation. She was transported to the Indian River County Jail without incident.

NARRATIVE

On 04/17/2024 at approximately 0750 hours, I responded to [redacted] in reference to a disturbance.

Upon arrival, I made contact with Melvin Stamps (victim). Melvin advised while hanging out in his residence earlier today he woke his buddy up, later identified as Glenn Brown (suspect), from his sleep. Melvin stated Glenn became angry at him and began to accuse him of stealing his pistol.

A verbal argument ensued, Glenn grabbed a knife and threatened Melvin to cut him if he didn't return his property. Melvin was in fear and felt as if he was not free to leave the residence. Melvin eventually managed to get out of the residence and while in the process Glenn managed to cut his right wrist with the knife, Glenn continued to pursue Melvin and threw a brick at him causing an abrasion to his right ankle and swelling.

As soon as Glenn heard someone was calling law enforcement, he fled from the scene. Myself and responding backup units canvassed the area for Glenn Brown. Several witnesses on scene confirmed Glenn's description and identity, they advised he was wearing no shirt and blue jeans however they refused to cooperate as named witnesses in this case.

Melvin refused medical treatment on scene, and at first, was hesitant to prosecute however he changed his mind after noticing the injuries he had. I cleared the scene and continued to search the area for Glenn Brown however was unsuccessful in making contact with him.

At approximately 1550 hours, I responded back out to [redacted] in reference to searching for Glenn at the residence as deputies in the area were provided intel that Glenn possibly returned to the property.

Prior to entering the property, we had permission from the property owner to enter the residence, I observed Glenn enter one of the rooms in the home. Glenn was instructed to step out of the room and he complied, I placed Glenn under arrest for Aggravated battery with a deadly weapon and read him his Miranda rights which he waived and advised he understood.

Glenn admitted to throwing the brick at Melvin Stamps, however, he advised it did not strike him. Glenn denied all further allegations of him threatening Melvin with a knife and cutting him. He advised he went over earlier in the day to hang out with friends who lived there. He stated he was upset with Melvin because he feels like they have been acting "weird" with him ever since his cousin went missing.

Based on the totality of the circumstances, I had probable cause to believe Glenn battered Melvin with a deadly weapon and he was subsequently placed under arrest for the aforementioned charges and transported to the Indian River County Jail without further incident.

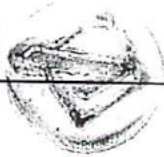

NARRATIVE

On Wednesday, April 17th, 2024 at 0508 hours I responded to State Road 60 and mile marker 18 in reference to a suspicious person. Prior to arrival, Public Safety Dispatch advised that a white male was seen running into the roadway, almost causing collisions with vehicles passing by.

Upon arrival, I observed the aforementioned male subject running across the roadway. I made contact with the male subject, who was identified as Garren Blier. Blier stated he was stopped on the roadway because his vehicle broke down. Blier stated he was approached by four black male subjects wearing all-black clothing and was assaulted. Blier continued to state the aforementioned male subjects were inside his vehicle, armed with handguns. Blier also stated there were bullet holes on the backside of his vehicle. After further observation, the aforementioned black male subjects were not located and there were no bullet holes observed on the backside of the vehicle.

Throughout my interaction with Blier, I observed him display symptoms of being under the influence of narcotics due to his excited behavior, mannerisms, and deranged statements. Blier also displayed symptoms of hallucination. I then asked Blier if he would consent to a pat down of his person which he granted. Throughout the patdown, a glass pipe with burnt residue was observed in plain view inside his jacket. Due to previous training and experience, I identified the pipe to be utilized for the use of narcotics.

Due to the previously mentioned, Blier was placed in handcuffs and in the back of my marked patrol vehicle.

Through a search incident to arrest, I located an atenolol pill bottle that contained several different colored pills within. I conducted a query of the aforementioned pills through drugs.com which informed me the pills within were identified as Xanax and Amphetamine/Dextroamphetamine. Xanax is classified as a Schedule IV controlled substance according to the Controlled Substance Act and can only be obtained through a prescription. Amphetamine/Dextroamphetamine is classified as a Schedule II controlled substance according to the Controlled Substance Act and can only be obtained through a prescription.

I then advised Blier of his Miranda warnings, which he acknowledged and continued to speak with me. Post Miranda, Blier stated the aforementioned glass pipe was not his and found it on the roadway. Blier continued to state the pills were not his and that they belonged to his mother. Blier declined to speak further.

Due to the above-mentioned, I criminally charged Blier with the following charges:

F.S.S 893.13(6)(a) Possession of Controlled Substance without prescription

F.S.S 893.147.1 Possession of drug paraphernalia

Blier was transported to the Indian River County Jail without further incident.

NARRATIVE

On 04/17/2024, at approximately 1929 hours, I responded to the intersection of 11th Street and 7th Court, due to subjects sitting along the roadway throwing trash on the ground.

Upon my arrival, I made contact with Michael Connors and Troy Scott who were both sitting on the ground. While speaking to Connors, I observed an open plastic Vodka bottle laying next to him. At the time, both subjects agreed to leave the area. While trying to stand up, I noticed that Scott was unable to maintain his balance and fell onto the ground, several times. I was then informed by Connors, that Scott has been heavily drinking all day.

While Connors assisted Scott off of the ground onto his feet, Scott became upset and started to walking away towards 11th Street in the middle of the roadway. To prevent Scott from being struck by a vehicle that was traveling southbound on 11th Street, I gave him numerous verbal commands to stop walking, but he refused. When I attempted to grab along his right elbow, he started yelling at me and pulled his arm away from me. Scott was then escorted onto the ground, once on the ground, Scott placed his left arm underneath his stomach, as an attempt to defeat my action's in grabbing his wrist. After having assistance from Deputy Mangel, I was able to place Scott into handcuffs.

At the time, I advised to Scott that I made contact with Indian River Fire Rescue, to come on scene and transport him to the hospital to treatment, Scott became upset, yelling and kicking trying to strike Deputy Mangel and myself. Due to Scott's erratic behavior, I noticed several patrons and employees of 1110 U.S. Highway 1 (Popeyes) and 1070 U.S. Highway 1 (Taco Bell), that were in the parking lot watching Scott's disruptive behavior.

After Deputy Hatton arrived on Scene, I placed Scott into his patrol vehicle, were he immediately started kicking the rear driver side window. Scott had to be placed into a hobble device, to prevent him from damaging Deputy Hatton's vehicle.

When Scott arrived at the Indian River County Jail for processing, he continued to be combative and had to be placed into a restraint chair.

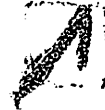



Upon arrival I made contact with Officer Chimenti and Officer Otis, who had Ian Anderson detained. Officer Otis observed Ian traveling south on 14th ave by the coffee shop located on 2001 14th ave (Coffee House 1420). Ian had a pretrial release conditions set on 03/25/2024, to not return to or within 500 feet of Seahorse Lane Boutique (1981 14th ave), in reference to case #2024 MM000401. On scene I made contact with Cpl. J. Brumley (#415). Cpl. J. Brumley advised me that a physical altercation had occurred between Brandi Smith (DOB: 4/1/1984) and Ricky A. Warner Jr (DOB: 10/8/1986). Cpl. J. Brumley further advised me that Ofc. Willis (#467) was at 40th Ave and 20th St. with Warner who he had detained.

Cpl. J. Brumley then briefed me regarding the incident. She explained Smith and Warner had been in an argument due to Warner wanting to go back to New York. She advised Smith stated Warner began calling her names and becoming angrier. Cpl. J. Brumley explained Smith stated that Warner then went into the bedroom she was in and grabbed her by the feet and pulled her off the bed. She further explained that Smith stated when on the ground Warner grabbed her by the hair and took her into the living room where he slammed her on the ground and started beating on her. She advised Smith stated that she was able to get back up and walk to the room where she attempted to make a phone call. Cpl. J. Brumley explained that Smith said when attempting to make a phone call, Warner grabbed the phone and smashed it on the ground. She further explained that Smith advised she attempted to walk out the front door but Warner slammed the door and was unable to leave. Cpl. J. Brumley advised Smith said that Warner then commanded her to go to the neighbor's house and get their daughter to take him to the airport. Cpl. J. Brumley stated Smith had injuries that were consistent with her statements.

Cpl. J. Brumley explained that Ofc. Bannister (#449) then made contact with Warner. Ofc. Bannister then Read Warner his Miranda Rights which he acknowledged and wished to speak. Cpl. J. Brumley advised me that Warner stated he did not put his hands on Smith and just wanted to leave the house. Cpl. J. Brumley further advised that Ofc.
