NARRATIVE

On the morning of 09/05/25, I responded to 4055 41st Avenue (Indian River County Jail) in reference to a disturbance. Upon my arrival I made contact with the victim Corrections Deputy Brian Givens. Deputy Givens stated that the defendant Londyn Capelton was [REDACTED] and causing a loud disturbance. It was decided by jail medical staff that the defendant would be given [REDACTED] Deputy Givens and several other Corrections Deputies entered the cell to restrain the defendant so medical staff could [REDACTED] During this process, Deputy Givens was restraining the defendant's feet to prevent her from kicking. The defendant was able to move enough to face in Deputy Givens' direction and spit. Deputy Givens stated the defendant's bodily fluid struck him in the face, chest, and upper legs.

The defendant's actions were witnessed by several other Corrections Deputies and was captured by the recording security camera in the jail.



On Friday September 5, 2025, while traveling west on CR 512 as I was in the turn lane for Publix (1451 CR 512), I observed a white Dodge Dakota (FL tag FJAB06) pass me traveling east. I observed the driver's window to be down and the driver to be Thomas Clauss. The truck was towing a black box trailer with the lettering "TNT" on the side in gray. The tag on the trailer was (FL tag Z854ZA).

I was advised prior to observing Thomas, that he had an active warrant out of Indian River County for battery and a burglary (# 2025-999). I was also aware that Thomas did not have a valid license, he only had an ID card in Florida.

I conducted a traffic stop on the truck and trailer in the 100 block of Bellamy Trail. I made contact with Thomas, who was asked to step out of the vehicle and began to try and utilize his phone. I then opened the locked driver's door of the inside and took control of his left arm removing him from the truck. Thomas was placed into handcuffs, which were double locked and check for fit. I walked him to the front of my patrol vehicle, where he was advised that he had a warrant for battery and he did not have a license. Thomas advised he didn't want to talk. He then became combative and tried to dictate the direction of the stop, at which time he was placed into the rear of my patrol unit 70.

NARRATIVE

On September 5th, 2025, at approximately 1108 hours, I responded to 754 U.S. Highway 1 South (McDonald's) in reference to assisting Sergeant D. Rodriguez with a possibly impaired driver.

Upon arrival, Sgt. Rodriguez explained the following to me: Civilian Traffic Assistant (CTA) C. Huskins. CTA Huskins was at McDonald's and walked past parked a black in color Ford sport utility vehicle (FL tag HGXP41) and observed a driver passed out behind the wheel. The vehicle was running. Huskins attempted to wake the driver for a welfare check and observed an alcoholic beverage in the center console. Huskins requested road patrol to respond, to which Sgt. Rodriguez did. Sgt. Rodriguez arrived on scene and parked just adjacent to the vehicle and explained to me he observed the vehicle was running and keys were in the ignition. He observed the alcoholic beverages and the driver passed out. Sgt. Rodriguez then positioned his marked patrol car behind the vehicle with its emergency lights activated. Sgt. Rodriguez then banged on the driver's window hard and identified himself as law enforcement and the driver began to wake slowly. The driver then woke, refused to exit the vehicle and gave the middle finger to Sgt. Rodriguez. The driver then put his foot on the brake and attempted to shift the vehicle, suggesting that he was attempting to leave. Sgt. Rodriguez immediately returned to his patrol vehicle and used his patrol car bumper to make contact with the rear bumper of the vehicle to prevent the driver from leaving. Sgt. Rodriguez then pointed his issued agency firearm at the driver and gave him commands to exit, to which he did. The driver was detained in handcuffs.

It should be noted that Sgt. Rodriguez was identified by his issued Sheriff's Office Class C uniform with five point star type Agency badge and was carrying out his official duties. Sgt. Rodriguez then turned over the investigation to me. The driver was identified as Lyle Fidgeon by his Florida driver's license which was retrieved from the vehicle by CTA Huskins.

As I interacted with Fidgeon, I observed several physical signs of impairment: he spoke with slurred speech and I detected the odor of an alcoholic beverage emanating from his breath as he spoke to me. I became concerned Fidgeon was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances. I observed an alcoholic beverage container in the center console labeled "Redd's Wicked Apple / 8% Alcohol / Vol". Fidgeon stated he was just going to McDonald's to get lunch.

To dispel my concerns, I asked Fidgeon if he would participate in a series of standardized field sobriety exercises, to which he refused. I advised Fidgeon that if he refused to participate in field sobriety exercises, I would have to base my investigation solely upon my observations and that there could be possible adverse consequences – towing fees, criminal charges, court fees, etc. This is known as a "Taylor" warning. Fidgeon then refused once again.

Based upon my investigation, probable cause exists that on September 5th, 2025, Lyle Fidgeon was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance and was impaired beyond his normal faculties, incapable of operating a vehicle safely. Fidgeon was arrested for DUI at 1126 hours and was advised of the charge.

A post arrest search of Fidgeon's vehicle revealed two more Redd's Apple beverages and three "Twisted Tea" alcoholic beverages. These were located in the front passenger area. A crumpled Busch beer can was located in the rear passenger

I responded to a disturbance at 3341 Bridge Plaza Drive (Riverside Cafe) in reference to an intoxicated Hispanic male refusing to leave the establishment upon security's request.

As I approached the aforementioned establishment, I observed a heavy set Hispanic male lying on his back in the parking lot/entrance of Riverside Cafe. The security advised they escorted the male out of the bar due to his intoxication and requested him to leave but the male refused. The security guard stated he wanted a trespass warning to be issued to the male.

In speaking with the intoxicated male, I noticed his speech was slurred and noted a strong odor of an alcoholic beverage emanating from his person. The male was advised that he was trespassed from the property as requested by the security and requested him multiple times to identify himself. He was uncooperative when requesting his identification, stating he did not have to identify himself. The male also stated he would walk home, however he made no attempt to leave.




It should be noted that the male was asked if he needed medical attention but refused.

Based on the foregoing, we attempted to place the male in handcuffs while he sat on the ground. In grabbing his arms to place them behind his back, he tensed his arms which were in front of him, in a way to make the handcuffing more difficult. The male refused to obey lawful verbal commands when telling him to place his hands behind his back. At that time, we guided the male onto his stomach, gaining control of his arms, and placing him in handcuffs without further incident.

The male's Florida drivers license was later located inside of his wallet and was identified as Francisco Cruz Maximo (H/M DOB: 02/04/1979). Maximo was transported to the Indian River County Jail for booking and processing and to be held on a \$1,500.00 bond.

 On **09/06/2025**, at **02:34** (Specifically include facts constituting cause for arrest.)

I conducted a welfare check on a black Toyota Corolla (FL tag # IMWG31) at the base of the Merrill Barber Bridge (westbound). Prior to activating my patrol lights, I observed the black Toyota parked with it's blinker on. The vehicle was stationary, blocking the bicycle lane.

After parking behind the vehicle and activating my patrol lights, I approached the vehicle on foot, from the driver side. At that time, I made contact with a male driver and sole occupant of the vehicle. The driver stated he parked at the base of the bridge to send a text message. The driver stated he did not need medical assistance and was not having car trouble however; as I interacted with the driver, I noticed signs of impairment. The driver displayed droopy tired eyes, slightly red and watery eyes, mumbled speech, and noted a moderate odor of an alcoholic beverage emanating from his person. The driver/defendant was later identified through his Florida license as Kerby Normil (B/M DOB: 12/03/1995).

The defendant stated he had just left Riverside Cafe (3341 Bridge Plaza Drive) and stated he had consumed some alcoholic beverages during the night. The defendant stated he was heading home but later stated he was actually on his way to his friends house.

Based on these observations and statements, I informed the Defendant I had a concern that he might be impaired and that I would be conducting Standard Field Sobriety Exercises. The defendant agreed and exited the vehicle upon my request. I asked the Defendant if he had any disabilities or pain to which he stated he did not have any pain at that time. The defendant also denied taking any prescribed medication.

I then began the Standard Field Sobriety Exercises. Each exercise was demonstrated and explained to the Defendant prior to having him perform them and he stated that he understood them. The Defendant was given the option to keep his shoes on or remove them for the exercises. The Defendant kept his shoes on.

The results of the field sobriety exercises are as follows:

HGN (Horizontal Gaze Nystagmus)

- Equal tracking and pupil size (Both eyes);
- Lack of smooth pursuit (Both eyes);
- Distinct and sustained nystagmus at maximum deviation (Both eyes);
- Onset of nystagmus prior to 45 degrees (Both eyes)
- Slight head movement when performing exercise
- Slight front to back swaying



WALK AND TURN

- Did not touch heel-to-toe on all initial steps
- Improper turn ; other than instructed
- Did not touch heel-to-toe on most returning steps
- Imbalance during the exercise
- Used arms for balance
- Incorrect number of steps
- Stepped off line

ONE LEG STAND (Left Leg)

- Used arms for balance
- Put foot down
- Did not count at the beginning of exercise
- Improper counting
- Hopping

FINGER TO NOSE

- Hesitated
- Missed tip of nose
- Not fingertip

On 09/06/2025 at 08:29 (Specifically include facts constituting cause for arrest.)

On Saturday September 6, 2025 I responded to the area of 690 Fleming Street in reference to a vehicle crash.

Upon arrival, I found a two-vehicle crash with one of the vehicles being parked. Several other officers with the Sebastian Police department were on scene performing a crash investigation. Upon the completion of the crash investigation by Officer Didier, myself and Officer Brandes advised the driver, Andres Santillan-Rincon, that we will be starting a DUI investigation.

Officer Brandes read Mr. Santillan-Rincon his Miranda warnings, which he stated that he understood and was willing to talk to officers. Officer Brandes asked Mr. Santillan-Rincon when he last ingested anything to which he responded his last meal was around 2200 hours and he consumed an alcoholic beverage at around 0400 hours. He was asked about physical limitations and any medical problems that may interfere with the DUI investigation to which he denied.

Officer Brandes asked Mr. Santillan-Rincon to stand with his feet together and his arms down to his side. Mr. Santillan-Rincon eyes were watery and glassy. I observed his eyes, which both eyes had lack of smooth pursuit in them. I also observed distinct nystagmus prior to 45 degrees in both eyes, which was sustained at maximum deviation. Mr. Santillan-Rincon had issues following the stimulus and was told several times not to move his head. During this exercise Mr. Santillan-Rincon had a front to back sway in the beginning and then transitions to a circular motion. Mr. Santillan-Rincon was also observed to have very distinct vertical Nystagmus.

Officer Brandes then transitioned to the walk and turn exercise. Officer Brandes explained the starting position and had Mr. Santillan-Rincon get into it after being asked if he was able to, which he replied yes. Mr. Santillan-Rincon got into the starting position but then stepped off over three times during the explanation phase. Mr. Santillan-Rincon began the exercise missing steps 2 and 5 on the first nine steps did an incorrect turn and missed several more steps on the returning nine steps. Mr. Santillan-Rincon further used his arms for balance.

The next exercise Officer Brandes asked Mr. Santillan-Rincon to perform was the one leg stand. Officer Brandes asked him to stand with his feet together and his arms down at his side until he finished explaining the entire exercise to him. Mr. Santillan-Rincon got into the starting position. Officer Brandes then explained the exercise and demonstrated it to him. Mr. Santillan-Rincon then began the exercise using his arms for balance, further placing his foot down at count 15. He also got to count 20 in a total of thirty seconds.



Officer Brandes then asked Mr. Santillan-Rincon to perform the finger to nose exercise, Officer Brandes explained and demonstrated the proper tip of the finger to the tip of the nose technique. Mr. Santillan-Rincon advised that he understood the explanation of the exercise and the correct understanding of tip to tip. Mr. Santillan-Rincon missed all explained finger to nose touches and further needed to be reminded to return his fingers and hands to the starting positions several times.

During the DUI investigation and after Miranda Warning, Mr. Santillan-Rincon admitted to being at a friend's house for a party prior to the crash. Mr. Santillan-Rincon admitted to drinking several alcoholic drinks including rum mixed with coke and white claws. Mr. Santillan-Rincon also admitted to driving but does not remember the events just prior to impact.

Mr. Santillan-Rincon was then placed under arrest for the suspicion of driving under the influence of alcohol. Mr. Santillan-Rincon was then transported to Indian River County Jail without incident. At the Indian River County Jail Mr. Santillan-Rincon refused to submit to the breath test.



NARRATIVE

On Saturday, September 6, 2025, at approximately 1812 hours, I responded to the area of 49th Street and 58th Avenue in reference to an auto accident with unknown injuries.

While en route the caller advised dispatch that the vehicle was leaving the scene of the crash traveling northbound on 58th Avenue. The caller stated a street sign was damaged in the crash and that the suspect vehicle had front end damage from the crash. The suspect vehicle was described as a silver Chevrolet 4 door. As I was approaching the intersection of 57th Street and 58th Avenue traveling southbound, I observed a silver Chevrolet Impala traveling northbound with front end damage and two flat front tires. I conducted a U-turn and the Impala pulled off the roadway in the 5800 block of 58th Avenue. The vehicle was a Chevrolet Impala bearing Florida tag DL20QX and was registered to Michael Marrero.

I made contact with the driver and sole occupant of the vehicle. The driver identified himself as Michael Marrero which was confirmed via FCIC/NCIC. I asked Marrero what happened to his car and he stated he hit something and was trying to get home. Marrero stated he did not recall how the crash happened but that he knew he was involved in a crash. Marrero attempted to blame the crash on [REDACTED]. EMS responded to the scene and [REDACTED] on Marrero. EMS advised that Marrero's [REDACTED] was within the normal range and should not have been a factor in his driving.

Contact was made with the witness Desiree Samuels-Schulz via phone. I was advised Marrero was all over the roadway which caught Schulz attention in the 2600 block of 58th Avenue. Schulz stated Marrero continued northbound and crossed the center line into oncoming traffic multiple times. As Marrero's vehicle approached 49th Street, Schulz observed the vehicle cross the center line, jump the median, strike a street sign, and go into oncoming traffic prior to pulling back onto the median. Schulz approached Marrero and asked him if he was okay. Marrero advised that he was okay. Schulz returned to her vehicle and [REDACTED]. While [REDACTED] Schulz observed Marrero drive off of the median and flee the scene northbound on 58th Avenue.

Through my investigation I found probable cause for the arrest of Marrero for leaving the scene of a crash with property damage and reckless driving. Based on the witness statements, Marrero's statements, and the obvious damage to the front of Marrero's vehicle, I determined that Marrero had knowledge of the crash and left the scene without reporting the crash. I also determined that Marrero was driving with a willful and wanton disregard for the safety of the public and property. Prior to the crash, Marrero crossed over the center line multiple times into oncoming traffic which was observed by the witness. Additionally, I observed Marrero operating his vehicle on a public roadway with two deflated front tires one of which the tire was completely shredded and the rim was contacting the roadway. Due to the condition of Marrero's vehicle, he would have been unable to control his vehicle in a safe manner due to little to no traction on his front tires.





NARRATIVE

On 09/06/2025 at approximately 1803 hours, I, Deputy M. Mangel #5949, was dispatched to 9475 85th Street, Indian River County, FL in reference to an ATV call for service.

While speaking with the complainants regarding the ATV issue, I observed a black truck traveling westbound on 85th Street at a high rate of speed, well above the posted 35 mph speed limit. The vehicle, identified as a 2017 black Dodge Ram (FL tag 72EXAV), failed to stop at the posted stop sign at 94th Avenue and 85th Street. The complainants on scene also commented on the excessive speed and noted that the driver had "blown through" the stop sign.

I entered the roadway and gave the universal hand signal to stop (raising my hand, palm forward). The driver was slow to react and nearly struck me before eventually bringing the truck to a stop.

I made contact with the driver, who was later identified by Border Patrol Liaison Caesar Barrientos as Honduran national Bairon Enrique Martinez Sarabia (DOB: 06/20/1994). Upon contact, I observed that his eyes were bloodshot and watery, his speech was slurred, and the interior of the vehicle smelled strongly of an unknown alcoholic beverage.

The subject primarily spoke Spanish, but he complied when instructed to exit the vehicle. Upon exiting, I observed him to be unsteady on his feet and detected the strong odor of an alcoholic beverage on his breath. I instructed him multiple times to keep his hands out of his pockets, which he understood. I requested a Spanish-speaking deputy (Deputy C. Perez #5744) to respond.

While awaiting Deputy Perez, coworkers of Mr. Sarabia arrived and attempted to approach. While I diverted my attention to instruct them not to interfere, Mr. Sarabia fled on foot. His wife, who was en route, was intercepted by Deputy Perez. Mr. Sarabia's wife made contact with him by phone, and he voluntarily surrendered at the 8700 block of 98th Avenue.

I transported Mr. Sarabia to the Indian River County Jail, where he agreed to participate in voluntary Standardized Field Sobriety Tests (SFSTs). A certified interpreter was present throughout. The tests were conducted in the DUI room on a flat, marked surface, and the entire process was video recorded.

Prior to testing, Mr. Sarabia stated he had no medical or physical conditions preventing him from walking in a straight line or standing on one foot. He admitted he had not consumed alcohol on 09/06/2025 but was hungover from the previous day, during which he consumed a case of beer.

Horizontal Gaze Nystagmus (HGN): Equal tracking, equal pupil size, no resting nystagmus. I observed lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation, and onset prior to 45 degrees. Mr. Sarabia swayed noticeably front-to-back and side-to-side.

Walk and Turn: Mr. Sarabia could not maintain the starting position, stepping out of it multiple times. He walked slowly and deliberately as if on a tightrope, struggling to maintain balance.




NARRATIVE

On September 6th, 2025 at 2353 hours, I conducted a traffic stop at the intersection of Vista Royal BLVD and US HWY 1 on a red Chevrolet Camaro bearing FL/ D0GQU, for a having a headlight out reference FSS 316.237(2). Upon making contact with the driver, later identified as Amanda M. Gillespie, I requested that she provide me with a valid driver's license, proof of insurance, and vehicle registration. Gillespie stated she did not have her wallet with her therefore she would be unable to provide me with her driver's license. Gillespie then provided me with valid vehicle registration before stating she could show me a picture of her driver's license via a photo on her cell phone.

I then requested Public Safety Dispatch (PSD) to run Gillespie through FCIC/NCIC databases. PSD responded and advised that Gillespie had a valid FL issued ID card, and that her FL issued driver's license had been suspended since 09/20/2021. After being advised of Gillespie's DL status, I then ran her FL ID card number through D.A.V.I.D. where I observed Gillespie to have 1 prior DWLSR charge, with adjudication withheld on 01/17/2023, reference IRC SO citation # AG06MBE.

I then requested Gillespie to exit the aforementioned vehicle too which she complied. After exiting the vehicle, I advised Gillespie of her Miranda Rights. Post Miranda, Gillespie expressed her understanding of her rights and agreed to speak with me. Gillespie stated she had knowledge of her FL issued DL being suspended but advised that she had paid an approximate sum of \$3,000.00 to reinstate her driver's licenses, but had not yet received a replacement DL. I then asked Gillespie if she could provide me with any documentation of her paying said fines, but Gillespie stated that she could not.

Through my investigation, I found Gillespie to be in violation of FSS 322.34(2)(B), Knowingly DWLSR (2nd Conviction); reference citation #A44X8OE.




