NARRATIVE

On March 13th, 2024, at approximately 1033 hours, I, Deputy A. Brady, responded to 4315 27th Avenue in reference to a disturbance.

Upon arrival, I made contact with the victim, Kolby A. Schweiger in the back yard of the residence. Schweiger stated she was just in an argument with Terry Smith, later identified as Terry Leonard Smith Jr, that became physical. Schweiger stated she said something in the argument Smith did not like, at which time he picked her up and body slammed her. Schweiger stated Smith then picked up a chair and hit her with it. I observed redness and swelling, along with what appeared to be light scratches consistent with landing on her back in the yard. Schweiger informed me that she is also pregnant but declined to be seen by EMS. Schweiger stated after the battery, Smith fled from the scene before my arrival.

At approximately 1502 hours, Deputy Sheriff J. Sheppard made contact with Smith at approximately the 2700 block of 43rd Street. I then made my way to D/S Sheppard and identified Smith. Smith was still shirtless and wearing blue jeans as described by Schweiger. I read Smith his Miranda Warnings to which he stated he understood. I told Smith about the allegations being made against him and ask him to tell me his side of the story. At first Smith stated he was never at the above-mentioned address. Later in his story, Smith stated he was doing lawn work a few houses down and made approximately four trips to 4315 27th Ave, to dispose of the leaves in the back yard. Smith stated he was not in an altercation. I asked Smith to start over again and be honest with me and he admitted there was a verbal altercation between himself and Schweiger but that it never turned physical. Throughout Smith's statement he would not say Schweiger's name as the individual he had an altercation with, but did make reference to it being a female. Smith places himself at the scene of the crime but would not admit to battering Schweiger.

I secured Smith in the rear of my patrol vehicle and transported him to the Indian River County Jail without incident. While in the jail sally port, waiting for a nurse to complete an intake form, Smith was talking about Schweiger, and told me she was pregnant. Smith stated Schweiger did not even know who the father was and that she is still using drugs while she is pregnant.

With the facts listed above and evidence, I placed Terry Leonard Smith Jr, under arrest for a violation of F.S.S. 784.0452B Battery on a pregnant woman.

My involvement with this case was recorded on my body-worn camera.

NARRATIVE

On Wednesday, March 13, 2024, I was conducting traffic enforcement on 10000 US Highway 1.

I observed a silver Dodge Durango heading southbound at a speed of 58/50 miles per hour. I pulled behind the vehicle and ran the Florida Tag (CG09FF) that was attached to it. The car returned with an F.R. suspension, and the only registered owner had a suspended driver's license.

I then stopped the vehicle at 9800 US Highway 1 and made contact with the driver, who did not have a driver's license but provided me with his name, Nicholas Campbell, and stated that he was the vehicle's registered owner.

During the traffic stop, Campbell was unable to provide the vehicle's registration or proof of insurance. The traffic stop was conducted at 6:49 p.m. Campbell stated that his sister handled the insurance, and he was currently on her policy. He then called his sister, who sent a text message about the insurance, which was effective on 03/13/2024 at approximately 7:20 p.m., which was after the traffic stop.

I then arrested Campbell, F.S.S. 324.221 (2), for the registered owner's failure to maintain insurance citation (AJSSOBE).

NARRATIVE

On 03/13/2024, at approximately 2118 hours, while finishing up with a traffic stop at the intersection of 21st Street and 14th Avenue, I observed a male subject operating a red gas-powered scooter bearing Florida tag (MXJT48) passed my location traveling westbound. When the scooter came to a red light at the above mention intersection, I noticed that the operator loss his balance and the scooter fell directly on top of him.

When made contact with the subject to assist getting the scooter off of him, immediately smelled the very strong odor of an alcoholic beverage. After the subject was able to place the scooter on its kick stand, I noticed that he was very unsteady on his feet and that his body had a noticeable orbital sway that was from left to right. I was able to identify the subject as Kip Palmquist, from his Florida license.

Next, I informed Palmquist that I would be conducting a D.U.I investigation, which he stated that he understood. When he made direct eye contact, I observed that both of his eyes were watery and glassy. I also smelled the strong odor of an alcoholic beverage emitting from his breath when he spoke.

During the Horizontal Gaze Nystagmus Exercise, Palmquist showed a lack of smooth pursuit in both eyes, with distinct and sustained nystagmus at maximum deviation. I also observed an onset of nystagmus prior to 45 degrees. Palmquist's body was observed swaying from front to back.

During One-Leg Stand Exercise, Palmquist's body was observed swaying from left to right and he placed his right foot on the ground, due to losing his balance. When he re-lifted with his left foot, he placed it on the ground at the 12 second mark and lost his balance. Palmquist was unable to complete the exercise, due to him being unable to maintain his balance.

During the demonstration and instructional phase of the Walk and Turn Exercise, I noticed several times, while Palmquist was in the starting position, that he loss his balance. During the first portion of the exercise, Palmquist conducted 10 steps, after being instructed to conduct 9. None of his steps were heel to toe or straight in a line. During the second portion, Palmquist missed all 9 steps, that were not heel to toe or straight in a line.

The following exercise I explained and demonstrated was the finger to nose. After explaining and demonstrating the exercise, Palmquist stated that he understood the instructions.

Left-used center pad of finger to touch center of nose
Right- used center pad of finger to touch bridge of nose.
Left – used center pad of finger to touch center of nose.
Right- used center pad of finger to touch above left nostril.
Right- used center pad of finger to touch center of nose.
Left- used center pad of finger to touch center of nose.

Throughout the exercise, Palmquist's body swayed from front to back.

Post Miranda Warnings, Palmquist advised approximately 1 hour prior, he consumed two shots of Jim Beam Whiskey, from two mini sized bottles, while hangout with friends at the Vero Beach Marina.

Based on my observations, Palmquist was placed under arrest and transported to the Indian River Jail. At the jail, Deputy Rodriguez requested Palmquist to submit to a lawful test of his breath for the purpose of determining its

On 03/13/24 I was stationary in the parking lot of the Sunshine Pharmacy on the southwest corner of 20th Street and U.S.-1 when I received an alert from the Flock license plate reader camera at eastbound 20th Street near 43rd Avenue about a gray Ford with Florida license plate CM0788 traveling east on 20th Street whose registered owner had an invalid license for failing to comply with a traffic ticket in North Carolina.

As I sat stationary, I observed a vehicle matching the description from the afore-mentioned alert; I observed the vehicle turn right from eastbound 20th Street onto southbound U.S.-1.

I pulled out onto U.S.-1 and behind the Defendant's vehicle and ran the license plate of the vehicle and confirmed that it was the same vehicle from the alert.

I initiated a traffic stop as the vehicle pulled into and parked at the IHop Restaurant located at 1838 U.S.-1. I exited my police vehicle and approached the vehicle as the driver side door opened at which time I noted that the Defendant was the sole occupant and driver of the vehicle.

I asked the Defendant for his driver's license as I informed him of the reason for the stop.

On 03/13/2024, at 02:32 (Specifically include facts constituting cause for arrest.)

On 03/13/24 at approximately 0231 hours, I, Ofc Aguilar responded to the 3410 Ocean Dr. (The Boiler) in reference to a hit and run accident. The complainant, Thomas Mooney advised that a dark colored SUV struck his vehicle and then left the area. Mooney advised he last observed the suspect vehicle proceeding westbound on Beach land Blvd towards the Barber Bridge. It should be noted as the call was being dispatched I was located within the 2000 block of the Indian River Blvd. and was able to respond to the west side of the Barber Bridge in a timely manner. I then observed a single dark colored SUV proceeding westbound over the Barber Bridge. This was the only vehicle observed on the bridge at the time of the incident. I then conducted a traffic stop on a black 2016, Mercedes SUV bearing (Florida tag# 725FH) based on the hit and run investigation.

I then made contact with the single occupant and driver of the vehicle, Christopher Schulze and advised him the reason for the stop. Schulze eventually confirmed that he was leaving The Boiler but was unaware if he was involved in a traffic accident. Ofc.Maslan (#440) was also on scene for the traffic stop and noticed that there was fresh damage/white paint transfer to the right rear bumper/wheel area of the Mercedes.

It should be noted while speaking with Schulze I observed him to having difficulty placing his vehicle in park and observed him to having slurred speech with watery red eyes. I also detected the odor of an alcoholic beverage emitting from his vehicle while speaking with him from the driver's side window. Ofc.Maslan then made left the traffic stop and made contact with Mooney at the incident location. Ofc.Maslan then advised me that he had completed his traffic crash investigation.

I then once again made contact with Schulze and advised him that the traffic crash investigation was completed and that based on my observations I was going to be conducting a DUI investigation. Schulze stated that he understood and I then read his Miranda warnings from an agency issued card, which he understood and agreed to answer my questions. Schulze stated that he did not recall being involved in an accident. Schulze stated 15min prior to the stop he was located at the Boiler. Schulze informed me over the couple of hours he was located at The Boiler he consumed a total of 2-beers (Bud light 12 ounce draft) and a single whiskey mixed drink. Schulze stated his last drink being one of the Bud light beers at approximately 0100 hours that same day. I then asked Schulze if he would be willing to perform some standardized field sobriety exercises to determine that he was capable of safely operating a motor vehicle. Schulze understood and agreed to complete the exercises and understood all instructions prior to demonstrating. Schulze informed that he did not have any physical limitations that would prevent him from completing the exercises or any medical issues with his eyes. Schulze was not wearing contacts/glasses and advised that he was not diabetic. The results were as follows:

Horizontal Gaze Nystagmus:

- Lack of smooth pursuit in both eyes
- Distinct and sustained nystagmus at maximum deviation
- Onset of nystagmus prior to 45 degrees

Walk and Turn

- Cannot keep balance while listening to instructions
- Stops while walking
- Does not touch heel to toe
- Improper turn

One leg stand

- Sways while balancing
- Uses arms to balance
- Puts left foot down

See Officer Maslan's supplement for information on the traffic accident. "On 3/13/24 at approximately 0231 hours, I responded to the area of the Barber Bridge and Indian River Blvd. Vero Beach, FL 32960, in reference to a hit and run that occurred at the Boiler Bar, located at 3400 Ocean Dr. Vero Beach, FL 32963.

VBPd Dispatch provided a description of the suspect vehicle as a black Mercedes traveling westbound on Beachland Blvd towards the Barber Bridge. VBPd Units were in the area approximately 30 seconds later and observed a single vehicle traveling westbound across the bridge. That single vehicle was a black Mercedes SUV.

I arrived on scene and assisted VBPd Ofc. R. Aguilar #437 with conducting a traffic stop of the vehicle. While making initial contact, I observed fresh body damage to the right rear quarter panel with white paint transfer. The sole occupant, identified as driver defendant Christopher Schulze, W/M DOB 7/10/02, stated he had left the Boiler and was not aware of him hitting any other vehicles.

I then responded to the Boiler and made contact with victim Thomas Mooney, W/M DOB 10/13/87. Mooney stated he was an Uber and was at the Boiler picking up passengers. While parked in the driveway entrance of the bar, the suspect vehicle approached him head on and flashed his high beams at him. Mooney backed his vehicle up a short distance; however, the suspect vehicle attempted to pass him on his passenger side. While passing Mooney's vehicle, the suspect vehicle struck the right rear quarter panel of his vehicle with the right rear quarter panel of the suspect vehicle.

The vehicle then pulled out onto the roadway, into the intersection of Ocean Dr. and Acacia Rd. where it stopped. The subjects who were waiting for the Uber yelled at the suspect vehicle to stop and come back due to him hitting the victim vehicle, at which point they stated the suspect vehicle took off at a high rate of speed westbound on Acacia Rd.

I then brought victim Mooney to the intersection to conduct a show up. A show up form was completed and signed by Mooney and he was informed of the show up instructions. Once Mooney observed the suspect vehicle at the traffic stop, he confirmed that was the definitely the same vehicle with the same tag that struck his vehicle at the Boiler".

Based on the above-mentioned circumstances, Schulze was then placed under arrest for violation of F.S.S. 316.193(3C1) DUI with property damage \$1000.00 (Citation# AFVKG7E) and F.S.S.316.061 (Leaving the scene of accident with property damage (citation# AIBZACE). Schulze was then transported to the Indian River Cleveland Clinic for medical clearance and then the Indian River County Jail without further incident.

While at the Indian River County jail, I conducted a 20-minute observation period for collecting a breath sample. Schulze agreed to provide a breath sample and the results are as follows sample#1 (0.152) and sample#2 (0.135). Schulze was then handed over to the Indian River County Jail staff.

Body Camera Video of the incident was submitted into a secure file at the Vero Beach Police Department.

On 03/13/2024 at 01:02 hours, I, Officer A. Gonzalez, responded to 1238 16th Street (Filthy's Cocktails and Beer) in reference to a dispute over a bar tab. Upon arrival I made contact with Luis Amaro. Luis did not mention any dispute about the bar tab, but did state that he did not like to be intimidated. Luis was having trouble explaining to me what had occurred or who called the Vero Beach Police Department. Officer Ayala made contact with David Hammond, the bartender at Filthy's who stated that Luis owed a tab of \$342.00.
