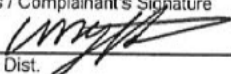

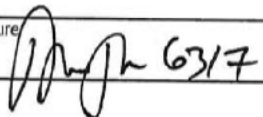

NARRATIVE

On Wednesday, October 22st 2025, at 1118 hours, I responded to 4495 U.S. Highway 1, Vero Beach, in reference to a retail theft.

Upon arrival, I made contact with the store manager, Richard Faxon, who advised at 1109 hours, he observed the suspect (Makalex Sarette) shoplifting from the store (WAWA). Faxon advised that Sarette entered into the store from the main rear door. Sarette walked straight towards the beer cage, entered the beer cage, then grabbed 1 case 24ct (Corona) and 1 case 12ct of (Heineken). Faxon also mentioned before Sarette exited the beer cage, Sarette stopped to ensure he was cleared to exit. Once exiting, Sarette speed-walked toward the rear exit. He bypassed all points of sale, with 2 cases of beer, jumped on his bike and started heading south onto Old Dixie Highway.

I asked Faxon for video footage with a description of the suspect. Faxon provided video footage, which I observed the suspect wearing: (brown shorts, long sleeve black shirt, black socks and black Nike slides). Faxon also provided a receipt copy of the items and the amount: (\$ 49.73) that was stolen.

I canvassed the store asking if anyone had seen or knew the name of the shoplifter. A few of employees advised they believed his name was "Alex."

I then spoke with Deputy Brady, who advised he saw the suspect on a bike headed toward the 4300 block 27th Ave, riding toward a rooming house at 4326 27th Avenue. Sarette spotted Deputy Brady in his patrol uniform, which had a badge and a patch displaying that he was Law Enforcement Officer, he then jumped off his bike, causing him to lose his slides, and ran inside the rooming house. Deputy Brady observed a female open the door as the suspect ran inside. Deputy Brady then instructed the female to tell the suspect to come out from the home. He stated the female yelled at Sarette requesting him to leave the property. Sarette responded by running out the back door of the house, jumping a wooden gate headed westbound on foot.

Numerous of deputies responded to the area, where the suspect was located. Sergeant Curby observed Sarette fitting the description, then activated his lights and sirens on his marked patrol vehicle. Sarette immediately fled from him. Sarette was then captured and arrested at 4226 25th Ave. I searched Sarette on NCIC/FCIC, it came back Sarette was on probation for: Grand Theft (Case # C92860) which started on 09/22/2025 and expires on 09/21/2028.

Based on the above, it was determined acts of retail theft and resisting arrest had occurred.

Due to the above, it was determined he failed to live within the law, which is a direct violation of the conditions of the Felony Probation.

NARRATIVE

On October 22, 2025 I responded to a physical disturbance in the 6500 block of US1.

Caller Crystal Rodney stated to our 911 dispatch center a black male was punching a black female along the side of the road with her 3 kids. On arrival contact with was made with the victim Donitra Washington. She stated that the male party was her husband and all they kids were there's in common. A short time later the suspect Kareem Coleman arrived on the scene of the incident. He stated want the problem I told him I would tell him once he was out of the car. He refused to exit the vehicle when instructed to and had to be removed from the vehicle. When I asked what occurred, he told me he didn't want to speak to me about the incident. The victim in the incident would not provide any logical statement as to what happened. I spoke to the witness she stated she was driving by and saw the suspect striking the female in a blue dress in the face. The victim in the case was wearing the same dress. I didn't observe any visible injuries on the victim

Hamad did not contact the Indian River County Sheriffs office to conduct a standby so he could obtain belongings.

NARRATIVE

On Wednesday, October 22nd, 2025 at approximately 1719 hours, I responded to [REDACTED] in reference to a disturbance. Prior to my arrival, dispatch advised that the caller identified as, Elisabeth Jane Lewis, stated that her husband, Randall Nelson Lewis, was hitting her.

Randall and Elisabeth have been married for 5 Years, [REDACTED] As Elisabeth was in custody, she managed to take her left hand out of the handcuffs, and as I tried to place her back into the handcuffs, Elisabeth began to actively resist me so that she could evade me putting her in handcuffs. Elisabeth was saying "I am not going into handcuffs".

Based off the evidence and statements made it has been determined that Elisabeth was in violation of FSS 827.03.1 Child Abuse, FSS 784.03.1a1 Battery Touch or Strike (Domestic Violence), and FSS 843.02 Resisting Officer without Violence. While Elisabeth was being taken into custody she rammed her forehead into the rear metal cage in my patrol vehicle, it caused her to have two lacerations to the forehead. She taken to Indian River Cleveland Clinic and was medically cleared and then was transported to the Indian River County Jail.

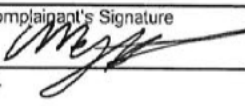
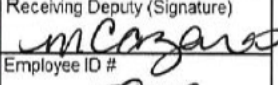

In the rear of the residence, I observed a gray Mercury Grand Marquis with several subjects around it. I immediately observed a black male in a black hoodie, who I recognized to be Jarvis, near the vehicle. I exited my vehicle and observed Jarvis attempt to slowly walk away from me. I began to loudly say "Jarvis Hicks" to signal for him to come to me. He instead ignored my commands and proceeded to take off on foot in a westbound direction, where I began to chase after him. As he tried to run past the southeast corner of the house, Deputy Magill was waiting for him. Jarvis attempted to maneuver around Deputy Magill; however, this caused him to fall on the ground. Since he fell on the ground, we were able to get him into custody.

He was transported to the Indian River County Jail and charged with FSS 843.02 Resisting Arrest Without Violence.

NARRATIVE

On October 19, 2025, at approximately 2251 hours, I responded to 3206 45th Street, Vero Beach, Florida, in reference to a disturbance.

Prior to my arrival, dispatch informed me that the caller stated someone is beating on my friend, his name is, Jarvis Hicks.

Upon arrival, I made contact with Cierra Cooper, and asked which way Jarvis went. She advised he ran east. Deputies conducted a search of the area, but were unable to locate Jarvis.

I asked Cierra what occurred this evening, she stated the following in summary; She and Jarvis, who she has been in an intimate relationship with for the past three years went to a club. When they returned Jarvis was exiting the vehicle from the front passenger seat, and Cierra handed him a picture that was taken of them at the club. Cierra told Jarvis to take the picture with him, which made Jarvis mad. Jarvis ripped the keys out of the ignition, exited and slammed the door, which prevented Cierra from leaving.

Cierra exited her vehicle from the driver's seat and stood next to the driver's door. She said Jarvis continued to get more upset.

Jarvis ran around the front of the vehicle, jumped on the hood, and ran across the roof, as Cierra walked towards the trunk. Jarvis jumped off the car, grabbed Cierra by the hair, and began to hit her. Cierra told Jarvis that was the last time you put your hands on me.

Cierra said she call Lakiesha Anderson, when she was unable to leave and Jarvis's behavior was escalating. Jarvis noticed Cierra making a call, which made him angry. Cierra attempted to run away, but he slammed her to the ground and began attempting to take the phone. Eventually Jarvis was able to take the phone from Cierra. Cierra said Jarvis began to drag her by her hair across the ground.

I asked Cierra how many times Jarvis struck her, she stated she was unsure because her adrenalin was pumping.

Cierra pointed to the right side of her face, which was red, and consistent with getting struck in the face. I asked if he struck her with a closed fist or slapped her, she stated she was unsure. I also observed a scratch on her forehead, I asked if that was related to today. She advised it was not, and stated it occurred the other day when Jarvis attacked her.

Lakiesha stated, when she arrived, she observed Jarvis on Cierra holding her down. Lakiesha got out of the vehicle and observed me approaching from the north, Jarvis got off of her and ran towards 4540 32nd Avenue, Vero Beach, Florida.

Lakiesha asked if I saw Jarvis when I was approaching, I informed her I did not.

Cierra stated, when Lakiesha arrived and Jarvis got off her, he said get your keys and phone and get out of here, as he went towards the above-mentioned address.

It should be noted that the individual that [REDACTED] was Lakiesha, when she heard Cierra being attacked by Jarvis.

I was unable to locate Jarvis to question him, I attempted to call Jarvis, but it went straight to voicemail.

Based on the statement provided by Cierra, and what Lakiesha observed when she pulled up, I believe if it was not for
