NARRATIVE

On October 21, 2024, at approximately 1430 hours, ATF TFO's Detective Thimmer and Detective McKay, along with Sergeant Clark were notified by ATF, they had an active federal warrant for Erman Eugene Hinton Jr., a black male, DOB: 07/10/1982, for possession of a firearm by a convicted felon.

Detectives Thimmer and McKay, along with Sergeant Clark located Hinton at the approximate 4500 of 33rd Avenue. Hinton was taken into custody and a search incident to arrest was conducted. Detective McKay asked Hinton if he had anything hidden on his person, genitals or inside of his body due to that being an extra charge upon enter the county jail. Detective McKay advised Detective Thimmer, Hinton advised him, Hinton may have something next to his genitals. Detective McKay asked Hinton exactly where the unknown item was, Hinton advised inside his underwear next to his genitals. Detective McKay at the time did not locate the unknown item and Detective Thimmer requested Hinton to walk over to Sergeant Clarks patrol vehicle. While Detective Thimmer attempted to escort Hinton to Sergeant Clark's vehicle he became belligerent, started lowering his center of gravity, which he was attempting to make himself heavy and attempted to pull away, which caused Sergeant Clark and Detective Thimmer to forcefully escort Hinton to Sergeant Clark's vehicle.

Once at Sergeant Clark's vehicle, he called for a zone deputy to assist with transporting Hinton to the jail. Deputy Hubbard arrived on scene and Detective Thimmer and Sergeant Clark escorted Hinton to Deputy Hubbard's vehicle. Once at Deputy Hubbard's vehicle, Deputy Hubbard and Detective Thimmer searched Hinton again, which is when Detective Thimmer located a clear plastic bag, containing a white rock type substance, which he knows to be cocaine, based on his training and experience, inside Hinton's waist band of his underwear.

Hinton was subsequently transported to the Indian River County Jail by Deputy Hubbard. Detective Thimmer and Detective McKay field tested the white rock type substance, which tested positive for cocaine. The cocaine weighed approximately 0.68 grams without packaging.

Hinton was issued a citation for the possession of a controlled substance, citation number AJSSSB E.

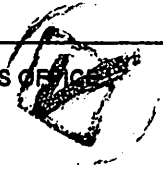

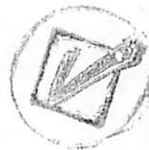
