The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:  
 On **04/20/2026** , at **20:17** (Specifically include facts constituting cause for arrest.)

On **4/20/2026** at approximately **1818** hours, I responded to **617 US Highway 1 (On the Fly Parking Lot)** in reference to an agency assist for a traffic stop. Upon arrival, I observed Florida Highway Patrol on a traffic stop.

I made contact with Corporal Griffin with Troop L who advised me of the following in summary: Corporal Griffin was on his way home when he observed a Black Nissan SUV (Florida Tag 23ARMB) attempt to drive the wrong way (West) on Sebastian Boulevard East. In doing so, Corporal Griffin observed the vehicle strike the curb, but ultimately correct itself back onto the roadway, continuing South on US Highway 1. While attempting to turn around, Corporal Griffin stated he observed another motorist attempting to flag him down, pointing at the vehicle that struck the curb in an attempt to notify him of the driver's behavior. Corporal Griffin stated he conducted a traffic stop on the vehicle and made contact with the operator, Matthew Culver. Corporal Griffin stated he believed the operator to be intoxicated. I then assumed primary investigator in the incident.

I made contact with Culver, who was now out of the vehicle, leaning against the front bumper of Corporal Griffin's patrol vehicle. It appeared Culver was using the vehicle for balance. When speaking with Culver, he had difficulty recalling his route but stated he was "Leaving the Marina". Through conversation, it was determined Culver was attempting to go to a restaurant but missed the turn. While speaking with Culver, he had a strong odor of alcoholic beverage emitting from his breath as he spoke. Culver's speech was slow, slurred and difficult to understand at times. Culver continued to have balance issues throughout the conversation. Upon Culver removing his sunglasses, he had slightly red and glossy eyes.

Based on the observations, I asked Culver if he would submit to field sobriety exercises which he agreed to. Culver stated he had two Fireball shots, starting at 1000 hours and the last shot being within the half hour. Culver stated he had no physical ailments, was not diabetic and not epileptic, however stated he "Wished he was". Culver stated he does not wear glasses or contacts. Culver was asked to walk to the front of the FHP vehicle, which had since been moved backwards after I made contact with Culver. Culver was leaning to the right and stumbling while walking.

For the HGN Exercise, Culver was asked to remove his ball cap, stand his feet together and arms by his sides. Culver appeared to have great difficulty in standing with his feet together, even after electing to remove his sandals, and continually lost his balance. Culver was instructed to follow the stimulus (Pen in this case) with his eyes only and to not move his head, which he stated he understood. While conducting the exercise, Culver had to be reminded frequently to not move his head. I observed lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes. The exercise was then concluded.

I then utilized a crack in the pavement of the parking lot for the line for the walk and turn exercise. I explained and demonstrated the starting position for Culver which he stated he understood. Culver would lose balance almost immediately after his feet would be heel-to-toe and would almost fall over. In addition, while getting in the starting position, Culver would begin attempting to walk heel-to-toe unprompted and despite being told to stop, almost walked into me. After being reset, and instructing Culver to get into the starting position, he again almost fell over, and began the exercise without any further instruction. Culver while walking unprompted, walked into me as I was standing directly in front of him. Any attempts to continue exercises were ceased for both Culver's safety and my own.

It was evident based on Culver's intoxication level, he was unable to safely perform the exercises. I determined Culver was in actual physical control of a motor vehicle within this State while under the influence of alcoholic beverage and was affected by such alcohol to the extent his normal faculties were impaired. Culver was placed under arrest and transported to the Indian River County Jail. Inside the vehicle being operated by Culver was a glass in the cupholder which was cool to the touch with condensation. The glass had the odor of cinnamon and an alcoholic beverage and was presumed to be the Fireball previously mentioned by Culver.

At the jail, Culver provided two lawful breath samples, one measured at 0.153 and one measured at 0.149.

PROBABLE CAUSE STATEMENT

On April 20, 2026, I was dispatched to 8755 92nd Avenue in reference to a disturbance. This location is a rooming board style house. I believe there are seven rooms total.

Upon arrival, I made contact with Angel Rivera-Santiago, who stated he was watching TV in his bedroom Room 6 with the door open. He reported that Kristin Phillips who lives in room 6 entered his room uninvited, yelling about the TV volume, and began striking him multiple times in the face before pushing him onto the bed. Angel stated he was able to break away, exit the room, closing the door, and then [REDACTED]. He further stated that Kristin then jumped through the bedroom window, breaking the glass.

I then spoke with Kristin Phillips, who stated she was forced into room 6 by Angel, who then locked the door and trapped her inside. Kristin stated she exited by jumping through the window. She also stated that Angel did not touch or strike her.

Based on my observations and statements obtained on scene, I determined Kristin Phillips to be the primary aggressor. While on scene, she was highly confrontational, yelling, making obscene gestures, and appeared visibly agitated. She also appeared to be intoxicated but denied consuming alcohol or drugs.

On April 21, 2026, at 00:43 hours, I Deputy D. Coon #6379 responded to [REDACTED] in reference to a Disturbance call.

Upon arrival, I met with 48-year-old Koren Lynn Travers. Koren is the victim, and she stated the following in summary:

F.S 29.072(3)(a) & Florida Constitution, Article 1, Section 16 (b)(5)

At approximately 21:00 hours this evening, Koren and her family were inside their [REDACTED] when an argument occurred. Koren and her sons, 22-year-old Gavin Charles Travers and 14-year-old Jayce Marcus Cannie were socializing in the kitchen and living room area. The topic of Jayce's father came up, and this tremendously upset Gavin. An argument between Gavin and Koren ensued, and it intermittently continued for several hours. This included Gavin having an occasional screaming outburst. While on the back porch, Gavin's antics were out of control. Koren stated that she was going to call the police. Gavin took Koren's phone from her hand and prevented her from calling [REDACTED]. He then struck Koren on the top of her head (with a closed fist) approximately four times. 14-year-old Jayce was present and tried to intervene. Koren's tenant, 47-year-old Carrie Ann Mobley rushed to the incident. Koren instructed Carrie to [REDACTED] and she complied. Koren did not strike Gavin in any way. I observed no injuries to Koren's head/face, and she declined medical attention. Photographs of her head were taken.

I then met with 14-year-old Jayce Marcus Cannie. Jayce is a witness, and he stated the following in summary:

Jayce acknowledged the family argument that began earlier inside the home. The drama continued for hours, and it climaxed on the back porch when he saw Gavin attempting to strike their mother on the head. Jayce stated that he could not be certain if physical contact was made. He added that Gavin was attempting to strike his mother's head with open-hand strikes. He attempted to intervene and push Gavin away, but Gavin was too big and strong. Gavin did not strike Jayce. Jayce did not strike Gavin, nor did their mother strike Gavin. Jayce was not injured.

I then interviewed 22-year-old Gavin Charles Travers. Gavin is the subject, and he stated the following in summary:

Gavin acknowledged socializing inside with the family earlier this evening. He became

upset when the topic of Jayce's father was discussed. This set off a chain of arguments with his mother Koren. While both were on the back porch, Gavin's antics escalated. Koren stated that she was going to phone police. Gavin admitted to standing in her way and intentionally blocking his mother from retrieving her phone to call police. As Koren tried to reach for her phone, Gavin gently patted the top of her head to get her attention. Koren did not strike Gavin. Gavin appeared uninjured, and he declined medical attention.

I then met with 47-year-old Carrie Ann Mobley. Carrie is a witness, and she stated the following in summary:

Carrie is a tenant in the home. She acknowledged Gavin's aggressive and erratic temperament, which is usual for him. Tonight, she heard Gavin's intermittent outburst from her room. Suddenly, she was summoned to the back porch by Jayce. Upon arrival, Carrie saw Koren sitting in a chair with Gavin towering over her. Koren was scared and pleaded with Carrie to phone police due to Gavin being out of control. Carrie did not see any physical violence, but she [REDACTED] as instructed.

Based on my investigation, it was determined that a domestic battery had occurred with Gavin being the primary aggressor. Furthermore, there is also probable cause that Gavin intentionally prevented his mother from communicating with law enforcement and summoning them to their home to intervene. Therefore, Gavin was placed under arrest and charged with the following:

- F.S.S. 784.03 (1)(a)(1) Battery - Domestic Violence
- F.S.S. 914.22 (1)(e) Tampering with or Harassing a Victim

NARRATIVE

On Tuesday, April 21, 2026, at approximately 0110 hours, I, Deputy M. Neill #6317 responded to the intersection of 26<sup>th</sup> Street and 58<sup>th</sup> Avenue, Vero Beach, Indian River County, Florida, in reference to wellbeing check.

A caller reported to the Vero Beach Police Department, who then relayed the information to the Indian River County Sheriff's Office that a driver was passed out behind the wheel at the intersection. It was unknown if they were awake or breathing at the time. They provided a vehicle description of a black GMC Sierra.

Upon arriving at the intersection, a black GMC Sierra was observed in the westbound lanes of 26<sup>th</sup> Street, sitting stationary. There was a white male driver, unconscious behind the wheel. The driver had his head tilted back, mouth open, and foot pressed on the break. The vehicle was on and in drive. The original caller had reported that he had attempted to wake the driver up but was unsuccessful.

Due to the safety concern of the subject being ill, injured, or impaired, the vehicle was boxed in to prevent a possible crash if not immediate stopped.

I knocked on the window of the vehicle. Originally, I did not get a response. After another round of knocks and identifying myself as law enforcement, the driver awoke. The driver appeared confused and disoriented. The driver took his foot off the break, letting the vehicle roll forward, almost in to a patrol vehicle. The driver was able to stop the vehicle before a crash occurred. I advised the driver to put the vehicle in park multiple times. The driver struggled to do this and instead put the vehicle in reverse. After asking the driver to roll the window down, I was able to get him to put the vehicle in park.

Based on it appearing that the driver was ill, injured, or impaired, I asked that they exit the vehicle. During this time, I observed a firearm near the center console, holstered. A pat down was conducted to ensure the driver did not have a firearm on him.

I then began speaking to the driver, who was later identified as Mr. Craig Kossman. I asked Mr. Kossman if he knew where he was at. He responded with stating that he did, but was then unable to advise where we were at. He stated this multiple times. During our conversation, I could smell the odor of an alcoholic beverage emitting from his breath. He had glassy eyes, an unsteady balance. I then asked if he knew what city we were in. He advised Vero Beach. I requested Mr. Kossman's license. He was able to obtain it from his wallet, but had difficulty with removing it from his wallet. I then asked Mr. Kossman if he would be willing to do Standardized Field Sobriety Exercises. He advised he would do whatever I asked him to do.

The SFSE's go as follows:

Horizontal Gaze Nystagmus (6/6): Mr. Kossman had a lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and a lack of smooth pursuit prior to a 45 degree angle in both eyes. He did not have a resting nystagmus. He did have equal tracking and equal pupil size. He moved his head during the exercise and had vertical

gaze nystagmus.

Walk and Turn (4/8): Mr. Kossman failed to remove in the instructional stance by falling off, took the incorrect number of steps both times, missed touching heel to toe, and turned improperly.

One Leg Stand (1/4) Mr. Kossman put his foot down multiple times throughout the exercise. Mr. Kossman was barely able to lift his foot off the ground, and kept the heel of his foot planted throughout most of the exercise. Additionally, he did not look at his foot, failing to follow instructions throughout the exercise.

I advised Mr. Kossman of his Miranda Rights. He advised he understood his rights and was willing to speak to me. He advised he was leaving from a friend's residence when law enforcement came in contact with him. He advised that he has consumed some alcohol, but would not say how much specifically. He advised "not that much". When asking him how much is not that much, I was only able to narrow down that Mr. Kossman was referring to less than six beers. Mr. Kossman than made a statement that I interpreted as he no longer wished to answer any questions.

Mr. Kossman was then placed under arrest for DUI. He was secured in handcuff restraints which were checked for proper fit and double locked. Mr. Kossman was then secured in the back of my patrol vehicle.

Mr. Kossman was transported to the Indian River County Jail. While at the jail, Corrections Deputy Rentas requested that Mr. Kossman submit to a lawful test of his breath to determine its alcoholic content. Mr. Kossman refused to provide a breath sample.

Based on the above information, I believe there is probable cause to arrest Mr. Kossman for the Offense of Driving Under the Influence, pursuant to FSS 316.193(1)a and for Refusing to Submit to a Lawful Test, pursuant to FSS 316.1939.1.
