





On Thursday June 12, 2025 at approximately 0630 hours, I responded to [REDACTED] in reference to a domestic disturbance in progress. Dispatch advised they received a call from a third party advising a disturbance was in progress involving a mother and daughter.

I made contact with the mother Donna Schiebler who stated she did not want her daughter Lindsey Theissen to have possession of a dog leash or to walk the dog. Schiebler attempted to grab the dog leash from Theissen, and in the process stated she grabbed the leash and part of Theissen's clothing and began to pull. Once this occurred, as per Schiebler, Theissen began to strike Schiebler. Both parties stated a physical altercation occurred on the ground. Due to the statements by both parties, it was determined Schiebler was the primary aggressor and was placed under arrest.





I then ran Jony by name and date of birth via dispatch who advised that Jony did have an active arrest warrant out of Indian River County.


I transported Jony to the Indian River County Jail where he was booked for the active warrant, reference Indian River County Court case number 312024CF001089A.

Jony's bond amount was set as "ROR" or release on own recognizance.



NARRATIVE

On Thursday, June 12th, 2025, at 1827 hours, I conducted a traffic stop on a Nissan sedan in front of [REDACTED]. The driver, Bobby Charles King Jr., and the passenger, Glenn'necia Jaylen Trimble, both advised they lived at the aforementioned address (rooming house). While conducting the traffic stop, I observed [REDACTED] and stand in the front yard and watch the traffic stop. Upon clearing the traffic stop, Public Safety Dispatch advised there was a disturbance at the same address. I responded back to the location of the traffic stop and met with the complainant, Tonya Renee Whitehead.

Whitehead advised that at the conclusion of my previous traffic stop, Trimble exited the vehicle and walked back towards the residence, which I observed prior to clearing the stop. Whitehead continued by stating that Trimble walked straight over towards her and engaged in a verbal altercation with her by calling her nosey, due to her being one of the bystanders that exited the residence and stood in the front yard for the duration of the traffic stop.

Whitehead stated that Trimble got in her face and poked her in her left cheek. Whitehead advised she wanted to prosecute Trimble for battery. I then made contact with Trimble who denied the allegations. Assisting deputies on scene spoke with additional residents/bystanders who advised they witnessed the altercation and provided supporting statements to Whitehead's allegation. I did not observe any redness / marks / bruises on Whitehead's cheek but due to supporting witness statements, my investigation found Trimble to be in violation of FSS 784.03, battery.

It should be noted that while escorting Trimble in handcuffs to the back seat of my agency issued patrol vehicle, Trimble told Whitehead that when she gets out of jail she's going to "really hit her." I advised that Trimble everything was being recorded and she replied by stating "I don't give a fuck"

I located Jamyiah, approximately an hour later at her residence, 2610 42nd Street. Jamyiah stated post Miranda that she was given permission over the phone by Arthur to go and get the tool box. Jamyiah provided a witness to this conversation, David (772-268-6545). I spoke to David who said, he was out with Jamyiah but he did not hear any conversation with Arthur about a tool box. David was adamant there was no conversation in regards to this.

Due to the totality of circumstances, to include the statements above, locating the stolen tool box inside Jamyiah's residence hidden behind a couch, there being no witness to Jamyiah's possible agreement with Arthur, and the residence being occupied by Arthur at the time of the incident, I found probable cause pursuant to F.S.S. 810.02.3a for residential burglary of an occupied dwelling.

NARRATIVE

On June 12, 2025, at approximately 2215 hours, I arrived at [REDACTED] in reference to a disturbance. Upon my arrival, contact was made with Avril Flemming, who advised the following verbally:

[REDACTED] Steadval Flemming. Avril and Steadval's granddaughter, Adrianna Lester, had come to [REDACTED] to spend the night since she was out of school for summer.

Avril explained over the past five (5) days, Steadval has been showing signs of anger and aggression towards her and she does not know why. Avril said that six (6) months ago, she filed for a risk protection order on behalf of Steadval through the courthouse and it had been granted. Steadval's firearms were removed, but Avril said over the past few days she had been told he had a firearm and he had been telling people he would use it against her. On June 11, 2025, Avril found Steadval with a firearm that he got from someone else, but other family members took it away and hid the firearm. Avril said she did not contact law enforcement about this incident.

Avril continued speaking and informed me on this date, Steadval had been getting upset with her throughout the day and Avril did not know why. Just prior to this incident, Avril was playing something on her phone and Steadval became angry with her and told her to turn off what she was playing. Steadval then took a shower and started getting dressed. Avril was worried about Steadval's mental health, so she told him if he left the home, she did not want him to come back. Steadval was angered by this and ran towards Avril. Avril went into the room Adrianna was in and she tried to close the door and lock it to protect them, but Steadval was able to get in the room. Avril tried [REDACTED] but Steadval wrapped his arm around her neck briefly and ripped the phone out of her hands before she was able to complete the call. It is to be noted, Avril confirmed she did not lose the ability to breathe and her airway was not constricted when this happened. Steadval did not give Avril her phone back and kept it on his person. While everything was going on, Adrianna [REDACTED] Eventually, Avril and Adrianna were able to get away from Steadval and ran outside to keep themselves separated from him.

Avril informed me Steadval has not been formally diagnosed with any mental illnesses, but believes he does have a mental illness. Avril confirmed she did not want medical attention. While speaking with Avril, I did not observe any marks or bruises on her person.

While I was speaking to Avril, D/S A. Consalo was on scene assisting with the investigation. D/S A. Consalo spoke to Adrianna who confirmed she observed Steadval wrap his arm around Avril's neck briefly and took Avril's phone when she tried [REDACTED] which is why Adrianna called.

While on scene, I tried speaking to Steadval at first, but he kept yelling and would not listen to me. While I spoke to Avril, D/S A. Consalo was able to speak to Steadval and he denied touching Avril, but he did say he took Avril's phone because she took his phone.

Based on the information above, I found probable cause Steadval was in violation of F.S.S 784.03-1A1; simple
