

NARRATIVE

On 8/7/2025, at approximately 0800 hours, I was dispatched to [REDACTED] in reference to a disturbance.

(The following statements by the involved individuals were paraphrased for documentation purposes)

Upon arrival, I made contact with reporting party, Khianti Troutman, who stated the father of her four children, Danershard Bristol, battered her after a disagreement about their sex life. Khianti advised Danershard invaded her personal space, by getting in her face and she pushed him back. Khianti claimed after she pushed Danershard, he punched her in the face with a closed fist multiple times, grabbed her by the hair and slammed her to the ground, and stepped on her chest.

This deputy observed two bumps on Khianti's forehead, and several minor lacerations inside her mouth.

I then made contact with Danershard, who did not confirm or deny the allegations. Danershard did not want to speak to this Deputy about the incident.

This Deputy observed minor lacerations in Danershard's left cheek and forehead. It should be noted that Danershard stated his injuries were from an accidental fall from this morning.


Based on my investigation, I determined that Danershard violated F.S.S (784.03) Battery- Domestic Violence.

NARRATIVE

On Thursday, August 7, 2025, at approximately 1745 hours, I was traveling Southbound on U.S. Highway 1 near the 5900 block, when I observed a black in color Ford F-150 overtake another vehicle in the left lane and rapidly accelerate. I visually estimated the vehicle to be traveling 80 miles per hour in a posted 50 mile per hour zone. I then activated my agency issued radar unit to confirm the vehicles speed. My Stalker DSR 2x was activated and confirmed the vehicle to be traveling 78 miles per hour in the posted 50 mile per hour zone, and I received a clear and consistent audio doppler and visual reading confirming the speed.

I initiated a traffic stop on the vehicle at the 5300 block of U.S. Highway 1, at which point contact was made with the driver, Antonio Hernandez-Rodriguez. Antonio was asked to provide me with his driver's license, the vehicle registration, and insurance. Antonio stated he does not have a driver's license and stated it was confiscated in Martin County due to failure to pay child support.

I confirmed through DAVID that Antonio was suspended, and has two previous convictions for knowingly driving while license suspended, revoked, or cancelled.

On November 24, 2021, Antonio was convicted in Martin County for DWLSR, with an offense date of July 28, 2021, Citation#: AD7EPOE. On August 16, 2021, Antonio was provided an additional citation for knowingly DWLSR, and was subsequently convicted on November 24, 2021, Citation#: AEYX7YE out of Martin County.

It should be noted that Antonio's most recent suspension was on August 04, 2025, for failure to pay child support. On August 07, 2023, he was suspended for failure to pay child support, and February 27, 2023 he was suspended indefinitely for failure to pay traffic fines.

It should also be noted that Antonio's license has not be reinstated at any point in time since the suspension in November 2021.

Due to the fact that Antonio was knowingly operating a motor vehicle while his license was suspended, cancelled, or revoked with previous convictions, he was placed under arrest and transported to the Indian River County Jail under the following charges.

Count 1: Knowingly Driving while License Suspended, Revoked, or Cancelled 3rd offense. Citation #: AA04CEE.

NARRATIVE

On Thursday, August 7, 2025, at approximately 1736 hours, I, Deputy M. Neill #6317 responded to 1646 3rd Court SW, Vero Beach, Indian River County, Florida, 32962 in reference to a wanted subject.

An Anonymous caller reported that Mr. Jacob Sullivan was at the above address. They also advised that Mr. Sullivan was driving a black Nissan pickup truck. Mr. Sullivan had active felony warrants out of Indian River County reference BW2023180.

While in the area deputies observed a black Nissan pickup truck leaving the area. After catching up to the vehicle, the driver passed by Sgt. Scranton, who was sitting perpendicular to the direction the vehicle was driving. Sgt. Scranton was able to confirm that the wanted subject, Mr. Sullivan, was operating the vehicle.

Upon stopping the vehicle, it pulled back in to the above address where the original caller reported Mr. Sullivan was staying at. Contact was made with the driver, who again appeared to be Mr. Sullivan. He was detained in handcuff restraints and removed from the vehicle.

After being removed from the vehicle, Mr. Sullivan provided the name of Isiah Patrick Sullivan (DOB 01/17/1996). Mr. Sullivan was warned that providing a false name would result in a additional charge. He advised that it was his correct name.

After reviewing the name provided, it resembled closely to Mr. Sullivan, as it was his brother. Although it appeared as a close resemblance, it was clear that it was not the correct name to Mr. Sullivan. I confirmed with the subjects that Mr. Sullivan was with that he was in fact Jakob Sullivan and not Isiah.

At this point Mr. Sullivan was placed under arrest for his active warrant, as well as providing a false name to law enforcement.

Upon inspecting his phone, which was in the vehicle he was driving, I located a Florida ID card which again confirmed the subjects name as Mr. Sullivan.

Per FCIC/NCIC Mr. Sullivan only possess an ID card and does not hold a valid drivers license. As of 03/21/2022, Mr. Sullivan was designated as a Habitual Traffic Violator for a period of 60.0 months. Mr. Sullivan also has multiple other suspensions on his license.

Based on the above information, I believe there is probable cause to arrest Mr. Sullivan for Driving While License Suspended – Habitual Traffic Offender, pursuant to FSS 322.34.5, and for providing a false name to law enforcement, pursuant to FSS 901.36.1.



The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On **08/07/2025**, at **23:01** (Specifically include facts constituting cause for arrest.)

On 8/7/2025 at approximately 2137hrs, Officer Keskinen and I responded to a call at 1030 Persian Lane in reference to vehicular burglary at 715 Surrey Terrace. Prior to our arrival, information was passed over the radio that the suspect was possibly Mitchell Clemmer, who was walked home by the caller.

Upon our arrival, we started approaching Mitchell's residence and I saw Mitchell approaching his front door. I introduced myself and ask him to speak with me concerning the vehicular burglary, but he didn't comply with my orders. Officer Keskinen stepped in and gave Mitchell several orders to talk with us, but Mitchell proceeded to enter into his residence while stating, he did not have to speak with us. Mitchell proceeded to close his screen door and stood behind his dog as Officer Keskinen continued to reason with him in the doorway. When Mitchell continued to refuse the orders, Officer Keskinen asked his wife to put the dog in the kennel and she complied with the request. Mitchell proceeded to close his main door in Officer Keskinen's face.


Based on Mitchell's non-compliance with law enforcement's orders and being the suspect of a burglary, which just occurred, Officer Keskinen opened the front door and attempted to restrain Mitchell. Upon Officer Keskinen grabbing Mitchell by the arm, Mitchell immediately tensed his arms, and attempted to pull his arms back, trying to defeat Officer Keskinen's actions. Mitchell then grabbed hold of Officer Keskinen's watch during the brief encounter. Officer Keskinen pulled Mitchell out of the residence and I proceeded to grab Mitchell to help subdue him. In the process, Mitchell fell to the ground and was placed in double locked mechanical restraints without further incident. The mechanical restraints were checked for proper fit.

As a result of the burglary investigation, the victim ultimately decided to decline pursuing charges.

Mitchell was placed in the patrol car and transported to the county jail. Mitchel was charged with one count of F.S.S. 843.02 Resisting an Officer Without Violence.

NARRATIVE

On August 7, 2025, at approximately 2122 hours, I was in the area of the 7800 block of 20th Street when I observed a gold Kia van bearing a Florida license plate of LNUK94 that did not have any functional tag lights. Based on the traffic violation observed, I conducted a traffic stop. I approached the vehicle and contact was made with the driver of the vehicle, Elizabeth Griffin and the passenger, James Hendee.

During the stop, D/S W. Shaw arrived on scene and deployed K9 Sunny for an exterior sniff of the vehicle. K9 Sunny alerted to the odor of narcotics emitting from inside of the vehicle. A search of the vehicle was conducted and [REDACTED] and 10 orange pills were located inside the vehicle on the seat behind the driver's seat.

James immediately stated the pills were his. James was verbally advised his Miranda Rights which he waived. Post Miranda, [REDACTED] and the orange pills were Adderall [REDACTED]

[REDACTED] James claimed he was prescribed the orange pills as well, but when he showed the pill being prescribed the pill was an oval shape and the ones in the bag were circular and seemed to have different markings.

[REDACTED] The orange pills had the number 404 printed on it with an odd-looking letter E on top of that and on the back side were two lines that made a plus symbol. Per Drugs.com pill identifier, the orange pills were identified as Amphetamine and Dextroamphetamine commonly known as Adderall [REDACTED] Per Drugs.com, [REDACTED] and Amphetamine and Dextroamphetamine is a schedule 2 narcotic. Both pills need to be prescribed by a doctor.

During the search, a small black bag was located right next to the clear bag of pills James claimed were his. The pouch had a straw in it and a small amount of a crystal-like substance inside the bag and the straw. From my training and experience, I recognized the substance to be methamphetamine. D/S R. Sides, who was on scene and assisting with the traffic stop tested the suspected methamphetamine via a field test kit, which yielded positive results for the substance to be methamphetamine. The suspected total of methamphetamine was less than a gram. James and Elizabeth were questioned about the methamphetamine. Both parties claimed the methamphetamines were not theirs, but James later said he would take ownership of the methamphetamine so Elizabeth would not be in trouble.

Based on the information above, I found probable cause James was in violation of F.S.S 893.13.6A, possession of a controlled substance without a prescription. I also found probable cause James was in violation of F.S.S 893.147.1, possess or use drug paraphernalia. James was arrested and was later booked into the Indian River County Jail without incident.

NARRATIVE

On Thursday, August 7, 2025, at approximately 2217 hours, I responded to the 8600 block of 20th Street, Vero Beach, Florida, in reference to a reckless driver. LT. Lester had stopped the vehicle and informed me he believed the driver to be under the influence of alcohol.

I arrived at the aforementioned location and made contact with LT. Lester, who advised the driver of the grey Ford F-150, Trevor Laporte, had been tailgating another vehicle, straddled the lane markers, and was unable to maintain his lane of travel.

As I interacted with Trevor, I observed several physical signs of impairment: a strong odor of an alcoholic beverage emitting from Trevor's breath, he was unsteady on his feet, had bloodshot, watery eyes, slurred speech, and stated he had been drinking.

I became concerned Trevor was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances.

To dispel my concerns, I asked Trevor if he would participate in a series of standardized field sobriety exercises, to which he agreed. I asked Trevor a series of medical questions to ensure he could participate in field sobriety exercises. Trevor stated that he had no physical defects, was not sick or injured, did not have epilepsy or diabetes, did not wear contacts or glasses. [REDACTED] however, stated it would not prevent him from participating in the exercises

All field sobriety exercises were explained and demonstrated proficiently prior to Trevor beginning each exercise, and I confirmed Trevor understood the instructions prior to the start of each exercise.

The following exercises were performed:

- 1.) HORIZONTAL GAZE NYSTAGMUS - No resting nystagmus was observed. Equal pupil size and equal tracking was observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior 45-degrees was observed. Trevor had to be instructed multiple times to maintain the starting position as instructed, as well as, to follow the stimulus with his eyes.
- 2.) WALK AND TURN - A straight white parking space line was used for the exercise. When asked, Trevor agreed with me that the line was straight, flat, and clear of debris. Prior to the start of this exercise, I ensured Trevor understood all instructions, and provided a demonstration. While providing my demonstration, Trevor was unable to maintain the starting position, stepped off multiple times, and was unable to follow instructions. Trevor stated he understood all instructions, and was instructed to begin. Trevor demonstrated the following: stepped off the line, used arms to balance, missed heel-to-toe, incorrect turn, did not look at his feet.
- 3.) ONE LEG STAND - This exercise was explained, and demonstrated prior to Trevor beginning, to which

he stated he understood. For this exercise, Trevor chose his right foot. Trevor demonstrated the following: placed foot down, used his arms to balance, did not look at his raised foot, had to be reminded to count in the provided manner, hopped up and down, leaned forward at the waist to maintain balance. Trevor made it to 23 seconds which was counted by the stopwatch feature on my watch. Due to safety concerns, based on Trevor's inability to maintain balance, this exercise was concluded at 23 seconds.

Overall, Trevor performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on Thursday, August 8, 2025, Trevor was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance, and was impaired beyond his normal faculties, incapable of operating a vehicle safely.

Trevor was arrested for DUI at 2239 hours, and was advised of the charge. I took Trevor into custody without incident, and transported him to the Indian River County Jail for booking.

After I arrived at the jail, Deputy Sheriff Hiss advised me that Trevor refused to provide a breath sample.

It should also be noted that post Miranda, Trevor advised he had consumed three "Beat Box", and a Vodka red bull. It should also be noted that one container of Beatbox contains 11.1% alcohol volume, and two containers were located inside of the vehicle still cold to the touch with one being half empty.

Also located in the center console, was a clear cup, containing a light green color beverage which smelled of alcohol. When questioned post-Miranda, Trevor stated it was a vodka red bull from what he stated from approximately 2000 hours. Due to the multiple open containers, Trevor was issued a citation, AA04CFE, as he was in direct possession of them while operating a motor vehicle.

Based upon my investigation, I charged Trevor with the following:

Count 1: F.S.S. 316.193(1), Driving Under the Influence of Alcohol or Drugs. Citation#: AJ8SY1E.

NARRATIVE

On 8/7/2025 at approximately 2323 hours, while patrolling the area of 28th Ave and 45th St in my marked patrol vehicle.

I conducted a traffic stop on a red Chevrolet Cobalt bearing FL Tag #CG54RB for having a defective tag light (not visible within 50 feet).

Upon contact with the vehicle, the driver was later identified as Bryan Martinez. While speaking with Bryan I smelled the strong and distinct odor of an alcoholic beverage emitting from within the vehicle. I asked Bryan if he had any alcoholic drinks tonight, to which he advised he had roughly five tallboys of beer, Bryan's words were mumbled and slurred as he spoke to me.

I requested Bryan to step out of the vehicle and asked him if he was willing to perform field sobriety exercises to determine if he can safely operate a motor vehicle. Bryan agreed. Bryan also advised the vehicle was registered to his wife and he only has an ID Card and no valid license at this time. An electronic query of Bryan's license revealed he was suspended on 12/30/2024

While inquiring of Bryan's medical history, I observed his eyes were bloodshot and I could smell the strong and distinct odor of an alcoholic beverage emitting from his exhaled breath. Bryan advised he has no medical conditions or physical impairments that would limit his mobility. Bryan did advise he had slight pain in his right leg but it would not prohibit him from performing the exercises.

While explaining the Horizontal Gaze Nystagmus exercise, Bryan had trouble standing with his arms to his side and swayed while standing. Bryan advised he understood the directions before I conducted the exercise. During the exercise, he exhibited a lack of smooth pursuit in both eyes and on-set prior to 45 degrees in both eyes and maximum deviation in both eyes. Bryan showed six clues of impairment in total during the exercise.

While explaining the Walk and Turn exercise, Bryan started too soon, he then advised he understood the directions. Bryan was unable to maintain his balance while listening to the directions. While performing the exercise he stopped to regain his balance, he did not touch heel to toe, used his arms/hands for balance (more than six inches from his body), stepped off line multiple times and he turned incorrectly. When he got to the tenth step Bryan stood still for a prolonged period of time, I advised Bryan to continue with the exercise as instructed, he began to walk backwards thirteen steps. Bryan showed seven clues of impairment during this exercise.

After explaining and demonstrating the One Leg Stand Bryan advised he understood. While performing the exercise, Bryan swayed while balancing, Put his foot down multiple times and used his arms to balance (more than six inches from his body). Bryan showed three clues of impairment during the exercise.

At the conclusion of the exercises, I placed Bryan under arrest for driving under the influence and Driving

Bryan was transported to the Indian river county jail without further incident.

Bryan refused to provide a sample of his breath and was read implied consent by Corrections Deputy Hiss, to which Bryan refused once again.

Bryan was subsequently charged and cited for DUI and Driving with a suspended license knowingly.
