NARRATIVE

On May 1st, 2024, at 1515 hours, I responded to Adams St and Barber St, Sebastian, FL, in reference to a DUI.

Upon arrival, I made contact with Deputy Kane, who advised he observed a silver Mitsubishi Outlander, failing to maintain the lane three times. After conducting a traffic stop, he made contact with Heather Quigley and observed signs of impairment. Deputy Kane advised Heather mentioned she took Xanax earlier in the day.

I then spoke with Heather and asked if she would submit to field sobriety exercises, she stated that she would.

She stated that she does not wear contacts or glasses. All field sobriety exercises were explained and demonstrated proficiently prior to Heather beginning each exercise and I confirmed she understood the instructions prior to the start of each exercise. The following exercises were performed:

- 1.) Horizontal Gaze Nystagmus - No resting nystagmus was observed. Equal pupil size and equal tracking was observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed; the onset of nystagmus prior 45-degrees was observed. Heather was not able to follow with her eyes only and was moving her head to follow the stimulus. Heather was also visibly unsteady on her feet.
- 2.) Walk and Turn - A yellow lane indicator was used for the exercise. During the instructional phase, Heather was unable to maintain her balance. On the first nine steps, Heather missed heel to toe on several steps and used her arms to balance. On the second nine steps, she stepped off the line, stopped to balance herself, and used her arms to balance and again missed heel to toe on several steps.
- 3.) One leg stand- I gave Heather clear instructions on the exercise. Once Heather was given the command to start, she did not count in the manner explained during the instructional phase through the whole exercise. Heather held up the leg of her choosing and stopped at 12 seconds, I continued to observed until the 30 seconds was completed.

At the jail, Detention Deputy Holiday requested Heather to submit to a lawful test of his breath for the purpose of determining its alcohol content. A lawful test of the Heather's breath was obtained using an Intoxilyzer 8000 to determine its alcohol content. The results were .082 BrAC and .080 BrAC.

Based upon the above, I charged Heather with the following:

F.S.S. 316.193(1) – DUI impairment and issued citation AJ8SU1E.

PROBABLE CAUSE STATEMENT

On 5/1/2024 I was in the area of the 1400 block of US Highway 1 when I was dispatched to a drunk driver call with the vehicle leaving 1405 Indian River Drive (Earl's Hideaway) heading north on US Highway 1. The caller stated a white Subaru with a New Jersey tag was being operated by a white female with a white shirt and jeans. I saw two vehicles traveling north approaching Jackson Street, one of them to be a white Subaru SUV bearing New York Tag LDM5788. I was able to finally catch up to the vehicle at Roseland Road and US Highway 1.

The vehicle turned left onto Roseland Road from US Highway 1. In doing so, the vehicle did not turn into the immediate left lane instead turning into the right lane of the roadway. While following the vehicle approaching the railroad tracks, the vehicle made a last minute merge in order to get into the correct lane as the right lane was ending. The vehicle accelerated to what I estimated to be 50 mph in a posted 35 zone due to my speedometer reading 45 mph and the vehicle gaining distance from me however I was unable to activate my radar in time to confirm the speed. Prior to the tracks, the vehicle crossed over the right fog line and returned back onto the roadway. After the railroad tracks, the vehicle then slowed down to 40 mph and accelerated back up to 45 mph in the 35 mph zone. This was confirmed by my front radar antenna in SPD Patrol Unit 41. While doing so, the vehicle crossed over the right fog line a few more times. It was evident the operator was struggling to perform the multitasking that is required for normal driving. Based on the totality of the circumstances, I conducted a traffic stop on the vehicle.

I made contact with the driver and sole occupant, Kimberly Aikey identified via Florida Driver License, who was wearing a white shirt and jeans as described by the caller. I asked Kimberly for her driver license and explained my observations and reasoning for the traffic stop. While retrieving her license, Kimberly had very slow movements. Kimberly appeared to have glossy eyes and droopy eyelids and seemed to have difficulty keeping her eyes open. There was a heavy odor of alcoholic beverage emitting from the vehicle and Kimberly slurred her words. Kimberly stated she was coming from a friend's house which was not true due to a witness observing her leaving a drinking establishment. Based on the above mentioned facts I asked Kimberly to exit the vehicle with the intention of continuing a dui investigation.

Kimberly refused to exit the vehicle and asked if she was being arrested. I again told Kimberly to exit the vehicle which she did not comply with. Kimberly became argumentative while still being seated inside of the vehicle which was still running. I instructed Kimberly to open the door after I attempted to pull the handle and it did not open. Kimberly reached for the inside door handle however hovered her hand over it not opening the door. I opened the door from the inside and grabbed hold on Kimberly's left arm and extracted her from the vehicle pressing her up to the driver door. Once at the driver door I placed her arms behind her back and she immediately tensed up her arms. Kimberly was arrested for resisting arrest and was transported to IRC Jail. It should be noted Kimberly was very talkative and while outside of the vehicle, there was a strong odor of alcoholic beverage emitting from her breath as she spoke.

Prior to departing the traffic stop location, I spoke with the caller/witness Justin Dipentima. Justin stated he saw a couple leaving the bar, a male and a female (Kimberly), and observed her to be visibly intoxicated. Justin described Kimberly as stumbling to her vehicle, and yelling obscenities while doing so.

At the jail I requested Kimberly submit to field sobriety exercises which she agreed to at first but then declined to do. I explained to Kimberly I would make an arrest decision for driving under the influence based on all my previous observations which she still declined to submit to sobriety exercises. Based on my observations I believe Kimberly to be under the influence of an alcoholic beverage or chemical substance to the extent that her normal faculties are impaired. Kimberly also declined to provide any lawful breath samples to determine its alcohol content.

Kimberly was charged with Driving Under the Influence and Resisting Arrest without Violence and left in the custody of the jail staff.

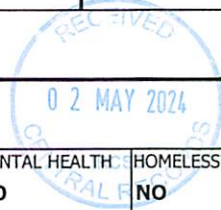

On 05/01/2024, at 21:50 (Specifically include facts constituting cause for arrest.)

On May 1st, 2024, at approximately 2057 hours, I responded to the area of Sebastian Blvd (CR 512) and Easy St in reference to a reckless driver. Dispatch advised the caller stated a white Jeep Grand Cherokee bearing FL tag KWAB94 was swerving in and out of lanes heading westbound on Sebastian Blvd.
