NARRATIVE

On Tuesday, June 2, 2026, at approximately 0301 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the intersection of Old Dixie Highway SE and Highland Drive SE, Vero Beach, Indian River County, Florida.

Prior to the traffic stop, I observed a gray Dodge Ram traveling eastbound on 21st Street SE near 1st Avenue SE. As the vehicle passed across my headlights, I was unable to see within the vehicle, leaving me to believe that the window tint was too dark on the vehicle. As I got behind the vehicle, we approached the intersection of 21st Street SE and Old Dixie Highway SE. The vehicle failed to stop prior to crossing the stop bar, resulting in both front tires to be in front of the stop bar upon the vehicle coming to a full and complete stop.

As I was calling out the traffic stop, the driver of the vehicle originally turned on their turn signal to make a right, but as I approached closer to them, they changed and indicated they were going to make a left turn. We approached the next intersection at Old Dixie Highway and Highland Drive. The vehicle indicated again using their turn signal that they were going to make a right turn. The driver turned this turn signal off and proceeded straight through the intersection. They then entered in to the 7-11 parking lot at the intersection. I activated my blue emergency lights on the vehicle. The driver was slow to pull over and stop, as they continued driving through the parking lot, eventually stopping at the front of the store.

I made contact with the driver, who identified herself as Ms. Lorraine Davis, by her Florida driver's license. While waiting for Ms. Davis to provide her insurance card on her Progressive app, I requested consent so that another deputy on scene could search the vehicle. Ms. David provided verbal consent to search the vehicle. The passenger, Mr. Curtis Chambliss, was removed from the vehicle.

While still waiting on insurance information, Deputy R.T. Williams conducted a consent search of the vehicle. During this time, he located a small plastic baggie that he suspected to be either cocaine or methamphetamine on the passenger side seat, right where Mr. Chambliss was sitting. This bag later field tested to be presumptive positive as methamphetamine and weighed approximately 0.01 grams.

I then conducted a probable cause search of Mr. Chambliss. Within his right pocket was a glass pipe which contained a white crystalized residue within it, consistent with being drug paraphernalia. He was then secured in handcuff restraints and secured in a patrol vehicle. As Deputy Edgar was placing Mr. Chambliss in to a patrol vehicle, Mr. Chambliss spontaneously stated "its mine, its all mine".

Deputy Williams continued searching the vehicle. He also discovered a clear plastic bag that contained large methamphetamine shards near the cupholder area, between the driver and passenger seats.

I advised Mr. Chambliss of his Miranda Rights. He advised he confirmed his rights and was willing to speak to me. Mr. Chambliss confirmed that I located a "bubble" in his pocket but it belonged to his son. He picked it up earlier when he visited him and took it because he did not want him to have it. He denied ownership or possession of any of the narcotics found within the vehicle. Mr. Chambliss did confirm that he does have an addiction to

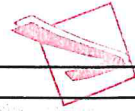

NARRATIVE

On Tuesday, June 2, 2026, at approximately 0301 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the intersection of Old Dixie Highway SE and Highland Drive SE, Vero Beach, Indian River County, Florida.

Prior to the traffic stop, I observed a gray Dodge Ram traveling eastbound on 21<sup>st</sup> Street SE near 1<sup>st</sup> Avenue SE. As the vehicle passed across my headlights, I was unable to see within the vehicle, leaving me to believe that the window tint was too dark on the vehicle. As I got behind the vehicle, we approached the intersection of 21<sup>st</sup> Street SE and Old Dixie Highway SE. The vehicle failed to stop prior to crossing the stop bar, resulting in both front tires to be in front of the stop bar upon the vehicle coming to a full and complete stop.

As I was calling out the traffic stop, the driver of the vehicle originally turned on their turn signal to make a right, but as I approached closer to them, they changed and indicated they were going to make a left turn. We approached the next intersection at Old Dixie Highway and Highland Drive. The vehicle indicated again using their turn signal that they were going to make a right turn. The driver turned this turn signal off and proceeded straight through the intersection. They then entered in to the 7-11 parking lot at the intersection. I activated my blue emergency lights on the vehicle. The driver was slow to pull over and stop, as they continued driving through the parking lot, eventually stopping at the front of the store.

I made contact with the driver, who identified herself as Ms. Lorraine Davis, by her Florida driver's license. While waiting for Ms. Davis to provide her insurance card on her Progressive app, I requested consent so that another deputy on scene could search the vehicle. Ms. David provided verbal consent to search the vehicle. The passenger, Mr. Curtis Chambliss, was removed from the vehicle.

While still waiting on insurance information, Deputy R.T. Williams conducted a consent search of the vehicle. During this time, he located a small plastic baggie that he suspected to be either cocaine or methamphetamine on the passenger side seat, right where Mr. Chambliss was sitting. This bag later field tested to be presumptive positive as methamphetamine and weighed approximately 0.01 grams.

Deputy Williams continued searching the vehicle. He also discovered a clear plastic bag that contained large methamphetamine shards near the cupholder area, between the driver and passenger seats.

Deputy Williams also discovered a pill bottle for a subject named Kylv Davis within Ms. Davis's nurse [REDACTED]

[REDACTED] According to Drugs.com, this is a drug that can only be possessed by prescription only.

I spoke to Ms. Davis next. She was advised of her Miranda Rights. She stated that she understood her rights and was willing to speak to me. She confirmed that she took Mr. Chambliss out to see a friend, but did not take him to see his son like he stated. She knows that he carries around a "bubble" on him all the time, and know that he has an

issue with "ice" (aka methamphetamine). Ms. Davis knows that he normally carries it in a clear plastic bag like we found, and will take from that bag as he uses the methamphetamine. Ms. Davis denied any ownership of the methamphetamine located within the vehicle. She did advise that the [REDACTED] located within the vehicle belongs to her son, but she uses the medication instead of him. She uses his medication because his is older and would rather use the older medication before using hers, that way she can have a longer supply.

I then searched Ms. Davis's wallet, that she had placed on the hood of my vehicle upon her being detained. Within the wallet, was a small plastic bag that contained shards of methamphetamine. There was less than one gram of methamphetamine located within her wallet. Within the same section was an old Florida drivers license for Ms. Davis as well as an old Port St. Lucie PD Bank identification card.

NARRATIVE

On Tuesday, June 2, 2026, I was dispatched to 7-11, 4150 9th ST SW, in reference to a disturbance EMS needed.

Dispatch stated the caller, Jameria Bryant, was reporting that her boyfriend, Deondravious St Fleur, had hit her multiple times and she was currently in the vehicle with him. They were traveling west bound on Oslo Road from 7-11 in a black Honda Accord. While enroute to the incident, Deondravious turned east bound on Oslo Road and began to travel to 856 18th Street SW. Jameria continued to update dispatch with her location. Deputy Caperton arrived to 856 18th Street SW, and located both Jameria and Deondravious.

When I arrived on scene, Deputy Caperton had Deondravious secured in mechanical restraints. I met Jameria by Deputy Caperton's patrol vehicle and asked her to explain to me what happened. Jameria stated the following: On today's date, just prior to her calling for law enforcement assistance, Deondravious was taking her to work. This morning, around 0300 hours, Deondravious arrived to her home at [REDACTED]. They spent the night together and Deondravious agreed to take her to work. While on the way to work, Deondravious brought up a text she had received from another male earlier in the morning. Jameria became defensive because due to them not dating, she did not believe Deondravious had a right to question who was texting her. Jameria showed me the texts messages between her and the other male that occurred around 0700 hours on today's date. After a verbal argument, Deondravious struck her twice with his left hand, closed fist. As a response, Jameria pushed Deondravious away several times. Deondravious then pulled into the 7-11 parking lot and that's when she called for law enforcement. Jameria stated she never attempted to get out of the car nor did Deondravious tell her to get out of the car. I asked Jameria to show me her injuries. Jameria pointed out a hematoma (egg size) on her forehead. She also stated Deondravious had hit her on the left side of her face. I did not observe any color change but did observe possible minor swelling. Indian River County Fire Rescue responded and ultimately Jameria declined to be transported to hospital.

It should be noted, per Jameria, her and Deondravious have had an [REDACTED]. There most recent breakup was just a few months ago and [REDACTED].

[REDACTED] Jameria stated that though they are not officially dating anymore, [REDACTED] Jameria explained in the past there has been several incidents where Deondravious has hit her, choked her and even has caused her such injury she had to get stitches to her face.

I then responded over to Deputy Caperton and Deondravious. Deputy Caperton stated Deondravious had been read his Miranda Right's and had agreed to speak to law enforcement. Deondravious stated that he arrived to Jameria's house around 0330 hours this morning and they have an [REDACTED]. While taking Jameria to work, she became upset over a diaper being on his dashboard. Deondravious stated that the diaper was none of Jameria business due to them not actively being together. A verbal argument occurred and then Jameria struck him with a closed fist 3-6 times while he was driving, and also hit his windshield causing a crack. That's when he pulled into the 7-11 parking lot and told Deondravious to get out of the vehicle. Deondravious denied ever touching Jameria and stated he did not have any injuries to report. Deondravious stated that him and Jameria did [REDACTED]. However, Jameria had him removed due to not being on the lease. Deondravious also stated that [REDACTED] but then changed his statement later on to him and Jameria had never live together.

Based on my investigation, I developed probable cause to charge Deondravious with violating FSS. 784.03 Battery,

NARRATIVE

On June 2<sup>nd</sup>, 2026, at approximately 2120 hours, I was traveling northbound on US Highway 1 from 85<sup>th</sup> Street, Sebastian, Florida.

At that time, I witnessed a white Buick station wagon (bearing IN tag 774RPG) pass me at a high rate of speed – I visually estimated the vehicle to be traveling at 70 miles an hour in a 45 mile an hour zone. As the white Buick passed in me in the right lane, the vehicle was unable to maintain a single lane and crossed the dotted white line and the solid white line numerous times. The vehicle then began completely traveling in the bike lane. The white Buick continued swerving while traveling northbound on US Highway 1.

Based on my observations, I conducted a traffic stop on the white Buick in the area of 9300 US Highway 1, Sebastian. I made contact with the driver, and sole occupant, Ms. Christa Martini, who I identified by her Florida-issued driver's license. While speaking with Ms. Martini, I observed that she had glassy eyes and constricted pupils. Ms. Martini stated she had been drinking Michelob Ultras earlier in the day and she was headed home from playing pickleball. She also stated the reason for her erratic driving was because she dropped her phone.

Additionally, as I conducted my traffic stop, Homeland Security Investigator J. Obrien, ID# S12860, also arrived on scene in an unmarked patrol vehicle. Investigator J. Obrien advised he had been traveling behind the white Buick from around 4500 US Highway 1, Vero Beach. He explained that the he was stopped at the light at 45<sup>th</sup> Street and US Highway 1 and the white Buick almost struck his vehicle, then stopped in the middle of the intersection. He stated the vehicle then continued northbound at a high rate of speed, almost striking other vehicles and guardrails.

I subsequently requested Ms. Martini perform Standardized Field Sobriety Exercises (SFSE's), and she stated she would. During the medical questionnaire, Ms. Martini stated she takes [REDACTED] and she last took it at approximately 0800 hours today.

The first exercise was the Horizontal Gaze Nystagmus (HGN) exercise. I explained the instructions for the exercise, and Ms. Martini stated she understood. During the exercise, Ms. Martini had a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes.

The next exercise, was the Walk and Turn (WAT) exercise. After I explained the instructions and demonstrated the exercise, Ms. Martini stated she understood the exercise and did not have any questions. During the exercise, Ms. Martini made an incorrect turn, used her arms for balance, and took the wrong number of steps.

The third exercise was the One Leg Stand (OLS) exercise. I explained the instructions and demonstrated it for Ms. Martini. She stated she understood and did not have any questions. During the exercise, I did not observe any clues.

The fourth exercise was the Modified Romberg Balance exercise. I explained the instructions for Ms. Martini and she stated she understood and did not have any questions. During the exercise, Ms. Martini estimated 30 seconds had elapsed after approximately 36 seconds.




**NARRATIVE**

On 6/2/2026, I responded to 5875 20<sup>th</sup> St, which is a location within Indian River County, FL, in reference to a Disturbance. Prior to arrival, Dispatch advised that a physical disturbance was taking place inside of the location.

Upon arrival, I located the Victim, Stephen Colona, who stated he was punched in the face. I then physically observed injuries to Stephen's face and he then pointed toward the Defendant, who was just outside of the door to the business. The Defendant, later identified as Chad Hartwig, was then detained.

Stephen Colona stated he left his girlfriend at the table for a short period of time and when he returned, he observed a personal bag sitting in the chair where he previously sat. He stated he asked the Defendant if he could move his bag, to which the Defendant responded by grabbing the bag and throwing it over a table. Stephen stated there were additional belongings still on the table so he asked the Defendant if he could remove the remaining items. He stated the Defendant then punched him with a closed fist with his right hand which then connected with the front of his face on his lip. Stephen stated he then located an employee to then contact the police. Stephen was unable to complete a written statement.

I physically observed fresh blood on Stephen's top lip as well as some bleeding from a maxillary incisor. I then took photographs of Stephen as well as his injuries.

I then collected a sworn statement from Stephen's girlfriend, Jannie Easling, who stated that she physically observed Chad pick up a bag from her table and throw it on another table. She stated the Defendant then punched Stephen with his right hand and a closed fist in the mouth.

I attempted to obtain a statement from the Defendant but he declined to speak without a lawyer present.

Video surveillance footage of the incident may be available but was not accessible at the time of arrest.

Based on the above stated facts, the fact that the injuries to Stephen were consistent with his and Jannie's statement, there is probable cause to believe the Defendant committed Simple Battery, which is a violation of FSS 784.04.

NARRATIVE

On June 2, 2026, at approximately 2230 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I met with Ms. Karina Cruz Guevara who stated the following: She was watching a movie, with her husband, Mr. Eduin Ayala Ramos. She went upstairs to their children's room. Eduin came upstairs a few moments later and was very angry as he thought Karina was talking on the phone to another man. Eduin and Karina went to their bedroom and were verbally arguing. Eduin pushed Karina onto the bed. Karina acted out the push and she motioned that Eduin used the back of his arm to intentionally push her onto the bed, and did not simply push past her. Eduin began breaking things around the room. Eduin left the residence and Karina [REDACTED]

Karina did not have any physical injuries and declined needing any medical attention. She confirmed Eduin is her husband and [REDACTED] There was a large mirror broken in the bedroom and adjoining hallway as well as other items scattered around the bedroom.

Eduin's vehicle tag information was put out over the radio, and Deputies located the vehicle near Highway A1A and Cypress Street. Eduin was detained and transported back to the residence.

In a post-Miranda interview, Eduin stated the following: He corroborated Karina's story regarding the initiation of the verbal argument. Eduin stated while in the bedroom he pushed Karina, and she pushed him back. I asked if Karina took any sort of aggressive posturing or touched him to warrant Eduin pushing her first, and he replied no. Eduin confirmed he broke several items in the bedroom and left the residence. Eduin stated he acted out because he was angry he heard Karina talking to another man.

Based on these circumstances, I found probable cause to arrest Eduin for battery – domestic violence in accordance with FSS 784.03.1a1. I determined Eduin was the primary aggressor as he stated he pushed Karina first.

NARRATIVE

On Wednesday June 3, 2026 at approximately 0052 hours, I responded to 1190 37<sup>th</sup> Street, Vero Beach (BHC) in reference to a disturbance.

Upon arrival I met with a hospital security employee, Carl Bess who stated the following:

Bess stated at approximately 0000 hours of today's date, Robert Matticks was brought to the facility for evaluation. Bess said at approximately 0040 hours Matticks began to scream at the health care providers because he believed he wasn't given the correct medication. Bess told me he attempted to calm Matticks down, but Matticks's aggression progressively grew stronger to the point where Matticks assumed a fighting stance with his hands curled into fists. Bess stated when he went to apprehend Matticks; Matticks threw a punch which impacted his right shoulder. Bess told me while the altercation was taking place another healthcare provider, Philip Tinor stepped in to help restrain Matticks in which Matticks spits on the left side of Tinor's torso. Bess denied needing medical attention.

I then spoke with health care provider, Philip Tinor who stated the following:

Tinor stated when he saw Matticks assume a fighting stance while Bess was trying to apprehend him, he rushed to help. Tinor told me while trying to restrain Matticks; Matticks turned towards him and spit on him, impacting the left side of his torso. Tinor told me he repeatedly told Matticks to not spit on him, but Matticks proceeded to do so anyways. Tinor denied needing medical attention.

I then met with Robert Matticks who stated the following:

Matticks who was read his Miranda Rights, but proceeded to speak with me stated he came to the hospital to get help. Matticks said the health care providers repeatedly tried to give him the wrong medication which caused him to get irate. Matticks told me when he saw Bess walking up to him, he stood up because he felt uncomfortable. Matticks stated he didn't throw a punch nor spit on Tinor.

Deputy C.Scott was provided video of the incident which showed Matticks get into a fighting stance and intentionally punch Bess on his shoulder as well as intentionally spit on Tinor.

Matticks was charged with two counts of FSS (784.07(1)c) Battery against medical care provider.

Matticks was placed under arrest then transported to the Indian River County Jail without incident.

This interaction was captured with agency issued BWC.
