NARRATIVE

On June 6, 2026, at approximately 0237 hours, the Indian River County Sheriff's Office Communications Center (Dispatch) broadcast a BOLO (Be on the Lookout) for a 2016 black Toyota RAV4 bearing Florida license plate PXUT04 that had fled from the Sebastian Police Department. Dispatch advised Sebastian Police Department had probable cause for Reckless Driving and Failure to Stop.

At approximately 0252 hours, I, Deputy M. Mangel #5949, observed the suspect vehicle traveling northbound on U.S. Highway 1 near Roseland Road and identified it as the vehicle involved in the BOLO. Knowing Sebastian Police Department already had probable cause to stop the vehicle, I initiated a traffic stop in my marked Indian River County Sheriff's Office patrol vehicle displaying agency insignia and jurisdictional markings by activating my emergency lights and siren. The driver failed to stop and continued northbound into Brevard County. Pursuant to supervisory direction, the pursuit was terminated.

A short time later, the vehicle re-entered Indian River County traveling southbound. Corporal Ron Thomas #6288 successfully deployed stop sticks, which the vehicle struck. Despite its tires being deflated, the driver continued to flee. Deputy Jason Pollacek #5866 then attempted a traffic stop in his marked patrol vehicle with activated emergency lights and siren; however, the driver again refused to stop. The vehicle was ultimately stopped after Deputy Pollacek successfully executed a PIT (Precision Immobilization Technique) maneuver.

The female driver, later identified as Kelly Cryns (DOB:07-07-1975), exited the vehicle and attempted to flee on foot but was quickly apprehended.

Based on the foregoing, probable cause exists that the defendant committed the offense of Fleeing or Attempting to Elude a Law Enforcement Officer, in violation of Florida Statute 316.1935(2), by knowingly and willfully failing to stop for clearly marked law enforcement vehicles displaying activated emergency lights and sirens.

Additionally, by exiting the vehicle and attempting to flee on foot while deputies were engaged in the lawful execution of their duties, the defendant knowingly and willfully resisted, obstructed, or opposed law enforcement officers without violence. Therefore, probable cause exists for Resisting an Officer Without Violence, in violation of Florida Statute 843.02.

Ms. Cryns was transported to the Indian River County Jail and booked in on aforementioned charges. Her car was towed by CJ's towing. Sebastian Police Department also booked her on charges that occurred in their jurisdiction (Flee and Elude).

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 06/10/2026 , at 02:21 (Specifically include facts constituting cause for arrest.)

On Wednesday, June 10, 2026, at approximately 0221 hours, I responded to 700 US Highway 1, Sebastian, FL 32958 (Speedway) for a call reference road rage. While en route, dispatch advised that the complainant was driving a tan sedan and was stating that the other driver was using their vehicle to prevent them from leaving the property.



When turning on the property, I observed a black SUV pull in front of a tan sedan, causing the vehicle to stop in its place slamming on their brakes. The tan sedan then attempted to turn away from the black SUV. When the tan sedan turned, the black SUV pulled forward, causing the tan sedan to slam on its brakes. At this time, i observed the vehicle operating in a careless manner and attempted to conduct a traffic stop on the vehicle.

Once I turned onto the property from the south entrance, I activated my emergency lights, attempting to get the vehicle to stop however, the black SUV drove around the sedan and drove up to my vehicle, accelerating. At this time, I activated my emergency siren. I observed a white female driver with blonde hair, approximately 50 years of age with a black shirt on.

The Black SUV then proceeded past my vehicle, running through the stop sign of the property and of Indian River Drive before traveling west on Indian River Drive to the intersection of US highway 1 and Indian River Dr. The Black SUV then proceeded North on US Highway 1 before turning back into the Speedway parking lot. Hitting a curb of the parking lot before making a U-Turn back onto US Highway 1. When the vehicle turned onto US Highway 1, it accelerated forward, causing its tires to spin in what is commonly referred to as a burn out.

At this time,

I advised other responding Officers that the black SUV had fled the scene.

Officer Fillipi responded and continued the pursuit of the vehicle with his emergency lights and sirens activated. Officer Fillipi advised the vehicle was a black Toyota SUV bearing Florida Tag PXUT04. Officer Fillipi advised that the vehicle was not yielding to him and was continuing North on US Highway 1.

Officer Antosia stationed himself at the intersection of US Highway 1 and Main Street, setting up a roadblock. When the vehicle approached the roadblock, it drove onto the bike lane to move around Officer Antosia's vehicle. Officers continued the pursuit northbound on US Highway 1 until the intersection of Roseland Road.

Once at the intersection of Roseland Road, the vehicle turned west onto Roseland. At this time, officers called off the pursuit of the vehicle.

At approximately 0317 hours, Indian River County Sheriff's Department Deputies advised they were pursuing the vehicle and had performed a PIT Maneuver on the vehicle on the bridge near the 14000 block of US Highway 1. I responded to the scene and positively identified the driver as the vehicle that had fled from Officers prior.

The driver was identified through her Florida Driver's License as Kelly Cryns, the vehicle's registered owner.

Kelly was placed under arrest by the Indian River County Sheriff's Department and transported to the Indian River County Jail without incident.

Kelly did not yield to my marked patrol vehicle with emergency lights and siren active at Speedway. Kelly continued to flee from Officers in marked patrol vehicles with emergency lights and sirens activated from US Highway 1 to Roseland Road, approximately 8.5 miles from where the stop was initiated. For these facts and circumstances, I am charging Kelly with Fleeing and eluding Law Enforcement with lights and sirens activated (FSS 316.1935 (2)).

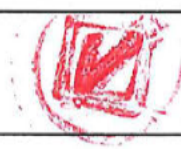

On June 8th, 2026, at approximately 0930 hours, I was assigned as the Indian River County Sheriff's Office Sexual Offender/Predator Tracking Detective.

On the above date and time, I was reviewing the "transient check-in" overdue log that is generated by the Florida Department of Law Enforcement Sexual Offender Predator System (SOPS). Upon review of the log, I noticed transient sexual offender Mark Hadden, date of birth March 6th, 1968, was overdue for his "transient check-in". Mark Hadden is a sexual offender and qualifies under Florida Statute 943.0435. Hadden was adjudicated guilty in 1998 for Attempted Lewd or Lascivious Indecent Act (F.S.S. 800.04). Hadden has also been adjudicated guilty of Failure of a sex offender to report a name or residence change (2007) and a failure of a sex offender to report an email address or internet identifier (2019).

Hadden is a transient offender, residing at two transient locations in Indian River County at 2065 U.S. Highway 1 Vero Beach, Florida 32962 and also near 1316 23rd Place Southwest, Vero Beach, Florida 32962. As a transient sexual offender, Hadden is required to report in person on or before every 30 days for a transient check-in per Florida law.

to the St. Lucie County Jail, the Okeechobee County Jail and the Brevard County Jail. Hadden was not an inmate at any jail. Hadden's FDLE SOPS profile was not updated to reflect any incarcerations. I attempted to make contact with Hadden via his FDLE SOPS registered phone numbers: 772-258-6083, 772-677-4414, 305-834-2733 and 772-801-4967. A Voicemail was left on the 4967 number urging Hadden to call me. The 2733 number was out of service. When calling the 4414 number, an unknown female stated I had the wrong number. I was unable to leave a voicemail on the 6083 phone number.

I then reviewed the body camera footage from the last transient check in from Hadden that occurred on May 8th, 2026. Hadden did not request an appointment for his next 30 day transient check-in. Specialist Vargas did recall that Hadden possibly made his appointment for 1000 hours on Friday June 5th, 2026 after the transient check in was completed and the body camera was deactivated.

Hadden was read his Miranda rights and told us he was "done" speaking with us but continued to converse with both me and Specialist Vargas. I offered Hadden a chance to provide us with the business card and show me on his phone when he called the Sheriff's Office. Hadden stated he had two phones and only one on him and refused to show me any calls to the Sheriff's Office.

Specialist Vargas informed me that his call logs only went back to May 13th. Furthermore, Specialist Vargas was adamant that he would not schedule a transient check in past 30 days, only on the 30 day mark or beforehand due to his sexual predator and offender training and experience. I informed Hadden that I made attempted phone calls to all of his registered phone numbers on Monday (June 8th, 2026). Hadden denied receiving any phone calls from me. Hadden provided me with an older Sheriff's Office business card with the date of "Friday June 10th at 10am" handwritten on blue ink on it. Hadden informed me that he wrote down the date after confirming it with Specialist Vargas in a phone call after his appointment on May 8th, 2026. Another date was handwritten on the card in black ink that read as follows: "Friday May 08 2026 @ 10AM". It should be noted that this is 33 days and not 30 days.

I then once again watched Hadden's May 8th, 2026 transient registration video. Hadden does not enquire about his next transient registration and leaves the building.

It should be noted that on Hadden's last transient check in on May 8th, 2026 he did not sign the form stipulation that he must check in within 30 days as the signature device was not working. The male was detained and read his Miranda warnings from my agency issued warning card. The male was identified with a Florida ID card as Allen M. Willoughby DOB: 12/05/1982. Willoughby stated that he understood his rights and was willing to speak with me. Willoughby stated that he entered the store with a friend and gathered tools for a job he was going to work. Willoughby stated that he thought his friend told him the items were already paid for and so he left the store. Willoughby stated that he was confronted by someone who stated that he was lost prevention for the store and he left without paying for the items himself. Willoughby then left the items and began to leave the property.

I then, made contact with the caller of the Home Depot store lost prevention personnel named Keith A. Weinberg DOB: 11/07/1972. Weinberg showed me camera footage inside the store of the incident. On in store camera footage it can be seen that Willoughby enters the store with another male. Willoughby takes a shopping cart and puts a Dewalt portable power unit priced at \$209.00 USD, a Dewalt 6 gallon and 1 tool combo kit priced at \$239.00 USD, and a Milwaukee M18 wet/dry vacuum priced at \$199.00 USD into the cart. At 1600 hours, it can be seen that Willoughby was not near the second person he walked into the store, and is seen walking past all registers into the front customer loading dock exit without making any effort to pay for the items. Willoughby was stopped by Weinberg who informed him that law enforcement was made aware and was on the way. Willoughby is seen leaving the items as he walks through the parking lot, until law enforcement make's contact with him.

Due to the totality of the circumstances, that Allen M. Willoughby DOB: 12/05/1982, is seen by witnesses and captured on in store camera footage taking possession of and carried away merchandise from the Home Depot store who is a merchant. Willoughby did so with the intent to deprive the merchant of possession, use, benefit, or full retail value of the merchandise by bypassing all points of sale without giving any good effort to pay for any of the items in his possession. Willoughby was placed under arrest for FSS 812.015 Retail Theft/Shoplifting misdemeanor with a \$150.00 USD bond.

NARRATIVE

On June 10th, 2026, at approximately 2110 hours, I was patrolling the 6700 block of 20th Street, Vero Beach, Florida, when I observed a white Ford F-150 displaying an obscured and defaced license plate, making it unreadable from 50 feet as required by F.S.S. 316.605(1).

As I positioned my patrol vehicle behind the F-150, I observed it turn into the mall area. I parked in a parking lot located west of where the vehicle had turned and subsequently observed it re-enter westbound 20th Street.

I then conducted a traffic stop and made contact with the driver, later identified as Perry Leon Morgan. I explained the reason for the stop and requested his driver's license, vehicle registration, and proof of insurance. Morgan was unable to provide proof of insurance or an up-to-date vehicle registration. I instructed him to continue searching for the documents while I returned to my patrol vehicle.

While continuing my investigation, I closely inspected the license plate and determined it to be Florida tag AV89MP. A query through D.A.V.I.D. revealed the registration had expired on August 2nd, 2025, and that no insurance was on file for the vehicle.

I then re-contacted Morgan and asked whether he had located proof of insurance. Morgan stated that he had not. When informed that no insurance was listed on file for the vehicle, Morgan stated that he believed insurance coverage on another vehicle would also cover the pickup truck. Morgan further advised that the vehicle remained registered to his father, who had passed away approximately two years earlier, and acknowledged that he needed to correct the registration and obtain insurance for the vehicle.

A further query through D.A.V.I.D. revealed that the insurance policy associated with the vehicle in question had been canceled. The query also showed that Morgan had only two trailers registered in his name and no insurance history associated with the pickup truck or any other vehicles.

Based on the totality of the circumstances. Morgan was removed from the vehicle and taken into custody. A search incident to arrest revealed a small clear plastic baggie containing a green leafy substance, which I recognized through my training and experience to be marijuana. The baggie was located in Morgan's left pants pocket. A query through Indian River County Public Safety Dispatch revealed that Morgan did not possess a valid medical marijuana card. Morgan was subsequently transported to the Indian River County Jail and charged with the following:

- Possession of Marijuana Less Than 20 Grams, in violation of F.S. 893.13(6)(b), Florida Statutes.
- Failure of Owner to Maintain Required Security, in violation of F.S. 324.221(2), Florida Statutes.

NARRATIVE

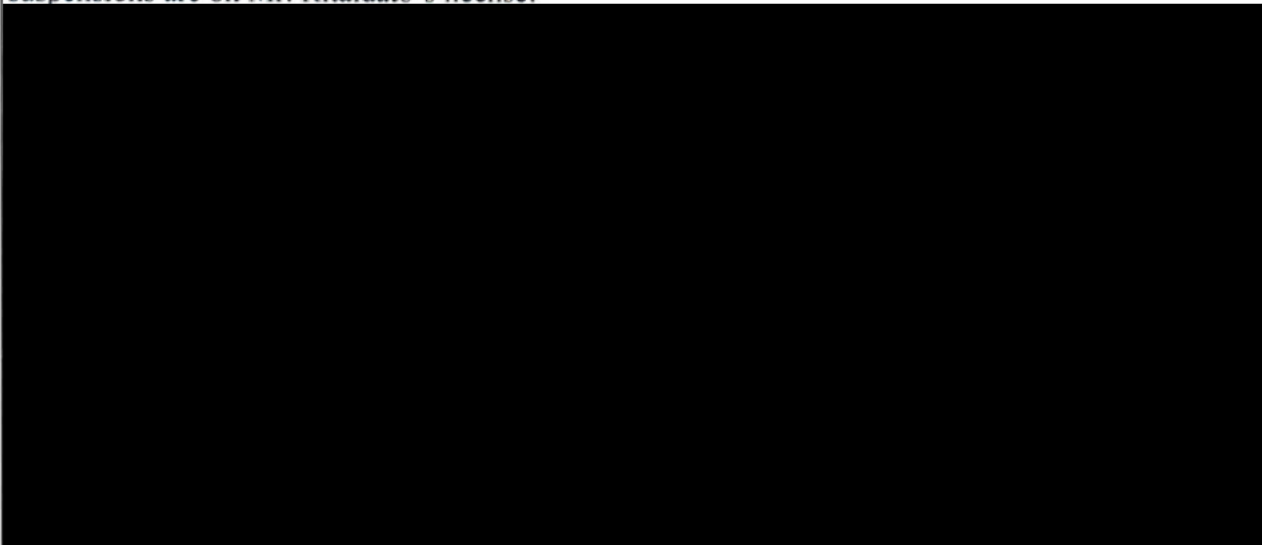
On Wednesday, June 10, 2026, at approximately 2108 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the 1100 block of 18th Avenue SW, Vero Beach, Indian River County, Florida.

Prior to the traffic stop, I was observing the BP gas station at 1999 9th Street SW. A Silver Nissan Altima was exiting the gas station. The vehicle failed to come to a complete stop prior to entering the roadway.

After calling out the traffic stop, I activated my blue lights to stop the vehicle. After doing so, the driver started making furtive movement within the vehicle. As the vehicle was making a right turn, the driver handed something to the backseat passenger. This was observed through the back window that was not tinted. The female in the back seat can then be seen moving more. The actions by the driver resulted in the driver running over a curb and nearly damaging the vehicle.

I made contact with the driver, who was later identified as Mr. Anthony Ritaldato. Upon asking him for his driver's license, he was very nervous and shaking. Mr. Ritaldato presented his Florida ID card.

once another unit arrived on scene, I removed Mr. Ritaldato from the vehicle. He was detained in handcuff restraints. I then check in FCIC/FCIC to ensure that Mr. Ritaldato still did not have a valid license. The following suspensions are on Mr. Ritaldato's license:



Mr. Ritaldato was then placed under arrest. He was secured in the back seat of my patrol vehicle.

While speaking to the other occupants, I could smell the odor of burnt marijuana emitting from the vehicle. Neither of the two remaining occupants admitted to smoking marijuana.

NARRATIVE (Continuation)

I then questioned Mr. Ritaldato. I advised Mr. Ritaldato of his Miranda Rights. After being advised of his rights, Mr. Ritaldato confirmed that he had smoked medical marijuana earlier in the day. He did not smoke within the vehicle, but smoked outside. He was still wearing the same clothing as earlier. He advised that he had smoked earlier with the front seat passenger.

I had dispatch check to see if Mr. Ritaldato had a valid medical marijuana license, as he had an expired one within his wallet. Dispatch confirmed that Mr. Ritaldato does not have any active medical marijuana prescriptions on file.

A probable cause search of the occupants was conducted with nothing being located on them.

During a probable cause search of the vehicle, I located a glass pipe in the backseat of the vehicle, behind a basket of laundry. The pipe had a white crystalized residue within the pipe, consistent with it being used to smoke methamphetamine.

I then spoke with the back seat passenger. After being advised of her Miranda rights, she confirmed that the driver handed her something as they were getting pulled over. The driver originally told her to shove it within her, but she did not want to do that. She then took the item and placed it behind the laundry basket.

Based on the above information, I believe there is probable cause to arrest Mr. Ritaldato for the offense of Knowingly Driving While License Suspended or Revoked, pursuant to FSS 322.34.2, and for Possession of Drug Paraphernalia, FSS 893.147.1.
