NARRATIVE On July 8, 2024, at approximately 2024 hours, I was inside of the Seven Eleven located at 4150 9th Street SW. Upon exiting the store, I observed a Hispanic female, later identified as Linsey Hernandez, laying on the ground next to a black Honda sedan (FL tag: GDLA31). As I approached the female to conduct a welfare check, a male, later identified as Raul Caban Martes, exited the driver's seat of the vehicle. As I made contact, it appeared the subjects were having an argument. At that time, Linsey got off the ground and both subjects were separated. I made contact with Linsey who verbally stated she was in the driver's seat of her vehicle and Raul was in the passenger seat when she stopped for gas at the Seven Eleven. Linsey said Raul went into the store and then exited as she was paying for the gas. Linsey said she and Raul got into an argument over finances and Raul then got into the driver's seat of her vehicle without permission. Linsey said she tried to pull Raul out of the driver's seat but he pushed her causing her to fall on the ground next to the gas pump. Linsey said she Linsey advised she and Raul see each other every day. Linsey While I was speaking with Linsey, I observed multiple bruises on both of her arms. When I asked Linsey about the bruises, she stated her and Raul argue often. Linsey refused to elaborate on the bruises any further. Upon asking Linsey if she wanted to prosecute and testify for Raul pushing her, she stated she did not want him to go to jail and she wanted to drive him back to his family's house in Orlando.

NARRATIVE (Continuation)
Raul Was placed in handcuffs and searched prior to being placed in the back of my patrol vehicle. In Raul's right front pocket, I located a black face mask. Prior to leaving for the jail, I attempted to use Raul's finger prints to identify him. Raul placed his hands in a fist and refused to provide his fingerprint.
While on the way to the jail, Raul stated multiple times that I was going to "pay for this" when these charges are dropped. Raul also stated he was going to "make my life miserable" and "if you were in Orlando I would beat the fuck out of you." Raul continued to make these statements while on the way to the Indian River County Jail. Upon arrival, at the jail, Raul provided his full identification to jail staff.
Due to Linsey becoming uncooperative and stating she did not want Raul to go to jail, no photographs of Linsey were taken. A Domestic Violence packet was completed and submitted.
Due to the incident being in progress, I failed to activate my Body Worn Camera. My camera was activated later during the investigation. Upon Deputy Bennett's arrival, his Body Worn Camera was activated during the investigation.

#### NARRATIVE

On July ,2024 at approximately 18:44 hours, I responded to 3146 1st Street SW, in reference to a suspicious incident.

Upon my arrival, I spoke with the victim, Kelsie Nicole Avent. Kelsie stated that both of her neighbors who live across the street were in the vicinity of her property looking for a lost cellphone that was pinging nearby. The two neighbors live together at 136 31<sup>st</sup> Avenue SW, and were identified as Charlene M. Edalatkhah and Jonathan E. Mackey. Kelsie stated that just prior to law enforcement arrival, Charlene was on her property up near her residence holding a laptop computer showing it through the window, advising Kelsie that she was trying to track her phone in which she believed to have fallen off the vehicle while pulling out of her residence. Charlene was able to track the phone on her laptop.

Kelsie stated that Jonathan was assisting in the search for Charlene's phone and he was at the base of her driveway which was short and approximately 30 feet from the house, while Charlene was up near the residence. Kelsie advised that she is the protected party in an injunction against Jonathan. The injunction was confirmed via Indian River County Dispatch, (injunction number: 17001069DV30) reference to Stalking. The injunction date was activated on 08/30/2017 and does not expire. Jonathan was served with the papers on 09/05/2017. The conditions of the injunction are clearly stated that Jonathan is required to stay away from the residence, property, school, or place of employment of the protected person or other family or household member, which Jonathan failed to do. From my investigation, I found probable cause that Jonathan violated the injunction by intentionally coming near Kelsie's property and making her feel as if she was in fear for her safety. Kelsie advised that she remained inside as she is in fear of Jonathan, and she knew that Charlene and Jonathan both live together.

Charlene stated that Jonathan was helping to look for the phone by going to neighbors' residences to check if they had Ring security camera footage.

After speaking with Kelsie, I went across the street where Jonathan resides. I located Jonathan in the back of his residence near the pool. Jonathan was uncooperative and refused to talk about his whereabouts. I informed Jonathan that he was under arrest for violation of an injunction, Jonathan then tensed up and tried multiple times to pull away. Jonathan made statements that he did not want to go to jail. During this entire interaction, Jonathan was tensed up and fell to the ground where he remained in a crouch position and refused to cooperate.

Deputy M. Mangel was on scene to assist and deployed her electronic control device to gain compliance (see deputy Mangel's supplement for further). Jonathan refused medical treatment and made a statement that he wanted to feel what it was like to get tased.

This interaction was captured on my agency issued Axon body worn camera.

Jonathan was transported to the Indian River County Jail without further incident.

On 07/08/2024, at approximately 1800 hours, I, Officer Hernandez (#443), responded to reference to a disturbance.

Upon arrival, I noticed EMS was already on scene. I then made contact with a white male who was in the front porch of the above mentioned address. The white male was later identified as Douglas Scali (W/M DOB: 01/14/1975).

Scali stated that he was in a verbal argument with his Jeanine Scali (W/F DOB: 01/20/1950). Scali stated that his Jeanine, repeatedly asked him for some iced tea and then started making derogatory comments to him. Scali stated Jeanine was sitting on the couch, in the living room at the time. Scali stated he was standing across from her, became upset and kicked the coffee table that was between both of them. Scali stated that the coffee table slid, and made contact with Jeanine's shins/legs, which would be reasonably expected to result in physical injury due to the close proximity of Jeanine and the coffee table. Jeanine's legs started bleeding.

Scali stated that Jeanine has some medical issues, which he's been taking care of her since January 2024 but denied having any previous physical altercations.

After speaking with Scali, I made contact with Jeanine after paramedics finished assessing her wounds. Jeanine stated that she had been sitting in the living room couch, when the incident occurred. Jeanine stated she asked Scali a question about the VA clinic (Veterans Affairs Clinic), but Scali became upset with her. Jeanine stated that the reason Scali became upset was because he told her she had asked him that same exact question too many times, and he had already provided her with an answer.

Jeanine stated that he proceeded to kick the coffee table, which struck her legs/shins and she began bleeding. Jeanine also stated that Scali had been verbally and physically abuse towards her all day. She stated that Scali pushed her around and used his hands to smack her on the head. Jeanine used hand movements to illustrate the interactions between Scali and she.

Jeanine also mentioned that Scali told her "today is the day, I will kill you." Jeanine stated that Scali did not elaborate on how he was going follow through with it. Jeanine denied asking Scali for some iced tea and pointed at the coffee table. Jeanine pointed at a can of Sprite that was sitting on the coffee table and stated she had been drinking the Sprite and that Scali lied.

It should be noted that upon speaking to Jeanine, she appeared frightened and repeatedly mentioned that she was scared to be at home with Scali. Jeanine was crying, speaking rapidly, and shaking during my interaction with her, causing her to have some trouble forming her sentences. Scali stated she did not feel safe at home and mentioned to the paramedics on scene, that she would go to the hospital if it meant she did not have to be around Scali.

Jeanine stated that this had not been the first time Scali had been physically or verbally abusive towards her. She also stated that her neighbor called her via telephone to check on her wellbeing, prior to law enforcement arrival.

I then assessed Jeanine, where she had bandages on her left and right shins (placed on her, by paramedics). Both shins had fresh blood dripping down her legs. No other noticeable injuries were noted but Jeanine was transported to the Cleveland Clinic Hospital for further treatment.

There was dried up blood on the floor, directly under Jeanine's legs and dried up blood on the edge of the coffee table.

Based on the entirety of circumstances, Scali was placed under arrest for Abuse, aggravated abuse, and neglect of an elderly person - F.S.S. 825.102(1).

Scali was then read his Miranda Warning from a prepared text, where he acknowledged and understood his rights and agreed to speak with me. Scali again, stated that his pleanine, repeatedly asked him for some iced tea and then started making derogatory comments to him. Scali stated Jeanine was sitting on the couch, in the living room at the time. Scali stated he was standing across from her, became upset and kicked the coffee table that was between both of them. Scali stated that the coffee table slid, and made contact with Jeanine's shins/legs, causing them to bleed. Scali stated he became upset, frustrated, and anxious at Jeanine's behavior and statements, which caused him to react that way. During that time, Scali mentioned that he had consumed some alcoholic beverages, which the odor was prominent upon speaking with him.

Scali was then transported to the Indian River County Jail for booking and processing and to be held on NO BOND.

BWC footage and photographs were taken and uploaded to VBPD evidence library.

A domestic violence packet was completed and a copy of the victim rights was provided to Jeanine.
