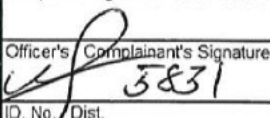
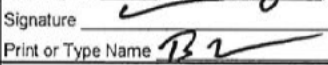
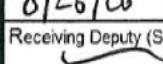

NARRATIVE

On August 26th, 2026, at approximately 1830 hours, I was patrolling southbound in the 1600 block of 58th Avenue, Vero Beach, Florida, when my License Plate Reader (LPR) alerted to a red Ford F-150 bearing Florida license plate BM00KA for a suspended registration. I conducted a query through D.A.V.I.D., which confirmed that the vehicle's registration was suspended and the registered owner's driver's license was suspended/revoked as well.

I conducted a traffic stop and made contact with the driver and sole occupant, Arturo Lopez Jimenez. I informed Lopez of the reason for the traffic stop and requested his driver's license, proof of insurance, and vehicle registration. Lopez, who already had a Mexican passport in his hand, provided the passport and stated that he did not have a driver's license. For clarification, I asked Lopez whether he did not have his license in his possession or had never been issued one. Lopez stated that he had never been issued a driver's license.

I instructed Lopez to exit the vehicle and placed him in handcuffs. The handcuffs were double-locked and checked for proper fit. While reviewing Lopez's passport, I observed that it contained a United States visa with an expiration date of June 1st, 2021.

I identified myself as a designated immigration officer assigned to the 287(g) Task Force and asked Lopez how he entered the United States. Lopez stated the following in substance:

Lopez entered the United States on a work visa, which expired on the aforementioned date. Lopez further stated that he had not contacted an immigration officer or initiated any immigration proceedings to legalize his status since the visa expired.

Based on this information, I contacted the Immigration and Customs Enforcement Agency (ICE), and informed them of the circumstances surrounding the investigation. ICE advised that an immigration detainer would be placed on Lopez for immigration violations.

Lopez was transported to the Indian River County Jail for the following charge.

1. Operating a motor vehicle without valid driver's license, consistent with F.S.S. 322.03(1).

NARRATIVE

On Wednesday, 08/26/2026, at approximately 1958, I was conducting uniformed mark patrol in the area of 4100 Indian River Boulevard, Vero Beach, Florida 32967, when I observed a black Honda Accord bearing Florida tag RZDE02 fail to slowdown for a steady yellow traffic signal going southbound, crossing past the stop bar as the traffic control signal turned red. While I caught up to the vehicle I observed the vehicle to only have one working rear brake light, building probable cause for a violation of Florida statutes 316.234(1) – Improper/no brake lights and 316.075(1)(C)(1) – Fail to stop at steady red signal.

I activated my emergency lights and sirens north of the intersection of Indian River Boulevard and Merrill Barber Bridge, signaling for the vehicle to pull over. The vehicle continued to the intersection, which I then activated my sirens a secondary time to signal a traffic stop. The vehicle continued southbound eventually stopping just north of Royal Palm Place and Indian River Boulevard. I made contact with the driver, identified as Jimmy Kentrell Morris, who was fumbling through multiple items in the vehicle. Morris was verbally combative with me and continued to fumble through items outside of my request for his driver's license, registration and proof of insurance. I asked Morris why he was so upset, to which he responded that he knew all the deputies and believed that law enforcement was racist. Morris continued to be verbally combative and kept going through the vehicle, based on this behavior I ordered Morris to step out of the vehicle. Once Morris exited the vehicle, I instructed him to go to the push-bar on the passenger side of my marked patrol vehicle. Based on Morris's behavior and movements inside the vehicle I told Morris I would be patting him down for my safety and asked if there were any weapons on him. When I attempted to pat-down Morris, he pushed my hands away from his waist and immediately took both of his hands and went down towards his waistband. I grabbed Morris's arms and lifted them away from his waistband, then attempted to place him in handcuffs. Morris began to lock his arms up and resist me, Morris also attempted to pull away from my control. I order Morris to get on the ground and place his hands behind his back as he was being placed under arrest, however Morris continued to struggle with me and eventually broke my grip. I pulled out my agency issued taser and warned Morris that he would be tased if he did not get on the ground. I continued to attempt to control Morris and eventually got Morris on the ground. While on the ground I attempted to control Morris's arms behind his back to place him in handcuffs, which he continued to lock his arm and make movements to prevent me from doing so. I got into a rear mount on-top of Morris and controlled his arms using his elbows so that he could not reach around his body. Once I had control of Morris, I waited for additional units to arrive on scene before I was able to successfully take Morris into custody.

Once in custody, Deputy Ciofalo, Deputy McPeek and I attempted to get Morris into the back of Deputy McPeek's agency issued patrol vehicle, at which time he resisted again and refused to walk, prompting us to push him towards the patrol vehicle. Morris then refused to get into the back of the vehicle, two

deputies had to place into the seat and push him in, while I went around the other side of the vehicle and had to pull Morris into the vehicle. Once Morris was secured in the back of the vehicle, I asked Morris if he had any injuries, to which he complained of backpain.

Morris was then transported to Cleveland Clinic Indian River Hospital for medical clearance based on his claim of injury. Doctors conducted a medical exam on him and he was discharged from the hospital shortly after. Morris was then transported to the Indian River County Jail and booked in under the following offenses:

- F.S.S. 843.02 – Resist law enforcement without violence.

Morris was issued citations for the traffic offenses that where committed during the initial traffic stop.
