#### NARRATIVE

On 05/15/2024, at approximately 0206 hours, while traveling southbound along the 1500 block of Old Dixie Highway, I observed a Toyota suv bearing Florida tag (Z113LA), traveling directly in front of my patrol vehicle.

While observeing the vehicle, I noticed that its passenger side tires were traveling directly onto the grass shoulder of the roadway. At the same time, I noticed that it almost struck a speed limit sign, head on. Prior to the vehicle making a large wide right turn onto 12<sup>th</sup> Street, I observed that the vehicle drifted towards the right and its passenger side tires, left the roadway again traveling along the dirt shoulder. Along the 1000 block of 12<sup>th</sup> Street, I noticed that the vehicle, was unable to maintain its lane, due to it straddling the white solid line of the shoulder of the road.

I conducted a traffic stop on the vehicle at the intersection of 13<sup>th</sup> Avenue and 12<sup>th</sup> Street.

Upon making contact with the female driver, I immediately smelled the strong odor of an alcoholic beverage emitting from the vehicle. When the female driver made direct eye contact with me, I observed that both of her eyes were watery and glassy. At the time, the driver was asked for her driver's license, registration, and insurance card. While the subject was looking for her license in her wallet, I noticed that she has a having a difficult time, removing it. I was able to identify the subject as Laurie Chadwell, from her Florida license.

During a brief conversation with Chadwell, she advised that she recently consumed a shot of Fireball whiskey along with one Michelob Ultra beer, while playing pool at Dom's Bar approximately one hour prior. She also informed me, that she was a light weight when it came to consuming alcoholic beverages and that it did not take much for her to become intoxicated. When Chadwell spoke, I noticed that her words were very slurred and I continued to smell the odor of an alcoholic beverage emitting from her body.

Next, I informed Chadwell that I would be conducting a D.U.I investigation, which she stated that she understood. Due to her standing in front of my patrol vehicle, I noticed that her body swayed from front to back.

During the Horizontal Gaze Nystagmus Exercise, Chadwell showed a lack of smooth pursuit in both eyes, with distinct and sustained nystagmus at maximum deviation. I also observed an onset of nystagmus prior to 45 degrees. During vertical gaze nystagmus, I observed that both eyes voluntary moved upward. Due to standing directly in front of Chadwell, I continued to smell the strong odor of an alcoholic beverage emitting from her body.


During the demonstration and instructional phase of the Walk and Turn Exercise, Chadwell started the exercise, by taking 4 steps that were not heel to toe or straight in a line, prior to being instructed to start. For the first phase, Chadwell took 9 steps, that were not heel to toe or straight in a line. When Chadwell conducted the turn to start the second portion of the exercise, she loss her balance and both of her feet stepped off of the lane. During the second phase, none of her steps were straight in a line or heel to toe. Chadwell had to place both of her arms out to the side of her body to help maintain her balance during both phases of the exercise.

During One-Leg Stand Exercise, Chadwell's body was observed swaying from front to back and she placed his right foot on the ground, at the 4 second mark of the exercise. Chadwell attempted to conduct the exercise, 3 times but was unable to

maintain her balance will standing upright and had to place both of her arms out to the side of her body to prevent from falling down.
The following exercise I explained and demonstrated was the finger to nose. After explaining and demonstrating the exercise, Chadwell stated that she understood the instructions.
Left-used knuckle of finger to touch center of nose. Had to be instructed to remove finger.
Right- used knuckle of finger to touch center of nose. Had to be instructed to remove finger.
Left – used knuckle of finger to touch bridge of nose.
Right- used center pad of finger to touch above bridge of nose
Right- used knuckle of finger to touch bridge of nose.
Left- used knuckle of finger to touch bridge of nose.
Throughout the exercise, Chadwell's body swayed was noticeable swaying from front to back.
Based on my observations, Chadwell was placed under arrest and transported to the Indian River County Jail.
At the jail, Deputy Rodriguez requested Chadwell to submit to a lawful test of her breath for the purpose of determining its alcohol content. A lawful test of the Chadwell's breath was obtained using an Intoxilyzer 8000 to determine its alcohol content. The results were 0.205 BrAC and 0.211 BrAC.





The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:  05/15/2024 22:52 On , at (Specifically include facts constituting cause for arrest.)
On 05/15/24, at approximately 2252 hours, I, Ofc.Aguilar, observed a white Ford pickup truck (bearing Florida tag# GZKD90) exiting the parking lot of 2296 US Hwy 1. (7-11). I observed the Ford fail to stop prior to leaving the parking lot and entering 12th Ave. in violation of F.S.S. (316.125). I then observed the Ford proceed northbound on 12th Ave and then fail to stop at the stop sign with Royal Palm Blvd. I then conducted a traffic stop on the above-mentioned Ford within the 2600 block of 12th Ave. I observed the Ford pull into the driveway of a nearby residence, 1166 26th St.
I then observed a white male, later identified as Drew Dram exit from the driver's side seat and walk toward the tailgate area of his pickup truck. I then made a driver's side approach to the vehicle and asked Dram to return to his vehicle. He was the single occupant and driver of the Ford pickup truck. While speaking with Dram, I detected the strong odor of an alcoholic beverage emitting from his vehicle observed him to having slurred speech and glossy red eyes. Dram stated that he consumed some alcoholic beverages a few hours prior to our interaction but he did not specify exactly what he drank.
Based on the above-mentioned circumstances, I requested that Dram conduct some field sobriety exercises in order to dispel my suspicion that he was under the influence and was capable of safety operate a motor vehicle. Dram agreed to perform the exercises and understood all instructions prior to commencing the exercises. Dram stated that he did not have any physical limitations that would prevent him from completing the exercises. The results are as follows:
Horizontal Gaze Nystagmus Lack of smooth pursuit in both eyes Distinct and sustained nystagmus at maximum deviation in both eyes Onset of nystagmus prior to 45 degrees in both eyes
Walk and Turn  Could not keep balance while listening to instructions Starts too soon Stopped while walking Dram performed 4-heel to toe steps and then stated, "Not happening" and "I'm at my house man." Dram then stopped the exercise.
One leg stand Swayed while balancing Put left foot down multiple times Counted from one thousand one- one thousand ten and placed his foot down prior to being instructed to stop. Dram then stated, "Yeah, I failed."
Based on the above-mentioned circumstances, Dram was placed under arrest for violation of F.S.S. (316.193 Driving Under the Influence, citation # AFVKGPE) Dram was then read his Miranda Warnings, which he understood and agreed to answer my questions. Dram stated that he had 4-5 beers approximately 7 hours prior to our interaction. Dram then refused to provide any further answers.
Dram was then transported to the Indian River County Jail without further incident. I then conducted a 20-minute observation period and then asked Dram if he would be willing to provide a breath sample in order to determine his blood alcohol content. Dram agreed to provide the samples and the results are as follows: 0.252 and 0.249.
Dram was the issued a citation #AJH06VE for violation of F.S.S. 316.123(2a Ran stop sign violation) and then handed over to booking staff. Body camera video of the incident was submitted into a secure file at the Vero Beach Police Department.
