The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

1.) POSSESSION OF HEROIN in that the Defendant was:

Knowingly in actual or constructive possession of HEROIN, a controlled substance; Contrary to Florida Statute 893.13(6)(a).

II.) POSSESSION OF PARAPHERNALIA (use) in that the Defendant did:

Use or possess with intent to use two (2) syringes and two (2) pipes, drug paraphernalia;

For injecting, ingesting, inhaling, or otherwise introducing a controlled substance, to wit: heroin, into the human body; Contrary to Florida Statute 893.147(1)(b).

III.) TRESPASS - STRUCTURE OR CONVEYANCE in that the Defendant did:

Unlawfully and willfully, without being authorized, licensed, or invited, enter upon or remain in a structure or conveyance;

The property of the Victim, REGINA BEAM; Contrary to Florida Statute 810.08(1).

On 11/24/25, I, Ofcr. S. Gonzalez (471), and other Vero Beach Police units, responded to the control of the Victim, REGINA BEAM, reported that the Defendant, JEFFREY T. BEAM, was at her front door attacking her and trying to break through the front door.

Upon arrival, I observed that Cpl. R. Lachowicz (429) was already on scene and had made contact with and detained the Defendant. Upon speaking with Cpl. Lachowicz, he informed me that as he arrived, he observed the Defendant leaving the property.

I then made contact with Ms. Beam, who stated that the Defendant had come to the house ostensibly to retrieve some belongings from the residence. However, when she told him no and to leave the premises, he tried to force his way past Ms. Beam into the residence, breaking the threshold of the doorway, and in the process, the Defendant tried to bite her.

Ms. Beam stated that the Defendant was not authorized, licensed, or invited to be on the property and had been previously issued a Trespass Warning.

I was able to confirm that the Defendant had been issued a Trespass Warning on 02/21/25. Please see VBPD CFS No. 022125-88.

Based on the totality of the foregoing, I determined that there was probable cause to charge the Defendant with not only Trespass After Warning but also Burglary of an Occupied Dwelling, pursuant to F.S. 810.02.

However, Ms. Beam stated that the Defendant suffers from an and that she wanted him to get help, but she did not want to press charges for burglary.

I then made contact with the Defendant, had him step off of his bicycle and placed him under arrest. During an inventory of the cooler on his bicycle, a brown eyeglass case was located containing two "Loaded" syringes containing an amber-colored substance which, based on my training and experience, I suspected to be heroin. The substance was field tested and yielded a presumptive positive result for Methamphetamine. The substance was later submitted for subsequent testing by the FDLE Crime Lab.

In addition to the two syringes, a metal tube was located of the type used for smoking or inhaling narcotics. A blue straw which had one end burnt and melted was also located which, based on my training and experience, is also used for smoking or inhaling narcotics.

Therefore, based on the totality of the foregoing, the Defendant was placed under arrest and transported to the Indian River County Jail where he was processed and booked.

The foregoing violation occurred within the City of Vero Beach, Indian River County, Florida.

The contraband described hereinabove was entered into Property & Evidence at the Vero Beach Police Department. All bodyworn camera video from this incident was uploaded to a secure server.

The Defendant was issued UTC No. ALZPJAE & ALZPJBE for possession of a controlled substance and drug paraphernalia.

NARRATIVE

On November 24, 2025, at approximately 1453 hours, I responded to in reference to a disturbance.

Upon arrival, I made contact with Carolyn Chambliss (Victim), who provided the following statement in substance: She was seated in the back room of the residence with her mother, Billie Chambliss, and Johnnie "Clyde" Williams. An argument began between her and Clyde regarding her sister's suicide. She told Clyde multiple times to leave the residence, but he refused. She stated that Clyde became upset at being told to leave and approached her aggressively, getting "in her face." She then picked up an iron magazine case from the floor and told Clyde to leave. She stated that Clyde then struck her on the side of the mouth with a closed fist. After striking her, Clyde exited through the back door, got on a bicycle, and left the property.

Visible injury was observed on Carolyn, specifically a bloody cut on the inside of her mouth. Carolyn stated that no video footage was available. Photographs of the injuries were taken and was uploaded to Evidence.com.

I then made contact with Billie Chambliss, who provided the following statement in substance: She had invited Clyde to the residence. She reported that Clyde is a family friend and that he was at the residence attempting to sell her food stamps. She stated Clyde previously lived at the residence but moved out approximately one year ago. She confirmed that Carolyn and Clyde engaged in a verbal argument about Carolyn's sister's suicide. She and Carolyn told Clyde to leave and he refused. She reported that Clyde then got into Carolyn's face. Carolyn picked up an iron magazine case in response. She stated that Clyde struck Carolyn in the mouth with a closed fist and then left the house.

A short time later, I made contact with Clyde Williams, who had returned to the property. He stated in substance the following: He told me he had lived at the residence for four years. He confirmed he and Carolyn engaged in a verbal argument about her sister's suicide. He denied striking Carolyn and stated he did not touch her. He stated Carolyn told him to leave the property, but he refused because he had been invited. He stated Carolyn became upset, picked up an iron magazine case, and struck herself in the mouth, causing her mouth to bleed. He said he left the property only because law enforcement had been called and returned because he believed it was "the right thing to do."

Based on the victim's sworn statements, corroborated by an eyewitness (Billie Chambliss), and the visible injury observed on the victim, Clyde Williams intentionally struck the victim against her will, causing bodily harm. Therefore, probable cause exists to charge Clyde Williams with Battery, in violation of F.S. 784.03(1)(a).

Clyde Williams was placed under arrest without incident and transported to the Indian River County Jail for booking.

NARRATIVE

On November 24th, 2025, I obtained an arrest warrant for a subject by the name of Kyle Young. The arrest warrant was signed by the Honorable Judge Rebecca I. White. Units observed Kyle in the area of of the 2000 Block of Old Dixie Highway SW, walking in the woodline.

Prior to my arrival, Sergeant David Rodriguez observed Kyle and ordered him to stop utilizing the PA system in his marked patrol vehicle, which had "SHERIFF" on both sides of the vehicle, clearly identifying him as Law Enforcement. Kyle ran into the woodline, resisting Sgt. Rodriguez.

Upon my arrival to the area, contact was attempted with Kyle Young. It should be noted that deputies on scene were wearing Law Enforcement vests which had "SHERIFF" in bold letters on the back, a gold star patch on the front. identifying ourselves as Law Enforcement Officers. Once Kyle was addressed by deputies and ordered to stop, Kyle walked away, resisting lawful commands. Kyle continued to yell at deputies to leave him alone. A short time after initial contact, Kyle pulled out a a canister, which was later determined to be bear repellent spray.

Kyle continued to resist by running away from deputies into an open parking lot on the 1700 block of Old Dixie Highway SW. Kyle continued to resist lawful commands to get on the ground or to put his hands behind his back. At that time, K9 Deputy Castano utilizing his K9 Jefe, in attempts to gain compliance. Once Jefe made contact with Kyle, Kyle utilized his Bear Spray, propelling chemicals toward Jefe. Due to the expelling of chemicals, eight (8) other deputies, including Jefe, experience chemical irritation to their eyes, skin, and throat. At that time, I deployed my agency issued Conducted Energy Weapon in attempts to gain compliance. At that time, Kyle experienced Neuro Muscular Incapacitation, which caused from him to fall to the ground. After Kyle fell to the ground, I observed a black firearm with a wooden handle next to his left arm, on the ground. Once compliance was achieved, the firearm was removed for safety purposes.

It should be noted that there was an extended period of time where deputies needed assistance due to the chemical irritant that was expelled by Kyle Young. Emergency Medical Services was requested for assistance. Kyle was subsequently transported to the Indian River Hospital at Cleveland Clinic where he was medically cleared. Once

NARRATIVE

On November 24, 2025, at approximately 2049 hours, I responded to Walmart, located at 5555 20th Street, Vero Beach, Florida, in reference to a retail theft.

Upon arrival, I made contact with the loss prevention officer, Nathan Toliver, who provided a written statement;

"I, API Nathan Toliver, observed the suspect now known to me as Chadwick Dean Hird in the sporting goods department ripping open packaging of collectable cards and concealing them into his pockets. I continued physical surveillance on the salesfloor as he moved to other empty aisles and continued to open additional packaging and conceal the contents into his pockets as I physically watched him perform the action. He then made his way to the front of the store and went to a self-checkout register where he paid for several other cheap items but made no attempt to pay for the concealed merchandise. He then exited the store through the Grocery doors. I approached him as he exited the doors and identified myself as Walmart loss prevention. I requested he return with me and APOC Cecilee to the LP office so that the concealed merchandise could be recovered. He cooperated without incident, once inside the LP office I asked him to empty his pockets of all stolen merchandise which he did and laid out on a bench. The value of the stolen merchandise was \$70.58. Walmart wishes to trespass and prosecute Chadwick Hird for this offense. End Statement."

I asked Nathan to let me observe the camera's, which he did. Nathan explained that due to the angle of the camera, he began physical surveillance. I did observe on camera, Chadwick fails to pay for the collectable cards, and pass all points of sale, where he was stopped by Nathan and Cecilee at the exit door, at approximately 2042 hours.

I also observed Chadwick on camera inside the loss prevention office empty out his pockets and remove the collectable cards.

I read Chadwick his Miranda warnings from my agency issued Miranda Card, which he stated he understood and wished to talk. Chadwick admitted to taking the items and said it was a stupid mistake.

I completed a trespassed affidavit for Chadwick, which he signed. I gave a copy to Walmart, one was placed into Chadwick's property at the jail, and one was placed into records.

I placed Chadwick in handcuff restraints and checked for proper fit, and began a search of his person, where I located more items from the collectable cards set, which I turned over to Nathan.

Photographs of the items taken, along with the receipt for the stolen items were taken and added to evidence.com

Nathan was provided a link to Axon to submit the video evidence.

This investigation was captured on my body worn camera.

This investigation is cleared by arrest.
