The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 08/25/2025 18:54 On (Specifically include facts constituting cause for arrest.)

I responded to a disturbance at

in reference to a possible physical altercation between a male and female.

As I approached the front door of the residence, I observed a white female and white male inside of the residence. The female was distraught and both subjects were yelling at each other. Both subjects were standing near a hallway by the living room area. The female walked to the front door upon making our presence known and both subjects were separated.

Ofc. Kuehn (#471) remained with the victim while I spoke with the male outside of the residence. The male/defendant was identified as Justice Cureton (W/M DOB: 02/17/1997). The defendant immediately stated he did not want to speak about the situation because he did not want the victim to get arrested. The defendant had visible injuries to his face and had dried up blood coming from his nose and down to his abdominal area. The defendants khaki shorts had blood stains as well. As I attempted to conversate with the defendant, he stated that his injuries were from a previous physical altercation that occurred at his residence (1119 29th Street) a few hours prior. The defendant stated that law enforcement responded to his residence in reference to a battery between his friend and he (defendant being the victim). Vero Beach telecommunications was able to confirm this incident. See Case # 2025001647. The defendant stated that after that incident, he called his girlfriend/victim to pick him up from his residence. The defendant provided limited information regarding the incident between the victim and he, stating that he has been with his girlfriend for one year and that she got upset for no apparent reason. It should be noted that the defendant was asked if he needed medical attention but declined.

I then made contact with the victim inside of the residence. The victim stated she picked the defendant up from his residence (1119 29th Street) after he was involved in a physical altercation with his friend, CJ. The victim stated that the injuries to the defendant's face and nose were from CJ, not from her. The victim stated that she's been in a intimate relationship with the defendant for approximately one year but they do not reside together. The victim stated that she was upset because she could not find her computer, which she uses for work purposes. The victim stated that she asked the defendant several times where he had placed the computer but he refused to tell her. The victim stated that the defendant has a history of hiding and taking her belongings to control her. The victim stated that during their interaction, the defendant became upset and grabbed her by the head. The victim stated that the defendant began slamming her head onto the wall several times. The victim also stated that the defendant physically assaulted her yesterday, stating that he pushed her against the wall, causing her left knee to break the wall near one of the outlets.

The victim also pointed towards the living room area, where I observed a broken VCR player on the floor. The victim stated that the defendant intentionally threw it, causing it to break. The victim also showed me her kitchen area, where I observed a pizza box on the floor. There was also pizza on the laundry room floor and pizza sauce on the walls. The victim stated that the defendant caused the mess during their altercation.

It should be noted that the victim's face appeared red and flushed. The victim had a small laceration with dried up blood on her head/scalp as well as bruising and a small laceration with dried up blood on her left knee. The victim stated that she felt like her vision was blurry from the head injury but refused any medical attention.

Based on the foregoing, the defendant (Justice Cureton) was placed under arrest for Battery - Domestic Violence F.S.S. 784.03(1A1). The defendant was transported to the Indian River County Jail for booking and processing and to be held on NO BOND.

A domestic violence packet was completed and a copy of the victim rights was provided to the victim. A domestic violence lethality assessment was also completed.

It should be noted that while completing the domestic violence lethality assessment the victim mentioned that the defendant has previously threatened to use a weapon against her, threatened to kill her, has previously choked and/or attempted too, and controls most of her daily activities.

It should also be noted that the defendant was previously arrested for Domestic Violence - Battery against this victim on 12/15/2024 by Vero Beach Police Department. See Case # 2024002538.



NARRATIVE

On Monday, August 25, 2025, at approximately 1954 hours, I, Deputy M. Neill #6317 responded to 1235 19th Avenue SW, Vero Beach, Indian River County, Florida, in reference to a wanted subject.

Prior to my arrival, I observed that Ms. Marie Thea Damis had an active Misdemeanor warrant out of Indian River County for Violation of Probation reference case number 2VP202505655. I went out to the residence I know her to reside out. I made contact with her sister, who advised she was not home. Additionally, her vehicle (a black Chrysler 300) was not at the residence. The sister advised she would return home in a little bit. Additionally, Ms. Damis does not have a valid license. On May 12th, 2025 Ms. Damis received a non judgement suspension, reference case number 650290675. Additionally on the same day, she was labeled as a Habitual Traffic Offender for a period of five years. On May 27th, 2025 Ms. Damis surrender her Drivers License to the DMV and was issued an ID Card only.

At 2037 hours, I observed a black Chrysler 300 come down 19th Avenue SW from 13th Street SW. The vehicle matched the description. As I got closer to the vehicle, I observed that Ms. Damis was driving the vehicle. As the vehicle pulled in to the residence, I conducted a traffic stop on the vehicle.

Upon making contact with Ms. Damis, she had a large stain on her shirt. She had a very noticeable slurred speech. Ms. Damis advised she was just coming back from getting Pizza for her 7-year-old child, who was in the backseat of the vehicle.

Once outside of the vehicle, I noticed that Ms. Damis had watery eyes, a sway in her stance, and the odor of an alcoholic beverage emitting from her breath. Ms. Damis was advised that she had a warrant. She stated she was aware that a warrant was being issued for her as she stated she has a drinking problem.

Ms. Damis was advised of her Miranda Rights. She advised she understood her rights and was willing to speak to me. Post Miranda she advised that she had a letter in the car which stated she could operate a motor vehicle until the 29th of this month. She also originally denied consuming an alcoholic beverage today.

Ms. Damis agreed to perform Standardized Field Sobriety Exercises. These exercises go as follows:

Horizontal Gaze Nystagmus (6/6): Ms. Damis had a lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and nystagmus onset prior to a 45-degree angle in both eyes. She also moved her head multiple times throughout the exercise. She did not have resting nystagmus and had equal pupil size.

Walk and Turn (6/8): Ms. Damis lost her balance multiple times while in the instructional stance, started before being told to do so on the first attempt, missed touching heel to toe, stepped off line, turned incorrectly, and took the incorrect number of steps. Prior to the exercise, Ms. Damis was shown the proper way to complete the exercise. She advised she understood the instructions and did not have any questions. During the exercise, Ms. Damis walked in a square, making a right turn after every 9 (sometimes she took more) or so steps, and kept walking in a square until having to be stopped by law enforcement. Ms. Damis asked to perform the exercise again. She was shown the

exercise a second time. She again completed the exercise in the same manner as stated above.

One Leg Stand (1/4) Ms. Damis put her foot down multiple times during this exercise. She also failed to listen to instructions and had her leg not fully extended out.

I questioned Ms. Damis again about consuming alcohol. She changed her story and advised she drank alcohol earlier today, but it was in the morning. Her last drink was around noon today, as she was drinking Amsterdam Vodka.

Based on the above information, Ms. Damis was placed under arrest for Driving While License Suspended – Habitual Traffic Offender, as well as DUI.

Upon searching the car, deputies located a plastic bag which had unopened Amsterdam Vodka Shooters, as if she just went to the store to pick them up, after getting a pizza for her kid in the backseat. Additionally, a drivers license and ID which has the top right part cut off was located in her purse. A Valid ID card was located in her purse. No paperwork from the DMV was located in the vehicle which states she can operate a vehicle.
