On Wednesday, October 8, 2025, I responded to the intersection of Sebastian Blvd and Roseland Road in reference to a reported hit and run crash.

During the course of my investigation, it was determined that the driver of Vehicle 1 fled the scene without providing any information or checking for injuries. While still on scene, a male subject approached me and stated that one of his employees was the driver of the vehicle that had fled. He advised me that the employee admitted to fleeing the scene out of fear to him upon his arrival to work. The male, who identified himself as the employee's manager, requested that the driver return to the scene to speak with law enforcement.

I then made contact with Oliver Gomez Lopez, who was identified by his Guatemalan passport. Due to a language barrier, Officer Martinez responded to the scene to assist with Spanish translation. Post-Miranda, Mr. Gomez Lopez admitted that he was the driver and sole occupant of the vehicle that fled. He stated that as the traffic light turned green, he began driving forward but became distracted while texting. Mr. Gomez Lopez confirmed that he struck the vehicle in front of him and, out of fear of law enforcement, chose to leave the scene without providing any information or checking for injuries. Mr. Gomez Lopez further stated that he is not a U.S. citizen and has never been issued a driver's license by any U.S. state.

Mr. Gomez Lopez was then placed under arrest for leaving the scene of an accident with property damage and driving without ever having a license issued to him.

On 10/8/25, at 2212 hours, I observed a black male who I later identified as (DI) Julson Monfort (DOB: 10/25/2001) standing in front of 2296 US Hwy 1 (Seven-Eleven) who appeared to be approaching customers and panhandling by the entrance of the business obstructing the door way.

I then stepped out with D1 and requested to speak with him. Once speaking with D1 an employee from the aforementioned location who I later identified as Jeremy E. Mount (DOB: 9/11/1978) approached me and stated "I told him he can't be panhandling on the property, I want him trespassed". I advised D1 he was being trespassed from the location and requested his information.

After obtaining D1's information I asked for consent to search his person and backpack to which he agreed to me doing so. Upon search of his backpack, I located a small clear plastic baggie in the main compartment of the backpack which contained residue of a white powdery substance. Based on my training and experience, I believed the substance to be Cocaine. A field test was conducted on the residue, which tested positive for the presence of Cocaine.

D1 was placed under arrest for violation of F.S.S.893.147 (1) (Possession of Drug Paraphernalia). D1 was also issued a trespass warning from the aforementioned location reference Vero Beach TAW# (VB1559).

D1 was transported to Indian River County Jail for processing and booking where he is held on a \$500 bond.

NARRATIVE

On October 8, 2025, at 2200 hours, I Deputy Fettig responded to 675 44th Avenue Vero Beach, FL 32968 in reference to a disturbance.

When I arrived, I met with Ashley and Heather Spoore, who stated they were delivering Door Dash orders in the area. Ashley stated she had just finished delivering an order to 675 44th Ave, and was seated in her vehicle speaking with door dash customer service a couple of few houses down from the original address location of incident LOI. Ashley stated a male subject approached her vehicle and demanded to know why she was parked in front of her house. Ashley stated she attempted to explain to the man what she was doing, but he continued to shout over her and demand they leave. Ashley then stated the man threw an alcoholic beverage through her open driver's door window.

While interviewing her, I observed a liquid running down her driver's side door, as well as multiple stains inside the car along the interior. Ashley described the man as a white male in his 60s wearing a blue shirt and shorts.

I then relocated to the residence LOI, and identified the homeowner as Frederick Scharfschwerdt. Frederick was wearing a blue shirt and shorts and matched the other descriptive details given by the victim. I advised Frederick of his Miranda Rights and asked if he was willing to speak with me, to which he stated "Yes." While interviewing him, I could detect the odor of an alcohol beverage emitting from his breath. Frederick appeared to be under the influence and I could smell the odor of alcohol emitting from his breath. When questioned Frederick admitted to being involved in an altercation with the door dash driver. Frederick stated while he was questioning them on why they were parked in front of his house, the driver began splashing him with a water bottle. Frederick stated because of that action he threw his beverage on the driver.

It should be noted while speaking to Frederick I did not observe any evidence of a liquid being splashed on his person. Also, there is a Ring Doorbell Camera at the front door of Frederick's residence pointing towards the palms and bush area where Frederick stated the incident took place. Lieutenant Jaworski assisted by reviewing the footage, where it shows Frederick coming out of his residence, and walking down the road to the right of the screen. You cannot see any vehicles parked in front of his residence, and Lieutenant Jaworski was unable to hear any type of verbal altercation immediately off screen.

Frederick was advised he was being place under arrest for Simple Battery. I secured Frederick in handcuffs, which were double locked and checked for proper fit. I conducted a search incident to arrest of Fredericks person, then placed him in the backseat of my patrol car. Frederick was then transported to the Indian River County Jail without incident.
