PROBABLE CAUSE STATEMENT

On January 14th, 2025, at approximately 1512 hours, I was dispatched to 1676 US 1 (Verizon Wireless) in reference to a suspicious incident. While en-route, dispatched advised a female customer made threats to drive her vehicle through the store. Dispatch also advised the caller stated the female drove the car up to the building wall.

Upon arrival, I made contact with the supervisor, identified as Timothy Quimby. Timothy stated that a female subject was inside of the store with her mother. Due to the female being a customer of Verizon and being inside of the store multiple times, Timothy was able to identify the female as Jaime Rutkowski. Timothy stated on today's date, Jaime was inside of the store causing a disturbance. According to Timothy, Jaime was yelling profanities such as "fuck you" and "I am coming after you, this isn't the end." Timothy informed me this behavior and language was directed toward the Verizon staff as well as the customers who were inside of the store, causing a disruption to the normal flow of their business. After Jaime finished screaming and causing a disturbance in the store, Timothy stated he observed her go back inside of her vehicle. Timothy informed me Jaime then drove her vehicle towards the entrance of the store, getting over the curb of the sidewalk and coming in close proximity of the front doors. Due to how Jaime was acting prior to this, as well as the statements she made while in the store, Timothy stated he had a well-founded fear of Jaime driving through the store with her vehicle causing harm to himself and the others inside of the store. Timothy stated prior to this date, on December 31st, 2024, Jaime was inside of the store acting the same way she did on today's date. Timothy informed me Jaime made a specific statement to other workers that she would drive her vehicle through the building. This statement was also a contributing factor into Timothy's well-founded fear.

I also made contact with an employee, identified as Dylan Morris. Dylan stated he recognized Jaime from previous encounters with her inside of the store, all involving Jaime yelling and screaming inside of the store. Dylan informed me Jaime has made numerous types of threatening statements in the past, however on today's date he felt as though Jaime was going to follow through with one of her threats. According to Dylan, Jaime left the store screaming. Dylan stated Jaime got inside of her vehicle and swerved her vehicle less than a foot away from the doors. Dylan stated he was in fear for the customer's and fellow employee's safety being at risk due to Jaime's actions.

I made contact with another employee identified as Mallory Hess. Mallory stated on December 31st, 2024, Jaime entered the store with her mother upset about the cost of their phone bill. Mallory was attempting to speak with Jaime and her mother, which is when Jaime began to act in an irate manner, screaming and yelling at Mallory. According to Mallory, Jaime stated to her that she was going to drive her vehicle into the building. She also began yelling at other customers inside of the store to leave due to Verizon being "scammers." During this incident on January 14th, Mallory stated Jaime was inside of the store again acting irate, screaming and yelling. Mallory stated that during this specific incident, it appeared Jaime was going to follow through with the statements and threats made while inside of the store. Mallory observed Jaime drive her vehicle toward the building, almost striking the front door. Mallory informed me she was in fear for herself and others safety inside of the building when this occurred.

I attempted to make contact with Jaime by contacting her mother, however was met with negative results.

While on scene I observed surveillance video of the white vehicle Jamie was seen driving towards the business. In the video, I observed the vehicle drive towards the front doors, over the curb of the sidewalk almost striking the front doors.

It should be noted, Timothy was able to provide me with Florida tag BL66ZV. Upon querying this tag via Sebastian Police Dispatch, I was able to confirm the tag belongs to the same vehicle seen in the video, registered to Jaime Rutkowski.

Due to the totality of circumstances including Jaime entering the Verizon business, screaming profanities and yelling at other customers disrupting the flow of their business, as well as making specific threats of violence by driving her vehicle through the business building with the apparent ability to do so as seen in the video showing the vehicle which all witnesses stated Jaime was driving, causing a well-founded fear in Timothy that violence was imminent with Jamie's vehicle being used as a deadly weapon, I find probable cause to place Jaime under arrest for violation of FSS 784.021(1A) AGGRAVATED ASSAULT WITH DEADLY WEAPON and FSS 877.03 BREACH OF PEACE.

Jaime was transported to the Indian River County Jail without incident.
