

NARRATIVE

On Tuesday, April 22, 2025, at approximately 0428 hours, while patrolling the 100 BLK of U S Highway 1, I received an LPR Alert on a Gold Toyota Camry Bearing Florida License plate IE75MB. The Alert advised the registered owner Ramos Bernabe Francisco's Florida Driver's License was suspended as of 10/04/2024. I observed a Hispanic male driving the vehicle whose appearance matched the photo of the Registered owner.

I conducted a Traffic Stop on the Gold Toyota Camry and conducted a passenger side approach. At the passenger window I made contact with the driver who was identified by his Guatemala ID card as Ramos Bernabe Francisco. I asked Francisco if he had a Driver's License to which he responded with "I don't have a license". A query of through DAVID was conducted and Francisco's Florida Driver's License was located and confirmed as Suspended on 10/04/2024. I returned to the vehicle and asked Francisco where his Florida Driver's License was to which he replied it is suspended. A search through NCIC/FCIC reviled Francisco had also received a Citation on 10/11/2024 (AH5SS7E) for Knowingly Driving while license suspended or revoked.

At this time, I asked Francisco to exit the vehicle to which he complied. As Francisco exited the vehicle, I placed him into handcuffs and escorted him to the passenger rear of marked agency issued patrol vehicle. Francisco was placed into the passenger rear of my agency issued patrol vehicle and transported to the Indian River County Jail without incident.

Francisco received a Citation (AKFS12E) for Knowingly Driving while license suspended or revoked.





On Tuesday, 4/22/2025, at approximately 1037 hours I responded to 5555 20th Street (Walmart) in reference to a shoplifting.

I made contact with Walmart loss prevention who had two subjects in their office. Loss prevention advised me of the following. While watching camera footage in the store he observed a white female, later identified as Donna Flores, take an electric bike from the sales floor. He continued to watch Flores walk the bike through the store. Once close to the exit of the store it appeared as though Flores was looking around to see if there was a door attendant. Flores then continued to wheel the electric bike past all points of sale and out the front door of the business. Loss prevention then stopped Flores and brought her back to the office. Loss prevention provided me with a receipt for the electric bike which totaled \$532.86.

I then read Flores her Miranda warnings to which she advised she understood. Flores advised me of the following. She came to Walmart to pick up the bike that her friend told her to pick up. Flores' friends name is Melissa who provided her with a receipt for the bike. Flores provided me with this receipt that was allegedly given to her by a female named Melissa. The receipt was for prescription prescription medication totaling \$105.94 and was dated for 4/21/2025.

I provided the receipt to loss prevention and requested that they review camera footage of the transaction.

While loss prevention was searching for the footage I asked Flores what Melissa looked like. Flores described Melissa as a white female with brown colored hair.

I reviewed footage of the prescription transaction which showed the person purchasing the item as a heavysset black female. I again asked Flores where she got the receipt because I knew she did not receive it from the Melissa female. Flores then admitted that she found the receipt laying on the floor of her residence and picked it up. Flores advised that it was one of her roommates receipts. Flores then admitted that she came to the store to steal the bike.

I placed Flores into handcuffs and escorted her to my patrol vehicle where she was placed under arrest for violation of F.S. 812.015 retail theft.

I then transported Flores to the Indian River County Jail where she was booked.




On April 23, 2025, at approximately 0038 hours, I conducted a traffic stop at 1015 Commerce Avenue, Vero Beach, Florida, in reference to a head light being out.

I approached the vehicle and made contact with George W. Murphy, the sole occupant of vehicle bearing Florida tag NLWZ20. Before I was able to identify myself and inform Murphy the reason for the stop, Murphy stated that he knows he was going to get pulled over and he knows what's going on. He stated that he knows it's the people where he's coming from and the people where he's going to and the people on his phone. I informed Murphy that I had no idea what he was talking about and Murphy continued to state that his son in-law was recently arrested with a lot of drugs on him and that it has something to do with that. I assured Murphy that I have no idea what he's talking about and informed him the reason for the traffic stop. Murphy stated that there could be drugs in the vehicle or all over him and that he's not sure because there has been other people in the vehicle.

I then instructed Murphy to step out of the vehicle and asked his consent to search the vehicle which he agreed to. My search revealed a broken piece of glass with visible residue. I asked Murphy where the rest of it was and he admitted it was in the air vent. Murphy was handcuffed with were double locked and checked for proper fitment. Murphy was placed in the back of my patrol vehicle and read his Miranda rights which he understood and agreed to speak with me. Murphy stated that he previously smoked cocaine out of the pipe. A glass pipe with a broken end matching the broken piece I found was tested with an agency issued cocaine testing kit and the results yielded positive for cocaine. Based on my training and experience I know that the glass pipe is commonly used to smoke crack cocaine.

Murphy was transported to the Indian River County Jail without further incident.

Based on the totality of the circumstances I have probable cause to charge Murphy with:

1. F.S.S. 893.147.1 – Possession of drug paraphernalia / and or use.

NARRATIVE

On Wednesday, April 23, 2025, I Deputy Martin responded to 1185 Old Dixie Hwy in reference to a business burglary in progress. Dispatch advised that a caller was reporting that they observed a male broke into a smoke shop near their location and entered the business. The caller was not able to provide a description of the male, but further stated that the male was still inside of the business while on the phone with dispatch.

Upon my arrival, I could observe a pile of glass by the front door and an entry into the business wide enough for a person to enter. As I approached the door I examined the inside of the business, to which I found a male wearing a black jacket with the hood covering his head and face in attempt to conceal his identity, and blue jeans standing inside of the business. I stated that I was law enforcement and told the male to raise his hands into the air and stay where he was. The male then walked away from myself toward the rear of the business. There he was met by other law enforcement deputies as he broke a bathroom window in an attempt to escape. The male eventually re-entered the front of the store where he began to follow lawful orders until he was placed into handcuffs and removed from the business. While searching the male a black in color vape device with the word "Quasar" was found on the male's person.

Once the business was secured and made safe, I read the male his Miranda warnings from my agency issued warning card. After reading his warnings the male; later identified as Denzell Deshay Washington via a Florida ID card, would not provide a statement to law enforcement as to why he was inside of the closed business and why the front door was smashed open. It should be noted that Washington matched the description of a male that was reported stealing a bike from a separate victim prior to the burglary. This bicycle was found on scene of the burglary. This case can be referenced in 2025-42124, a separate arrest affidavit was filed per the separate incident and victim. The business owner of The World Is Yours Smoke and Vape Shop; Handsome J. Fanning, informed me that the vape device found on Washington's did come from the business and cost \$25.00 USD. Fanning also informed me that his wife reviewed the security camera footage of the store, and it could be seen that Washington used a rock to break the glass of the front door of the business. It could also be seen that Washington was attempting to steal the money out of the tip jars and cash registers inside of the business. A rock was located inside of the business in close proximity of the front door. Handsome J. Fanning would later inform me the cost for the replacement and repair of the bathroom window and the front door of the business would be \$1000.00 USD for material and labor.

Due to the totality of the circumstances, that Denzell D. Washington entered The World Is Yours Smoke and Vape Shop at 1185 Old Dixie Highway owned by Handsome J. Fanning. At the time of entering the business, Denzell Washington had the intent to commit theft in that business. That Denzell Washington also, intentionally damaged the business of The World Is Yours Smoke and Vape Shop owned by Handsome J. Fanning. Denzell Washington did so while he unlawfully trespassed and occupied the business. That the damage was approximately \$1000.00 USD per the owner. Finally, Denzell Washington was placed under arrest for FSS 810.02 Burglary felony with a no bond status, and FSS 806.13 Criminal Mischief felony with a no bond status.

When Washington was interviewed he admitted to stealing Sherman's bicycle stating "it was free for the taking." Sherman was arrested wearing a black hoodie with writing on it and blue jean pants.

Sherman was taken to the IRC Jail for booking.
