NARRATIVE

On Monday, June 2, 2025, at approximately 1020 hours, I was dispatched to 4145 9th Street SW (Publix) in reference to a shoplifting. Dispatched advised that the suspect told the caller, Jordan Sihombing, who is the store manager, that he just exited the store with stolen items and the suspect advised him that he did it on purpose to get arrested.

Upon entering the office where the suspect was detained, I noticed it was James Jamel Washington. Washington was detained earlier at approximately 0758 hours at Cumberland Farm located at 880 27th Avenue SW for shoplifting (2025-58086) at that store. The manager did not to press charges due to the amount of the Gatorade which was approximately \$3.00.

I made contact with Sihombing and he advised that Washington stated to him that he wanted to be arrested because he has a drug problem. Sihombing advised that he wanted to press criminal charges due to the total amount of the items.

The items that were taken are:

NARRATIVE

On 06/02/2025 at approximately 1943 hours, I Deputy Austin Binner responded to a reckless driver near the intersection of County Road 510 and State Road A1A.

Prior to my arrival the victim (later identified as William Briggs) advised Indian River County Emergency Dispatch that a white female had followed him from the Wabasso Bridge to the Sebastian Inlet State Park in her vehicle screaming at him. Mr. Briggs had stayed on the phone with Indian River County Emergency Dispatch during the duration he had called in until Deputies were on scene with him.

As I arrived on scene, I observed Mr. Briggs on top of the female driver (later identified as Gayl Nye) as both parties were verbally argumentative.

Prior to interviewing all parties, I detained Mrs. Nye for safety due to myself being the sole Deputy at the location. Probable cause from my investigation is as follows.

In attempts to get away from Mrs. Nye, Mr. Briggs traveled North on A1A towards the Sebastian Inlet State Park. Mr. Briggs approximates Mrs. Nye had followed him a total of 10 miles.

While on the phone with Indian River County Emergency Dispatch, Mr. Briggs had pulled his vehicle into the Sebastian Inlet State Park to stop at a safe location, for responding Deputies. Mr. Briggs stated while he was attempting to enter the park he observed Mrs. Nye stopped in her vehicle approximately 40 yards behind him, which he believed she was going to block him in the park if he were to attempt to make a U-turn to escape. Mr. Briggs stated as he entered the park he informed the Park Ranger (identified as John Sweeney), that he was being followed by Mrs. Nye who was waiting outside of the park in her vehicle. Mr. Briggs expressed he was in fear due to Mrs. Nye following him from the Wabasso Bridge, and previously yelling at him.

Mr. Briggs stated he parked his vehicle where he was informed by the Park Ranger. Mrs. Nye immediately entered the parking area parked her car directly behind Mr. Briggs blocking him in, and denying him an escape route. Mr. Briggs stated Mr. Nye approached his vehicle, and began to knock on his window and yell at him in an aggressive manner. Mr. Briggs stated he believed his doors were locked on his vehicle. Shortly after she began to yell at him, Mrs. Nye opened Mr. Briggs door. In attempts to distance himself, Mr. Briggs closed his door attempting to lock it. Prior to successfully locking his door, Mrs. Nye opened the door a second time. Mr. Briggs stated he attempted to close the door again, but Mrs. Nye had stepped closer to him blocking his ability to close the door. Mr. Briggs advised due to Mrs. Nye denying him the ability to move on his own free will, he stated he forced her away from him to and simultaneously exited the vehicle. Mr. Briggs stated due to Mrs. Nye continuing to act in an irate manner he forcibly held her down in attempts to deescalated the incident. Mr. Briggs stated while he was attempting to restrain Mrs. Nye for their safety, Mrs. Nye had bit his right arm leaving a red bite mark with teeth impression (not drawing blood). Mr. Briggs advised he took these actions due to not knowing if Mrs. Nye was armed, and deemed his actions were appropriate to keep both parties safe.

Mrs. Nye advised post Miranda that she had parked her car directly behind Mr. Briggs. She stated she got out of her vehicle in attempts to speak with Mr. Briggs of his driving pattern. Mr. Nye advised she had opened Mr. Briggs door to
