NARRATIVE

On July 29th, 2026, at 2222 hours, I conducted a traffic stop on a black in color Kia sedan bearing FL/ LAJK79, for traveling 60+ mph in a 45mph zone. Prior to conducting the traffic stop, I observed the suspect vehicle travel over the solid white line of the bicycle lane. Upon making contact with the driver who was the sole occupant of the vehicle, I was met with an overwhelming odor of burnt marijuana. The driver identified himself as Clifvonta Lamar Sands. I questioned Sands if he had recently consumed marijuana too which he expressed the he had previously smoked and was wearing the same clothes he consumed the marijuana in. I requested Sands to provide me with his Florida issued driver's license, and he advised he did not have his wallet. I then requested Sands to provide me with valid proof of insurance and vehicle registration. Sands responded by advising the vehicle he was operating was his girlfriend's and he would have to make contact with her to obtain the requested information.

It should be noted that while speaking with Sands, I observed him to continuously look at the glovebox of the vehicle. Sands was able to provide me with an electronic copy of the vehicle's insurance, but was unable to locate the vehicle registration. I requested Public Safety Dispatch (PSD) to run Sands through FCIC/NCIC databases. While waiting for PSD to advise their findings, I requested Sands to exit the vehicle. Sands exited the vehicle and was detained without incident. PSD advised that Sands Florida issued driver's license was previously suspended on 7/14/2026 for a financial responsibility, and that he did not have a medical marijuana card issued to him. After securing Sands in the rear passenger compartment of my agency issued patrol vehicle, I advised him of his Miranda Rights too which Sands expressed his understanding and agreed to speak with me. Post Miranda, Sands expressed he no longer resided at the address listed on his Florida issued driver's license.

While speaking with Sands, he advised he consented to me searching the vehicle. While searching the suspect vehicle, I locate a tan Glock 26 in the glovebox. A query through PSD revealed Sands had one prior felony conviction in the State of Florida. After securing the firearm and the concluding my search of the vehicle, I went and made contact with Sands who expressed, before I even asked about the firearm, that it belonged to his girlfriend. At the time of contact, Sands was the sole occupant and sole individual in control of the vehicle. The firearm was located inside the glovebox, an area that's readily accessible to the driver. As the sole occupant, Sands had exclusive access to the firearm and the ability to take control of it. In addition, Sands' unsolicited statement that the firearm inside the vehicle belonged to his girlfriend further supports his knowledge of the firearms presence.

While enroute to the Indian River County Jail, my agency issued patrol vehicle increasingly became overwhelmed with the odor of raw marijuana. I questioned Sands if he was in possession of any raw marijuana too which he replied he did not. Sands became argumentative and advised he did not have a joint in his possession. After completing my initial arrest affidavit, I returned to my agency issued patrol

**NARRATIVE**

On Thursday, 07/30/2026, at approximately 0125 hours, I was flagged down by a firefighter on the scene on a structure fire at 3980 Lincoln Drive, Vero Beach, Florida 32967, in reference to a black female who said she was hit in the head with a rock.

I made contact with the female, identified as Stephanie Nicole Reese, who was extremely intoxicated and irate. I observed Reese to have a large welt on her head that was bleeding. Reese led Deputy Mims and I to the area where it occurred, at which time Reese began to accuse everyone who was outside on a balcony (for reference several houses were evacuated due to a structure fire IRC SO case # 2026-80981). The accused parties stated that Reese had fallen down, which while I was speaking with them, Reese fell on her face behind me. Reese then got up and started using extremely vulgar language, cussing at law enforcement and the people outside of the residences. Reese then became uncooperative, stating she would come back later and handle it herself. I attempted to calm Reese down and get her medical treatment, however she continued to use extremely vulgar language and refuse medical treatment. Reese persistently refused to cooperate with any investigation and refused to de-escalate during this incident. Reese then began to engage with the crowd that was evacuated with the structure fire and got irate with them.

Reese was omitting a strong odor of alcohol, her eyes were bloodshot and watery, and she was extremely unsteady on her feet. Reese later advised me that she did not remember how much alcohol she consumed but stated that she did have too much to drink.

Once Reese refused the ambulance and stated she was going to walk away, I told her that she needed to stop cussing and yelling at everyone that was around the area. Reese then used vulgar language at me and started to twerk in the middle of the road. At that time, I gave her a warning that if she continued this behavior she would be placed under arrest for disorderly intoxication. Reese continued on with her behavior, at which time I attempted to take her into custody. Once handcuffed, Reese threw herself on the ground and went dead weight on us. Reese refused any verbal commands to get up and cooperate with law enforcement, however she refused, prompting myself and other deputies on scene to lift her onto a medical stretcher. Reese's belligerent behavior continued, to the point where medical staff refused to transport her to the hospital because she was too irate.

I retrieved my agency issued patrol vehicle and positioned it next to the medical stretcher. Myself and other deputies on scene attempted to get Reese to get into the back of the patrol vehicle on her own accord, however she refused and went limp on us again. This prompted me and other deputies to lift her and carry her to the vehicle. Reese refused to get in the patrol vehicle and while we attempted to get her in, she deliberately cocked back her leg and kicked me in my right thigh. Reese attempted to kick me

again however I grabbed control her of leg and continued to try to carry her into the vehicle. Once she was put into the patrol vehicle, she began to kick my windows and headbutt the divider between the backseat and front seat of my patrol vehicle. Reese kicked my vehicle and headbutted it several times.

Reese was transported to Cleveland Clinic Indian River Hospital for medical treatment and clearance. Upon arrival at the hospital Reese again had to be dragged out of the vehicle and put into a wheelchair because she refused to cooperate with law enforcement. While attempting to get her into the wheelchair she attempted to kick at deputies again however we controlled her legs. Once in the wheel chair, Reese attempted to get up and resist myself and other deputies at the hospital. Reese was not cooperative until she was put in a hospital room and handcuffed to a hospital bed. While in the hospital bed, Reese attempted to get out of handcuffs and rolled out of the bed. Reese later calmed down when receiving treatment and began more cooperative.

During this incident, Reese while in an intoxicated state, endangered the safety of the people evacuated during the structure fire by making threats to do harm to them and caused a public disturbance by yelling obscenities at the crowd of evacuated people, prompting multiple people to be upset and start recording her behavior asking for law enforcement intervention. While being placed under arrest, Reese intentionally hindered law enforcement by refusing to cooperate and physically using her body weight to cause law enforcement to have to physically escort her. While attempting to get Reese into a patrol vehicle to transport her for medical treatment, clearance and eventually to the County Jail, she intentionally kicked me in my right inner thigh.

Based on the totality of the circumstances, Stephanie Nicole Reese was placed under arrest for the following offenses:

- F.S.S. 784.07.2d – Battery on a Law Enforcement Officer.
- F.S.S. 843.02 – Resisting arrest without violence.
- F.S.S. 856.011 – Disorderly Intoxication.

Reese was transported to the Indian River Cleveland Clinic Hospital for medical treatment and clearance. After receiving medical clearance, Reese was transported to the Indian River County Jail without further incident.
