The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On **09/07/2026** , at **22:48** (Specifically include facts constituting cause for arrest.)

On September 7th, 2026, at approximately, 2248 hours, I, Ofc. Z. Dominguez, responded to the area of 1700 Indian River Blvd, in reference to a vehicle crash.

Upon arrival, I spoke with the defendant, Jeffrey Karshner. It should be noted that while speaking with Karshner, he seemed visibly disoriented and was unable to stand up straight. I asked Karshner if he required medical attention numerous times, receiving no reply. Indian River County Fire Rescue responded to the scene and evaluated Karshner. I also asked Karshner for his Driver's License, which he didn't provide. It should also be noted that during this interaction, Karshner's shorts appeared to fall down and he urinated on himself. While speaking with Karshner, he advised that he didn't see a vehicle stopped in front of him and "kept going". Karshner also said that he "had a few beers". Karshner's lack of balance continued to be apparent and I offered for him to grab my wrist as support. Despite my helping hand, Karshner still almost fell over, claiming he had prior medical issues which resulted in him using a cane.

Due to the aforementioned statements, Karshner's inability to stand, a blank stare with red glossy eyes, and a fruity odor of alcohol emitting from his breath/vehicle, I informed Karshner that the civil crash investigation had been concluded, and I'd be switching to a criminal DUI investigation. I Mirandized Karshner, who acknowledged his rights, and refused to speak with me. SFSTs were not offered to Karshner on scene due to his prior medical circumstances and safety reasons. Upon running Karshners name through VBPD Communications, I was advised that Karshner didn't possess a Florida Driver's License and had an active warrant out of Collier County for a past DUI.

At this time, I placed Karshner under arrest for DUI and DWLS, in violation of F.S.S. 316.193(1a) and 322.34. Karshner was also issued 2 criminal citations for DWLS (AMZ94HE) and DUI (AO914FE)

While conducting an inventory on the vehicle, officers discovered an empty 8-pack box containing 16oz Budweiser. Empty Budweiser cans were also scattered throughout the vehicle and in the front seat cup holders.

Karshner was transported to Cleveland Clinic Indian River Hospital, where he received medical clearance, and Doctors collected a blood sample.

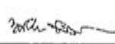
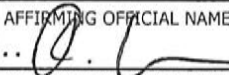
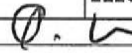
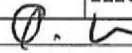
Karshner was then transported to the Indian River County Jail for booking/holding, \$650 bond.

While at IRCJ, Karshner agreed to supply a sample of his breath for testing to determine it's alcoholic content. However, it should be noted that his samples were taken at approximately 0245 hours (4 hours after the original incident) The breath samples showed the following results:

Sample 1: 0.057

Sample 2: 0.058

NARRATIVE

On Tuesday September 8, 2026 at approximately 0100 hours, K9 Deputy B.Mckay (5941) observed a red Cadillac passenger car bearing Florida tag (DZ08EI) located at 880 27th Avenue SW (Cumberland Farms). The vehicle proceeded onto SW 9th Street without coming to a complete stop violating FSS 316.125. I, Deputy Sibole conducted a traffic stop at the 3300 block of SW 9th Street on the above vehicle.

I then approached the passenger side B pillar when I made contact with the driver, Chad Walters who was identified via Florida driver's license and passenger, Christina Rodrigues who was also identified via Florida driver's license. While asking Walters for his driver's license and other vehicle documentation I observed sweat dripping down his face and his hands shaking, indicating nervousness. I found this alerting due to Walters sitting inside a vehicle with climate-controlled air conditioning.

While running a FCIC/NCIC query on Walters Deputy Mckay approached Walters who remained in the driver seat and ordered him out of the vehicle. While outside the vehicle Deputy Mckay asked Walters for consent to search the vehicle in which Walters exercised his fourth amendment and denied. Deputy Estrella (6212) then ordered Rodrigues out of the vehicle. Deputy Mckay then proceeded to walk around the vehicle with his K9 partner Tobi in which the K9 alerted on the vehicle.

At this time Deputy Mckay and I proceeded to search the vehicle. Inside a purse located on the passenger seat which also contained the identification card of Rodrigues I observed loose marijuana in a plastic bag. While searching the trunk of the vehicle Deputy Mckay observed a black zippered bag located inside a plastic bag. Inside the black zippered bag a glass pipe with white crystal residue consistent with methamphetamine, two aluminum foil wrappers with burnt residue which through my training and experience I've learned to be "tooters", consistent with methamphetamine users, two lighters, a red straw which was cut in to approximately three inches, and a plastic baggie with an unknown white crystal material was located.

While continuing to search the trunk compartment of the vehicle Deputy mckay proceeded to detain Walters in which Walters grabbed a plastic bag containing a white crystal-like rock substance out of his left cargo pocket and attempted to throw it under my patrol vehicle; in an obvious attempt to conceal this piece of evidence from discovery. While attempting to throw the item in his pocket Walters braced and actively pulled against Deputy Mckay and Deputy Estrella. At this time Deputy Mckay, Deputy Estrella, and I conducted a front take down on Walters causing him to land in a prone position on the asphalt.

Once in custody, Walters was searched then placed into the rear passenger seat of my patrol vehicle

while we continued to further investigate. While continuing to search the trunk, I found a small plastic bag which contained a white powder substance located inside a black tool pouch as well as another plastic bag which contained a white crystal-rock substance.

Once all the narcotics and paraphernalia were collected, I proceeded to individually field test each item which revealed the following:

The glass pipe was scrapped and field tested positive for methamphetamine. The white rock substance inside three separate plastic bags field tested positive for methamphetamine. The white powder inside a small plastic bag field tested positive for cocaine as well as fentanyl. It should be noted that fentanyl is often added to numerous other controlled substances for various reasons, one of which is a "speed ball" method, an upper mixed with a downer, to elongate or control the following high received by its' consumption.

Walters was charged with three separate counts of FSS (893.13) possession of controlled substance, one count of FSS (893.147)(1b)) possession of drug paraphernalia, one count of FSS (918.13) tampering with or destroy evidence, and one count of FSS (843.02(3143)) resisting without violence.

Deputy Moon (6015) responded and transported Walters to Indian River Hospital (Cleveland Clinic) for medical clearance. While at the hospital Deputy Moon read Walters his Miranda Rights in which he refused to speak.

Once cleared by the medical staff, Walters was transported to Indian River County Jail where he was turned over to the care and custody of the corrections Deputies without incident.
