An employee walked him to the bathroom unlocked the door and the male later identified as Ian Lyle Anderson took the key from the employee's hand, then went into the bathroom. Upon the male exiting he was asked about the key and said he did not have it. The male then went to the cooler and was looking at the water. Candice believes the male took a bottle of water and exited without paying for the concealed item and the store bathroom key.

Candice valued the water at \$2.50, the turquoise key chain at \$5.00 and the key at \$5.00.

Corporal Barcaro located a male matching the description behind Checkers located at 1495 US Highway 1, Vero Beach. The male was identified by his Arizona ID Card as Ian Anderson. On Ian's person Corporal Barcaro located a turquoise key-chain with a gold/bronze colored key.

Corporal Barcaro read IAn his Mirand Warning's and Ian advised he understood and wished to talk with law enforcement. Ian was asked if he had the bathroom key to Five Below and he advised he did not.

I conducted a show up with Candice and read the agency's show up instructions to her. Candice advised she understood. Upon arrival at the location, Candice positively identified Ian as the suspect. Ian was placed into custody for petit theft.

Ian was transported to the Indian River County Jail Complex without incident.

This was captured on my agency issued body worn camera.

Ian intentionally deprived Five Below of their keychain and bathroom key, by taking the key from them and exiting the store without returning it. Ian was charged with F.S.S. 812.014.3A 2nd degree petit theft.

NARRATIVE

On Friday, May 15, 2026, at approximately 1800 hours, I responded to 5555 20th Street, Walmart, in reference to a shoplifting.

Upon my arrival, I spoke with Loss Prevention Officer Sara Ingo, who provided the following written statement:

"I, Sara Ingo, Asset protection for Walmart, witnessed on CCTV an unknown male, later identified as Javier Sanchez Vazquez, approach the self-checkout register 23 at approximately 16:55. Upon arrival, subject began stacking 2 items together and scanning them as one. (Stacking items is identified when the subject places 2 or more items together over the scanner at one time, only prompting the register to account 1 of the items). I immediately pause the transaction for an associate to come over to assist. After unpausing the transaction, Subject continued to place items into Walmart bags without any intent or attempt to scan the items. Subject then pays for the items he did scan and the exits out the GRC doors, passing all points of sale. I then approach the Subject and explain my role as Asset Protection. I then explain that some items did not get rang up correctly. Subject is then escorted back to the Asset Protection office where I was able to verify what was rung up on his receipt versus what was unaccounted for. The total item count was 8 items with a total loss of \$42.56. Walmart wishes to prosecute and trespass."

I then spoke to Javier, Javier through spontaneous utterance advised that he did not know that they were Walmart employees because they were in plain clothing. Javier thought he was getting jumped.

Walmart reported the following items stolen:

Walmart has a total loss of \$42.56

At the scene, I reviewed the store's surveillance footage, which corroborated the details provided in the written statement. Considering all evidence presented, Javier Sanchez Vazquez is in violation of Florida Statute 812.014 (3)(A) Second Degree Petit Theft.

Javier was transported to the Indian River County Jail.

PROBABLE CAUSE STATEMENT

I conducted a traffic stop on a silver Toyota Camry (FL tag # 21AVBX) at the 3300 block of Atlantic Boulevard. Prior to the stop, I was at the intersection of 34th Ave (Airport Drive) and Atlantic Boulevard when I observed the aforementioned vehicle traveling south on 34th Avenue (Airport Drive) and then fail to stop, entering the intersection which had a clearly marked stop line and stop sign. The silver Camry made a left turn onto Atlantic Boulevard, traveling east bound which I then activating my patrol lights. It should be noted that there were vehicles in the immediate area when the traffic violation occurred.

Once stopped, I made contact with the driver (drivers side) and one additional passenger. The driver/defendant was later identified as Edward Ramcharran (W/M DOB: 10/31/1972) by his Florida drivers license.

I requested the defendant to provide me with his documents and while standing by the front driver side and speaking with the defendant, I noticed a moderate odor of an alcoholic beverage emanating from within the vehicle and possibly from his person. I noticed the defendant had slowed mused speech and lethargic, slowed movement. The defendant also had glossy, red, watery eyes. The defendant stated he had drank three beers today but stated he consumed them around 1600 hours. The defendant stated he had just left the airport and was on his way home.

Based on these observations and statements, I had reasonable suspicion to believe that the defendant was impaired and requested that he exit the vehicle. Once outside of the vehicle, I confirmed the odor of an alcoholic beverage to be coming from the defendant's person which was moderate.

I then informed the defendant that I would be conducting Standard Field Sobriety Exercises. I asked the defendant if he had any illnesses, pain, or disabilities to which he denied. The defendant stated he did not take any prescription medication and stated he only uses reading glasses.

I then began the Standard Field Sobriety Exercises. Each exercise was demonstrated and explained to the defendant prior to having him perform them and he stated that he understood them. The defendant was given the option to keep his shoes on or remove them for the exercises. The defendant kept his shoes on.

The results of the field sobriety exercises are as follows:

HGN (Horizontal Gaze Nystagmus)

- Equal tracking and pupil size (Both eyes);
- Lack of smooth pursuit (Both eyes);
- Distinct and sustained nystagmus at maximum deviation (Both eyes);
- Onset of nystagmus prior to 45 degrees (Both eyes)
- Slight front to back swaying
- Trouble following red stimuli
- Head movement

WALK AND TURN

- Did not remain in starting position during instruction phase
- Began exercise prior to being instructed
- Interrupted during instruction phase
- Conducted 10 steps on returning instead of the instructed 9 steps
- Used arms for balance
- Stepped off line
- Missed heel-to-toe
- Stopped while walking

ONE LEG STAND (Right Leg)

- Began exercise prior to being instructed
- Used arms for balance
- Placed foot down
- Improper counting ; other than instructed
- Stopped exercise

At approximately 2259 hours, the defendant provided the first sample which read Volume Not Met, the second sample at approximately 2302 hours which read 0.180 g/210L, and the third sample at approximately 2305 hours which read 0.173 g/210L.

I then read the defendant his Miranda Warning from a prepared text. The defendant stated he understood and agreed to speak with me. At that time, the defendant stated he had been operating a motor vehicle and stated he had consumed some Budweiser beer cans that were around 6 ounces and stated he drank them around 1130 hours but then stated he had consumed some around 1400 hours. NARRATIVE

On May 16th, 2026, at approximately 0250 hours, I responded to 1090 S. U.S. Highway 1 in reference to a suspicious person. The calling party was identified as Focus Auto, a video camera monitoring company which car dealerships use. They advised a male party was laying in the bed a pickup truck within the lot. It should be noted, the address is a parking lot near an empty building. This parking lot contains overflow Ford vehicles which are for sale for a nearby Ford dealer. As such, there is little legitimate reasons to be present at such location at 0250 hours in the morning. The parking lot is lights, with 24/7 video cameras, and signage indicating such at multiple points around the property.

Deputy Goodrich, Deputy Yerian, and I responded. Upon arrival, I observed a male later identified as Mason McGuire, in the bed of a pick-up truck. The truck was identified as a Ford with vin 1FTBF2BA0TED86709. We issued multiple verbal commands to for him to exit the vehicle, where he was handcuffed (double locked/checked for fit) and detained.

Deputy Goodrich read Mason his Miranda rights, where he refused to speak with law enforcement. While attempting to speak with Mason, I observed his eyes to bloodshot, glassy, and he had an odor of alcohol coming from his person. Since Mason refused to answer questions, he would not allow to dispel our beliefs of loitering and prowling.

A look into the rear of the truck bed he was ordered out of, was a Busch Light Beer can (cold to the touch). The beer was open half drunk. The beer can was dumped out and thrown out. I also observed a half-smoked marijuana cigarette on the other side of the truck. This item was seized as evidence. It should be noted the bed of the truck was otherwise empty besides these items.

Deputy Yerian contacted the caller at Focus Auto. It was learned Mason had pulled on one vehicle's door handles (Vin 1FT8W3BM2TED87550), and actually entered the cab of another vehicle. The vehicle he was found lying in the bed of was the vehicle he entered. Therefore, all the elements of attempted auto burglary are met, however, due to an inability to make contact with a victim, this charge is not being pursued at this time. Attempts will be made in the next 24 hours regarding this. Still photographs were sent to me of these, which were uploaded to Evidence.com.

Pursuant to Mason's possession of alcohol, marijuana, and loitering and prowling, he was placed under arrest.

PROBABLE CAUSE STATEMENT

I observed a white Nissan 4 door car traveling well above the posted speed limit cutting in and out of slower moving vehicles that were traveling the speed limit. I visually estimated the cars speed to be between 75-80mph in a posted 50mph zone. I activated the front antenna of my radar unit in moving mode and received a target speed reading of 77mph and a patrol speed consistent with my speed.

I turned around and called it out on the radio, but was able to catch up to the vehicle before other officers. I initiated a traffic stop near Captain Hiram's on US Highway 1 in Sebastian and the vehicle continued driving for nearly a quarter mile with my emergency lights and sirens activated. Once stopped near Jackson Street and US1 I observed a small child jump from the front seat to the back seat.

I made contact with the driver who said his license was suspended and identified himself as Rodolfo Deleon. He said his 2-year-old son, Leonard was in the front seat prior to being stopped. There were no child restraints int the vehicle at all. While speaking with Rodolfo I also observed an open Modelo beer can on near the center console within arm's reach of both him and his 2 year old son. In the back seat was 2 female passengers approximately 8 years old, both restrained in seat belts.

I confirmed that Rodolfo's license had been suspended multiple times form 2023 with the latest one being on 03/31/2025. Once arrangements were made for his sister to pick up the children and the vehicle Rodolfo was placed under arrest.

NARRATIVE

On 05-16-2026 at approximately 1841 hours, the Indian River County Sheriff's Office Communications Center (Dispatch) received a reckless driver call for service in reference to a black Porsche bearing Florida License Plate RLW119 traveling northbound on Interstate 95 near the Vero Beach exit area in Indian River County, Florida. The complainant advised the vehicle was swerving off the roadway and unable to maintain its lane of travel.

Deputy D. Magill #6298 responded to the area and entered Interstate 95 northbound from State Road 60 in an attempt to locate the vehicle. At approximately mile marker 153 northbound, Deputy Magill observed a black Porsche abruptly travel from the number one lane into the number three lane without signaling and nearly leave the roadway onto the right shoulder. Deputy Magill attempted to catch up to the vehicle but was temporarily obstructed by traffic.

As Deputy Magill continued northbound, he observed a white Dodge truck whose driver began pointing toward the black Porsche, which was captured on Deputy Magill's in-car camera system. Deputy Magill then observed the black Porsche traveling in the number three lane. The vehicle's left tires crossed over the white lane divider into the number two lane before the driver overcorrected back to the right. This caused the vehicle's right-side tires to cross over the solid white line onto the shoulder of Interstate 95.

Deputy Magill attempted to conduct a traffic stop near the State Road 512/Fellsmere exit area; however, the driver failed to immediately stop and continued traveling before eventually pulling over near the 9400 block of County Road 512 in Indian River County, Florida.

I responded to Deputy Magill's traffic stop location and made contact with the driver and sole occupant of the 2020 black Porsche bearing Florida License Plate RLW119, who was identified via his Florida Driver's License as Mr. Marazzi (DOB: 02-27-1972).

Upon contact with Mr. Marazzi, I immediately observed several indicators commonly associated with impairment. Mr. Marazzi was extremely unsteady on his feet and had to utilize poor balance while standing. I detected a strong odor of an unknown alcoholic beverage emitting from his breath while he was standing outside and away from the vehicle. I further observed Mr. Marazzi's eyes to be watery and glassy, and his speech was slurred, thick-tongued, and slow.

Mr. Marazzi displayed a visible orbital sway of approximately three inches and was unable to maintain his balance while standing. At one point, Mr. Marazzi had to sit down on the ground while Deputy Magill conducted a driver's license and warrant status check through Dispatch.

Throughout our interaction, Mr. Marazzi continued displaying numerous indicators consistent with impairment. He demonstrated poor divided attention and struggled to process and respond to basic questions and instructions.

NARRATIVE (Continuation)

When asked, Mr. Marazzi stood back up; however, he remained extremely unsteady on his feet. I asked Mr. Marazzi if he would voluntarily participate in roadside sobriety exercises so I could determine whether he was safe to operate a motor vehicle, and he agreed.

Prior to beginning the exercises, Mr. Marazzi stated he did not have any injuries, physical impairments, or medical conditions that would prevent him from walking in a straight line or standing on one foot. Mr. Marazzi advised he suffered from acid reflux but denied any other medical conditions.

Horizontal Gaze Nystagmus (HGN):

I attempted to administer the HGN exercise; however, Mr. Marazzi was unable to properly follow the stimulus. Mr. Marazzi maintained a fixed gaze and was unable to follow instructions necessary to complete the exercise.

Walk-and-Turn:

Mr. Marazzi was unable to assume or maintain the starting position for the exercise. He began walking before instructions were completed and kept his elbows flared outward for balance. Due to his level of impairment, I was unable to properly provide instructions for the exercise. I attempted the exercise a second time; however, Mr. Marazzi remained unable to complete the physical task safely.

Finger-to-Nose:

I attempted to administer the Finger-to-Nose exercise; however, Mr. Marazzi was unable to follow the directions necessary to complete the exercise.

At that point, Mr. Marazzi was so impaired he was unable to safely complete standardized field sobriety exercises. Mr. Marazzi displayed a continuous orbital sway throughout the investigation. During transport to the Indian River County Jail, Mr. Marazzi fell asleep in the rear seat of my patrol vehicle and began snoring.

Based upon the totality of the circumstances, including the reckless driving observations made by Deputy Magill, Mr. Marazzi's physical indicators of impairment, his inability to maintain balance, his poor divided attention skills, the odor of an alcoholic beverage emitting from his breath, and his inability to complete field sobriety exercises, I determined Mr. Marazzi was under the influence of alcoholic beverages or chemical substances to the extent his normal faculties were impaired and he was unable to safely operate a motor vehicle.

Mr. Marazzi was subsequently taken into custody for Driving Under the Influence and transported to the Indian River County Jail.

At the jail, Mr. Marazzi was requested to provide a lawful sample of his breath pursuant to Florida's Implied Consent Law. Mr. Marazzi refused to provide a lawful breath sample.



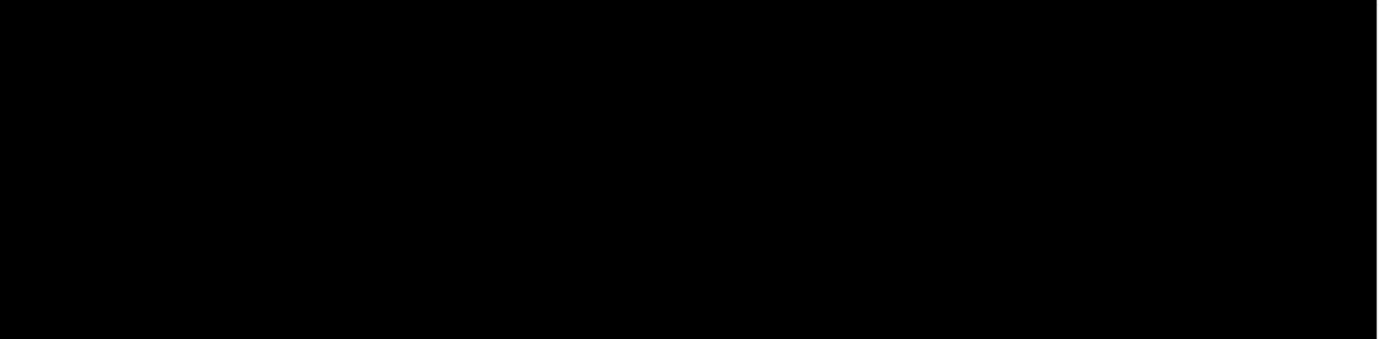

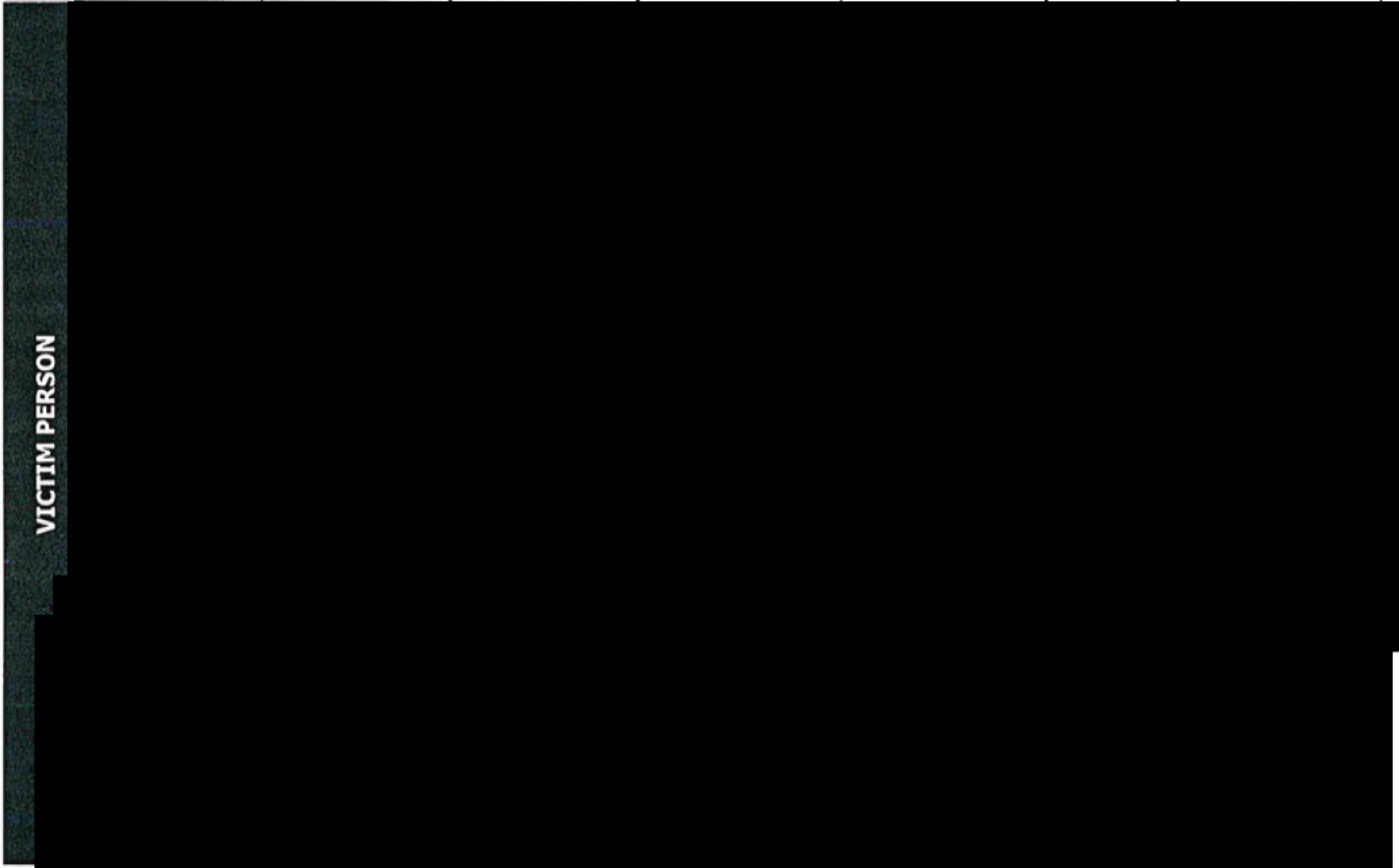

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 05/16/2026 at 21:35 (Specifically include facts constituting cause for arrest.)

PROBABLE CAUSE STATEMENT

On 16 May 2026 at approximately 1913 hours, I responded to [redacted] for a disturbance.

Upon arrival, I as I approached the front door, Ofc. Smith was exiting the residence with the caller, identified as Donna Schiebler. Ofc. Smith stated that the victim, [redacted] identified as [redacted] had just left. Donna stated she believed the suspect, her daughter, identified as Lindsey Theissen, was still hiding in the house. Ofc. Smith and myself check the residence and located Lindsey in a bedroom at the rear of the residence. I instructed Lindsey to come out of the room and speak with us about what had occurred.

She said today she had gotten into an argument with Donna about a missing vape she believed Donna had taken. She said that during the argument, [redacted] injected [redacted] into the argument, and threaten to call the police. I asked Lindsay if, at any time, the argument became physical, and she stated no. I asked Lindsey if she ever took the phone and again she stated no; however she did look at it to see who [redacted] was trying to call.

While I was speaking with Lindsey, [redacted] returned home. Ofc. Smith took [redacted] outside to speak with [redacted] about what had occurred. See Ofc. Smith Supplement.

I spoke with Donna, and she stated that she had been arguing with Lindsey throughout the day about a missing vape, which Lindsey believed she had taken. She stated that due to the escalation, she went to a bedroom to separate herself from Lindsey. Donna said Lindsey started to beat on her door, making threats to "beat her up". She stated that Lindsey started to yell at [redacted] attempting to take [redacted] phone from [redacted] because she was afraid, [redacted] was going to call the police. During the altercation, she said Lindsey pushed [redacted] and was grabbing [redacted] wrist, causing injury to [redacted] right hand and wrist. She said ultimately, Lindsey was able to get the phone from [redacted]. She stated she called the police. Donna refused to provide a written statement and denied EMS.

I spoke with Ofc. Smith, who stated there were injuries to [redacted] hand were consistent with what Donna had stated occurred.

He stated [redacted] said that Lindsey began accusing [redacted] and Donna of stealing her THC vape. During the argument, [redacted] said [redacted] took [redacted] phone out to call Lindsey's boyfriend to come get her. When [redacted] did, Lindsey believed [redacted] was calling the police and began trying to take [redacted] phone. In the struggle over the phone, [redacted] said that Lindsey squeezed [redacted] hand and caused [redacted] skin to tear on [redacted] right hand and index finger. [redacted] explained that once Lindsey got [redacted] phone, [redacted] was scared, so [redacted] got into [redacted] car and attempted to leave. While in [redacted] car in the garage, [redacted] said Lindsey got into the back seat and told [redacted] she would give [redacted] the phone back if [redacted] got her vape back. Eventually, Lindsey got out of the car and threw the phone at the front of the car, causing it to fall onto the driveway. There was no damage to the car or phone. I observed the injuries on [redacted] hand that were still actively bleeding while I was speaking to [redacted].

Due to the statements provided and evidence of injury, Lindsay was placed under arrest for the following charges: FSS 784.08 Battery on persons 65 years of age or older: Lindsey intentionally grabbed [redacted] in an attempt to get [redacted] cell phone. [redacted] is over the age of 65 years old and is the [redacted] of Lindsey.

Lindsey was arrested and transported to the Indian River County Jail without incident. All parties involved refused EMS and did not want to press charges against Lindsey. They were explained due to the Domestic Violence Laws; I was required to make an arrest.

This incident was captured on my rear in-car camera and body worn camera. A Domestic violence packet was completed.

NARRATIVE

On Saturday, 05/16/2026, at approximately 1959, I was dispatched to 2495 South U.S Highway One, Vero Beach, Florida 32962, in reference to a reckless driver.

The complainant, David Kazmerowski, was driving behind a White Bentley Continental convertible bearing New Hampshire tag 5642896 when observing the vehicle swerve between lanes, go off into the grass in the median and stop in the middle of the intersection at 9th street southwest and US Highway One, impeding traffic. Kazmerowski followed behind the vehicle and notify Indian River County Public Safety Dispatch of the vehicle's driving pattern and direction of travel. I was located at 8th street and US Highway One when I was informed that the Complainant was behind the vehicle at 4th street and US Highway one. I pulled off into a turn lane and observed a vehicle matching the description approach my vehicle, still continuing northbound, at which time I turned around and started to catch up to the vehicle.

I followed the vehicle, which had the same license plate and description as provided by the caller, as it continued westbound on 8th street from US Highway One. I noticed the vehicle cross the middle line just east of Old Dixie Highway on 8th street. When approaching the intersection at Old Dixie Highway and 8th street, the Bentley failed to stop on a solid red light and continued westbound after running the stoplight. I conducted a traffic stop on the vehicle at 1000 8th street based on probable cause of a violation of F.S.S 316.075(1)(C)(1) – Fail to stop a steady red signal.

I made contact with the driver, identified as Peter earl Morrissette, and requested his driver's license, registration and proof of insurance. I observed Morrissette to have glassy, watery eyes as he continued to try to avoid eye contact with me. Morrissette while going through his wallet pulled out 2 business cards and a credit card. While Morrissette was collecting his documents I asked him where he was coming from, which he started to give me two different restaurants where he just had dinner. I asked Morrissette if he had anything to drink, Morrissette stated he had 1 beer while at dinner. I told Morrissette to continue to look for his documents, however Morrissette was unable to produce registration or insurance for his vehicle. I asked Morrissette about his medical history, Morrissette stated he is not diabetic but had gone to the hospital a few weeks ago because of [REDACTED] Morrissette advised me he takes 7 pills daily but the medications he takes do not prevent him from driving. Morrissette also wears glasses and utilizes a walking cane to move around because he has difficulty walking. I asked Morrissette if he was willing to complete standard field sobriety exercises to determine if he had the ability to drive, which he stated he would attempt to perform them but would struggle because of his medical issues. I asked Morrissette to step out of the vehicle to conduct modified tests, when exiting the vehicle, I observed a plastic cup half full of dark colored liquid inside of it. Deputy Ciofalo asked Morrissette if he could sniff the glass to see if it was alcohol. Morrissette stated that the plastic cup contained titos and coke.

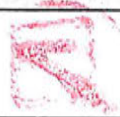

NARRATIVE

On May 16th, 2026, at approximately 2116 hours, I responded to the Indian River Mall located at 6200 20th Street, Vero Beach, Florida, in reference to a DUI investigation.

Upon arrival, I made contact with Sergeant D. Rodriguez, who informed me that the driver of a Honda Odyssey bearing Florida tag #Y33VCM, later identified as Lauren Ashley Lewis, appeared to be under the influence of an unknown substance due to exhibiting signs of impairment. Sergeant D. Rodriguez further stated that he did not observe any alcoholic beverages inside the vehicle. Sergeant D. Rodriguez requested that I conduct a DUI investigation.

I then made contact with Lewis. During my interaction with her, I observed droopy eyelids, slow speech, slow deliberate movements, and drowsy behavior throughout the investigation. I asked Lewis if she was willing to participate in standardized field sobriety exercises in order to dispel my suspicion that she was driving under the influence. Lewis agreed to participate.

Prior to administering the exercises, I asked Lewis a series of medical questions to ensure she was capable of safely performing the exercises. Lewis stated that she did not suffer from any medical or physical conditions that would prevent her from completing the exercises. Lewis stated that she wore contact lenses; however, she advised that she was able to see clearly during the exercises.

All field sobriety exercises were explained and demonstrated prior to Lewis beginning each exercise. I confirmed Lewis understood the instructions before the start of each exercise.

1. **HORIZONTAL GAZE NYSTAGMUS (HGN)** – Resting nystagmus was not observed. Equal pupil size was observed in both eyes. Lewis had difficulty following the stimulus, as she moved her head and followed slowly with her eyes. Distinct and sustained nystagmus at maximum deviation was not observed in either eye. Onset of nystagmus prior to 45 degrees was not observed. Vertical gaze nystagmus was not observed. During this exercise, Lewis displayed drowsy behavior and a dazed appearance.
2. **WALK AND TURN** – A straight white line on the roadway was used for this exercise. Lewis stated she had no orthopedic issues and preferred to perform the exercise while wearing her sandals. Lewis began the exercise facing northbound and failed to touch heel-to-toe on all steps. Lewis stepped out of line several times and counted to step ten before asking if the exercise was complete. Lewis then turned improperly by failing to take a series of small steps and walked southbound, again missing heel-to-toe on all steps and counting to step ten as well.
3. **ONE LEG STAND** – During this exercise, Lewis raised her left foot and swayed side to side. Lewis placed her foot down at count six and asked if I wanted her to restart the exercise. When I asked if she understood the instructions, Lewis stated that she did not hear me. I then re-explained the instructions and allowed her a second attempt. Lewis counted improperly by stating, “one thousand one, two, one thousand three.” Lewis again placed her foot down multiple times, swayed side to side, and was unable to maintain balance. Lewis repeatedly restarted her count and was unable to progress consistently through the exercise.
4. **FINGER TO NOSE** – Lewis was instructed on how to perform the exercise and stated she understood the

instructions. Lewis was instructed to touch the tip of her nose with the tip of her finger in the following sequence: left, right, left, right, right, left. Lewis was unable to properly touch the tip of her nose and instead touched the bridge of her nose, the side of her nose, and her upper lip. Overall, Lewis performed poorly on all field sobriety exercises.

Based upon my investigation, I determined there was probable cause to believe that on May 16th, 2026, Lauren Ashley Lewis was in actual physical control of a motor vehicle while under the influence of alcoholic beverages and/or controlled substances to the extent that her normal faculties were impaired, rendering her incapable of safely operating a motor vehicle.

I then placed Lewis under arrest without incident and advised her of her Miranda rights. Lewis stated she understood her rights and voluntarily agreed to speak with me. Lewis stated that she previously [REDACTED] Lewis further stated that the medications were located on the passenger-side floorboard of her vehicle.

After retrieving the medications, I observed that the [REDACTED] prescription bottle contained several mixed pills. When asked about the pills, Lewis showed me multiple prescriptions listed under her name through the Walgreens mobile application. Lewis stated that the pills inside the [REDACTED] bottle included [REDACTED] Lewis stated that she mixed the medications together for convenience because the original prescription bottles were too large to carry with her throughout the day.

With the assistance of Deputy Yerian, the following was noted. For the [REDACTED] bottle. Four pills were prescribed per day with a total amount of 360 pills per bottle. Last refill was dated on April 4th, 2026. At the time of this incident, 18 [REDACTED] pills were inside the bottle. Three [REDACTED] were located in the bottle. Seven [REDACTED] were also located, and seven [REDACTED] pills were inside the bottle as well.

For the [REDACTED] bottle. Ninety pills were prescribed for this medication with three pills to be taken per day. last refill was dated on May 10th, 2026, and 47 pills were left in the bottle. Both bottles state on the side "May cause you dizziness or drowsiness. Do not drink alcohol with this drug. Use care when operating a vehicle, vessel, or other machines".

I then transported Lewis to the Indian River County Jail without incident. Upon arrival at the jail, Lewis agreed to provide breath samples. The results of the breath test indicated a breath alcohol concentration (BrAC) of 0.000 grams of alcohol per 210 liters of breath on both samples.

Due to Lewis' observed impairment, combined with the presence of prescription medications, I requested both a urine and blood sample as part of my investigation. Lewis refused to provide either sample. I then read Lewis the implied consent warning for urine testing and advised her of the consequences of refusal. Lewis stated she understood and still refused to provide a urine sample.

At the conclusion of my investigation, I determined there was probable cause to believe Lauren Ashley Lewis
