

On May 21, 2025 at approximately 1515 hours, I responded to the 1300 6th Avenue, East Gate Condos, in reference to a suspicious person call.

Prior to my arrival, Public Safety dispatch advised a male was watching females in the area and supposedly did not live within the complex.

NARRATIVE

On Wednesday, May 21st, 2025 at approximately 1918 hours I responded to 4490 US Highway 1, Cumberland Farms, in reference to a shoplifting. The complainant, Megan C. Thompson, stated that a black female riding a bicycle stole two packages of beverages and was riding a bicycle westbound on 45th Street.

While I was responding to the location K9 Sgt. Curby located a female matching the description provided by Megan at the 2700 block of 43rd Street.

Upon arrival I made contact with Megan, who is a store employee of the Cumberland Farms Gas Station. Megan stated that she observed the female who was later identified the defendant, Laketa L. Harris, walking around the store. She advised that she noticed that the female was carrying two beverage packages, one that she believed to be Pepsi. She stated that she noticed her walking around the sandwich shelve and then walk outside of the side door. She advised that she did not observe her go to the registers and she confirmed with her co-worker that she never paid. She stated that she followed her outside and saw the Pepsi and another unknown beverage case inside of the cart of her tricycle. She advised that she began to ride away going westbound.

I asked Megan if she would be able to identify the suspect if she saw her again, she stated that she would. I read Megan the show up instructions from a pre-printed agency card. She stated that she understood the instructions. I transported Megan to Harris's location. Megan positively identified Harris as the suspect.

I responded back to the store location and reviewed the in-store footage. On the surveillance footage I observed Harris enter the store from the north side door at 1907 hours. Harris is observed walking around the store. Harris is observed entering the beer cooler and grabbing a 12 pack of Twisted Tea, valued at \$18.99, and an 8 pack of Pepsi, valued at \$6.99. Harris was carrying both beverages on her right arm. Harris is then observed walking past the registers and approaching the sandwich rack. After looking through the sandwich's Harris walks back out of the north side door at 1913 hours. Harris made no attempt to pay for any of the items and walked past all points of sale. Harris then places the items and her purse into the cart of her tricycle and rides away from the business. Total loss: \$25.98.

K9 Sgt. Curby provided the following statement:

"On Wednesday, May 21st 2025, at approximately 1917 hours I responded to the area of the 2500 block of 45th Street after a shoplifting had just occurred at Cumberland Farms (4490 US1). The caller stated the suspect was a black female wearing a black tank top, and black shorts, with her hair pulled back, and riding a bicycle. The caller stated the female was last seen going westbound over the railroad tracks at 45th Street.

Approximately 5 minutes after the call came out, I observed a female matching that description traveling southbound in the 4400 block of 27th Avenue. I then went to stop out with the female and she then quickly turned into a yard in the 4300 block of 27th Avenue. Upon walking over to her, she jumped in a vehicle in an attempt to hide. The occupants of the vehicle then yelled at her to exit the vehicle.

I then had the female, later identified as Laketa Harris, step to the front of my patrol vehicle. Harris seemed to be under

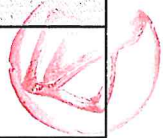

the influence of a stimulant. I then advised Harris the reason I stopped her, and she spontaneously uttered if she returned the items, would she still go to jail. "

K9 Deputy Le provided the following statement:

"On May 21st, 2025, at approximately 1920 hours, I responded to 4300 27th Avenue, in reference to a shoplifting call for service.

Prior to my arrival, Sergeant Curby advised over the radio that he had located the suspect. Upon arrival, I made contact with a black female who identified herself as Laketa Harris. I read Harris her Miranda Warnings which she verbally stated she understood. Harris stated that she stole some cans of Twisted Tea and food items from the store."

Sgt. Flores transported Harris to the Indian River County Jail. None of the stolen merchandise was recovered. Upon my arrival at the county jail, I re-advised Harris of her Miranda Warnings. Post Miranda Harris admitted to entering the Cumberland Farms and stealing the Twisted Teas, Pepsi, and sandwiches. Harris stated that she was homeless and only has \$1.00 and some change in her possession. She advised that she entered the store with the intent to steal. Harris also admitted to another shoplifting that occurred on this same date at WaWa in reference to IRCSO 2025-53389.

Harris was subsequently charged with violation of FSS 812.014(3)(a) – Petit Theft / Shoplifting. Total confirmed loss for Cumberland Farms, \$25.98.

NARRATIVE

On 5/21/2025, at approximately 1821 hours, I was dispatched to 800 US Highway 1(Speedway), in reference to a welfare check.

Upon arrival, I observed a Hispanic female later identified as Cassandra Noce, sitting in the driver's seat of a White in color Chevrolet Sedan, bearing Florida Tag (03ESTK). Cassandra's vehicle was parked next to one of the Gas Station Pumps and she had an iced water cup in her hand. I noticed Cassandra's statements were inconsistent. I also recognized Cassandra's demeanor as very animated, exaggerated, and restless while maintaining paranoia. She acted paranoid when Corporal Hatton asked her to raise her voice so he could hear her and she said she was concerned about people hearing her. It should be noted there was nobody in the immediate area that would have been able to hear her. Cassandra's car keys were in the passenger seat of the vehicle. While she was speaking with Corporal Hatton, she showed him her current

Kassandra stated she drove from the City of West Palm Beach to meet her aunt, to pick up her daughter. Kassandra advised she has not had an alcoholic beverage or illicit drugs since 5/11/2025.

Based on my concerns listed above, I asked Kassandra if she would consent to Field Sobriety exercises, to see if she could safely keep driving and she agreed.

For the exercises, Corporal Hatton conducted the HGN and the One Leg Stand, while I did the Walk and Turn exercise. The results are as follows:

Horizontal Gaze Nystagmus Exercise (HGN):

-No indicators were seen; however, she had very pinpoint pupils.

Walk and Turn:

-Used arms for balance in the starting position.

-Started walking before being instructed to.

-Took an improper number of steps.

-Did not count out loud.

-Made an improper turn by keeping both of her feet planted.

-After taking her first series of steps, she stopped to stretch for an extended period of time.

-Her second series of steps, she walked in a backwards direction and used her arms for balance.

It is important to note that she had a hard time understanding simple instructions during the exercises.

Based on my investigation, I determined Kassandra was too impaired to operate a motor vehicle and placed her in custody. After being transported to the Indian River County Jail, Kassandra submitted to a lawful test of her breath for the purposes of determining its alcohol content. Her first sample was 0.00 and her second was 0.00. After the test was completed, she was asked to submit to a urine test read off of an implied consent warning card and she agreed.

Drug Recognition Expert Lieutenant Jaworski arrived at the Jail to perform an evaluation of Kassandra. By that point, she was extremely uncooperative with booking deputies and was verbally combative and screaming at the top of her lungs. Her behavior was taken as a refusal to participate with Lt. On May 21, 2025, at approximately 1914, I was dispatched to _____ in reference to Suicide attempts and threats.

Upon arrival, I met with the compliant Philip Haberstroh, who stated Eyling threatened to kill him and herself with a knife. Philip stated he had the incident on video recording and would provide Officers the video. Philip stated Eyling was still in possession of the knife at this time. Philip described it as a large kitchen knife approximately with an eight-inch blade. Philip and _____ Kylie were outside the residence by the doorway when I and Officer Vazquez arrived.

Upon entry into the residence, Officer Vazquez and I could hear loud screaming coming from the Northeast bedroom which Philip stated was their master bedroom. We believed this to be Eyling due to it sounding like a female and Philip stating that's where she was last seen. Officer Vazquez and I attempted to locate Eyling but met negative results due to the bedroom door being locked. Officer Vazquez gave Eyling multiple commands to exit the bedroom without the knife in her hand. Officer Vazquez and I took the entryway and shouted for Eyling to come out with her hands in the air. Officer Barton arrived and stayed in the entryway with Officer Vazquez and myself. After shouting for Eyling to exit without the knife, she unlocked and opened the door and briefly came outside the bedroom into the hallway with the large kitchen knife in her hand screaming. Eyling was commanded multiple times to drop the knife which she did not. Eyling then entered back into the bedroom where she continued shouting. Other officers shortly arrived and after commanding Eyling to exit the bedroom many times, she exited the bedroom with a stuffed animal in her hand and stood in the hallway stated she was not going to come over to us. Officers then moved in and handcuffed Eyling. Eyling was very tense and stressed during the incident and kept shouting and talking to herself in the bedroom. Eyling was also very emotional and appeared to be hysterically crying during the incident.

Myself and K9 Irwin performed a protective sweep of the master bedroom and located the knife used in the incident. the knife was a large kitchen knife with approximately an eight-inch blade and silver in color. There was what appeared to be red on the knife which was possibly blood from the small laceration Eyling made on her wrist when she cut herself.

Photographs of the knife in question were taken. Philip completed a written statement which will be included in this report. DCF was notified due to a juvenile being present during the incident. A DCF incident report was completed.

Philip stated at one point he got Eyling to drop the knife and put a Band-Aid on her wrist. He stated she then began to freak out and grabbed another knife and threatened to kill him.

A Sebastian Police domestic violence packet was completed and will be submitted with this report.

The video sent by Philip of the threatening incident will be submitted with this report. The video clearly shows Eyling pick up a kitchen knife and threaten Philip with it and swing it in his direction.

This incident was cleared by arrest.



NARRATIVE

On Wednesday, May 21, 2025, at approximately 2051 hours, I responded to 13665 111th Street in reference to a disturbance.

Upon arrival contact was made with the victim Russel Preece. Preece advised that he had a truck at the location which he believed was destroyed. Preece was contacted by [REDACTED] Caleb Young, who resides at the location in reference to removing a hog that he was storing in the pasture. Preece was on his way to get the hog when Caleb told him it was too late, he had killed the hog. Preece told Caleb he was not coming to get the hog since Caleb had killed it. Preece was then notified by [REDACTED] Travis Drinkard, that Caleb sent him a snapchat of Preece's truck with the roof ripped off. Preece described the truck as a white Dodge Ram 1500 mega cab and stated the vehicle was worth 8500 dollars.

Contact was then made with Caleb's father Daniel Young. Daniel stated his son was not home. I asked Daniel if he was aware of the situation involving the hog. Daniel stated that he was and that Caleb buried it in Preece's truck. I asked Daniel how he buried the hog in Preece's truck. Daniel stated he used an excavator on the property to rip the roof off of the truck and put the hog inside of the truck. Daniel stated Caleb informed him of his action prior to leaving the location.

I then went to the location of the vehicle which was on the south end of the property. I observed the aforementioned white Dodge Ram 1500 with the roof of the truck crushed and ripped open. I observed a dead hog in the front passenger seat of the vehicle. Approximately 100 yards away from the truck I observed an excavator. The excavator was a Cat 305 CR with a bucket attachment. Within the bucket I observed fresh blood and white paint transfer consistent with the excavator being used to damage the truck and put the dead hog into it.

I then made contact with Travis Drinkard. Drinkard stated Caleb had contacted him on Snapchat stating he was fed up with Preece. Drinkard stated Caleb told him he was going to rip the roof off of Preece's truck and put the dead hog inside of the truck. Drinkard told Caleb he should not do it. Drinkard then received an additional Snapchat from Caleb showing the damage to the truck after Caleb had ripped the roof off.

Contact was made with Caleb at his brother's residence located at 13495 81st Street. Caleb was advised of his Miranda Rights via my agency issued card. Caleb acknowledged an understanding of his rights and stated he was willing to speak with me. Caleb stated that he was in an argument with Preece over one of his dogs injuring his piglet. Caleb told Preece to come get his hog from his property and Preece refused. Caleb stated he shot the hog and told Preece to come get the hog and he stated now that it was dead it was Caleb's problem. Caleb

stated he got so mad that he "saw red and did what he did." Caleb was asked if he was referring to using the excavator to damage Preece's vehicle and put the hog in it and he stated yes. Caleb stated that his mother loaned money to Preece to purchase the truck and Preece had not put it in his name yet. I asked Caleb if he used the excavator to rip the roof off of Preece's truck and he stated that he now wanted a lawyer.

Through my investigation I found there to be probable cause for the arrest of Caleb Young for felony criminal mischief. Caleb intentionally damaged Preece's property by ripping the roof off of his truck and while doing so caused over \$1,000.00 in damages. Caleb Young was placed under arrest and transported to the Indian River County Jail without incident.
