NARRATIVE

On Friday, June 12, 2026, at approximately 1454 hours, I responded to Wawa, 9050 20th Street, in reference to a trespassing in progress.

An employee of the location called in to IRCSO requesting a male be trespassed due to loitering and bothering customers. The employee provided a description of a white male, wearing a black shirt and carrying a box fan.

Upon arrival, I observed the male subject, later identified as Ronald Snoha, sitting on Wawa property near the 90th Avenue entry/exit.

Contact was made with Snoha who provided his information, which was ran via dispatch. Dispatch confirmed Snoah was trespassed from the location in 2025 (IRCSO 2025-113242). I pulled up the case file and confirmed Snoha was issued a trespass after warning by this agency.

I advised Snoah that he was already trespassed from the agency back in 2025, and that I needed him to place his hands behind his back. Snoah repeatedly said that he loves me, and to not do this to him. I got a hand restraint secured on Snoah's left wrist, but upon trying to secure the right wrist, Snoah kept looking back at me, tensing, and pulling away. I asked Snoah to stop tensing, or he would be brought to the ground. Snoah continued to tense, restricting my ability to get the right restraint on. Snoah was brought to the ground, where he then placed both of his hands beneath him, and locking his arms. It took multiple deputies on scene to free Snoah's arms, so he could be restrained.

Once placed in my patrol vehicle, Snoah made repeated death threats towards me the entire route to the jail. Snoah made statements for me to "watch out when you see me", "I'm going to kill you", "you're dead, done for", etc. Snoah was banging his legs against my partition, as well as attempting to spit at me through it.

Once we arrived at the county jail, Snoah was turned over to jail staff without incident.

Snoah was charged with Trespass on Land, Resisting without, and Threats to Kill LEO.

Upon arrival I met with Kwamane Clark who stated that him and his wife, Antoinette Cooper, had a verbal disagreement. After separating the two parties, Clark said that Cooper was acting wild, previous to my arrival and showed a video of Cooper shoving Clark in the back hard enough to cause him to stumble.

I asked Clark about that specific event and he said Cooper was yelling, "I would love someone to put their hands on me". Clark turned to separate himself from the situation Cooper shoved him in the back. He stumbled forward and the try to separate himself from the situation.

The battery was video recorded by Clark's son Kwamrie Clark.

I read Cooper Miranda Rights but she said that she did not understand because she did not want to go to jail.

Antoinette Cooper did actually and intentionally touch or strike Kwamane Clark against the will of Kwamane Clark and did intentionally cause bodily harm to Kwamane Clark and Kwamane Clark was family with Antoinette Cooper. Florida Statute 784.03(1)




I asked Jonathan if he had consumed any alcoholic beverages; he responded no. I requested Jonathan perform Standard Field Sobriety Exercises; he initially responded with no and stated he just wanted to go home. After I asked if he was certain he did not want to, he changed his mind and agreed.

During the HGN Exercise

- HGN present at maximum deviation in both eyes
- Unable to maintain balance
- Turned head while following stimulus
- Continuously stopped exercises, stating he did not understand what to do and was informed of the instruction's multiple times

During the Walk and Turn Exercise

- Unable to maintain balance
- Continuously began exercises before being instructed
- Did not take complete heel-to-toe steps each way
- On return walk, did not count out loud

During the One Leg Stand Exercise

- Began exercises before being instructed to do so
- Did not count out loud
- Failure to maintain balance

During the Finger to Nose Exercise

- Opened both eyes several times
- Head was not tilted back

Based on my observations, Jonathan was placed under arrest for FSS 316.193 DUI and transported to the Indian River County Jail. While in route to the jail, after being informed of the destination multiple times, Jonathan continued to ask where he was being taken to.

At the jail, staff conducted a Breath Alcohol Test. The first reading was 0.160 and the second was 0.158.

On **June 13, 2026**, at approximately **0154** hours, I responded to **Riverside Cafe** located at **3341 Bridge Plaza Dr.** in reference to a disturbance. The disturbance was reported over the radio by officers who were present at **Riverside Cafe** on a detail.

Witnesses **Kayla Cannon** and **Rebecca Malone** corroborated the statement provided by **Davis** and **Pressley** that they were both struck by **Foxwell**.

According to **Officer Green (ID 420)**, **Foxwell** was instructed by security to leave after the first altercation between **Foxwell** and the group of girls. **Foxwell** then tried to approach the group again and was asked to leave the establishment by **Officer Green (ID 420)**, who told him he was prohibited from remaining on the property. **Foxwell** ignored the lawful command and tried to cause another confrontation with the group of girls. **Ofc. Green** intervened and grabbed **Foxwell's** arm to take him into custody. **Foxwell** then resisted **Ofc. Green** and began to throw punches at **Ofc. The vaporizer included an orangish wax in the cartridge which I identified to be THC resin from my training and experience. In the same pocket was an additional cardboard packaging container that was labeled "Loud Extracts- Live Rosin Liquid Diamonds 2 gram Disposable – Flavor New York Sour Diesel". On the back of the packaging included labeling "Hybrid" and an additional label of "Total THC 90.26". Inside the packaging was an additional THC vaporizer disposable cartridge. The two disposable cartridges were the same branding and packaging- both Loud Extracts (containing THC). On the packaging, there was an ingredients list that included the following: Live Resin, Liquid Diamonds, & Cannabis.

James advised that he does not have a medical marijuana card.

James was transported to Cleveland Clinic for his injuries and ultimately Indian River County Jail for booking.

James was served for the warrant out from Orange County Sheriff's Office and additionally charged with FSS 893.13 Possession of Controlled Substance as he constructed actual possession of the THC vaporizer disposables on his person.

James was issued citations for the Possession of Controlled Substance (citation AJSSVQE).





NARRATIVE

On June 13th 2026 at approximately 1550 hours I was dispatched to [REDACTED] in reference to a disturbance.

Upon arrival I met with Jamar Gillerson who made the following summarized statement:

Sunita Paul, his girlfriend, had a verbal argument. He was recently in Massachusetts and returned to Vero Beach on Monday, June 8th 2026, this afternoon he went through Paul's phone and was questioning her about dating other people while he was gone. He said they argued about it in the bedroom until Paul walked out and went to [REDACTED]. He said that there was no physical violence from either person and no direct threats of harm made by either party.

Paul made the following statement summarized: Gillerson went through her phone and confronted her about someone she dated after they broke up. He did not find anything and wanted to know the guy's information. She stated he was standing in front of the door of the bedroom and she was not allowed to leave. She reached for the door handle and he pushed her arm away, not allowing her to leave. During this time, she was in fear of him. Paul also stated that he had pulled her hair while they were arguing in the bedroom. Gillerson had Paul's phone, she told him to give it back and he refused.

[REDACTED] Laramya Mullapudi, knocked on the door and then opened the door. While the door was open Paul stated she was able to escape the room and ran to [REDACTED] for safety. [REDACTED]

[REDACTED] Gloria Zohn, was able to retrieve Paul's phone from Gillerson [REDACTED]

Laramya Mullapudi made the following summarized statement: She has been [REDACTED] and had never met Gillerson until last Monday. Today Mullapudi heard yelling coming from Paul's bedroom. There was screaming but it sounded like an emotional argument screaming, not fear for my life screaming. Mullapudi knocked on the door and Paul told her to open the door.

When she opened the door Gillerson was standing just to the left of the door and Paul was standing further inside the room in front of Gillerson. Mullapudi asked if they were ok and they said yes. She stated that Gillerson exited the room 1st, hold his phone and Paul's phone, and stood in the living room. Paul exited next and went to the front door and left the residence. Gillerson left and they continue the verbal argument outside and Paul asked Mullapudi to retrieve her laptop from the bedroom. Gillerson came in, went past Mullapudi to grab the laptop saying, "Ill give it to her", pushing past her in the process. Paul also told Mullapudi that Gillerson had pulled her hair.

Gloria Zohn made the following summarized statement: She heard yelling [REDACTED] then there was a knock on her door. She opened the door to see Paul looking frightened with Gillerson yelling from

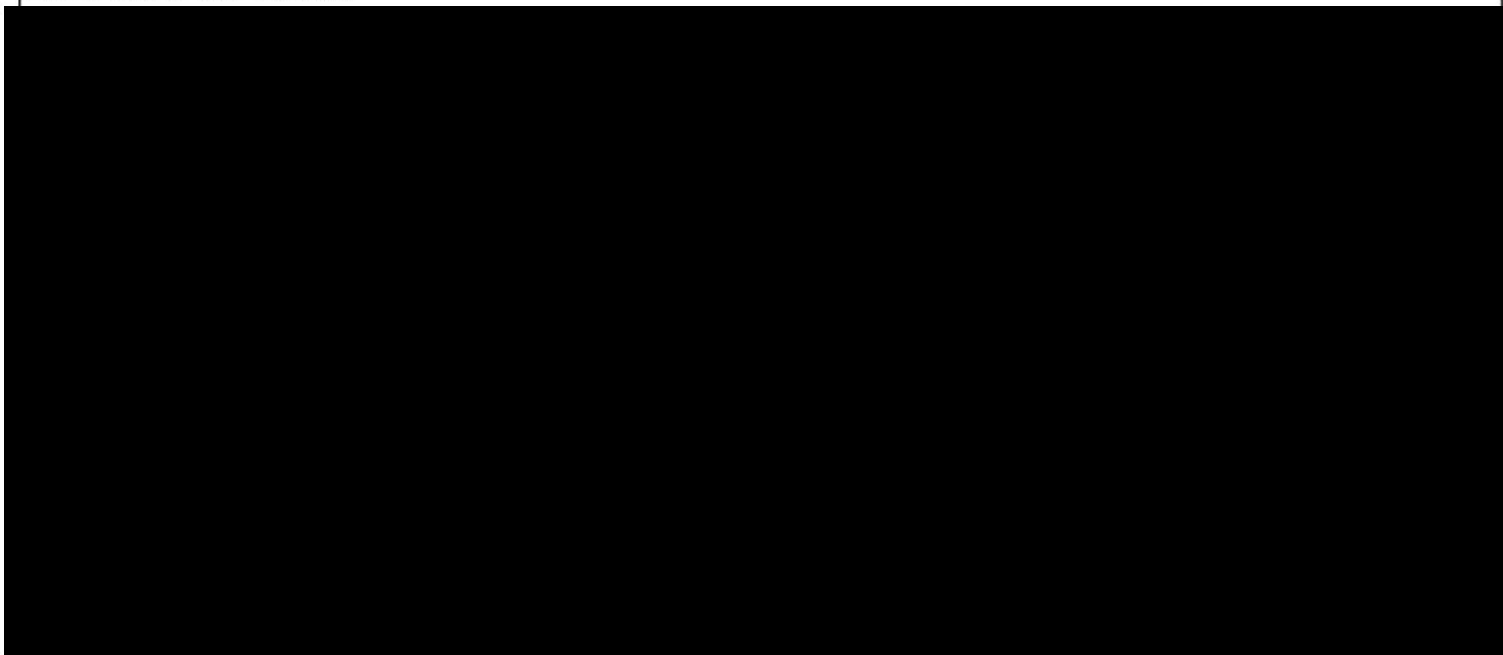

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On **06/13/2026** , at **23:06** (Specifically include facts constituting cause for arrest.)

On 6/13/26 at approximately 2306 hours, I, Officer W. Brumley, conducted a traffic stop at 16th Street and 14th Ave. On a grey Lexus sedan, bearing FL tag# JS145M, in reference to the registered owner not having a valid license and not having insurance.

Upon approach, I made contact with the driver, identified as Suzanne Ward (defendant), and explained the reason for the stop. she stated she was the registered owner and was unaware she did not have a valid license and that she does have insurance. She stated her and her front passenger, identified as Nicholas Sklare, were coming from the Cumberland Farms in the 1600 block of US1 and heading home. It should be noted another officer observed the aforementioned vehicle sitting in the parking lot of Cumberland Farms for more than 40 minutes, while the defendant and the passenger were walking around, looking through bushes and rummaging through the car. After stating there was nothing illegal in the car the defendant denied consent to search the vehicle. At which point K-9 Officer Hatfield was on scene and with the use of his partner K-9 Batman conducted an exterior sniff of the vehicle. While I continued speaking with the defendant and her passenger, K-9 Batman alerted to the vehicle. Ofc Hatfield and Sgt Plumb conducted a search of the vehicle. Ofc Hatfield located a small wallet on the drivers seat containing crumpled up note book paper, which is a method used to conceal illegal narcotics. The defendant and front passenger were then detained and interviewed separately. I then went to observed the contents of the wallet and saw a clear crystal rock like substance concealed in the white paper, along with a glass pipe with white residue inside also concealed in the white paper. Through my training and experience I identified the clear crystal rock like substance to be Methamphetamine and the glass pipe as a tool used to smoke the Methamphetamine.

Post miranda, the defendant stated the wallet was hers and stated she kept it next to her on the seat, between her and the center console, she then stated she knew the clear crystal rock like substance and glass pipe was contained within. The defendant stated both were hers and she knew the substance to be Methamphetamine containing Fentanyl and she used the glass pipe to smoke the substance the other night.

Post miranda, Sklare stated he knew she had it however, was unaware she had it with her in the car. He said he thought she left it at the house.

A field test was conducted of the clear crystal rock like substance and glass pipe, both had a positive reaction to the presence of Methamphetamine and Fentanyl.

Based on the forgoing, the defendant was placed under arrest for violation of FSS. 893.13(6A) Possession Of A Controlled Substance Without Prescription, and FSS. 893.147(1) Possession Of Drug Paraphernalia. She was then transported to the Indian River County Jail without incident.

This event was captured on my BWC and uploaded to Evidence Library. The drugs and paraphernalia has been submitted into Evidence.

NARRATIVE

On Sunday, 06/14/2026, at approximately 0208, I was on patrol in the area of Merrill Barber Bridge and Indian River Boulevard, Vero Beach, Florida 32960, when I observed a white Nissan Altima bearing Florida tag AH61ZC travelling northbound on Indian River Boulevard, bouncing back and forth in the inside lane.

When I caught up to the vehicle on Indian River Boulevard, I began to observe its driving pattern. While watching the vehicle, I observed it go over the inside yellow lane marker 3 times, go onto the grass in the median, and cross over the center line into the outside lane, building probable cause for a violation of F.S.S 316.089(1) – Fail to drive in a single lane.

I conducted the traffic stop at 5300 US Highway One, Vero Beach, Florida 32967, based on the probable cause. I made contact with the driver (identified as Yrani Almonte) and requested his documentation. While Almonte looked for his registration and insurance, I asked him where he was coming from, which Almonte stated he was coming from Sol Mar Cocktail Lounge (2855 Ocean Drive # B3, Vero Beach, FL 32963). I asked Almonte if he had anything to drink, which he stated he consumed a beer and a coke mixed with Jack Daniels approximately 2/3 hours prior to our interaction. While speaking with Almonte, I observed his eyes to be glossy, watery and red, as-well as his speech was slurred. I also detected the odor of an adult beverage emitting from his breath.

Based on the circumstances of this investigation thus far, I asked Almonte if he would be willing to complete field sobriety exercises so I could determine his ability to drive, which he voluntarily agreed to complete. Prior to the exercises, I asked Almonte a series of medical questions, to which he stated he takes no medications or has any medical diagnosis or issues. Almonte advised he has no issues walking or any disabilities that would prevent him from being able to complete the exercises.

The first exercise I demonstrated and explained was the Horizontal Gaze Nystagmus (HGN) exercise. I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes. During the exercise, I observed a lack of smooth pursuit in both eyes, I observed distinct and sustained Nystagmus at maximum deviation in both eyes, I observed Nystagmus prior to 45 degrees in both eyes. I did not observe any vertical gaze Nystagmus (VGN). During this exercise Almonte had 6 out of the 6 clues that indicate impairment.

The second exercise I demonstrated and explained was the Walk and Turn exercise. During the instructional phase Almonte was unable to maintain the starting position, and had to reset himself twice. After providing the instructions and demonstration I asked Almonte if he understood the exercise and its instructions, to which he stated he did. During the exercise Almonte stepped off the line, did not take heel to toe steps, conducted an improper turn, paused between steps to maintain his balance and utilized his

The third exercise I demonstrated and explained was the One-Legged Stand exercise. After acknowledging the instructions, Almonte was told to begin the exercise. Almonte used his arms to maintain balance, put his foot down, switched feet and was swaying while attempting to balance himself. During this exercise Marriott had 3 out of the 4 clues that indicate impairment.

Based on the totality of the circumstances I placed Yrani Almonte under arrest for the following offenses:

- F.S.S 316.193.1c – DUI Breath Alcohol 0.08 or more per 210 L.

NARRATIVE

On June 14th, 2026 at approximately 0203 hours, Deputy T. Lowell and I were on routine patrol at 6200 20th Street unit 496 (Casa Amigos) parking lot. As we patrolled through the parking lot, we witnessed a white Ford Explorer bearing Florida tag CH24DZ accelerate through the parking lot at a high rate of speed. Deputy T. Lowell then conducted a traffic stop based on his observations of the vehicle driving patterns.

Deputy T. Lowell wrote the following supplement:

“On June 14, 2026 at approximately 02:03 hours, I was on routine patrol at 6200 20th Street unit 496 (Casa Amigos) parking lot.

While on scene, I observed a party event that was coming to an end due to it being after hours. While stationary in the parking lot, I observed a white Ford SUV (bearing FL tag CH24DZ) exit the parking lot squealing tires at a high rate of speed. The vehicle left Casa Amigos and headed Eastbound. The vehicle continued to drive at a high rate of speed around the mall and failed to come to a complete stop at every stop sign on the premise. Due to the speed and driving patterns of the vehicle, I believed the drivers normal faculties to be impaired.

I conducted a traffic stop on the vehicle at the South Entrance to the Indian River Mall, just off of 20th Street. The driver of the vehicle was a Hispanic female who was later identified as Karen Soliz. Karen appeared to be extremely intoxicated and had red bloodshot eyes. Karen spoke very little English. When asked for the necessary requirements, Karen did state that she did not have a valid driver's license. I observed opened and empty alcoholic beverages in the front center cupholders of the vehicle, as well as a strong odor of alcoholic beverages emitting from inside of the vehicle.

Karen was asked to turn off and exit the vehicle for the duration of the investigation.

Deputy A. Ballester arrived on scene for translation, and Deputy O. Green took over the investigation.

I have no further involvement in this case.”

Further investigation revealed that Karen s name and date of birth were being queried through dispatch to verify whether she had been issued a driver's license. Shortly thereafter, dispatch confirmed that she had never been issued a Florida driver's license. Upon arrival, Corporal J. Chamberlain approached Karen and questioned her. As she attempted to walk away from an active investigation, Corporal Chamberlain grasped her arm. She actively pulled away, causing him to lose his grip and evade several attempts to gain compliance. Ultimately, deputies on scene succeeded in applying hand restraints. Based on the aforementioned facts, Karen is in violation of Florida State Statute 843.02 (Resisting Officer Without Violence) and Florida State Statute 322.03(1) (No Driver's License – Not Valid Driver's License). Karen was subsequently placed in the rear of a patrol vehicle issued by the agency and transported to the Indian River County Jail.

NARRATIVE

On June 14, 2026, at approximately 1330 hours, I arrived at [REDACTED] in reference to a disturbance. Upon my arrival, contact was made with Curtis Alfonso, who advised the following verbally:

Curtis's mother, Ruby Tascon, lives at the address above, [REDACTED] Ruby also rents the home to another man, later identified as Parasram Persaud, who has lived at this location for two years.

On this date, Tyler woke up early in the morning to go fishing. Tyler entered his white 2021 Chevrolet Silverado 1500 that bore a Florida license plate of FDZB84. Tyler realized his right front truck tire was completely flat and thought that was odd since his tire was not damaged prior to this morning. Tyler did not want to report the incident this morning since he was going fishing, so he left.

When Curtis came over to the address mentioned above, he met with Ruby and they saw Tyler's tire was flat. Curtis mentioned since Tyler [REDACTED] Parasram has been argumentative with Tyler due to being jealous of Tyler [REDACTED] Curtis and Ruby approached Parasram and asked him about Tyler's tire being damaged and Parasram said he was responsible for the damage to Tyler's truck tire.

Next, contact was made with Tyler via phone call. Tyler confirmed what Curtis mentioned above. Tyler stated no one had permission to damage his truck's tire and he desired prosecution for the incident. Tyler advised the tires for his truck were valued between approximately \$300.00-\$400.00.

I then spoke with Parasram. I verbally advised Parasram of his Miranda Rights, which he stated he understood and waived. Post Miranda, Parasram advised the following verbally:

Parasram informed me approximately one week ago, he could not find his sunglasses. Parasram believed Tyler had taken his sunglasses, but could not provide any information as to why.

Parasram went on to explain he consumed alcoholic beverages the day before and continued drinking them into today. Parasram was upset with Tyler since he believed Tyler had stolen his sunglasses, so he went outside earlier and slashed Tyler's tire. Parasram said he takes responsibility for the damage to Tyler's tire. I asked Parasram what he used to damage Tyler's tire and he said he used a tool, possibly a screwdriver, but he could not specifically remember what he used. I asked Parasram which part of the tire he damaged and he would not say.

Let it be noted, Parasram stated there were surveillance cameras on the property that were faced towards Tyler's truck that would show the incident, but Parasram removed them. While I spoke with Parasram, he was unsteady on his feet, he slurred his words, and there was an odor of an alcoholic beverage emitting from his breath. Also, Parasram's sunglasses were located on his bed.

I checked Tyler's tire and confirmed it was completely flat. I observed a slash to the bottom of Tyler's tire that was between one and three inches long.

Based on the information above, I found probable cause Parasram was in violation of F.S.S 806.13, criminal

On **06/14/26** at approximately **1344** hours, Officers were dispatched to **994 Riomar Drive** on a report of a female in a black Ford Super Duty that may have been drinking and driving.

Upon arrival, I observed a black Ford Super Duty Truck with FL plate PLE4K parked up against a no parking sign in the Riomar Beach Access parking lot (Riomar Dr / Ocean Dr) facing the beach. I then made contact with a witness on scene, James Sullivan, (an Off Duty Police Officer from Illinois) who stated the following, " Myself and my wife were driving west from the beach when a black pickup truck was stopped at a light. Vehicles were beeping their horns and going around the black pickup truck. I followed the truck west when I observed the truck swerving back and forth along with striking the center curb. When the truck came to a stop I approached the driver (w/f) blonde hair who appeared intoxicated. Driver told me to GO FUCK MYSELF. The driver allowed me to drive her truck to a safe location where we were able to contact VBPD " End of statement.

I then made contact with the female who was located in the front passenger seat. Female was identified as: Brooke Ann Richards DOB 07/10/79. Richards stated she was not driving and that some other guy was driving. Richards further stated she did not know who was driving the vehicle. As Richards was speaking she was slurring her words and I could smell a strong odor of an alcoholic beverage emitting from her breath. I also observed that Richards eyes were bloodshot and glossy. Richards stated she was drinking but was not driving. Officers located a purple tumbler cup inside the vehicle next to Richards which emitted a very strong odor of an alcoholic beverage.

Based on the witness, James Sullivan, being able to put Richards behind the wheel of her truck, and that Richards was observed slurring her speech with red bloodshot glossy eyes, I asked Richards if she would be willing to perform Standardized Field Sobriety Exercises (SFST's). Richards stated she would not. Richards was then placed under arrest for DUI and transported to Indian River County Jail for a breath test. Once inside the jail Richards was read the implied consent for DUI. Richards refused to test. Richards was then read the State of Florida affidavit of refusal to submit to breath test and Richards still refused.

Richards was in violation of Florida Statute 316.193 DUI in a motor vehicle and Florida Statute 316.1939 refusal to submit to breath test. Richards was issued two citations for the offense (AFVKKTE , AFVKKUE)

Richards is being held on a \$1000 dollar bond.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On **06/14/2026** , at **18:37** (Specifically include facts constituting cause for arrest.)



On **June 14th 2026** at approximately **1658** hours, I was dispatched to **2001 US Highway 1 Sebastian Florida (Walmart)** in reference to a theft.

Upon arrival, I was informed by the complainant Dawn (Loss prevention officer) that the female in question was ticket switching items. Dawn explained that the subject removed low price item stickers from one item and placed them over other high-priced items in an effort to pay the low price. Dawn provided me with the following statement:

" I, APA Dawn Ethier, working Loss Prevention for the Sebastian Florida Wal-Mart store # was walking the floor when I came across this female in girls wear selecting items in the area and then going to the clearance table and taking the stickers off of the clothes that had the clearance stickers on them and placing them on the higher price clothing that she selected. She also traveled by jewelry and selected an umbrella. She then traveled back to girls wear and selected more items and put the clearance stickers on them also. She then traveled to the grocery self checkout and proceeded to scan all items with the cheaper stickers on them. After making payment she exited out of the grocery doors passing all points of sale where myself and my witness approach her and ask her to come back inside with me. The items that were ticket switched with the clearance stickers were a girls moana t-shirt with the last four upc 6890, a spiderman t-shirt with the last four upc 3042, a ladies ruffle romper with the last four upc 4559, a pair of girls jean shorts with the last four upc 8589, a paw patrol t-shirt with the last four upc 6785, a ladies maxi skirt with the last four upc, a pair of girls jean shorts with the last upc of 8621, a two piece boys short set with the last four upc 3616, a two piece boys hot wheels short set with the last four upc 3598, a ladies white ruffle dress with the last four upc 9539, a toy story t-shirt with the last four upc 6715, a two piece bluey short set with the last four upc 3592, a two piece California cruisin short set with the last four upc 2539, a black girls rock t-shirt with the last four upc 6905, a box of hello kitty girls briefs with the last four upc of 6856, a box of super mario brothers boys briefs with the last four upc 4794, a pair of white girls socks that she had concealed in her purse with the last upc 3834, and four items that she did not attempt to scan at all was an umbrella with the last four upc 1300, a bottle of oxi clean with the last four upc 1355, a pack of spiderman socks with a upc of 4321 and a pack of hello kitty socks with the last four upc 7611. The amount for this incident is \$211.54."

I identified the female subject by her New Jersey drivers license to be Katherine Pamlea Llerena Uchillan. Post Miranda, Katherine stated that she is a struggling single mother and was given advice by a former colleague of hers to ticket switch items if she can't afford to pay for them. Katherine explained that she grabbed multiple low-price stickers ranging from different prices and placed them on multiple items. Katherine stated she walked over to the self-checkout registers and knowingly scanned the items which reflected a different price. Dawn advised Katherine did pay for two items that were not manipulated, UPC ending in #7379 and #4863.

Katherine then proceeded to exit the store passing points of sale. Based on Dawns and Katherine's statements, I find probable cause to arrest Katherine for FSS: 812.14(3)(A) retail theft for knowingly altering UPC tags to deprive Walmart of the actual total amount that totaled \$211.54 USD. Katherine was subsequently transported to the Indian River County Jail without incident.


