NARRATIVE

On March 25, 2026, at approximately 0104 hours, I responded to the Mobil gas station (975 27th Avenue SW, Vero Beach, Florida) due to Sgt Thimmer being out with a vehicle and two subjects in the parking lot.

Sergeant Thimmer stated the following to me: he was driving north on 27th Avenue SW, when he passed the gas station he observed a blue SUV, in the parking lot, with a door open and two suspects sitting on a curb, near a U-Haul box truck.

Sergeant Thimmer pulled into the parking lot and made contact with the two suspects, who were later identified as white male, Adam Carbone, DOB: 03/06/1981 and white male, Erik Souders, DOB: 05/07/1969. Sergeant Thimmer ran their information through communications, which was negative for locals, but Carbone had a non-extraditable warrant out of Georgia for trafficking narcotics. Sergeant Thimmer questioned why they were at the closed gas station, which they explained they were there to rent a U-Haul, even though the store was closed and there was no way for them to retrieve keys. Sergeant Thimmer asked if they would consent to a search of the vehicle, which both Carbone and Souders declined. As they both declined K9 Deputy McKay arrived and utilized his K9 partner Tobi to conduct an open-air sniff of the vehicle. K9 Deputy McKay informed me of the positive alert to the vehicle.

During a search of the vehicle numerous items were discovered by Sergeant Thimmer, which were inside a black backpack in the back passenger floorboard behind the driver's seat. Inside the backpack was a scale with white residue, Sergeant Thimmer knew to be narcotics due to his training and experience. Several baggies of pills and baggies of residue were located as well.

I began to conduct the search of Erik's vehicle at which time a clear glass pipe with burnt residue was located under the radio between the driver and passengers' compartment. I utilized my agency issued narcotics test kits to test the residue on the scale Sgt Thimmer located inside of the black backpack, which tested positive for Methamphetamine. I also conducted a test of the white powdery substance on a triangle silver tray inside in a bag containing a large quantity of small Ziploc bags. The residue from the silver tray tested positive for Fentanyl. There was also an unused hypodermic needle located inside of the backpack.

I separated Erik from Adam, and advised him of his Miranda Rights to which he stated he understood. Erik confirmed that the black bag behind the driver seat which contained sex toys, pills for both erectile dysfunction and HIV were his. It should be noted that four separate small bags each containing different pills in numerous quantities were located by Sgt Thimmer inside of the same bag. The pills are as

follows: (5) Sildenafil Citrate "SC 100" for Erectile dysfunction, (2) Cobicistat (TG 800) for HIV, (1) unidentified red in color round pill marked with "R 10", (1) Tivicay "SV 572 50" for HIV, and (5) Sildenafil Citrate round white pills marked with "I 58" used for Erectile Dysfunction. All the aforementioned pills require a prescription from a doctor and to be carried in the properly marked container. All individually packaged pills were in unmarked clear plastic bags, and no prescription was provided.

When asked about the scale, and clear bags located inside of the backpack next to the items he stated were his, Erik stated he no longer wished to speak without his attorney present.

I conducted a search of Erik's person, at which time as I was about to search his left front pocket of his pants he stated there was "dope in the pocket." I located a small black box inside of the front left pocket of Erik's pants, which contained two small plastic bags containing a white crystal substance. I immediately recognized this to be Methamphetamine due to my training and experience, and I placed Erik into custody. I utilized my scale to obtain an initial weight for the Methamphetamine which was 3.83 grams.

Erik was placed into the rear passenger compartment of my agency issued patrol vehicle.

Due to the aforementioned facts and circumstances, I find probable cause to charge Erik Ronald Souders with the following:

Count 1: F.S.S. 893.13.1A1- Possession of Methamphetamine with the intent to distribute.

Count 2: F.S.S. 499.03.1 -Possession of Harmful Legend Drug Without Prescription.

NARRATIVE

On March 25, 2026, at approximately 0104 hours, I responded to the Mobil gas station (975 27th Avenue SW, Vero Beach, Florida) due to Sgt Thimmer being out with a vehicle and two subjects in the parking lot.

Sergeant Thimmer stated the following to me: he was driving north on 27th Avenue SW, when he passed the gas station he observed a blue SUV, in the parking lot, with a door open and two suspects sitting on a curb, near a U-Haul box truck.

Sergeant Thimmer pulled into the parking lot and made contact with the two suspects, who were later identified as white male, Adam Carbone, DOB: 03/06/1981 and white male, Erik Souders, DOB: 05/07/1969. Sergeant Thimmer ran their information through communications, which was negative for locals, but Carbone had a non-extraditable warrant out of Georgia for trafficking narcotics. Sergeant Thimmer questioned why they were at the closed gas station, which they explained they were there to rent a U-Haul, even though the store was closed and there was no way for them to retrieve keys. Sergeant Thimmer asked if they would consent to a search of the vehicle, which both Carbone and Souders declined. As they both declined K9 Deputy McKay arrived and utilized his K9 partner Tobi to conduct an open-air sniff of the vehicle. K9 Deputy McKay informed me of the positive alert to the vehicle.

During a search of the vehicle numerous items were discovered by Sergeant Thimmer, which were inside a black backpack in the back passenger floorboard behind the driver's seat. Inside the backpack was a scale with white residue, Sergeant Thimmer knew to be narcotics due to his training and experience. Several baggies of pills and baggies of residue were located as well.

I separated Adam from Erik; at which time I advised him of his Miranda Rights, to which he stated he understood. When asked about the backpack, Adam stated "which bag" and then stated he did not wish to speak with me further. I instructed Adam to return to the curb near the vehicle and have a seat. I began searching Erik's person at which time I located a black container containing two small bags of Methamphetamine and placed him into custody. As I placed Erik inside of my agency issued patrol vehicle, Cpl Lang searched Adam's person due to the positive alert by the narcotics trained K9, paraphernalia, scales, and bags used to package narcotics inside of the vehicle which Erik and Adam both stated they had just exited. Cpl Lang advised me that Adam had a loaded hypodermic needle in his left cargo pocket, and instructed Adam to again sit on the curb near the vehicle while I concluded with Erik.

Due to the paraphernalia located between where Erik and Adam were seated, and the hypodermic

needle located on Adam's person, I instructed him to stand up and placed him into custody. It should be noted that as Adam stood up, Deputy Henry advised he heard a "thud" at which point a black Ziploc bag was located where Adam was sitting on the curb. I opened the Ziploc bag which revealed a large quantity of a white crystal-like substance, known to me by my training and experience to be Methamphetamine. The substance was later weighed and tested which tested positive for Methamphetamine, and weighed 57.3 grams.

Due to the aforementioned facts and circumstances, I find probable cause to charge Adam John Carbone with the following:

Count 1: F.S.S. 893.135.1F1- Trafficking in Methamphetamine 14 grams or more, 57.3 grams.



NARRATIVE

On March 25, 2026, at approximately 1831 hours, I was dispatched to TA Truck Stop, located at 8909 20th Street, Vero Beach, Florida, in reference to a trespassing.

Upon arrival, I made contact with the complainant, Angeline Shaw, who is an employee at TA Truck Stop, and has the ability to have people trespassed from the property. Angeline stated the following in summary; Angeline asked to have the male at the register, wearing tan shorts, black shirt, and red backpack, later identified as Dennis Agosto trespassed from the location.

Angelina advised, Dennis was harassing patrons and asking them for money earlier in the day, and left the property before law enforcement could be notified. When Dennis returned, she contacted the Indian River County Sheriff's Office dispatch.

When Dennis was complete with returning his item, I informed Dennis he had to leave the property. Dennis became argumentative, and asked for probable cause to have him trespassed. I asked Dennis for his identification, he informed me he was not giving it to me, I informed Dennis he was trespassed from the location and not to return, and if he did, he would be arrested.

I followed Dennis outside, and informed him again that he was being trespassed from the property, and if he returned, he would be arrested. Dennis continued to be argumentative towards me. I informed Dennis again not to return to the property. I told Dennis to leave the property several times, and if he did not leave, I would arrest him for trespassing.

Dennis continued to be argumentative towards me, and refused to leave. I asked Dennis several more times to leave and if he did not, I would arrest him. I asked him to please leave, Dennis continued to be argumentative towards me.

I attempted to grab Dennis's left hand to take him into custody, because he fused to leave, and was being argumentative. Dennis pulled away from me, and informed me, I could not arrest him, at which time, I grabbed the straps to Dennis's backpack and escorted him to the ground. While I had Dennis on the ground, he continued to pull his hands away from me. I secured Dennis right hand, then left and secured him in handcuff restraints, checked for proper fit. I stood Dennis behind my patrol vehicle and conducted a search of his person, then placed him into the rear of my patrol car.

It should be noted, while I was talking to Dennis and asking him to leave to property, I observed two (2) pocket knives, one (1) in each front pocket. Due to Dennis's behavior, and him pulling away when I attempted to take him into custody, I immediately escorted him to the ground and straddled him, placing my rear end on his legs, and I utilized my knees to cover the pocket knives, as I placed him into handcuff restraints.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On 03/25/2026, at 23:39 (Specifically include facts constituting cause for arrest.)

On 3/25/26 at approximately 2339 hours, I, Officer W. Brumley responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with Officer (Ofc) Wickert and Hernandez who were both already on scene and separated the two individuals involved in the disturbance. Both Ofc Wickert and Hernandez stated prior to them knocking on the door they could hear a male, identified as Payton Yarema (defendant), stating "thats why I beat your ass" to a female, identified as Madison Evans (victim).

After gathering information, I made contact with the victim inside the residence. She stated they were in a verbal argument that turned physical in the parking lot after just getting home. She said the defendant grabbed her shirt to pull her close to him outside of the vehicle they were [REDACTED] Stating the defendant then let her go and they continued to head back to [REDACTED] residence. Once at the residence they engaged in another verbal argument in the parking lot where the defendant grabbed the victim by her throat.

It should be noted there are clear visible red marks on both sides of the victims neck and on her left cheek bone area. The victim stated the red marks on the right side of her neck were from the defendant pulling on her shirt and the red marks on the left side of her neck were from the defendants hand. Due to the placement of the marks on the left side of the victims neck, the defendant would have used his right hand when grabbing the victim by the throat. She said she was not sure why there was redness around her left cheek bone area.

The victim then stated she did hit the defendant, grabbing the defendant hair, but in an attempt to get the defendants hand off of her throat. She also said he did not use a lot of pressure and he only grabbed her throat as a way of getting her inside.

I made contact with the defendant who was detained and placed in my patrol vehicle. Post miranda, the defendant stated he and the victim were in a verbal argument that turned physical when he grabbed her by her shirt and she hit him, for him to let her go. When the victim did that he stated he grabbed her by her hair and then grabbed her by her throat. The defendant stated when he grabbed her hair he "pulled the shit out of it". The defendant said he grabbed her by her shirt somewhere down the street but then the rest of the altercation occurred in the parking lot of the residence. He also said he grabbed her shirt because she would not look at him in the face when talking to him. He said he only grabbed her by her throat to pull her toward him so she would look him in the face as well. The defendant stated the incident that occurred in the parking lot was also all in the vehicle in front of their kids.

It should be noted at this time, the defendant does not have any marks on his face or body.

Based on the totality of the circumstances the defendant was placed under arrest for violation of FSS. 784.041(2A) Domestic Battery By Strangulation. The defendant was transported to the Indian River County Jail without incident.

Due to the defendant and victim being in a romantic relationship [REDACTED] have a child in common, Ofc Hernandez completed a DV packet with the victim.
