On			(Specifically include facts constituting cause for arrest.)

On 08/29/2025, at approximately 01:18 hours, I was behind a silver Chevy Impala (FL tag #93CHZH) as we were traveling northbound in the 2100 block of 10th Avenue. The driver was operating in a hurried manner and conducted a left turn onto Royal Palm Boulevard from 10th Avenue. The driver then braked and conducted a right turn onto Granada Avenue from Royal Palm Boulevard without using any form of signal. I tried to catch up to the vehicle to conduct a traffic stop for the violation. The driver then briefly pulled into an apartment complex (located at 2421 Granada Avenue) before turning around within the complex and attempting to exit through the main driveway to the complex. At this point, I activated my agency lights on my marked patrol vehicle to conduct a traffic stop on the Chevy Impala.

The driver was facing me through his front windshield, due to our vehicles being positioned front bumper to front bumper. The driver, later identified as the defendant, exited from the driver's seat and stood outside of his car. While standing outside of his vehicle, the driver began to question the stop. I exited my patrol vehicle and asked the defendant to sit back down in his car. The defendant did not cooperate and began to make statements that I wasn't going to "fuck" with him and that he didn't do anything wrong. I warned the defendant to not make this more complicated and told him to get back into the car. The defendant willfully refused and began to walk away from his vehicle towards the apartment complex. It appeared that the defendant was attempting to retreat into one of the apartments, and I pursued after him. I closed the distance between us and gave the defendant several more commands to stop. The defendant continued to walk away from me, reach around on his person, and verbally expressing that he was not going to comply. I grabbed the defendant by his arms and ordered him to place his hands behind his back. The defendant tensed up and pulled away from me. I could not secure the defendant's hands behind him because he continued to resist me by pulling away while walking away from me. A brief struggle ensued before I was able to arrest the defendant and secure him in handcuffs. When I was able to place the defendant's arms behind him to secure him in handcuffs, I observed a small plastic baggy that the defendant released from his hand, and subsequently dropping this bag onto the ground. This bag was recovered shortly after, and it was discovered that the bag contained a small user amount of Marijuana (estimated to be approximately 4 to 6 grams).

I read the defendant his Miranda Warning before trying to interview the defendant about the reasoning behind his actions. Post-Miranda, the defendant did not provide any reasonable explanation as to why he attempted to evade the traffic stop, and he refused to acknowledge that he resisted a law enforcement officer.

I conducted a records check on the defendant through VBPD dispatch. It was verified that the defendant did not possess a Medical Marijuana Card, and I discovered that the defendant had a criminal history of resisting arrest.

Based on the facts above, the defendant, Mackenzy Dorvillas, was placed under arrest for violation of FSS 843.02 resisting arrest without violence, and violation of FSS 893.13(6)(b) for possession of less than 20 grams of Marijuana.

The defendant was transported to the Indian River County Jail for booking and processing.

Arrest Affidavit Report

NARRATIVE

On August 28, 2025, at approximately 2254 hours, I was patrolling west on 45th Street, from US Highway 1, Vero Beach, Florida, when I observed Joshua Willis standing on the north side of Wawa, located at 4495 US Highway 1, Vero Beach, Florida.

Having pervious knowledge that Joshua has been trespassed from the location, reference Indian River County Sheriff's Office case # 2025-90581. I pulled into the parking lot and detained Joshua in handcuff restraints, and checked for proper fit.

I removed a gray backpack, off Joshua's back, and black fanny bag that he had across his body. I placed Joshua in the rear of my patrol car.

I conducted a search of the aforementioned bags and located two clear bags with a white rocky substance. I conducted a field test of the white rocky substance with a cocaine field test kit, which resulted in a positive hit for cocaine. I field weighed both bags, one was 0.10 grams, and the second was 0.08 grams.

When I entered into my patrol car without saying anything, Joshua spontaneously began asking me to get rid of the bags with the drugs I located in his belongings.

After Joshua continued trying to talk to me, I read Joshua his Miranda warnings from my agency Miranda card. Joshua said he understood and wish to talk. I informed Joshua that I did not need to ask him about the drugs located, because he spontaneously admitted to them when I entered into the vehicle.

Joshua asked me to get rid of the drugs, then asked why I was doing this to him. I informed Joshua he was trespassed from the location, then on August 28, 2025, at approximately 0500 hours, after being trespassed two days earlier, he was back at Wawa causing a disturbance. Reference Indian River County Sheriff's Office case # 2025-92030. When I arrived at the disturbance Joshua was not on scene, but I located him later and conducted a traffic stop on him. Reference Indian River County Sheriff's Office case # 2025-92033. During the traffic stop, I informed Joshua if I caught him at Wawa, I would arrest him.

Joshua began to get irate and made a vague threat towards me, I informed Joshua he did this to himself, I had nothing to do with it, and I warned him not to go to Wawa. Joshua began telling me he is going to get eight years because of his points. Joshua was referencing his lengthy criminal record, to include his release from prison on May 28, 2024, for battery on a law enforcement officer.

This investigation was captured on my agency issued body worn camera.

This investigation is cleared with an arrest.



NARRATIVE

On Thursday, August 28, 2025, at approximately 1810 hours, I responded to the area of 66th Avenue and 85th Street in reference to an auto accident leaving the scene. While en route, Sergeant Garrison advised that he had the suspect vehicle stopped in the 5700 block of 69th Street.

Upon arrival contact was made with Kentoria Smith. Smith advised she was driving to Vero Beach from Orlando to visit family in Gifford. Smith stated due to the rain she could not see so she pulled over so her boyfriend, Jaylin Hemmings, could drive. While making a right-hand turn onto 66th Avenue from 85th Street to travel southbound, Smith stated Hemmings struck another vehicle in the northbound turn lane. Smith stated she and Hemmings were both aware of the crash and did not stop due to Hemmings not having a license and fear that he would get arrested.

Contact was then made with the victim Soledad Hernandez. Hernandez stated she was in the left-hand turn lane facing northbound on 66th Avenue waiting to turn westbound onto 85th Street. Hernandez stated her vehicle was then struck by the vehicle driven by Hemmings. Hernandez stated the vehicle left the scene traveling southbound on 66th Avenue. Hernandez conducted a U-turn and followed Hemmings until law enforcement stopped the vehicle. Hernandez advised as the vehicle stopped, she observed Hemmings jump into the back seat and Smith move from the front passenger seat to the driver's seat. I observed damage on the rear driver's side quarter panel of Hernandez's vehicle consistent with her statements.

Contact was then made with Jaylin Hemmings. Hemmings was advised of his Miranda Rights which he acknowledged an understanding of and stared he was willing to speak with me. Hemmings stated he was driving due to his girlfriend, Kentoria Smith, being unable to see. Hemmings stated he was driving and attempted to make a right turn to go southbound onto 66th Avenue. Hemmings stated during the turn Smith started freaking out saying he was supposed to yield. Hemmings stated he then struck Hernandez's vehicle and continued driving because he "was not sure where to stop." It should be noted that Hemmings drove approximately 3 miles after the crash and only stopped due to law enforcement conducting a traffic stop on his vehicle. Hemmings additionally stated he was aware he did not have a license. Per DAVID Hemmings did not have a license nor did he ever have a license in the State of Florida. I observed damage to the driver's side headlamp area consistent with the statements made in reference to the crash.

Hemmings was place under arrest for leaving the scene of a crash with property damage and no valid driver's license. Hemmings was issued UTC AAO4CWE for leaving the scene of a crash and UTC AAO4CXE for no valid driver's license.

On Thursday August 28, 2025 at approximately 1430 hours, Officers were dispatched to the area a Schumann Drive and Barber Street in reference to a reckless driver. Dispatch advised the caller was following and had pulled in front of a residence.

I checked the area but when I arrived in the area the suspect vehicle (red 2016 Jeep FL tag CZ0596) was no longer in the area. I believe the address the Jeep pulled into was 102 Curtis Circle.

The original caller called back a short time later and advised the Jeep was now at Bristol Street and Barber Street and had struck a garbage can. The caller further advised the driver was walking around and had been running off the road and honking at random vehicles. NARRATIVE

On August 28th, 2025, at approximately 1020 hours, I was conducting a routine patrol at the Salvation Army (505 27th Avenue Southwest). I observed wanted subject Tyrone Walter Smith (date of birth February 22nd, 1971) standing in line at the entrance to the building. I knew that Smith was a wanted subject per an active Indian River County bench warrant (312025CF000353AXXVB) signed by the honorable Judge Robert Meadows.

The warrant was for F.S.S. 843.15(1)(A) - Failure To Appear (Felony) - No Bond. I placed Smith into handcuffs and confirmed the warrant via public safety dispatch. I then placed Smith under arrest. I conducted a search of Smith's person post arrest. Inside Smith's left front shorts pocket, I discovered a clear capsule with a silver in color screw on top. This was not a prescription bottle(s). There were multiple white pills in the container. Smith stated he did not have a prescription for the pills as they belonged to his girlfriend Yvette and he was holding them for her while she was in the shower. This was a spontaneous utterance as I was attempting to search Smith prior to placing him in my patrol car.

I transported Smith to the jail without incident.

While at the jail, I conducted a search of the pills via the drugs.com pill identifier. Inside the clear container, there were a total of nine pills.

Two were oval shaped and white with "AN 355" imprinted on one side. The pills were identified as Sildenafil Citrate which is prescribed for erectile disfunction and pulmonary arterial hypertension. Sildenafil Citrate requires a prescription but is not a schedule drug.

Seven pills were round shaped and white with "OP" imprinted on one side and "10" imprinted on the other. The pills were identified as Oxycontin, a narcotic analgesic schedule / controlled substance that requires a prescription.

Smith did not have any prescription pill bottles on his person which the drugs may have been in at any point.

Smith was transported to the Indian River County Jail without incident.

I activated my body worn camera at the jail and spoke with Smith at his holding cell and read him his Miranda rights. Smith waived his rights. Smith insisted the pills belonged to the girl he had been hanging out with, Yvette. Smith initially denied knowledge of the Sildenafil Citrate but then stated Yvette received them from a friend who he referred to as an "old man". Smith stated Yvette took the other pills for back pain.

Based upon my investigation, I charged Smith with the following:

F.S.S. 893.13.6A – possession of a controlled substance without a prescription.

F.S.S. 893.147.1 - possession of drug paraphernalia

F.S.S. 499.03.1 - possession of a legend drug
