The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On 04/25/2026, at 02:11 (Specifically include facts constituting cause for arrest.)

On April 25th, 2026, at approximately 0135 hours, I responded to 1205 Schumann Drive, Sebastian, Florida 32958 in reference to a welfare check. While en-route, Sebastian Communications advised a male [redacted] stating his mother was laying in the middle of the road after punching him in the mouth. Sebastian Communications also advised the male appeared to sound under the influence of alcohol, and stated he was going to run from officers upon our arrival.

Officer Smith arrived on scene and made contact with the female in question, identified as Amy Tucker. Officer Smith advised via SPD Channel 1, that the incident was possibly going to be domestic violence related.

As I approached Officer Smith's location, I observed a white male wearing no shirt, blue shorts with long blonde hair standing to the north of Officer Smith's location. The male appeared to be on the phone. I activated my scene lights on my marked Sebastian Police Department patrol vehicle (unit 22) to have a better visual of the male. As I began to park my vehicle, the male turned around and began to run east toward Marsh Street. This information was relayed to other officers via SPD Channel 1. I circled around to the south end of Marsh Street and began traveling north to attempt to locate the male. Due to Sebastian Communications still being on [redacted] with him, they were able to advise me the call was plotting in between houses on Marsh Street and Schumann Drive. I exited my patrol car at this time and attempted to catch up to the male on foot, who I observed running west toward Schumann Drive. Once I caught up to the male, he stood in place and was safely assisted to the ground by Officer Smith and I, and was placed in mechanical restraints for the remainder of the investigation. The male in question was identified as Dominik Munoz.

Officer Smith and I helped Dominik to his feet and began to walk him over to a patrol vehicle. However, while doing so, Dominik began to tense his arms and pull away from officer's multiple times even after being told to stop. Dominik failed to comply with these commands, which forced officers to escort him to the ground to gain control of him. Once control over Dominik was gained, he was placed inside of Officer Glines's patrol vehicle. While in the back of Officer Glines's vehicle, Dominik began to excessively kick and hit the door and window frame of the back of the vehicle. Due to the severity of this, Officer Glines and Sergeant Melius made the decision to place his legs in a hobble restraint. Sergeant Melius along with Officer Glines attempted multiple times to de-escalate Dominik however were met with negative results. While attempting to place Dominik in the hobble, he stood up towards Sergeant Melius in an attempt to defeat his efforts of placing him into a hobble, forcing Sergeant Melius to place his hand on Dominik's chest to stop him from making contact with him. Dominik was subsequently placed into a hobble at this time.

While on scene I made contact with Amy, who was visibly injured on her face. I observed Amy to be bleeding from her face and also had blood on her left arm and right leg. I observed the left side of Amy's lip to be swollen and cut, causing her to bleed along with other cuts on her face. Upon speaking with Amy, she stated her son, Dominik, picked her up from her residence in Fort Pierce and brought her to his residence. While at her son's residence, 1205 Schumann Drive, her son wanted to continue drinking alcohol. However, Amy stated she told him no and broke the bottle of alcohol. According to Amy, this was followed by Dominik punching her in the face. Inside the residence, officers observed broken glass consistent with bottles being broke. The injuries I observed on Amy were also consistent with being struck in the face. Initially, Amy denied EMS responding to the scene when asked by officers. However, Amy later [redacted] and requested EMS due to the pain she felt from being struck.

Officers attempted to interview Dominik after being advised of his Miranda Rights, however Dominik was extremely intoxicated and was unable to provide any coherent statements. The only statement made were in reference to him being involved in another physical altercation with another male who had no involvement in this incident nor was he present. Dominik did state he was struck in the face by Amy however had no injuries consistent with that statement.

Based on the totality of circumstances which include statements and what I observed on scene as well as Dominik being combative with officers, forcing us to escort him to the ground and place him in a hobble restraint, I found probable cause to place Dominik under arrest for violation of FSS 784.03(1A1) BATTERY DOMESTIC VIOLENCE and FSS 843.02 RESIST OFFICER WO VIOLENCE.

Dominik was transported to the Indian River County Jail. Dominik continued to kick and bang on Officer Glines' door and window frame throughout the entire ride, and was again uncooperative with booking deputies forcing them to place Dominik in a restraint chair.

which made the scene very unsafe for deputies.

Ahmaud was approached and finally placed in handcuffs, without further incident. I placed him in the backseat of my patrol vehicle. I advised Ahmaud of his Miranda Rights, which he indicated he understood and still agreed to speak freely to me.


Ahmaud admitted the argument in the kitchen sparked over plastic wrap not being in its box. Ahmaud said Breanna was the aggressor and started hitting him with closed fists in the back. I inspected Ahmaud back for any visible injuries and there were none. I asked Ahmaud if he required medical aid and he declined. Ahmaud admitted he might have tried to defend himself but he did not remember hitting Breanna.

Ahmaud did actually and intentionally touch or strike Breanna against her will of {or} did intentionally cause bodily harm to Breanna and Breanna was a family or [REDACTED] of Ahmaud, contrary to Florida Statute 784.03(1), 741.28 and 741.283. DV Simple Battery.

Ahmaud did resist, obstruct or oppose Deputy Martin and I, a law enforcement officers of the Indian River County Sheriff's Office, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02. Resisting without violence.

NARRATIVE

On Saturday, April 25, 2026, at approximately 1735 hours, I responded to the area of 2700 20<sup>th</sup> Street, Vero Beach, Florida, in reference to a reckless driver. The caller, Scott Dunbar, stated the vehicle, a grey in color dodge pickup truck, was Eastbound on 20<sup>th</sup> Street near 58<sup>th</sup> Avenue, and was all over the road. Scott further stated the pickup had stopped in the turning lane to Wal-Mart located at 5555 20<sup>th</sup> Street, before continuing East on 20<sup>th</sup> Street. Scott advised communications he was unable to obtain the license plate due to the driving behavior.

Communications advised Scott had called back into [redacted] as the pickup truck was turning southbound on 27<sup>th</sup> Avenue from 20<sup>th</sup> Street, and provided Florida tag#: BX84RM for the vehicle. Communications advised Scott disconnected and was no longer following the vehicle.

It should be noted, I later made contact with Scott via phone, at which point he advised me that he was behind the pickup truck since 7400 20<sup>th</sup> Street, and observed the vehicle all over the roadway sometimes crossing all three lanes of traffic. Scott further stated, at one point another motorist had attempted to stop Fredy from driving while they were at a red light; however, they were unsuccessful in doing so. Scott stated there was two younger males in the vehicle, and the driver had dark possible curly hair with a beard.

Communications put a BOLO (Be-On-The-Lookout) for the vehicle, at which point, Deputy Snowhill, stated he had located the vehicle at the 1600 block of 27<sup>th</sup> Avenue at approximately 1736 hours, and it was backed into the driveway. It should be noted that Scott had stopped following the vehicle at 2700 20<sup>th</sup> Street at approximately 1732 hours. Deputy Snowhill further stated the male driver, Fredy Diaz-Perez, appeared heavily intoxicated.

I responded to the location and made contact with Deputy Snowhill, who informed me, as he was Southbound on 27<sup>th</sup> Avenue he observed the pickup matching the description from the BOLO, and Fredy had exited the driver seat and was standing near the open driver door with keys in his hands. Deputy Snowhill further advised me he had turned around to confirm the vehicle was the correct one from the BOLO, at which point Fredy was at the rear of the vehicle, and had placed the keys on the rear bumper.

I began to speak with Fredy, who predominately only spoke Spanish, at which point he provided me with the name Alfredo Ramirez and a date of birth of 09/28/1999. Fredy stated to me that he did not have a driver's license or passport, and he had never been issued a license as he was an immigrant from Honduras.

As I interacted with Fredy, I observed several physical signs of impairment: inability to balance, bloodshot-watery eyes, slurred speech, a strong odor of an alcoholic beverage emitting from his breath, two open Modelo beers in the center console of the vehicle, and Fredy stated he had been drinking.

Fredy stated he did not reside at the address he had parked at, at which time contact was made with the residents. The male resident, Constantino Alvarado, stated he had been in the passenger seat with Fredy as they were picking up construction material. Constantino stated Fredy was driving, and was all over the road prior to their arrival at the residence.

It should be noted the description provided by Scott also matches Fredy's description, further placing him behind the wheel.

Due to the fact of the driving pattern and description provided by Scott, and Constantino confirming Fredy was behind the wheel, I became concerned Fredy was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances.

Fredy began attempting to get into the driver seat of the pickup truck as Deputy Nunley and I were speaking with him so he was placed into custody due to my observations that Fredy was impaired, and his attempt to reenter the vehicle, as well as, him not having a valid driver's license. This is due to Fredy's close proximity to the open driver side door, possession of keys to the vehicle, the signs of impairment, and his attempt to reenter the vehicle. It should also be noted that the Modelo containers in the center console were in the cupholder between both the driver and passenger seat, and were cold to the touch as if they had just been opened.

Fredy was transported to the Indian River County Jail, at which time Deputy Estrella, whom is fluent in Spanish, responded to assist me with translation to complete the Field Sobriety Exercises. While Deputy Estrella was speaking with Fredy, he had informed Deputy Estrella, he had provided me with a false name as he was scared due to previous interactions with law enforcement. Fredy also provided Deputy Estrella with a photograph on his cellphone of his Honduran Passport, allowing us to confirm his actual identity.

To dispel my concerns, I asked Fredy if he would participate in a series of standardized field sobriety exercises, to which he agreed. I asked Fredy a series of medical questions to ensure he could participate in field sobriety exercises. Fredy stated that he had no physical defects, was not sick or injured, did not have epilepsy or diabetes, did not wear contacts or glasses.

All field sobriety exercises were explained and demonstrated proficiently prior to Fredy beginning each exercise and I confirmed Fredy understood the instructions prior to the start of each exercise. All instructions and Demonstrations were completed in both Spanish and English to ensure Fredy understood all instructions.

The following exercises were performed:

- 1.) HORIZONTAL GAZE NYSTAGMUS - No resting nystagmus was observed. Equal pupil size and equal tracking was observed in both eyes. I observed a lack of smooth pursuit in both eyes; distinct and sustained nystagmus at maximum deviation was observed in both eyes; the onset of nystagmus prior 45-degrees was observed, and was prominent. Vertical Gaze Nystagmus was not present. Fredy was also heavily swaying, and had to be reminded to keep his head still and follow the stimulus with his eyes only.
- 2.) WALK AND TURN - A straight line of tape was used for the exercise inside of the jails DUI room. Fredy exhibited the following signs: started prior to being instructed to do so, stepped off the line, incorrect turn, used arms to

balance, missed heel-to-toe.

- 3.) ONE LEG STAND – This exercise was explained and demonstrated prior to Fredy completing this exercise. For this exercise, Fredy chose to utilize his right foot. Fredy exhibited the following: Used arms to balance, did not count in the manner provided, swayed, placed foot down to maintain balance for an elapsed time of 10 seconds.

Overall, Fredy performed poorly on all field sobriety exercises.

Based upon my investigation, probable cause exists that on Saturday, April 25, 2026, Fredy was in actual physical control of a motor vehicle while under the influence of alcohol beverages and/or a chemical or controlled substance and was impaired beyond their normal faculties, incapable of operating a vehicle safely.

After I arrived at the jail, Deputy Sheriff Rentas advised me that Fredy agreed to provide a breath sample. At the conclusion of the test, the breath sample showed Fredy had a breath alcohol concentration (BrAC) of 0.303 grams per 210 liters of breath, 0.273 grams per 210 liters of breath, and 0.266 grams per 210 liters of breath. Due to Fredy's initial breath sample exceeding 0.300, I transported him to Cleveland Clinic Indian River Hospital for medical clearance.

It should be noted that after further investigation into Fredy's driving history, it was discovered he is listed as a Habitual Traffic Offender as of 05/22/2024 for a period of five years, citation#: AJ5RMHE. Fredy also has two previous DUI convictions within 10 years. The first was on 06/05/2022 out of St. Lucie County, citation#: AGC5Z4E, and the second on 03/22/2024 out of Indian River County, citation#: AJ8ST1E.

NARRATIVE

On April 26<sup>th</sup> 2026, at approximately 0001 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I met with Ms. Alisa Altenhoff who stated the following: She was in the upstairs bedroom of the apartment, when her mother, Ms. Lisa Bennet, let Mr. Gerrit Barber inside the residence. Gerrit Barber is Alisa's ex-boyfriend and [REDACTED] Gerrit walked up the stairs to the bedroom and knocked on the bedroom door, demanding to be let in. Alisa got up and opened the door, which she keeps locked because she is fearful of Gerrit. When the door opened, Gerrit pushed Alisa on the bed, and punched her in the face with a closed fist. Lisa heard the commotion and came out of her bedroom and ushered Gerrit downstairs while [REDACTED] Alisa confirmed she has lived with Gerrit in the past.

Alisa was not aware that Gerrit was coming over tonight and did not know Gerrit was bringing his little brother, Gerrie Barber as well. She stated Gerrit does not live at the apartment but he stays there sometimes. Alisa's left lower jaw was red and appeared to be starting to swell compared to the other side of her jaw. When I first arrived on scene, I observed what appeared to be vertical striations in the red marking on her jaw consistent with the fingers of a fist impacting it. As I stayed on scene, Alisa's jaw turned redder and these markings went away. Alisa declined medical treatment but stated her jaw and ear area was in significant pain. Alisa was crying and upset on scene.

I met with Lisa who stated the following: She let Gerrit inside and went upstairs to the bedroom adjacent to Alisa's. She heard Gerrit demanding that Alisa let him in her bedroom. She then heard a loud smack which sounded to her like Alisa being struck. She ran to aid Alisa and ushered Gerrit away, downstairs while [REDACTED]

In a post-Miranda interview, Gerrit stated the following: He arrived at the residence intending to stay the night with Gerrie. A verbal disturbance began between Gerrit and Lisa, because Lisa does not like Gerrit. Gerrit went outside to smoke a cigarette, and law enforcement arrived. He claimed Lisa and Alisa just call law enforcement to get him put in jail when they have issues with him. Gerrit stated he never went upstairs and he did not put his hands on anyone. Gerrit confirmed he has [REDACTED]

Gerrit was highly intoxicated, agitated and his answers were frequently incoherent. He continually asked that I interview Gerrie.

I met with Gerrie who stated the following: Gerrit and himself were supposed to stay the night elsewhere, but Gerrit got into an argument with someone while he was out drinking. Gerrit decided they would stay the night at Alisa and Lisa's house. When they arrived, Lisa let them in and she got Gerrie a blanket to stay on the couch. Gerrit and Lisa went upstairs. Shortly afterwards, he heard Gerrit yelling at Alisa to open the door. Then he heard Alisa crying.

Based on these circumstances, I found probable cause to arrest Gerrit for the offense of battery, domestic violence,

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 04/26/2026, at 00:00 (Specifically include facts constituting cause for arrest.)

On April 26th, 2026, at approximately 0000 hours, I, Ofc. Z. Dominguez, responded to the area of 3150 Ocean Dr in reference to a possible child neglect.

Upon arrival, I made contact with security at Waldo's. Security advised he observed a white F250 in the parking lot of Waldo's with the engine on and a [REDACTED]. Security claimed he first observed the vehicle approximately 15 minutes prior to our arrival and [REDACTED] remained sleeping despite flashlights illuminating his face.

At approximately 0010 hours, I observed a group of adults walking toward the truck from the northwest end of the parking lot. I made contact with the adults, identified as Brittany Gabbert, and the defendant, Bobby Moneyhan. When questioned where they were coming from, Gabbert stated "Grind and Grape". I first spoke with Moneyhan who's behavior indicated impairment with observations of loudness, racist remarks, a confrontational attitude, and an odor of an alcoholic beverage emitting from his person. It should be noted that Moneyhan remained non-compliant throughout the investigation and later [REDACTED] on his cellphone while speaking to another officer. While attempting to question/identify Moneyhan, he claimed he had only been gone "7-9 minutes" to pickup others from the bar and wasn't drinking. When asked about the [REDACTED] being unsupervised, he claimed "I was only gone for a few minutes and that [REDACTED] was under supervision the whole time". [REDACTED]

I then met with security, who provided video surveillance footage capturing the time elapsed of [REDACTED] being left unsupervised from [REDACTED] (Moneyhan). The following approximate timestamps are shown:

- 2256 hours: Truck pulls into parking space.
- 2316 hours: Moneyhan and [REDACTED] get into truck.
- 2325 hours: Moneyhan exits truck walks west of camera view.
- 2345 hours: Security observes vehicle with [REDACTED] sleeping in front passenger seat.
- 0000 hours: Law Enforcement arrives on scene.
- 0009 hours: [REDACTED] return to truck and are met by law enforcement.



Surveillance footage from the inside bar of Grind and Grape was later obtained. The footage shows Moneyhan purchase and mix a drink at approximately 2356 hours.

I then returned to Moneyhan, stating the aforementioned timestamps showing [REDACTED] being left unsupervised by [REDACTED] for over 40 minutes while he was drinking at a bar. Moneyhan stated "false" and declined to further comment on the incident. When attempting to Mirandize Moneyhan, he continuously shouted over me and was uncooperative resulting in him declining to speak further.

At this time, Moneyhan was placed under arrest for Neglect of a Child by Caregiver Without Bodily Harm, in violation of F.S. 827.03(2D). Moneyhan was transported to the Indian River County Jail for booking, no bond.

This incident was captured by my department issued Body Worn Camera (BWC) and surveillance footage from Waldo's and Grind & Grape were uploaded to VBPD Evidence Library.

NARRATIVE

On Sunday, April 26, 2026, at approximately 1216 hours, I Corporal Martin, responded to 5470 45<sup>th</sup> Street in reference to a reported shoplifting incident. Dispatch advised that a caller who was an employee at the Jackie's cash and carry store, was reporting that a black male wearing a blue jacket and blue pants stole cigarettes and a drink from the store.

Upon my arrival, I made contact with the caller who identified herself as Tancey D. Glover DOB: 11/07/1984. Glover stated that a younger black male who looked like he was in his twenties, who was wearing a blue jacket and blue pants walked up to the payment counter with an Arizona Ice Tea can and asked for a pack of cigarettes. Once the pack of cigarettes was placed on the counter the male pretended to hold a phone over the chip scanner to act like he was paying. Kaylee D. Curles DOB: 07/28/2005; who was operating the cash register at the time, observed that the male did not have a phone in his hand, and pick up the items and began to exit the store. When Curles told the male he needed to pay for the items, the male stated "just call them". The male would then leave the store on foot walking west from the store with the items he did not pay for. Both the pack of cigarettes and Arizona tea came to a total of \$13.83 USD. Glover stated that as a business representative she did want to pursue charges against the suspect.

A short time later, an assisting deputy located the previously described male walking on foot west from the store in the 5700 block of 45<sup>th</sup> Street. In the males' hand was an opened Arizona tea can and the pack of cigarettes with a cigarette already lit. The male was not able to produce a receipt or proof of payment for the items. The male would be identified as Oringen S. Colebrook Flowers DOB: 06/30/1999. It should be noted that on 04/21/2026, Colebrook was the suspect of a shoplifting at the MLK Plaza store located at 2416 45<sup>th</sup> Street, where he stole items from the business. In the previous incident the business did not want to prosecute charges against Colebrook.

Due to the totality of the circumstances, that Oringen S. Colebrook Flowers took possession of and carried away merchandise from a merchant. Colebrook did so with the intent to deprive the merchant of possession, use, benefit, and full retail value of the merchandise. Colebrook was seen doing this by bypassing all points of sale without making any good effort to pay for the items. Colebrook was placed under arrest for F.S.S. 812.015 Retail theft / Shoplifting misdemeanor with a \$150.00 USD bond status.

NARRATIVE

On April 26, 2026, at approximately 13:24hrs, deputies arrived on scene to a possible disturbance at [REDACTED]. The caller was unsure of the apartment number, and stated a female was being yelled at by a male who appeared to be intoxicated.

Upon arrival, I made my way to the back of the structure, and located the entrance door for [REDACTED]. I could hear a male and female inside the residence, and the male appeared to be yelling or upset with the female. I knocked on the door, and a female, later identified as Amanda Plude, answered.

Plude began telling me that her boyfriend, Edwin Gates, was intoxicated and belligerent. Plude stated they had been arguing, and that she was attempting to move out. Gates then came toward the front door, and appeared to be heavily intoxicated, slurring his words and showing unsteadiness on his feet. Gates began yelling at deputies to leave his residence, as they did not have a search warrant. I attempted to ask Gates what was going on, and he never replied, only continued yelling. At this time, Gates was placed in handcuffs and told he was being detained. Gates was escorted to the front porch of the residence, where he was instructed to sit in a chair.

I returned inside the home to speak with Plude, who stated she had been dating Gates since November 2025, and stated [REDACTED]. Plude stated Gates had been drinking since the previous day, which is when they began arguing. Plude stated sometime throughout the night or early morning hours, Gates had struck her in the face and lower back, and choked her with both his hand and arm around her neck. Plude showed me her lower lip, which had swelling and a small laceration. She also pointed out bruising on the left side of her neck, which she said was from being choked. Plude stated at no time did she lose the ability to breathe. I did not detect any injuries on Plude's lower back.

I returned to Gates, where I read him Miranda Warnings. I attempted to speak with Gates, however he refused to answer any questions.

I completed a Lethality Assessment and First Appearance Questionnaire with Plude, and due to the scoring system, informed her that she was in a potentially lethal situation. I advised her of the nearest domestic violence shelter, Safe Space. I also provided Plude a copy of her Victim's Rights & Remedies.

Gates was advised that he was being placed under arrest for DV Battery, and escorted to the back of my patrol vehicle. Gates was transported to the Indian River County Jail without incident.

NARRATIVE

On Sunday April 27, 2026 at approximately 2206 hours, I responded to [REDACTED] reference to a domestic disturbance.

Upon arrival I met with the victim, Jakia Bennefield who stated the following:

Bennefield stated at approximately 2100 hours she went to 4316 27<sup>th</sup> Avenue, Vero Beach to see her fiancé, Charles Stokes. Bennefield told me shortly after her arrival the two of them started to engage in a verbal argument over \$2,000 Bennefield loaned to Stokes. Bennefield said Stokes progressively began to raise his voice then proceeded to stand up and get into her face in an aggressive manner with his fist clenched. Bennefield told me Stokes began to strike her in the face multiple times with a closed fist as well as the "nub" on his right arm. It should be noted that Stokes right hand and wrist were amputated leaving him with a only a nub. Bennefield stated she reached into her pocket to retrieve her cell phone in attempt to [REDACTED] Stokes once again struck her with his right arm and grabbed the phone out of her hand with his left hand forcing it out of her possession. Bennefield told me she fled from the scene on foot until her mother picked her up down the street and proceeded to drive her to her residence on [REDACTED] where she was able to [REDACTED] on her mothers' phone. Bennefield stated she has had an on and off intimate relationship with Stokes for approximately three years, stating they each reside at their respective addresses but [REDACTED]

I observed a contusion on the left side of Bennefield's head and cuts on the inside of her lip which were consistent with being struck in the manner she described.

While still on scene other responding Deputies located a black male matching the description of Stokes which was earlier provided by Bennefield at 4855 32<sup>nd</sup> Avenue, Vero Beach. I then responded and read Miranda Rights to the male who was identified via Florida ID card as Charles Stokes who stated the following:

Stokes told me he met with his girlfriend, Jakia Bennefield earlier today at approximately 1700 hours, but hasn't had an interaction since. Stokes told me he never hit Bennefield nor did he take her phone.

With other responding Deputies still on scene I walked to his truck and proceeded to place my hand on the hood and inside the wheel and noticed it was still hot, which didn't correlate with Stokes earlier statement. Also, his mother who refused to identify herself stated "stop lying to the Deputies, I knew you were over there". It should also be noted that Stokes was dripping in sweat stated he was just dropped off at the residence approximately 30 minutes prior to our arrival from a fishing trip by a friend

Due to Stokes using force to deprive Bennefield of her phone, striking her multiple times in the face,

On April 26, 2026, at 18:15 hours, I Deputy D. Coon #6379 responded to Vero Beach Police Department at 1055 20<sup>th</sup> Ave in Indian River County in reference to a Disturbance call. The complainant advised Dispatch that she wanted to report a domestic violence incident that occurred on March 18, 2026.

Upon arrival, I met with Nicole Grace De La Ross. Nicole is the complainant and victim. She swore verbally to the following in summary:

[REDACTED] Alfred persisted to bar her from entry. Alfred slammed the interior garage door shut and grabbed Nicole's upper left arm. He then abruptly pulled her arm to remove her from the garage. Alfred acknowledged his long-term relationship with Nicole, including their breakup, and her late term pregnancy at the time of the March 18<sup>th</sup> incident. Alfred explained that he had a female guest in the home that night, and he was surprised to see that Nicole had entered the home without warning. Alfred did not want to make a scene or make his guest feel uncomfortable. So, he grabbed Nicole's hand and casually walked her out to the driveway. Nicole confronted him for having a female visitor so soon after their breakup. Nicole then tried to reconcile their relationship, without success. NARRATIVE

On April 24, 2026, at 2115 hours, Your Affiant responded to CVS (5825 20<sup>th</sup> Street, Vero Beach, Florida), which is a location within Indian River County, to assist Deputy Scott with an accident leaving the scene investigation (Reference IRC SO Case # 2026-43174).

Prior to arrival, Deputy Scott responded to a vehicle collision, at 6600 20<sup>th</sup> Street, which resulted in a BOLO being issued for a gray Buick bearing Florida registration XFV914. IRC SO's Real Time Crime Center then notified deputies, the suspect vehicle was observed on FLOCK camera in the area lot of Chipotle (5855 20<sup>th</sup> Street). After which, Sergeant Thimmer located the suspect vehicle, parked in the parking lot of CVS (5825 20<sup>th</sup> Street), Deputy Scott responded which resulted in the driver, who was later identified as, David Williams, being placed under arrest for Driving while Suspended, 3<sup>rd</sup> Offense and Leaving the Scene of an Accident. During the investigation, it was revealed David Williams, nor the front seat passenger, who was later identified as, Lauriene Annacer (Defendant), were the registered owners of said vehicle. Deputy Scott advised the Defendant, the vehicle was going to be towed due to neither of them being the owner of the vehicle.

Your Affiant was standing at the passenger side of the vehicle, while the Defendant, who was in the front passenger seat, began collecting her belongings, to exit the vehicle. After the Defendant opened the front passenger door, to step out, your affiant physically observed a small zip lock bag, containing a white powdery substance, sitting on the front passenger seat, under the defendant's body. After detaining the Defendant, she stated, she possessed more cocaine, which she was storing inside of her vagina. Deputy Moon responded to our location, to assist with searching the defendant and to retrieve said substance. Once Deputy Moon arrived on scene and assisted with the search, she located one clear plastic bag, containing a white powdery substance. Deputy Moon then released the substance to your Affiant. The defendant was then asked if there were any more drugs on her person and she responded with, there was no more. Your Affiant then placed the Defendant under arrest for Possession of Cocaine and transported to the Indian River County Jail.

Once your Affiant arrived at the Jail, Corrections Deputy Rentas came to assist with the search of the Defendant, in the sally port. While conducting a search of the Defendant, Deputy Rentas located one additional small zip lock bag, containing a white powdery substance, in the Defendant's bra. Deputy Rentas then transferred custody of this substance to your Affiant. Once inside the jail, the Defendant was scanned by an x-ray machine, prior to booking. While conducting a detailed search, Deputy Rentas located one additional small zip lock bag, containing a white powdery residue, as well as, a receipt from a debit withdrawal, in North Miami, Florida in the Defendant's left sock. Deputy Rentas then released said contraband to your Affiant.

The total package weight of the three bags, containing the white powdery substance, is approximately 4.5 grams. The white powdery substance field tested positive for the presence of cocaine.

NARRATIVE

On Friday, April 24, 2026 at approximately 1814 hours, I was conducting an investigation at Burger King, 13555 US Highway 1, in reference to an auto accident leaving the scene.

The complainant in the crash stated an older model, black, lowered truck, struck the rear of her vehicle at Roseland Road and US Hwy 1 while she was stopped at a red light, before pulling away and entering the Burger King parking lot. While still on scene speaking with her, she pointed at a black truck parked on the north side of the Burger King parking lot, and stated, "it kinda looked like that truck".

I relocated to the Burger King parking lot and identified the black truck, bearing FL specialty Army tag, BSJ5I. The truck was running and the driver (and sole occupant) appeared to be asleep as he was leaned back and his head pointed toward the ceiling. Myself and D/S Edgar (6319) knocked on the windows of the truck for several minutes, attempting to awaken the driver. Additionally, we shined flashlights in the window at the driver's face; all attempts to wake him up failed. It was determined that the driver's door was unlocked, so I opened it announcing "Sheriff's Office" several times to alert him to our presence and make sure he was okay. The male driver did eventually wake up, but appeared very confused. Also identified in the door when it was opened were three Corona beer bottle caps.

The driver could not form statements that made sense when asked if he was okay. He denied sleeping in his truck and stated he was at Burger King getting food. The first ID provided was a FL learner's permit with the upper corner cut off (a valid class E FL DL was later found). The male was identified as Adolfo Hernandez DOB 09/12/2007. I asked Hernandez if he had been in a crash a short while ago, to which he said no. While Hernandez spoke, I could smell the odor of an alcoholic beverage coming from his breath. He additionally had difficulty forming words and phrases, slurring his speech. Despite being advised to not use his phone and stop reaching into his pockets and the car, Hernandez continued to do so.

When asked where was coming from this afternoon, Hernandez stated "Fellsmere". I then asked where he had been all day today, to which he stated, "Drinking". I asked where he had been drinking and he first stated "at a restaurant". I then asked the name of the restaurant, and he immediately stated, "not at a restaurant". Hernandez could not indicate how long he had been drinking other than "all day". He could also not remember exactly many drinks he had had, possibly four or five, but that he was only drinking Coronas. Hernandez stated he has been alone and no one else has been in his vehicle.

I then asked Hernandez to submit to Standardized Field Sobriety exercises, which he refused. I explained that I would be forced to base my decision on whether to arrest Mr. Hernandez or not based on my observations thus far, if he refused to participate in the exercises. He again refused and was placed under arrest.

Inside the center console of Hernandez's vehicle, were two, cold, mostly empty Corona beer bottles. In the back seat was an additional empty Corona bottle and Corona bottle cap. Resting on the passenger front seat was a small, black cooler bag. Inside was an empty, 24 ounce "Hard Iced Tea Twisted Tea", and an empty, 24 ounce "Victoria Vicky Mango" beer can. In the bed of the truck were three additional, full and unopened Corona bottles and a mostly empty tequila bottle.

Hernandez was then transported to the Indian River County Jail. It should be noted that Hernandez repeatedly asked the same questions regarding using his phone at the jail, the process of being booked, and how long he would be there, despite





**NARRATIVE**

She stated Chris was in [REDACTED] and she wanted him to leave so she could be alone. Chris told her she didn't want to leave, and she got upset. Chris said while arguing, Ekalejia went inside the kitchen and grabbed a large knife. While Chris was still laying in bed, Ekalejia hovered over him with the knife in her hand telling him he better get out of the bedroom. Chris said he asked her if she was going to stab him, and Ekalejia stated, "I might if you don't leave." Chris said Ekalejia then exited the bedroom, and started boiling a pot of water. Chris said he then locked the bedroom door so Ekalejia couldn't get to him, and [REDACTED]

I asked Chris what his and Ekalejia's relation is, and he said they have been married for approximately a year. Chris said they just recently [REDACTED] I asked Chris if he felt in fear while Ekalejia was wielding the knife, and he initially stated he didn't, because he could overpower her if he needed. However, while continuing to speak with Chris he reiterated he locked the door so Ekalejia couldn't cut him with the knife.

NARRATIVE

On Friday, 04/24/2026, at approximately 0340, I was dispatched to [REDACTED] in reference to a disturbance.

Upon arrival I made contact with the suspect, Nikita Yolandashirne Mcgriff, outside of the residence. Mcgriff resides at [REDACTED]

[REDACTED] Mcgriff was extremely intoxicated and got into a verbal argument with Smith, Smith locked Mcgriff out of the residence. As a result of being locked out of the residence, Mcgriff stated she used bricks from outside the residence and threw them through the windows of the house. Mcgriff also stated she threw a brick into the window of Smith's pick-up truck (White Chevrolet pick-up truck bearing Florida tag CQ49CL). While speaking with Mcgriff she stumbled into the roadway multiple times and almost fell over. After Mcgriff was detained and put into the back of my patrol vehicle, she began to kick the back passenger window repeatedly. I opened the door and told Mcgriff to stop, she stated she was going to continue to kick until we contacted her family and got her property taken to them. Due to the circumstances, I transported Mcgriff to the Indian River County Jail based on the probable cause of a violation of F.S.S. 856.011 – Disorderly intoxication.

Deputy Apollon remained on scene with the victim and continued to investigate the incident. I was advised by Deputy Apollon that Smith stated Mcgriff told him she was going to "fuck him up" and with her knowledge of the residence, went to the bedroom window where Smith's bed is position under and purposefully threw the brick through the window. The shattering of the window caused glass to cover the bed and the brick had also landed on the bed. See Deputy Apollon's supplement for further information.

At the time of the investigation, Mcgriff was actively endangering Smith by throwing bricks through the windows of the room he was in. Smith stated he felt his safety was at risk from the bricks coming through the window and feared that Mcgriff was going to hit him with the bricks. Mcgriff while intoxicated endangered the safety of Smith. Additionally, Mcgriff made verbal threats to cause harm to Smith and had the ability to carry out the threats, proven by the actions of throwing the brick into the window of where Smith sleeps.

Based on the totality of the circumstances, I placed Nikita Yolandashirne Mcgriff under arrest for the following:

- F.S.S. 784.021 – Aggravated Assault – Domestic Violence.
- F.S.S. 856.011 – Disorderly intoxication.

NARRATIVE

On Friday, April 24, 2026, at approximately 2006 hours, I responded to 6600 20<sup>th</sup> Street, Vero Beach, Florida, in reference to an accident leaving the scene.

I arrived at the aforementioned location, and made contact with the complainant, Gary Rivard, and a witness, Tamika Thompson-Fall. Tamika stated she had hit her brakes to avoid hitting a group of birds that had landed in the roadway, which caused the vehicle behind her, a silver in color sedan, to swerve into Rivard's vehicle which was in the middle lane. Fall stated Rivard and her pulled into the turning lane, at which point the silver sedan also pulled over. Fall stated a large black male approximately 6 foot 2 inches and 250-280 pounds, exited the vehicle, then returned to the vehicle and drove away eastbound.

Rivard stated he was able to capture a picture of the vehicle, and provided the same description of the male as Fall. Rivard showed me the picture of the vehicle on his phone, which was of low quality. Rivard stated his wife, Peggy Rivard's, back was hurting from the collision; however, Peggy stated she did not want EMS to respond.

I requested the Indian River County Sheriff's Office Real Time Crime Center, begin a search for the vehicle in an attempt to locate it. RTCC advised the vehicle had hit our FLOCK cameras simultaneously at 90<sup>th</sup> Avenue and 20<sup>th</sup> Street, then again just after the accident at 66<sup>th</sup> Avenue and 20<sup>th</sup> Street. RTCC informed me that the silver in color Buick Lacrosse was bearing Florida tag#: XFV914, and had again hit FLOCK at 58<sup>th</sup> Avenue and 20<sup>th</sup> Street at 2032 hours with no other hits afterwards.

At approximately 2116 hours, RTCC advised they had located the vehicle in the parking lot of CVS located at 5855 20<sup>th</sup> Street. I responded to the location, at which point, I made contact with the male driver, who matched the description provided by both Rivard, and Fall. The male was identified by his Florida driver's license as, David Williams, and was advised of his Miranda Right's, to which, he stated, he understood.

During questioning, David stated, he was involved in the accident leaving the scene, and he had left due to him having a suspended driver's license for failure to pay traffic fines. David stated, he became scared due to having a suspended license and left the scene of the accident without providing aid or leaving information as he had just gotten off of probation.

It should be noted I conducted an inquiry through DAVID, which revealed multiple convictions for Driving while License Suspended, Revoked, or Cancelled. David was found Guilty on the following:
