NARRATIVE

On Friday, October 25th, 2024, at 0155 hours, I conducted a traffic stop of a white Ford Ranger bearing FL/ CG04IS, for failing to stop prior to the stop bar of an intersection prior to conducting a right turn while facing a steady red traffic signal, and the rear window of the vehicle being non-transparent due to a white sheet covering the entirety of the back glass. Upon making contact with the driver of the vehicle, the driver, James Arthur Thomas Jr., failed to produce a driver's license and valid proof of insurance. Thomas was able to provide valid Florida vehicle registration but when asked to provide valid insurance for the vehicle, he requested to retrieve the identification card from his phone, to which I advised that he could. Thomas stated he had to make an account with his insurance provider in order to log in and obtain the card. I ran his registration, FL/ CG04IS, through FCIC/NCIC and DAVID databases which revealed Thomas, did not possess valid insurance on the aforementioned vehicle.

Through my investigation, I found James Arthur Thomas Jr. to be in violation of FSS 324.022 Failure of owner/operator to maintain required insurance. I issued Thomas a citation for the violation, Citation #AJSSRHE, and transported him to the Indian River County Jail without Incident.

NARRATIVE

On Thursday, October 24, 2024, at 2019 hours I responded to [REDACTED] in reference to a domestic disturbance. Prior to arrival, Public Safety Dispatch advised, that a white male was seen in a physical disturbance with a [REDACTED] on the roadway.

Upon arrival, I made contact with the aforementioned white male, identified as Brent Hahn. I asked Hahn if he was involved in a disturbance with anyone in his residence, in which he stated no and that he was home alone with [REDACTED] who will be identified as [REDACTED]. I asked Hahn if it was okay if I spoke with [REDACTED] which he stated yes. It should be noted that throughout my interaction with Hahn, I detected the strong odor of an alcoholic beverage emitting from his person as he spoke.

I then made contact with [REDACTED] stated [REDACTED] was with [REDACTED] when Hahn began to grab [REDACTED] by the arm and drag [REDACTED] down the road. [REDACTED] stated that Hahn at one point began to drag [REDACTED] by the hair and pushed [REDACTED] on the grass in front of [REDACTED] residence. Throughout my interaction with [REDACTED] I observed a severe red mark from the top of [REDACTED] left arm that led all the way down to the bottom of [REDACTED] hand.

[REDACTED] also had dirt on the backside of [REDACTED] pants and red marks on [REDACTED] knees which is consistent with [REDACTED] statements. It should also be noted that both of [REDACTED] sandals were found outside on the roadway where Hahn began to drag [REDACTED]. [REDACTED] stated that Hahn has previously physically abused [REDACTED] in the past and is consistently making statements to kill [REDACTED]. [REDACTED] was found in a distressed state of being and advised [REDACTED] did not feel safe at home with Hahn.

After speaking with [REDACTED] I made contact with Hahn and placed him in handcuffs. I advised Hahn of his Miranda warnings, in which he acknowledged and agreed to speak with me. Post Miranda, Hahn admitted to grabbing [REDACTED] but denied causing any significant harm. Hahn stated he did not drag [REDACTED] on the roadway and that the red marks on [REDACTED] arm might have been caused when he first picked [REDACTED] up.

Due to the above-mentioned, I placed Hahn in the back of my marked patrol vehicle and transported him to the Indian River County Jail without further incident.

While transporting Hahn to the Indian River County Jail, Deputy Consalo made contact with the complainant of the incident, who requested to remain anonymous. Deputy Consalo advised the witness stated he observed the victim, [REDACTED] express that [REDACTED] was scared as [REDACTED] was approached by [REDACTED] Brent Hahn in an aggressive manner. W1 stated Brent began yelling at [REDACTED] and demanded that [REDACTED]. W1 stated [REDACTED] expressed [REDACTED] did not want to go home with Brent due to him being physically abusive and [REDACTED] stated [REDACTED] was going to call the cops.

W1 stated Brent returned to his residence after [REDACTED] said [REDACTED] call the cops, but Brent returned shortly after, holding [REDACTED] phone. W1 stated Brent held [REDACTED] phone out in a luring manner while telling [REDACTED] here's your phone, call the cops. W1 stated Brent did this to entice [REDACTED] closer to him so he could grab [REDACTED]. W1 stated Brent appeared to grab [REDACTED] by the neck but he believed he grabbed [REDACTED] by [REDACTED] upper arm and hair. W1 stated Brent spilled a beer can he was holding in his hand all over the roadway while he dragged [REDACTED] down the roadway. I then asked W1 if Brent dragged [REDACTED] by [REDACTED] hair or arm and W1 advised he was unsure, but expressed Brent grabbed [REDACTED] all over.

Due to the above-mentioned, I criminally charged Hahn with the following charges:

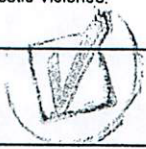

NARRATIVE

On Thursday, October 24th, 2024 at 1655 hours, I responded to Home Depot, which is located at 1885 58th Avenue, in reference to a Shoplifting. Prior to arrival Public Safety Dispatch advised three Hispanic males were detained by Loss Prevention staff outside of the Home Depot. Public Safety Dispatch continued to advise that Loss Prevention only wanted one of the Hispanic males to be prosecuted.

Upon arrival, I made contact with the complainant, identified as Barbara Eide. Eide continued to state that she had observed one of the Hispanic males picking up his items that had been ordered online from a pick-up desk. It should be noted those items were already paid for online through the Home Depot website. Eide stated through video camera footage she observed one of the Hispanic males, who was later identified as Argenis Gonzalez, place a Dewalt Atomic Power drill, valued at \$149 dollars, on top of the shopping cart where the items that were already paid for were inside while the other two male subjects were not paying attention. Eide stated once all of the items were placed in the shopping cart one of the other males, identified as Yorbani Arocha, began to push the shopping cart past all points of sale, which included the Dewal Atomic Power Drill.

After speaking with Eide, I made contact with one of the Hispanic males, identified as Alberto Petit. Petit stated he is the owner of a construction company and came to the Home Depot to pick up items that he ordered online. Petit stated he was not aware of the Dewalt Power Drill being placed on top of the shopping cart.

After speaking with Petit, I made contact with Loss Prevention staff, who provided me with video camera footage of the incident.

I then made contact with Gonzalez and advised him of his Miranda warnings, in which he acknowledged and continued to speak with me. Post Miranda, Gonzalez stated he was told by Petit to place the Dewalt Power Drill on the shopping cart. Gonzalez denied having the intent to steal the Dewalt Power Drill and did not know it was not paid for.

Due to the above-mentioned, I criminally charged Gonzalez with the following charges:

F.S.S 812.014.3(1) 1st Degree Petit Theft

Gonzalez was transported to the Indian River County Jail without further incident.

I, Officer Hernandez (#443), made contact with a white male sleeping inside of a gray Toyota four-door (FL tag # 69E11B) in the parking lot of 858 21st Street. It should be noted that the business is closed and vacant.

As I approached the gray Toyota, I noticed the vehicle's brake lights were lit up and as I walked towards the drivers side of the vehicle, I observed a white male sleeping in the front driver seat of the vehicle. It should be noted that the vehicle was running at that time.

I then, walked towards the passenger side of the vehicle where I observed the keys in the ignition, which indicated that the vehicle was running while the white male was sleeping in the front driver seat. I also observed an open can of Twisted Tea in the front cup holder area of the vehicle and noticed the white male was slightly slumped over to the left side, resting his head on the front driver side door.

I then walked to the front driver side door and began knocking on the window in an attempt to wake the male up. After knocking on the front driver window several times, the male awakes but does not seem to acknowledge my presence. He then removed the keys from the ignition and placed the keys on his lap. The male opened his eyes and began staring straight ahead. The male eventually rolled the left rear window down but rolled the window back up. He then rolled the front driver side window down, less than half way.

The male then stared at me with a confused look (sleepy eyes and mouth slightly open) and continued staring at me as I ask him if he is okay. The male responded but I was unable to understand him. Eventually the male stated he was "just chilling out here" and when asking him if he knew where he was at, he responded with "I'm waiting for a ride." I then ask the male where he was at once again but he remained silent and began using his cell phone. After some silence, the male stated "I'm waiting to go home right now."

I ask the male once again if he knew where he was at and he began looking around and stated "I'm not going to drive. Please don't fucking.." and then continues saying "I'm waiting for my friend to pick me up. I'm not going to drive." As the male is speaking to me, I observe him reach with his right hand for his vehicle keys that were on his lap, and tossed them towards the backseat, saying "I don't have my key."

It should be noted that while speaking with the male, I noticed a strong odor of an alcoholic beverage emanating from his mouth as he spoke. I noticed the male's speech was slurred and he had red, glossy and watery eyes.

Based on all my observations, I had reasonable suspicion to believe that the male was impaired and requested the male to step out of the vehicle. The male then places his feet outside of the vehicle but still remained in a seated position on the front driver seat and asked "why do I have to get out of the car." After explaining to him the reason why, he proceeded to say "I'm waiting to get an Uber driver home" and made no effort to exit the vehicle as requested. The male eventually exited the vehicle.

The male denied having consumed any alcoholic beverages and upon questioning him, he would not provide an answer and instead, would re-iterate that he was getting an Uber driver and was trying to go home. The male/Defendant was eventually identified as Bryce Christopher Francis Nolan (W/M DOB: 06/14/2001) by his Florida drivers license.

The Defendant's information was provided to Vero Beach Police Telecommunications and they advised the Defendant had:

- PRIOR SUSPENSION FOR REFUSAL TO SUBMIT TO LAWFUL TEST OF BREATH, URINE, BLOOD

The Defendant then told me he was trying to go to his parents house and he "was not planning to drive tonight" and works at Quail Valley. The Defendant then stated "I left work with a friend. I left my car here. I had some thing to drink and I'm waiting for an Uber driver to come get me. I have no driver." The Defendant then stated "I'm not driving right now, I stopped my car."

I then asked the Defendant once more of the quantity of alcoholic beverages he had consumed and he stated he had not consumed any alcoholic beverages. It should be noted that the Defendant previously stated to me that he had some drinks.

I then, informed the Defendant that I would be conducting Standard Field Sobriety Exercises to determine if he was impaired to which he stated "yes ma'am."

Before starting, I asked the Defendant if he had any illnesses, recent surgeries, or disabilities to which he remained silent. Eventually the Defendant did state he had a [REDACTED]. I then continue asking the Defendant further questions in reference to [REDACTED] but the Defendant remained silent and did not answer the questions being asked.

As I attempted to explain the first exercise, I instructed the Defendant to stand with his feet together and hands by his

side. In doing so, the Defendant stated "No ma'am." I then advised the Defendant that if he did not perform the exercises requested of him, I would have to make a decision based on the totality of circumstances. I then asked the Defendant five additional times if he would be willing to perform the Standard Field Sobriety Exercises. Each time the Defendant was asked, he would either interrupt me or not answer the question being asked.

I then asked the Defendant a sixth time if he would be willing to perform the Standard Field Sobriety Exercises and warned him that if I did not get a verbal yes or no, I would be taking that as a refusal. The Defendant refused to answer after providing him multiple attempts to perform the Standard Field Sobriety Exercises.

Based on the foregoing, I placed the Defendant under arrest at 0231 hours, for Driving Under the Influence (DUI).

The Defendant was transported to the Indian River County Jail for booking and processing.

The Defendant was placed in the Indian River County Jail Intox Room under video surveillance. After an approximate 20 minute observation period, I asked the Defendant if he would be willing to attempt the Standard Field Sobriety Exercises to which he stated "no ma'am." I then asked the Defendant if he would provide a sample of his breath for the purpose of determining its alcohol content to which the Defendant refused. I then read the Defendant Implied Consent and asked him once more if he would provide a sample of his breath for the purpose of determining its alcohol content to which he refused again.

I then read the Defendant her Miranda Warning from a prepared text. The Defendant stated he understood and refused to speak with me.

Based on a totality of the foregoing, the Defendant was charged as follows:

- F.S.S. 316.193(1A) DUI in that the Defendant was:
 - Driving and/or in actual physical control of a motor vehicle ;
 - Under the influence of alcoholic beverages;
 - Affected to the extent that the person's normal faculties were impaired

- F.S.S. 316.1939(1) Refusal to Submit to Testing
 - Prior refusal on record that resulted in the suspension of the Defendants driving privileges in the state of Florida.

The Defendant was issued the following citations for this incident:

- Citation # AFVKI2E ; DUI F.S.S 316.193(1A)
- Citation # AKDC0HE ; Refusal to Submit to Testing F.S.S. 316.1939(1)

The Defendant was turned over to jail staff and to be held on a \$1,500.00 bond.
