On Friday, October 25th, 2024, at 0155 hours, I conducted a traffic stop of a white Ford Ranger bearing FL/ CG04IS, for failing to stop prior to the stop bar of an intersection prior to conducting a right turn while facing a steady red traffic signal, and the rear window of the vehicle being non-transparent due to a white sheet covering the entirety of the back glass. Upon making contact with the driver of the vehicle, the driver, James Arthur Thomas Jr., failed to produce a driver's license and valid proof of insurance. Thomas was able to provide valid Florida vehicle registration but when asked to provide valid insurance for the vehicle, he requested to retrieve the identification card from his phone, to which I advised that he could. Thomas stated he had to make an account with his insurance provider in order to log in and obtain the card. I ran his registration, FL/ CG04IS, through FCIC/NCIC and DAVID databases which revealed Thomas, did not possess valid insurance on the aforementioned vehicle.

Through my investigation, I found James Arthur Thomas Jr. to be in violation of FSS 324.022 Failure of owner/operator to maintain required insurance. I issued Thomas a citation for the violation, Citation #AJSSRHE, and transported him to the Indian River County Jail without Incident.

NARRATIVE

On Thursday, October 24th, 2024 at 1655 hours, I responded to Home Depot, which is located at 1885 58th Avenue, in reference to a Shoplifting. Prior to arrival Public Safety Dispatch advised three Hispanic males were detained by Loss Prevention staff outside of the Home Depot. Public Safety Dispatch continued to advise that Loss Prevention only wanted one of the Hispanic males to be prosecuted.

Upon arrival, I made contact with the complainant, identfied as Barbara Eide. Eide continued to state that she had observed one of the Hispanic males picking up his items that had been ordered online from a pick-up desk. It should be noted those items were already paid for online through the Home Depot website. Eide stated through video camera footage she observed one of the Hispanic males, who was later identfied as Argenis Gonzalez, place a Dewalt Atomic Power drill, valued at \$149 dollars, on top of the shopping cart where the items that were already paid for were inside while the other two male subjects were not paying attention. Eide stated once all of the items were placed in the shopping cart one of the other males, identfied as Yorbani Arocha, began to push the shopping cart past all points of sale, which included the Dewal Atomic Power Drill.

After speaking with Eide, I made contact with one of the Hispanic males, identified as Alberto Petit. Petit stated he is the owner of a construction company and came to the Home Depot to pick up items that he ordered online. Petit stated he was not aware of the Dewalt Power Drill being placed on top of the shopping cart.

After speaking with Petit, I made contact with Loss Prevention staff, who provided me with video camera footage of the incident.

I then made contact with Gonzalez and advised him of his Miranda warnings, in which he acknowledged and continued to speak with me. Post Miranda, Gonzalez stated he was told by Petit to place the Dewalt Power Drill on the shopping cart. Gonzalez denied having the intent to steal the Dewalt Power Drill and did not know it was not paid for.

Due to the above-mentioned, I criminally charged Gonzalez with the following charges:

F.S.S 812.014.3(1) 1st Degree Petit Theft

Gonzalez was transported to the Indian River County Jail without further incident.





The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of large 10/24/2024 02:18

On , at (Specifically include facts constituting cause for arrest.)

I, Officer Hernandez (#443), made contact with a white male sleeping inside of a gray Toyota four-door (FL tag # 69EIIB) in the parking lot of 858 21st Street. It should be noted that the business is closed and vacant.

As I approached the gray Toyota, I noticed the vehicle's brake lights were lit up and as I walked towards the drivers side of the vehicle, I observed a white male sleeping in the front driver seat of the vehicle. It should be noted that the vehicle was running at that time.

I then, walked towards the passenger side of the vehicle where I observed the keys in the ignition, which indicated that the vehicle was running while the white male was sleeping in the front driver seat. I also observed an open can of Twisted Tea in the front cup holder area of the vehicle and noticed the white male was slightly slumped over to the left side, resting his head on the front driver side door.

I then walked to the front driver side door and began knocking on the window in an attempt to wake the male up. After knocking on the front driver window several times, the male awakes but does not seem to acknowledge my presence. He them removed the keys from the ignition and placed the keys on his lap. The male opened his eyes and began staring straight ahead. The male eventually rolled the left rear window down but rolled the window back up. He then rolled the front driver side window down, less than half way.

The male then stared at me with a confused look (sleepy eyes and mouth slightly open) and continued staring at me as I ask him if he is okay. The male responded but I was unable to understand him. Eventually the male stated he was "just chilling out here" and when asking him if he knew where he was at, he responded with "I'm waiting for a ride." I then ask the male where he was at once again but he remained silent and began using his cell phone. After some silence, the male stated "I'm waiting to go home right now."

I ask the male once again if he knew where he was at and he began looking around and stated "I'm not going to drive. Please don't fucking.." and then continues saying "I'm waiting for my friend to pick me up. I'm not going to drive." As the male is speaking to me, I observe him reach with his right hand for his vehicle keys that were on his lap, and tossed them towards the backseat, saying "I don't have my key."

It should be noted that while speaking with the male, I noticed a strong odor of an alcoholic beverage emanating from his mouth as he spoke. I noticed the male's speech was slurred and he had red, glossy and watery eyes.

Based on all my observations, I had reasonable suspicion to believe that the male was impaired and requested the male to step out of the vehicle. The male then places his feet outside of the vehicle but still remained in a seated position on the front driver seat and asked "why do I have to get out of the car." After explaining to him the reason why, he proceeded to say "I'm waiting to get an Uber driver home" and made no effort to exit the vehicle as requested. The male eventually exited the vehicle.

The male denied having consumed any alcoholic beverages and upon questioning him, he would not provide an answer and instead, would re-iterate that he was getting an Uber driver and was trying to go home. The male/Defendant was eventually identified as Bryce Christopher Francis Nolan (W/M DOB: 06/14/2001) by his Florida drivers license.

The Defendant's information was provided to Vero Beach Police Telecommunications and they advised the Defendant had:

- PRIOR SUSPENSION FOR REFUSAL TO SUBMIT TO LAWFUL TEST OF BREATH, URINE, BLOOD

The Defendant then told me he was trying to go to his parents house and he "was not planning to drive tonight" and works at Quail Valley. The Defendant then stated "I left work with a friend. I left my car here. I had some thing to drink and I'm waiting for an Uber driver to come get me. I have no driver." The Defendant then stated "I'm not driving right now, I stopped my car."

I then asked the Defendant once more of the quantity of alcoholic beverages he had consumed and he stated he had not consumed any alcoholic beverages. It should be noted that the Defendant previously stated to me that he had some drinks.

I then, informed the Defendant that I would be conducting Standard Field Sobriety Exercises to determine if he was impaired to which he stated "yes ma'am."

Before starting, I asked the Defendant if he had any illnesses, recent surgeries, or disabilities to which he remained silent.
