


On 09/04/2025, at 12:45, I, Officer A. Gonzalez, responded to a 1645 35th Ave in reference to a call for service regarding a subject possibly struck by a vehicle and observed lying on the ground near a bicycle. Upon arrival, officers observed a subject matching the description on a bicycle traveling North on the 1700 block of 35th Ave on the southbound lanes. Sgt. Plumb conducted a traffic stop on the subject for the violation at 1870 35th Ave.





During the stop, the subject, later identified as David Klein, reached into his pocket to retrieve a pack of cigarettes. Once he opened the pack and pulled out a cigarette, a white plastic baggie containing a white powdery substance fell to the ground from the cigarette pack. The substance was collected and field-tested, yielding a positive result for methamphetamine.

Klein was advised of his Miranda Rights and chose not to make any statements. Klein was subsequently placed under arrest and transported to the Indian River County Jail for Possession of Methamphetamine (F.S.S. 893.13(6)(a)), to be held on NO BOND. Klein was given citation number ALZP7GE for the aforementioned charge.

It is to be noted that the Klein was never struck by a vehicle and it is uncertain how or why he was on the ground. The Indian River County Fire Department responded to the scene to asses Klein. Klein refused transport to the hospital.

I obtained information a mother living on Beard Avenue in Sebastian was potentially having sexual intercourse with an [REDACTED] there was also a photograph circulating around children's phones of the same female in a compromising position revealing a back tattoo with the female's name and the child living at the residence is Anthony D. I am familiar with a juvenile named Anthony DiRoma and his mother Jennifer DiRoma whom reside at 702 Beard Avenue from previous contacts.

I established a list of contacts from previous calls for service at the location. Being there was potentially a minor at risk I made contact with the guardian of minor SJ, Cathy C. On 09/02/2025 at about 1444 hours, I made telephone contact with Cathy and she informed me her and minor SJ would be available to respond to the Sebastian Police Department on 09/03/2025 at about 1700 hours.

On 09/03/2025 at about 1709 hours, minor SJ arrived with his guardian, Cathy. Both came into the interview room and were present during questioning. I asked SJ if he was aware of any form of sexual interactions with any juveniles to include any kind of nude photographs or videos. I explained SJ was not in any trouble and he can inform me of anything going on at the residence.

SJ stated "Miss Jennifer" is nice, SJ is aware of a photo of Jennifer going around friends but there are rumors going around "Miss Jenn had sex [REDACTED] SJ informed me it "was some kid [REDACTED] SJ stated [REDACTED] SJ did not have a copy of the photo, however he described it as "Miss Jennifer on the bed" and said she was wearing shorts and a shirt.

On 09/04/2025 I determined minor [REDACTED] Detective Radock and I responded and arrived on scene at about 1000 hours and made contact with IRCSSO School Resource Deputy Vazquez. I informed him of the circumstances and requested [REDACTED] be called to his office for and interview to confirm the allegations.

[REDACTED] came to the office at 1017 hours, I informed [REDACTED] of the reason I was there. I asked if [REDACTED] was familiar with "Jennifer DiRoma" and [REDACTED] responded with "yes". I asked [REDACTED] if [REDACTED] was aware of any photographs circulating around of Jennifer. [REDACTED] responded with "yes sir, it was one of me grabbing her but and one of her actual vagina". "I took the video: it was me in the video". I asked if the photos and videos were still on [REDACTED] phone and [REDACTED] said "yes" the phone was located at [REDACTED] residence.

[REDACTED] stated it was really weird, I went over that night (702 Beard Ave in Sebastian, FL) and she would flirt with me. I went over there one night and she was letting me hit the vape. Anthony wasn't there, and she took her clothes off and "I touched around her ass and stuff". [REDACTED] recorded the encounter and it took place in December. When it was over [REDACTED] left the residence and has not returned due to being uncomfortable. I asked if there was any sexual intercourse or oral sex. [REDACTED] stated it was only touching and there was no sex.

After confirming a form of sexual act was preformed between a 41 year old adult and at the time [REDACTED] I concluded the interview as notification would need to be made to the Child Protection Team.

I made notification to School Administration so they are aware of the circumstances and informed them I would be responding to [REDACTED] residence to make family notification.

At 1042 hours, Detective Radock and I arrived at the residence of [REDACTED] We made contact with [REDACTED] informed Mary of the information I had obtained from the investigation to this point. Mary advised she was in possession of [REDACTED] phone, pays the bill and is the owner of the phone. I requested permission to search the phone and she provided both verbal and written consent by completing a Sebastian Police Department Consent to Search Electronic Device form 92.

I responded back to Sebastian Police Department and conducted a visual search of the black iPhone 14 serial number: LVM4TFYG5L.

The photo is described as a nude vagina with legs spread, anus visible with a hand extended performing digital penetration. Contained within the device in "PHOTOS" is image # IMG_3589 taken on December 30, 2024 at 7:04 PM. The video is described as 5 seconds long showing a white female adult wearing black shorts and a dark gray shirt, leaning over the edge of the bed with torso down back facing up. The lower back is exposed with a distinct tattoo "Jennifer". A [REDACTED] is seen standing behind the woman with [REDACTED] left hand extended rubbing the left buttocks of the female under the shorts. Under the

At this time, I had probable cause to believe Jennifer DiRoma had some form of sexual contact with minor [REDACTED]. I contacted Vero Beach Probation Department and spoke with Probation Officer A Phillips. DiRoma was due for a probation check in at 12:15 hours and I requested to come to the office and interview her. PO Phillips agreed and Detective Radock and I responded to the Vero Beach Probation Department located at 1470 Old Dixie HWY Vero Beach, Florida 32960.

Jennifer DiRoma arrived and was walked into an interview room at about 1232 hours. I activated my digital recorder, informed DiRoma of why I was there and admonished her per my pre-printed card. I asked DiRoma if she understood her right to which she replied "yes". I asked if she was willing to talk to me and she responded with "yes, sir".

I started the interview with informing DiRoma I was there to inquire if she had any form of sexual contact with [REDACTED]. DiRoma denied the allegation and said this is stemming from an altercation from her son AD and [REDACTED] was accused of stealing something from AD and over the last few weeks since August 27th she has been receiving harassing phone calls saying "she is a pedophile, she is going to jail".

I then showed DiRoma the above-described photos and informed her the two were both geo-located and marked back to her residence. I informed DiRoma the photos are authentic and my goal was to show that this is an isolated incident.

DiRoma then stated "it is isolated". I showed DiRoma the video that showed [REDACTED] in the video standing behind her and asked "what happened that day". DiRoma then went on to explain "this is an isolated incident" I asked if it there was sexual intercourse she responded "no" I asked if there was oral sex and she responded "no" I then asked if it was just the touching and she responded with "I didn't do anything" I asked "well what did [REDACTED] do to you? Was it just this? (Pointing down to the photos)". DiRoma stated "I would never have sex with a kid" and went on to say "yes sir" when asked if she allowed [REDACTED] to touch her and are "the images accurate of [REDACTED] touching you? Did [REDACTED] touch you?" DiRoma responded with "yes sir".

DiRoma went on to confirm the images as being her and [REDACTED] in her bedroom with [REDACTED] touching and digitally penetrating her. DiRoma then stated "[REDACTED] touched me once, on my vagina and my buttocks". [REDACTED] had come over that day to see if Anthony was home. I invited [REDACTED] in and I had been drinking a little bit that evening [REDACTED] was being very flirtatious and [REDACTED] touched my butt. [REDACTED] asked if [REDACTED] could touch me and I let [REDACTED] [REDACTED] would always tell me I was a hot mom and whatever, whatever" "I went into the bathroom to get something and when I came out, [REDACTED] was in my bedroom and started touching my butt" "I allowed [REDACTED] to touch me, [REDACTED] took my clothes off and was touching me for about 5 minutes tops".

I asked DiRoma if she could show me her back and if I could take a photo of her tattoo. She stated "yes" stood up and exposed her lower back. I took a photo of the same tattoo depicted in the video of "Jennifer" with flowers below and on the side.

At this time with the statements from juvenile [REDACTED] the above listed digital media observed and post Miranda statements made by Jennifer DiRoma, I have probable cause to believe 2 separate acts (on 12/30/2024 at 6:27 PM and 7:04 PM) of lewd and lascivious battery had occurred between minor [REDACTED] and Jennifer DiRoma for sexual gratification of DiRoma. This is a violation of Florida State Statue 800.04(4) encourages, forces or entices with any sexual activity with a minor over the age of 12 years old and under the age of 16 years old, as the victim [REDACTED] at the time of the incident.

Corporal Dean responded to the scene and took custody of DiRoma and transported her to the Indian River County Jail where she was ultimately booked on the above listed charges.

A CPT forensic interview has been scheduled at this time on 09/09/2025.

NARRATIVE
