NARRATIVE

On Tuesday, November 4, 2025, at approximately 2351 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the 1000 block of 27th Avenue, Vero Beach, Indian River County, Florida, in reference to a speeding violation.

Prior to conducting the traffic stop, I was patrolling nearby neighborhoods. While doing so, I drove by the residence of 2444 3rd Street SW, which is a known drug house. While patrolling, I observed a beige Chevrolet Malibu bearing Florida tag 23DQFE parked outside along the street. I continued patrolling the area and eventually responded to another call for service. After clearing that call for service, I continued patrolling my area. During this time I observed the vehicle now traveling northbound on 27th Avenue SW near 1st Street SW. As the vehicle continued northbound, I was able to pace the vehicle using my patrol vehicle. Over the course ten to fifteen seconds, the vehicle was traveling approximately 50MPH in a posted 40MPH zone. A traffic stop was conducted for the speed violation.

During contact with the driver, she was identified by her Florida Driver's license as Ms. Jorlena Williams. Upon writing Ms. Williams a warning, K9 Deputy R.T. William

s responded to the scene. His narcotics trained canine completed a free air sniff of the vehicle during the traffic stop. His canine alerted to the presence of narcotics within the vehicle.

During a search of the vehicle, I located a glass pipe within the upper door cubby of the driver's door, right next to where Ms. Williams was sitting. Based on my training and experience, I believed this pipe to be a glass smoking device that is used to consume narcotics based on the burn residue as well as the burnt crystal / powder substance observed within the pipe. Corporal Moon conducted a search of Ms. Williams. In her right front jeans pocket that she was wearing was a 0.61 gram bag of a white crystalized substance. This substance field tested presumptive positive as methamphetamine. I later field tested the pipe located in the door. The pipe field tested presumptive positive for the presence of Fentanyl.

I advised Ms. Williams of her Miranda Rights. She advised she understood her rights and was willing to speak to me. Ms. Williams advised that the pants she was wearing do not belong to her, but she understands that she takes the responsibility as she is wearing the pants. The pipe I located in the vehicle she uses to smoke her medical marijuana, and that she does not use it to consume other drugs within the vehicle. Ms. Williams advised she tried methamphetamine out about ten days ago, to see what it was like as her daughter smokes methamphetamine. She advised that she has not used it since.

While speaking to Ms. Williams, I observed that her pupils were dilated, when even in some white light. She had bruxism (grinding of the teeth) and restlessness as she could not stop moving while detained in handcuffs. Due to her, already being placed under arrest for the methamphetamine, she was transported to the Indian River County Jail.

While at the jail, I requested Ms. Williams complete Standardized Field Sobriety Exercises. Ms. Williams agreed. They go as follows:

Horizontal Gaze Nystagmus (0/6): Ms. Williams did not have a lack of smooth pursuit, she did not have a distinct and sustained nystagmus at maximum deviation, and she did not have nystagmus prior to a 45 degree angle. She did not have resting nystagmus. She did have equal pupil size and equal tracking with both eyes.

Lack of Convergence: Ms. Williams had a lack of convergence in her left eye.

Walk and Turn (6/8): Ms. Williams could not maintain the instructional stance, she started prior the exercise prior to being

instructed too, she stopped walking to balance herself, missed heel to toe on multiple steps, stepped off line, and took the incorrect number of steps during the exercise.

One Leg Stand (3/4): Ms. Williams swayed while attempting to balance herself, used her arms to balance herself, and put her foot down multiple times throughout the exercise.

Ms. Williams agreed to provide a sample of her breath. She provided two breath samples of 0.00 and 0.00. Ms. Williams subsequently agreed to perform a Drug Recognition Drug Influence Evaluation. Drug Recognition Expert Deputy Hackett of the Indian River County Sheriffs Office responded to the jail. He completed the evaluation and in his expert opinion stated that Ms. Williams is under the influence of a CNS Stimulant and Cannabis and is not able to safely operate a motor vehicle.

Based on the above information, as well as my training and experience as a certified Drug Recognition Expert, I believe there is probable cause to arrest Ms. Jorlena Williams for the offense of Possession of Methamphetamine, pursuant to FSS 893.13, possession of Drug Paraphernalia, pursuant to FSS 893.147.1B and Driving Under the Influence, pursuant to FSS 316.193.2b2.

NARRATIVE

On Tuesday, November 4, 2025, at approximately 0822 hours, I responded to 9495 108th Avenue, Vero Beach, Indian River County, Florida, in reference to a disturbance.

Upon arrival, I made contact with Antonio Mauricio, who stated that he and his girlfriend, Miciah Baysden, had been traveling from North Carolina to Florida for an upcoming court date. While in Indian River County, their vehicle ran out of gas, and they pulled into a local gas station located at the above address.

Antonio advised that he asked Miciah to text her sister for \$10.00 to purchase gas. An argument ensued when Miciah asked him to text her sister instead. Antonio stated that during the argument, he asked Miciah to look at him while he was speaking, and when she refused, he grabbed the bottom part of her chin and turned her head toward him. Antonio reported that Miciah then slapped him in the face with an open hand and began striking him multiple times, causing visible scratches to his face, right arm, and a bite mark on his right forearm. I observed that Antonio had visible scratches on his face with minor bleeding and a bite mark on his right forearm, consistent with his account of the altercation. Antonio stated that he was holding their baby during the altercation and attempted to exit the vehicle; however, Miciah continued to pull him back inside.

I then made contact with Miciah Baysden, who provided a similar account of the incident. Miciah stated that during a verbal argument regarding the gas money, Antonio became upset because she did not want to contact her sister because it was too late. Miciah reported that Antonio grabbed her by the face, turning her head toward him, and then slapped her in the face with an open hand. In response, she slapped him back, and the two began physically fighting inside the vehicle. Miciah admitted to scratching Antonio on the face and biting his right forearm during the struggle. She also confirmed that Antonio attempted to exit the vehicle with their baby and that she tried to pull him back inside to retrieve the child.

Miciah stated that she and Antonio have been in a romantic relationship for approximately three years, and share one child in common, Mauricio A. Alonzo (DOB: 03/23/2025).

Based on this information, the relationship meets the criteria of a domestic relationship under Florida Statute 741.28.

Based on the statements provided and the physical evidence observed, there is probable cause to believe that during a verbal argument, Miciah Baysden did intentionally touch or strike Antonio Mauricio against his will, resulting in minor injury. The offense meets the elements of Domestic Battery which states:

NARRATIVE

On November 4th, 2025, at approximately 0939 hours, I responded to 1500 42nd Circle (Laguna Condominiums) in reference to indecent exposure.

Upon arrival, I made contact with the victim, Alyssa Young. Alyssa advised the following, paraphrased: She was busy cleaning the clubhouse when she noticed a male in a yellow vest and blue t-shirt looking at her through the windows. When Alyssa went to move about the building, he continued to follow her from outside the building such as to maintain sight of her. When Alyssa got to the front of the clubhouse, she observed the male's penis out of his pants and him "bouncing" or manipulating it with his hands while maintaining eye contact and sticking his tongue out.

I found the male, later identified as Brandon Powell, walking on the north side of the clubhouse after which he was detained. Deputy T. Rollando read Brandon his Miranda Warnings to which he consented to speak with deputies without an attorney present.

It should be noted Brandon's statement changed several times. Brandon stated the following, paraphrased:

He initially stated he was not doing anything. After advising him there are cameras all about the building and its exterior, he changed his statement, advising he had his thumb hanging out of his zipper. Brandon then changed his statement again, advising his penis was out, but that it merely fell out and he was not manipulating it. Brandon finally stated that he was touching or manipulating his penis and did not know why.

Due to the aforementioned, I found probable cause to arrest Brandon for Exposure of Sexual Organs pursuant to F.S.S. 800.03(1)(a) due to him exposing his sexual organs on a private premises in the view of Alyssa in a vulgar manner.



NARRATIVE

On November 4, 2025 at approximately 1130 hours, I responded to 1590 9th Street SW, Vero Beach (IG Center) in reference to a male passed out behind the wheel.

Dispatch advised they received several calls about a male passed out behind the wheel of a vehicle. The first caller stated a white male was passed out behind the wheel of a white Volvo SUV bearing FL tag # PIMV84 at the intersection of 5th Ave SW and 27th Ave SW. The caller stated the male was completely passed out then woke up and took off southbound on 27th Ave.

A second caller called in about the same subject and stated a white male was passed out behind the wheel of a white Volvo SUV at the intersection of 27th AVE SW and 9th Street SW.

A third call was received about the male who stated a white male in a White Volvo SUV was passed out behind the wheel in front of 1590 9th Street SW.

Lt. Nolan responded to the scene where she located a white Volvo SUV bearing FL tag # PIMV84, upon making contact with the vehicle she observed a single occupant white male slumped over in the driver seat of the vehicle. She then deployed a single stop stick in front of the driver's rear tire, opened the passenger door and removed the keys from the vehicle to prevent the male from driving off. During this time the male was still passed out and hadn't moved. Lt. Nolan then opened the driver's door and shook the driver's shoulder. The male woke up at this point but was very slow and disoriented.

At this point I arrived on scene; Lt. Nolan was asking the male for his documents. The male later identified as Henry Ray Short, by his Florida ID card, was rummaging through his wallet looking for his license, he attempted to hand LT. Nolan a debit/credit card to which she stated she needed his license. I was standing at the passenger side of the vehicle watching the interaction, his movements were very slow and disoriented. I observed his drivers license sitting in the cup holder directly to the right of him in plain view. He continued to look for his license in his wallet pulling random cards out. Lt. Nolan then asked if his license was in his cup holder to which he moved it and proceeded to grab the debit/credit card underneath it and try to hand it to Lt. Nolan. At this time Lt. Nolan requested he step out of the vehicle.

I moved to the driver side of the vehicle and made contact with Mr. Short; he was than directed to the front of the vehicle. As we began to speak with Mr. Short, he started to put his hands in his pockets, to which I asked him to keep his hands visible. I then asked if I could search his pockets, he agreed. Upon searching his pockets, I located a pill bottle in his front right pocket with 6 capsule pills inside. A pill bottle in his left front pocket that contained smaller blue bottle and a syringe inside it. The blue bottle inside contained a clear liquid. The bottle had Flubrotizolam printed on the label, which after a quick search, it was discovered the substance not approved by the FDA for human consumption and is classified as a sedative, with some remarks being compared to a Benzo. Mr. Short also had an unopened suboxone in his front pocket, as well as a yellow capsule in his rear pocket. While standing with Mr. Short, I ran his drivers license through dispatch, to which they advised his license was suspended. I confirmed this information with the Driver and Vehicle Information Database, which showed that Mr. Shorts license was suspended on December 8, 2014, and he has 8 prior guilty convictions for driving while suspended or revoked.

Next, I had Mr. Short perform finger to nose, I read the instructions to him and he agreed he understood. First, I called left hand, he brough his left hand in and touched his nose, but held his finger there. I told him that it was one fluid motion and to bring his hand back out. I then called right hand, he brough it in and had to be told to extend it back out. I then called left hand again and he brough in his right hand, then called right hand and he brought in his left hand. Mr. Short then said I was tricking him. After another attempt, he again brought the wrong hand in each time.

At this time Mr. Short was placed back into handcuff and placed into the patrol vehicle.

Mr. Short was than transported to the Indian River County jail, while in route to the jail, i contact Deputy Ruiz who is a drug recognition expert. I requested he send a drug recognition expert to the jail for an evaluation.

Due to Mr. Short's level of intoxication not matching the breath sample results, a Drug Recognition Expert (DRE) was contacted. Corporal Chouinard, ID# 6176, subsequently responded to the jail to complete the evaluation. Corporal Chouinard subsequently advised Mr. Short was under the influence of a Narcotic Analgesic and a CNS Stimulant (downside) and was unable to operate a motor vehicle safely (see his DRE evaluation, for further).

Mr. Short is being charged with one count of driving under the influence of substances other than alcohol, for willfully and intentionally operating a motor vehicle while intoxicated to the point his normal faculties were impaired.

Mr. Short is also being charged with possession of a controlled substance for being in actual physical possession of a schedule 2 substance without a prescription.

Mr. Short is being charged with one count of driving while license suspended or revoked 3rd or subsequent offense for knowingly operating a motor vehicle with knowledge that his license was suspended and having 8 prior conviction or for driving while license suspended.

NARRATIVE

On Tuesday, November 4, 2025 at approximately 1235 hours, while at Walmart located at 5555 20th Street, Vero Beach, FL, I was on a separate call for service (case #2025-119220). While on this call, Loss Prevention Specialist Jacob B. Parker alerted me to a retail theft in progress.

Jacob informed me that the suspect, later identified as Eden Raine Archer, was currently in the store collecting items and that he believed she was preparing to commit another retail theft. Jacob advised that on October 11, 2025, Eden had been observed collecting several grocery and general merchandise items in a similar manner. She then pushed the cart past all points of sale and ran out of the store without paying. Jacob stated they were unable to intercept Eden at that time due to her "running" through the front door.

Jacob retrieved surveillance footage from the October 11 incident, which we reviewed together. The video shows Eden running past all points of sale with unbagged items and exiting the store. In the footage, Eden is seen wearing a similar outfit to what she was wearing today: a black snow hat, black sunglasses, a black sweater, and dark-colored pants and shoes. Jacob was able to recognize and identify her as the same individual from the previous theft. After reviewing the video at a later date, Jacob completed an itemized list of the stolen merchandise, which totaled approximately \$891.71.

Due to the prior theft, the Loss Prevention team maintained constant surveillance on Eden as she walked throughout the store. On this date, Eden again began collecting items from several departments and placed them in a shopping cart. She then approached the front of the store and stopped at an empty register. For an unknown reason, she abandoned the cart and walked out the front doors, where deputies were already waiting, as she was considered a flight risk.

Eden was intercepted by deputies and escorted back to the Loss Prevention office. The shopping cart she left behind was recovered by staff. Upon Jacob's request for prosecution for the previous retail theft, Eden was taken into custody. During the course of the investigation, it was discovered that Eden had consumed an apple pie while inside the store and failed to pay for it. The apple pie was valued at \$1.48.

Jacob provided a sworn written statement attesting to the facts of the case, along with a digital copy of the surveillance video and the itemized list of merchandise taken during the October 11 theft. The video was uploaded to the Axon Evidence site via the Axon App community request function. The affidavit and itemized list will be attached to this report.

During a search incident to arrest, Eden was found to be in possession of two glass pipes, which she stated she had used earlier in the day to smoke methamphetamine. The pipes were placed into evidence at the Crime Scene Unit.

The incident was captured on my Axon body-worn camera.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 11/04/2025 12:53 On (Specifically include facts constituting cause for arrest.) On 11/4/2025 at approximately 1253 hours, Sebastian Police received a call for assistance from Jose Morals Morales w/ Treasure Coast Mobile Crisis Response. While enroute, dispatch advised they were there to see was highly intoxicated. Upon arrival, I spoke with Morales who advised his office had received a call regarding the Defendant's who was verbally abusive and needed to be Morales explained that was throwing rocks at the Defendant. Additionally, upon initial arrival and contact with the Defendant, Morales advised the Defendant was very impaired, unable to walk, and was leaning on him for support while trying to stand. During the interaction, the Defendant became hostile towards Morales. Based on the information provided by Morales, officers went to investigate the possible allegations of As well as her ability to care for the minor in the residence. Upon knocking, the Defendant opened the door. During my initial contact, I noted the Defendant appeared highly intoxicated. I advised the Defendant of why officers were present and advised her to step out of the residence to speak with us. The Defendant stated no and proceeded to retreat into the residence. I ordered the Defendant twice to "come here" and she continued to back away from me. At this, I followed the Defendant into the residence and grabbed her arm in an attempt to gain compliance. The Defendant pulled her arm away from STATEMENI me and yelled "don't touch me". At this, I grabbed the Defendant's arms, turned her away from me, and pinned her against the kitchen / bar countertop to prevent further resistance. At this, the Defendant was placed into handcuffs. I then turned the Defendant over to other assisting officers (Ofc Sanchez and Cpl Dean). This was due to living room which was in direct line of sight to the Defendant fighting with officers. I proceeded to try and calm / reassure while other officers addressed the Defendant. During this, other officers continued to address the Defendant who was not cooperating. Cpl Dean and Ofc Sanchez began to escort the Defendant out of the residence. She became enraged and began using profanity toward Cpl Dean and Ofc Sanchez. She kicked her leg backwards, intentionally striking Officer Sanchez in the left leg. The Defendant was taken down to the ground until she became compliant again. Once calm, Ofc Sanchez and Cpl Dean helped the Defendant to her feet and began to escort her again out of the residence. She became angry again, attempting to pull away and spin around and tried to spit at Ofc Sanchez. Cpl Dean, utilized a shoulder lock technique and pinned the Defendant against the wall to prevent her from further attacking. Once she calmed down again, she was able to be removed from the residence. Once out of the residence, the Defendant was seated in a nearby chair. While there, she advised she had recently taken Klonopin (Clonazepam) as well as Zoloft. The Defendant also advised she had been drinking alcohol after taking this medication. The Defendant knew she shouldn't mix the medications. While talking with officers, she fell asleep. Additionally, throughout the interaction, the Defendant would ask a question and it would be answered for her. She would then ask the same question a few minutes later, forgetting it was just asked and answered. This occurred numerous times and with several different questions. While speaking with the Defendant, officers tried to determine what the original reason she called the mobile crisis response team for. During this, Lamp changed her timeline numerous times. When asked why was not in school, Lamb advised was hostile towards her and refused to go to school. Lamb was transported to the sepastian ER and then the Indian River Jail. who advised did not go to school because slept in and Officers spoke with Defendant) who never woke When asked if had thrown anything at the Defendant or yelled at her explained no. On November 4, 2025, at approximately 1449 hours, I was dispatched to KFC/Taco Bell located at 1809 US Hwy 1, regarding a trespassing for an employee who was being terminated.

Upon arrival, I made contact with Christina, who was the general manager. She stated that one of the employees, Azarion Pryor, was being terminated and needed to be escorted out after termination. Ofc Irwin and I made contact with Azarion at the back office. He was startled at first, but then he realized he was being terminated. Azarion then stated that he needed to leave. I tried to explain to Azarion that he was being trespassed after termination. Ricardo Bautista Vazquez was the manager who had handed Azarion his termination paperwork.

After the paperwork was given to Azarion, he was annoyed/mad and ripped the paperwork in front of Ricardo. Azarion then proceeded to leave, when Ricardo put his hands on Azarion's right arm, trying to stop him from leaving. Officer Irwin and I stepped in and corrected Ricardo, and advised him that he can not put his hands on anyone, let alone try to stop him from leaving.

Azarion made his way to the parking lot. Azarion was agitated and stated that he had no right to put his hands on him. Azarion then stated that he wanted to press charges against Ricardo.

I returned to speak to Ricardo and explained that he had committed a misdemeanor exception in our presence and that Azarion wanted to pursue charges against him.

Ricardo was placed in mechanical restraint, double-locked, and searched. Ricardo only had his wallet and phone with him. I explained to Ricardo that we were able to take his belongings with us to the county jail.

Ricardo was charged with simple battery, FSS 784.03.

On 11/4/25 at approximately 8:41PM, I was traveling northbound in the 1000 block of U.S. Highway I when I observed a white chevy Impala traveling southbound. As it passed my location opposite direction, I noticed the driver side headlight was not operational. I safely conducted a U-Turn of my marked patrol vehicle and caught up to the vehicle near U.S. Highway 1 and Schumann Drive. At no point did I lose sight of the vehicle. As I got behind the vehicle, the vehicle had a Florida tag of 63BWME. I activated my emergency lights as we passed the intersection of U.S.1. and Schumann Drive to conduct a traffic stop. The vehicle came to a stop near the entrance of Whispering Palms and U.S.1.

I conducted a driver side approach and made contact with the driver. The vehicle was occupied with just the driver. I identified myself as Corporal Singh with Sebastian PD and I requested the driver for her driver's license, registration, and proof of insurance. The driver stated she had forgotten her license at home and then proceeded to look for the other two items. I then asked the driver for her name and date of birth. The driver provided me with the following name and date of birth: Alashia A. Knight with a DOB of 11/04/1999 out of Florida. The driver stated her license was out of Florida and no other state.

I provided Sebastian Police Department dispatch center with the name and date of birth and they could not locate anyone with that name. I then confirmed with the driver again if she had provided me with the right name and date of birth. I showed the driver how I had spelled her name and she confirmed again that her name was Alashia A Knight. The information was provided again to dispatch and they still could not locate anyone with that name.

At that time, I requested the driver to provide me with her social security number to which she provided. I informed dispatch center with the social security number and they were able to locate a female by the name De'Jah A. Jacobs (FL DL J241-474-262-00-0). I was able to get a positive ID through the photo provided by ELVIS Database with the driver. Dispatch also advised De'Jah's license was suspended since 09/15/25 due to failure to pay.

At that time, the female was asked to step out of the driver seat and stand by my patrol vehicle to which she complied to. I read the driver her Miranda Rights from an agency issued card. The driver stated she understood her rights and was willing to speak to me.

NARRATIVE

On 11-4-25, I Deputy Mims, responded to the area of 41st Street and US Highway 1, in reference to locating a vehicle with a stolen tag attached who was observed by other deputies driving recklessly by running redlights and stop signs.

Upon my arrival on scene, I was advised the vehicle was traveling north on US Highway 1 approaching the intersection of 41st Street. I observed the vehicle at the traffic light at that intersection. The vehicle then proceeded north on US Highway 1 as I pulled behind the vehicle and attempted to conduct a traffic stop by activating the emergency lights and siren of my agency issued patrol vehicle. The vehicle immediately changed lanes and turned west on 42nd Street at a high rate of speed. The vehicle failed to stop at the stop sign at 42nd Street and Old Dixie Highway. The vehicle then proceeded to pass other vehicles at a high rate of speed. I deactivated my emergency equipment at that time. The vehicle then ran the redlight at Old Dixie Highway and 45th Street, heading west bound on 45th Street. At this point the vehicle lost control and crashed into a railroad crossing sign and was disabled. The driver; later identified as Tamir Divine Harrison, and sole occupant of the vehicle, immediately exited the vehicle and fled northwest from the crash on foot, ignoring all lawful commands to stop. The driver was described as a black male approximately 5'11" thin build with short dreads in his hair, wearing a blue jacket, black shirt, and black pants.

Harrison was apprehended with the assistance of other deputies. He was located wearing the same clothing as described previously. A query of Harrison's information through FCIC/NCIC and the Driver and Vehicle Information Database (D.A.V.I.D.) revealed that he had a Florida ID Card only and has never been issued a driver's license in Florida.

Based on my investigation I determined there is probable cause to charge Harrison with FSS 316.1935 Aggravated Fleeing to Elude with Damage (Felony No Bond), FSS 316.192 Reckless Driving (Felony No Bond), FSS 322.03 No Valid DL (Misdemeanor \$500 Bond), FSS 843.02 Resisting Officer without Violence (Misdemeanor \$500 Bond), and FSS 316.061 Leaving the scene of a crash (Misdemeanor \$500 Bond).
