NARRATIVE

On October 22<sup>nd</sup>, 2024, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with the caller, later identified as Michael Mowad, who informed me that he was arguing with [REDACTED] later identified as Marrisa L. Dyal, about moral issues when he got close to her face and began to flip her off. Dyal then slapped his hand and began to hit him. Mowad stated that he grabbed her hair and placed her in a chokehold in order to calm her down. Mowad sustained a small lump and scratch to his face.

I got in touch with Dyal, who told me that she and [REDACTED] were arguing outside the house about kittens when he got really close to her face and started flipping her off several times. At that point, Dyal pushed his hand away from her face, and Mowad proceeded to push his body towards hers. Dyal pushed him away with her left hand, causing Mowad to pull his hand backwards and upwards with a closed fist with a punching gesture. Dyal claimed that he attempted to punch her, but he missed. Dyal responded by punching him in the face, which caused Mowad to grab her hair, pull her towards him, punch her in the back of the head, and then place her in a chokehold until a [REDACTED] came and helped break them up. Dyal stated that she got dizzy after Mowad punched her in the head, but she was still able to breathe when he had her in a chokehold. During my interview with Dyal, I did not observe any visible injuries on her person.

I then made contact with [REDACTED] later identified as Toni L. Christino, who informed me that she was outside and witnessed the entire incident. According to Christino, Mowad was engaged in an argument with Dyal when he approached her closely and became physically aggressive. Christino also observed Dyal defending herself against Mowad. Christina tried to break up the fight until he [REDACTED] Malike, came over and assisted by separating them.

Contact was made with [REDACTED] later identified by his first name as Malike, who informed me that he was reading his book in his car when he observed Mowad and Dyal verbally arguing until Mowad got really close to Dyal's face, causing her to push his hand away. Mowad and Dyal were both involved in a physical fight until he was able to separate them. I was unable to obtain further personal information from Malike because he expressed no desire to be involved in this case.

Due to the evidence and statements from all parties involved. I believe probable cause exist to charge Michael Mowad with battery domestic violence, consistent with FSS. 784.03.1a1. Mowad was taken into custody and transported to the Indian River County Jail without incident.





**NARRATIVE**

On October 22nd, 2024, I was traveling eastbound in the 8000 block of State Road 60 when I observed a white Cadillac sedan bearing Florida registration RFEY17. When the vehicle passed me, I observed a white male driver not wearing his seat belt. I conducted a query of the above registration which showed the registered owner's license was suspended. I conducted a traffic stop in the 7600 block of State Road 60 where the vehicle yielded.

I made contact with the driver and sole occupant of the vehicle who identified himself via Florida Driver's license as Kevin Kelly, the registered owner of the vehicle. I requested his vehicle registration and proof of insurance. While Kelly was looking for his proof of insurance on his phone, I noticed his hands begin to shake and his chest began to rise and fall quickly. I asked Kelly if he had anything illegal inside of his vehicle, and he advised no. I asked Kelly for consent to search his vehicle while he continued to look for his proof of insurance, Kelly verbally granted me consent to search his vehicle. I then asked Kelly to exit the vehicle and stand on the sidewalk.

While searching Kelly's vehicle I observed a multicolor backpack on the drive-side rear seat of the vehicle. It should be noted due to the position Kelly's seat was in, he was so far leaned back, that he could easily access the backpack while operating the vehicle. I opened up the big compartment of the backpack and noticed there was another smaller pocket inside. Upon opening the smaller pocket, I observed a small clear plastic baggie containing a white powdery substance, a used syringe, and an orange bottle cap with a white powdery residue. Based on my training and experience I suspected the white powdery substance to be fentanyl and the needle used to inject illicit narcotics.

I placed Kelly into handcuffs and advised him of his Miranda warnings, Kelly advised he understood his rights. Kelly admitted to the powdery substance being Fentanyl and he is an avid user. He further advised the spent needle in the same compartment is the needle he uses to inject the fentanyl. Kelly was not able to provide me with proof of insurance further advising he does not have insurance on his vehicle due to not being able to afford the payment to maintain insurance on his vehicle.

The white powdery substance field tested positive for fentanyl using an agency-issued test kit. The fentanyl weighed less than one gram.

Based on the above Kelly was placed under arrest in violation of the following statutes;

- F.S.S. 893.135 POSSESSION OF CONTROLLED SUBSTANCE
- F.S.S. 893.147.1(3768) POSS OF DRUG PARAPHERNALIA
- F.S.S. 324.221(2) FAILURE OF OWNER TO MAINTAIN REQUIRED INSURANCE

I canvassed the area and located Jennings at the 4600 block of 32nd Avenue. I read Jennings Miranda warnings which he confirmed understanding. Jennings stated that he attempted to enter the structure through the window but alleged that a female subject was already inside and unlocked the rear door. Jennings admitted to stealing all of the above items but stated that once he exited the building he left the LED lights on the side of it. Jennings admitted to selling Morgan the tools for approximately \$20.00. Jennings admitted he knew who had the lights but failed to produce the name or address of the subject.

I found probable cause that Jennings committed dealing/trafficking in stolen property and unarmed burglary of a structure.

Jennings was transported to the Indian River County Jail without incident.

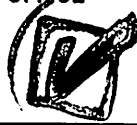

Darel was placed into my custody and transported to the Indian River County Jail without further incident.
