#### NARRATIVE

On October 22nd, 2024, I was traveling eastbound in the 8000 block of State Road 60 when I observed a white Cadillac sedan bearing Florida registration RFEY17. When the vehicle passed me, I observed a white male driver not wearing his seat belt. I conducted a query of the above registration which showed the registered owner's license was suspended. I conducted a traffic stop in the 7600 block of State Road 60 where the vehicle yielded.

I made contact with the driver and sole occupant of the vehicle who identified himself via Florida Driver's license as Kevin Kelly, the registered owner of the vehicle. I requested his vehicle registration and proof of insurance. While Kelly was looking for his proof of insurance on his phone, I noticed his hands begin to shake and his chest began to rise and fall quickly. I asked Kelly if he had anything illegal inside of his vehicle, and he advised no. I asked Kelly for consent to search his vehicle while he continued to look for his proof of insurance, Kelly verbally granted me consent to search his vehicle. I then asked Kelly to exit the vehicle and stand on the sidewalk.

While searching Kelly's vehicle I observed a multicolor backpack on the drive-side rear seat of the vehicle. It should be noted due to the position Kelly's seat was in, he was so far leaned back, that he could easily access the backpack while operating the vehicle. I opened up the big compartment of the backpack and noticed there was another smaller pocket inside. Upon opening the smaller pocket, I observed a small clear plastic baggie containing a white powdery substance, a used syringe, and an orange bottle cap with a white powdery residue. Based on my training and experience i suspected the white powdery substanace to be fentayl and the needle used to inject illicit narcatoics.

I placed Kelly into handcuffs and advised him of his Miranda warnings, Kelly advised he understood his rights. Kelly admitted to the powdery substance being Fentanyl and he is an avid user. He further advised the spent needle in the same compartment is the needle he uses to inject the fentanyl. Kelly was not able to provide me with proof of insurance further advising he does not have insurance on his vehicle due to not being able to afford the payment to maintain insurance on his vehicle.

The white powdery substance field tested positive for fentanyl using an agency-issued test kit. The fentanyl weighed less than one gram.

Based on the above Kelly was placed under arrest in violation of the following statutes;

- F.S.S. 893.135 POSSESSION OF CONTROLLED SUBSTANCE
  - F.S.S. 893.147.1(3768) POSS OF DRUG PARAPHERNALIA
- F.S.S. 324.221(2) FAILURE OF OWNER TO MAINTAIN REQUIRED INSURANCE

#### NARRATIVE

On October 22nd, 2024, at approximately 1031 hours I responded to met with Tiki Cobb who stated the following:

in reference to a past burglary. I

On October 13th, 2024, at approximately 0400 hours a male entered the above address through a small window that was unlocked. Cobb explained that no subjects have permission to enter or remain at the business during the above hours. Cobb stated that he observed camera footage from a church just to the west of his property that showed a male entering a window on the rear side of the building. I attempted to view the footage but due to the time lapse, it was deleted from its server. Cobb stated that the suspect stole two pole saws, one weedeater, one hedge trimmer all Echo brand, and approximately 24-30 Topaz LED lights. Cobb estimated all of the stolen items to be worth \$3000.00. Cobb stated that near the date of the crime, he learned information from an unknown source that Perry Morgan had purchased all of the Echo brand tools for approximately \$30.00 from Trellis Jennings. Cobbs stated he wished to pursue criminal charges.

I met with Morgan who was at Cobbs's place of business who stated the following: Morgan stated that Jennings had sold him the above tools for approximately \$30.00. Jennings had alleged that he received the tools from his father. No further statements were collected from Morgan.

I canvassed the area and located Jennings at the 4600 block of 32nd Avenue. I read Jennings Miranda warnings which he confirmed understanding. Jennings stated that he attempted to enter the structure through the window but alleged that a female subject was already inside and unlocked the rear door. Jennings admitted to stealing all of the above items but stated that once he exited the building he left the LED lights on the side of it. Jennings admitted to selling Morgan the tools for approximately \$20.00. Jennings admitted he knew who had the lights but failed to produce the name or address of the subject.

I found probable cause that Jennings committed dealing/trafficking in stolen property and unarmed burglary of a structure.

Jennings was transported to the Indian River County Jail without incident.

On October 18th, 2024, at approximately 1438 hours, I conducted a traffic stop at the 9600 block of SR 60.

Upon my approach to the vehicle, I smelled the strong odor of burnt marijuana emitting from it.

While conducting my investigation, I identified Darel Destinoble was an occupant in the vehicle. Darel is currently on felony probation reference robbery with a gun/deadly weapon F.S.S. 812.13(2)(b) (Broward County case no. 2302032).

Upon learning of Darel's probation status, I called his probation officer, Sharola Hall DOC #01985, who advised that Darel, who does not reside in Indian River County, but Broward County, is violating a stipulation of his probation to not leave the county without permission. Sharola further advised Darel was never granted permission to leave the county. Moreover, Darel is not to be around narcotics. Darel was in a vehicle emitting the odor of freshly burnt marijuana. There was a tray of "shake" (marijuana flakes) under the driver's side seat approximately where his feet were.

A subsequent teletype query would reveal additional information that Darel was a fugitive from jus an active warrant out of Georgia for which extradition is being sought.

Due to these aforementioned facts, I found Darel in violation of his probation and probable cause was developed for F.S.S. 948.06, Violation of Felony Probation and F.S.S. 941.02 Fugitive from Justice.

Darel was placed into my custody and transported to the Indian River Couny Jail without further incident.
