NARRATIVE

On Tuesday, May 14, 2024, the IRCSO received a BOLO regarding a possible DUI driver. The male was reportedly in the area 2900 of 49th Street and left a residence. The male left with a container of alcohol and was possibly under the influence. The vehicle was a gray Honda Accord (FL-62DTBU) (Statements are paraphrased)

I ocated the vehicle traveling southbound in the 900 block of S US Highway 1. I observed the tag and saw it was a match to the vehicle provided. I also observed the front right passenger window to be very dark to the point where I could not see through it.

I conducted a traffic stop on the vehicle in roughly the 2000 block of S US Highway 1 in a marked agency issued patrol car. I made contact with the driver and sole occupant of the vehicle, identified via Florida DL as Aaron Falkner. I confirmed with an agency issued tint reader that the front right passenger window was 12%. I then asked Aaron to give me his vehicle information, which was where I observed in plain view, a clear plastic baggie of a leafy green substance inside of a lunch box in the front passenger seat. I know the substance through my training and experience to be Marijuana. Aaron also admitted to me it was Marijuana and that he did not possess a Medical Marijuana card.

I then began to conduct a probable cause search of the vehicle, which is where the Marijuana was located and had a weight of approximately 15 grams. A further search of the car revealed a small black rectangular device in the center console area of the car. The device had a very thick yellow oil-like substance inside of it, which I know through my training and experience to be THC oil.

After conducting a post Miranda Interview with Aaron, he admitted to me all the substances were his and they are used for recreational use. He also admitted the black device was his and it contained THC oil, which he got from a friend. IRCSO Public Safety Dispatch confirmed he did not possess a Medical Medical Marijuana card.

Based on this information, I charged Aaron with violation of F.S. 893.13.6B Possession of Marijuana Under 20 Grams and F.S. 893.13 Possession of a Controlled Substance. Aaron was transported to the Indian River County Jail.

NARRATIVE

 Φ n May 14, 2024, at approximately 1844 hours, I responded to 6156 20th Street (Best Buy), in reference to a shoplifting.

Upon my arrival, a male suspect was in custody. I spoke with Sergeant Hoilett and Cpl. Thomas about the incident. The male was identified as Andrew Joseph Causa. Sergeant Hoilett advised that Andrew Joseph Causa, was exiting Best Buy with a box in his hand, in which he failed to purchase. Sergeant Hoilett stated that he advised Andrew he was with the Sheriff's Office and to stop, but Andrew proceeded to throw the package and run from law enforcement presence. Sergeant Hoilett proceeded to chase Andrew on foot and was able to get close to tackle Andrew to the ground.

furthermore, into my investigation, Andrew was read his Miranda Warnings, and he advised he understood. Andrew refused to cooperate with law enforcement.

I spoke with Wesley Reed Dean who was an employee at Best Buy. Wesley provided me with a written statement that revealed the following: "witnessed 2 known people whom have stolen from our store 2 weeks ago \$1600.00 worth of product Re-enter the building. The women entered first and walked headphones and mobile dept. proceeded to leave. Minutes after she left, the other person (male) walked in went to headphone grabbed product, went to appliances took off security device next to washers and dryers. Once off he stowed the security device and proceeded to leave store."

I followed Wesley back into the store where he showed me CCTV footage from April 30, 2024 of Andrew inside of the store concealing items, you can clearly see Andrew conceal them on his person. Wesley also showed me CCTV footage of the most recent incident 5/14/2024, which showed Andrew taking the security device off a product and then tossed it away. The product that Andrew passed all points of sale with and failed to pay for on 5/14/2024 was identified as Openfit shokz Beige color headphones valued at \$179.99.

Wesley advised that Andrew had previously stolen \$1,649.97 worth of items from their Vero Beach store during the April 30th theft, which included a Dyson Airwrap Smooth + Control (PERSONAL CARE) valued at \$499.99, Sonos port (Black) (Dig Home AUD Systems) valued at \$449.99 and Sonos AMP (Dig Home AUD system) valued at \$699.99.

Wesley stated that andrew is a suspect in the state of Florida, in reference to over \$16,000 worth of stolen goods from different Best Buy locations. Inside of the store, I spoke with Jose Landrua, who was a Best Buy employee that stated while he was outside of the store at his personal vehicle, he saw Andrew in the front passenger seat of the vehicle he arrived in.

Wesley stated they were having computer issues and were unable to put the CCTV footage on a disc, but advised it will be an a hard drive and will be available in the next day or so.

The vehicle in which Andrew arrived in, had a clear plastic baggie with white powder residue in plain sight on the front right passenger side door, where Andrew had been sitting. While searching the vehicle incident to arrest, a yellow bag was discovered on the passenger seat, that revealed what appeared to be more drugs and drug paraphernalia, such as a bottom piece of an aluminum can that had burn markings. Inside of the yellow bag were 5 pill capsules, white rock substance and a syringe. An agency issued test kit was used on the rock substance which tested positive for Fentanyl and was approximately 3 grams in weight. Due to not being able to test the other substances, the pill capsules and white

NARRATIVE

Oh May 14, 2024, at approximately 1844 hours, I responded to 6156 20th Street (Best Buy), in reference to a shoplifting.

Upon my arrival, a female suspect was in custody. I spoke with Sergeant Hoilett and Cpl. Thomas about the incident. Sergeant Hoilett stated that Danielle was inside her vehicle and tried to leave the scene when she saw law enforcement after having been identified as being one of the suspects by the complainant.

The female suspect was identified as Danielle Marie Lorini.

Furthermore, into my investigation Danielle was read her Miranda Warnings and advised she understood. Danielle stated at first, she was inside of her vehicle while her boyfriend, Andrew was in the store shopping and did not know what was going on. Danielle advised both herself and Andrew came to Best Buy together.

I spoke with Wesley Reed Dean who was an employee at Best Buy. Wesley provided me with a written statement that revealed the following: "witnessed 2 known people whom have stolen from our store 2 weeks ago \$1600.00 worth of product Re-enter the building. The women entered first and walked headphones and mobile dept. proceeded to leave. Minutes after she left, the other person (male) walked in went to headphone grabbed product, went to appliances took off security device next to washers and dryers. Once off he stowed the security device and proceeded to leave store."

I followed Wesley back into the store where he showed me CCTV footage from April 30, 2024 of Danielle concealing items, I can clearly see from reviewing the footage, Danielle point to items on the shelf showing her boyfriend what to steal. I also could clearly see Danielle remove an item from the shelf and conceal the item in her pink bag. Danielle made no attempt in any way to purchase the item. I was able to positively identify Danielle as the suspect on the CCTV footage. During the April 30th theft Danielle stole approximately \$1,149.98 in merchandise. The two items were a, Sonos port (Black) (Dig Home AUD Systems) valued at \$449.99 and Sonos AMP (Dig Home AUD system) valued at \$699.99.

Wesley advised that she is suspect in the state of Florida in reference to over \$16,000 worth of stolen goods from different Best Buy locations. Danielle admitted to being apart of several thefts and that the stolen merchandise was sold to fuel her drug habit.

NARRATIVE

On 05/14/2024 at approximately 2007 hours, while traveling westbound along the 1000 block of 17th Street, I observed a suv bearing Florida tag (EGSG97), traveling eastbound. When the vehicle passed my location, I noticed that the operator was James Mcelheny. Due to the driver's window being partial down, I observed that James was wearing a white Floral shirt, without a seatbelt. It should be noted, that I have had numerous contacts with James in a law enforcement capacity and had knowledge that his Florida was license was currently not valid.

When I conducted a u-turn to follow behind the vehicle, I noticed that it accelerated down 10th Avenue and then made a left turn onto 16th Place. Due to cutting across the parking lot of 1615 U.S. Highway 1, I observed that the vehicle entered into the parking lot 1605 U.S. Highway 1 (Arby's) and immediately accelerated through the parking lot east bound and failed to stop for a stop sign, prior to it making a right turn onto U.S. Highway 1. When the vehicle entered the parking lot of the above mention establishment, I observed several patrons that were standing in the area.

While the vehicle was traveling at a high rate of speed south on U.S. Highway 1, I noticed that the vehicle made an abrupt left turn onto 16th Street, turning directly in front of a vehicle that was traveling northbound. The vehicle was visually estimated to be traveling approximately 80 mph in a posted 30 mph zone, along the 700 block of 16th Street. When the vehicle, failed to stop for a stop sign at the intersection of 16th Street and 6th Avenue, I attempted a traffic stop utilizing both my emergency lights and sirens, the vehicle failed to stop and accelerated south on 6th Avenue prior to it making a wide left turn onto 15th Street. Once on traveling along the 1400 block of 15th Street, I observed that the vehicle continued traveling at a high rate of speed in a reckless manor passing two motorist that were traveling eastbound. The vehicle was than observed failing to stop for a stop sign at the intersection of 14th Street and 3rd Court.

After the vehicle made a sudden stop, I observed that it pulled into the driveway of 1371 3rd Court, which is James currently residence. James was then noticed, exiting the driver's seat and started running westbound behind several residences. At the time, the vehicle's registered owner Denley Bell come out of her home and informed me that James has been driving her vehicle all day and believes that he ran because of him possible having illegal narcotics on him or in the vehicle.

Due to standing in front of the residence, on a perimeter post, talking with Bell and surrounding neighbor's, we all heard the sound of glass breaking coming from the rear of the residence. Bell gave assisting Deputy's and myself, permission to enter her residence. Contact was made with Deputy Williams who deployed his K-9 partner Remy, who conducted a track, from the south side of the residence directly to a broken window along the rear. Assisting Deputy Mangel and Officer Doty with the Vero Beach Police Department, made contact with James in the living room of the residence, who was placed into custody.

Post Miranda Warnings, James advised when he passed by my location on 17th Street, he became scared after seeing me conduct a u-turn, due to his Florida license currently not being valid. After seeing my marked patrol vehicle for a second time, while he was traveling in the parking lot of Arby's, he panicked and took off at a high rate of speed. James also advised, that he was traveling in a reckless manor speeding and failing to stop for several stop signs, while trying to make it back to his residence. James then explained, that he noticed both my emergency lights and sirens on my marked patrol
